Hello David,

Thank you for your follow-up question, regarding the Income Assistance (IA) program. In August 2016, the Department of Education, Culture & Employment (ECE) restructured IA to improve the financial support provided to families. In addition to exempting all income intended for children (as previously outlined), we updated our

benefits to better support our families with children. The revised IA benefit structure coupled with the exemption of income intended help with the cost of raising children, such as the new Canada Child Benefit, child support and the NWT Child Benefit, results in families (with children) having more money each month.

Since August 1, 2016 food and clothing benefits are issued for all family members 18 years and older. We have also introduced a new benefit called the Community Cost Adjustment (CCA). This benefit is issued for each child 17 years and younger and accounts for the varying cost of living between each community.

In the example, provided below, the applicant has \$1013.75 more after the changes made to the IA program in August 2016. The rates are based on a single parent with two children living in Fort Smith:

Hello Mr. Poitras,

Thank you for your email regarding the Northwest Territories (NWT) Income Assistance (IA) program. The Income Assistance Program provides financial assistance to help Northerners meet basic living costs. The program reduces poverty, provides support and promotes self-reliance.

In July 2016, the Government of Canada replaced the Canada Child Tax Benefit (CCTB) with the new Canada Child Benefit (CCB). To ensure our residents receive the full benefit of this increased income program we have revised the IA Program and exempted income intended to help with the cost of raising children. I am pleased to share with you that as of August 1, 2016 all payments received from the new Canada Child Benefit (CCB) from the Government of Canada are exempted from the calculation of IA benefits. Additionally, the revised IA Program no longer count all other income types intended to help with the cost of raising children, such as child support, earnings that a child may make from working, and the NWT Child Benefit.

This approach supports the 18th Legislative Assembly's mandate related to reducing cost of living, fostering healthy families, improving the affordability of childcare and reducing poverty by increasing income of low and modest income families. We made these changes at the same time as the Federal Government changes so that our clients with children would benefit immediately from the new CCB rates.
