## Minister of Aboriginal Affairs and Intergovernmental Relations

- Support the growth of Aboriginal business development corporations and the capacity of Aboriginal governments, through the completion and implementation of memoranda of understanding that reflect the economic opportunity objectives found in modern land claims
- In collaboration with the Department of Finance, collaborate with our partners in Yukon and Nunavut, and work with the Government of Canada to increase the federal Northern Resident's Tax Deduction by at least 33 per cent, indexed to inflation
- Collaborate with our partners in Yukon and Nunavut, and work with the Government of Canada to increase federal investment in Nutrition North by at least \$40 million over four years and seek improvements to the transparency, accountability and effectiveness of the overall federal program
- Consistent with the policy of Respect, Recognition & Responsibility, invite any regional or community Aboriginal governments that are not yet a party to one, to strengthen their intergovernmental relations with the GNWT through the negotiation of an intergovernmental memorandum-of-understanding
- Work to resolve outstanding land, resource and self-government agreements with the Akaitcho, Dehcho, NWT Métis Nation, Acho Dene Koe and the Government of Canada during the term of our government, and advocate that particular focus in our negotiations be placed on land quantum
- Continue to support the Intergovernmental Council towards implementation of the vision of cooperative and collaborative management of lands and resources, as set out in the Lands and Resources Devolution Agreement
- Seek to establish a joint committee between Cabinet Ministers and Regular Members to share information and discuss approaches on the advancement of land, resource, and self-government agreements as well as initiatives to enhance relationships with Aboriginal governments
- Work with Aboriginal governments to jointly develop their human resource capacity, for example by participating in and evaluating the existing pilot project with the Gwich'in Tribal Council
- In collaboration with the Department of Industry, Tourism and Investment, pursue an agreement with the federal government on the management of offshore resources

- Support the Calls to Action of the Truth and Reconciliation Commission that fall within the jurisdiction of the territorial government, especially related to violence against indigenous women and girls
- In collaboration with the Minister Responsible for the Status of Women:
  - o support and participate in a National Round Table and National Inquiry into Murdered and Missing Indigenous Women in collaboration with families, Aboriginal governments, the federal government, and other organizations
  - o support the delivery of workshops that help to get women into politics
  - o support a communications campaign to increase the participation of women in politics

- Finalize and implement the Commercial Fisheries Revitalization Strategy to increase fish production, encourage and mentor new entrants to the Great Slave Lake fishery, negotiate an agreement with the Fresh Water Fish Marketing Corporation to access markets outside of NWT, seek federal funding to build a new fish processing plant in Hay River, and work with the Tu Cho Co-operative to promote and market fish caught in Great Slave Lake
- Develop a northern manufacturing strategy in collaboration with industry and the NWT's Manufacturer's Association to expand the manufacturing sector, identify potential areas of growth, promote, and market products manufactured in the NWT and aid in the professional and technological advancement of the industry
- In collaboration with the Department of Aboriginal Affairs and Intergovernmental Relations, pursue an agreement with the federal government on the management of offshore resources

- Increase exports by working with the tourism, diamonds, and traditional economy sectors to promote NWT products to international markets
- Attract foreign direct investment, and cross-promote minerals, furs, fish, forest products, and tourism to investors and markets



- Establish an Open Government Policy through public consultation and stakeholder engagement to provide a policy basis for a Government of the Northwest Territories approach
- Publish an Open and Accountable Government/Cabinet Manual document explaining the foundations and functions of consensus government
- Advance the principles of open data, and expand the volume and accessibility of open data from the territorial government
- Enhance awareness about how to access GNWT programs and services
- Enhance awareness about how to serve on territorial boards and agencies
- Promote gender equity on territorial boards and agencies
- Identify standards for public engagement by the Government of the Northwest Territories, including awareness, reporting, and data
- Promote awareness about information on government accountability, and enhancing the understanding and use of that information
- Support the review of the ATIPP Act and the implementation of the GNWT Privacy Framework
- Develop legislation within two years to establish an independent parliamentary Office of the Ombudsman

I am writing to confirm your mandate as Minister of Environment and Natural Resources, Minister of Transportation and Chair of the Economy and **Environment Committee of Cabinet.** 

Together, Cabinet is responsible for implementing the recently approved Mandate of the Government of the Northwest Territories in order to advance the priorities set by all Members of the 18th Legislative Assembly. The people of the Northwest Territories have entrusted all of us to manage effectively, prudently, and responsibly over the next four years. It is my expectation that you will do your part to achieve the Legislative Assembly's vision of a healthy, just, sustainable and prosperous territory.

There are both challenges and opportunities ahead of us. In order to grow the NWT economy we must stimulate economic growth, respond to the effects of climate change, and confront the rising cost of living. At the same time, we must continue to provide quality programs and services to residents. We know that in order to sustainably grow our economy we need to increase the territorial population, attract investment, settle outstanding land, resource, and selfgovernment agreements, and address the ongoing impacts of colonialism and residential schools.

These pressures exist at a time when our fiscal situation requires a strong commitment to prudence and strong financial management. Difficult decisions will be required to ensure fiscal balance and future prosperity. More than ever, we must ensure our actions are responsible and transparent.

We are well-positioned, in this post-devolution environment, to leverage our good working relationships and partnerships with other levels of government to our mutual benefit. Indeed, many of the Mandate objectives, such as adapting to climate change, lowering the cost of living, and investing in strategic infrastructure and renewable and alternative energy solutions are aligned with the priorities of other governments, including the Government of Canada.

People want a government that is more open and transparent, and which is clearly open to input from them. They also want their government to take the interests of all residents, in communities both big and small and in every region, into account. Meaningful dialogue and engagement with the residents of the NWT must be an ongoing priority for all Ministers.

The Guiding Principles of consensus government set out expectations for all Members, as well as the relationship between Cabinet and Regular Members. I expect Ministers to respect and act within the provisions of the Process Conventions governing Cabinet's communications, consultation and relationship with Standing Committees of the Legislative Assembly, Caucus and Regular Members. Our consensus government depends upon our collective commitment to working effectively together for the public good, in all that we do.

In addition to collaboration with Standing Committees, I expect Ministers will work closely and effectively with each other, to ensure that all pertinent, cross-departmental perspectives are considered when solutions to complex issues are developed. Ministers should use the appropriate Committee of Cabinet to advance Mandate commitments.

Your Deputy Ministers are accountable for assisting you to fulfill the responsibilities of your portfolio and the specific Mandate objectives for which you are accountable. You can rely upon your Deputy Ministers to advise you on process and policy, and to bring forward comprehensive options and advice for your consideration, but it is your responsibility to provide clear direction to your Deputy Ministers, including your expectations with respect to cross-departmental collaboration.

In addition to meeting the provisions of your departments' Establishment Policy, you are accountable for the specific Mandate commitments listed in the attachments to this mandate letter. Although they are not all included in the attachment, it is understood that you will continue to be accountable for the entire scope of programs, services and operations for the portfolios you hold.

As Minister, you must exercise the utmost compliance with the Conflict of Interest Act, the Financial Administration Act and the policies and procedures of the Financial Management Board. The role of Minister demands the highest ethical standards and must bear the closest scrutiny. Your actions will be the basis on which this government is measured for its commitment to ethical conduct, openness and transparency.

Our Cabinet has broad experience, fresh ideas, diverse backgrounds, and a shared commitment to respectful relationships and transparency— qualities that will generate innovative solutions to complex problems. I have full confidence that our collective capacity will result in good governance, programs and services that improve the lives of residents, stronger relationships with Canada and provinces and territories, NWT Aboriginal and municipal governments, and strategic investments that enable the prosperity of future generations and make the Northwest Territories an attractive place to live and work.

I look forward to working with you to realize our commitments. The future of the global economy, and what this will mean for the Northwest Territories, remains uncertain. However, I am certain that with a strong commitment to fiscal responsibility, thoughtful deliberation, respectful engagement and a willingness to innovate, we can achieve our vision of social progress, environmental sustainability and economic development built on a foundation of strong consensus government.

## **Minister of Environment and Natural Resources**

- Through agreements with communities, help establish and/or expand selfsufficient businesses that sell products from renewable resource harvesting
- Build partnerships to expand resources available for community-based traditional economy programs, which could be used to support, amongst other things, local operators, culturally-based tourism, and the conservation economy
- In collaboration with the Department of Lands, use the Land Use and Sustainability Framework to clearly and transparently:
  - o finalize and implement the Conservation Action Plan in order to finalize existing candidate protected areas
  - o establish Thaidene Nene Park
  - o finalize and implement the Water Stewardship Strategy action plan
  - develop an integrated comprehensive approach to the management of contaminated sites including prioritizing, sharing of responsibility in collaboration with other governments, monitoring, and a sound financial security system to prevent public liabilities
- Advance the territorial vision of land and resource management in accordance with the Land Use and Sustainability Framework, and our legislative, regulatory, and policy systems by:
  - o collaborating with the Department of Lands and the Department of Industry, Tourism and Investment to develop and propose amendments to the *Territorial Parks Act*
  - o developing and proposing amendments to the *Waters Act*
  - o developing and proposing amendments to *the Environmental Protection Act* (including the development of air quality regulations)
  - o developing and proposing amendments to the *Forest Management Act*
- Develop a strategy to manage the resources and potential economic and environmental benefits derived from household, commercial, and industrial garbage from private sector sources and in our municipalities
- Continue to implement the Traditional Knowledge Policy and Framework across the GNWT, while working with Aboriginal governments to develop an action plan to improve the inclusion of traditional knowledge in program development, implementation and decision making

- Support the Cumulative Impact Monitoring Program (CIMP) and respond to recommendations in the Northwest Territories Environmental Audit for improved environmental management
- Negotiate with Yukon, Nunavut, and Saskatchewan towards the completion of transboundary water agreements
- Develop a territorial climate change strategy that takes into account northern energy demands and the cost of living, while reflecting international and national commitments to lower greenhouse gas emissions, exploring options for carbon pricing systems, and capturing local alternatives such as hydro, biomass, wind, geothermal and solar
- Finalize, in conjunction with Aboriginal governments, co-management partners and traditional user groups, a culturally appropriate, made in the north, hunter education program for delivery in all communities of the NWT
- Develop and implement a multi-year management strategy for barren-ground caribou in the Northwest Territories
- Develop a range plan for boreal caribou in the Northwest Territories
- Develop species-specific wildlife management strategies for wood bison, muskox, and moose
- Develop country food programming to promote opportunities for the consumption of foods such as fish, wildlife, berries, and mushrooms
- Finalize a strategic plan to enhance existing programming and build new partnership initiatives to support healthy and sustainable traditional lifestyles
- Consult with Aboriginal governments to complete the next phase of regulation making under the *Wildlife Act*
- Finalize community wildland fire protection plans, and develop and propose amendments to modernize forest protection legislation

In addition to the Mandate objectives listed above, you are also accountable for:

- Supporting the efforts of our government to build and maintain respectful government-to-government relations by implementing the government-wide Aboriginal government engagement strategy
- Supporting the efforts of our government to advance the federal engagement strategy
- Updating the NWT science agenda and developing a science strategy

# **Mandate of the Minister of Transportation**

- Capture opportunities for investment in transportation infrastructure by working to secure funding to advance the Mackenzie Valley Highway, make an all-weather road from Highway 3 to Whatì, and improve access into the Slave Geologic Province
- Strengthen connections with private sector partners in transportation infrastructure, such as encouraging CN Rail to continue improving the rail line to Hay River to serve resupply needs and expand the system in accordance with demand
- Strengthen connections with public sector partners in transportation infrastructure, such as encouraging Fisheries and Oceans Canada to maintain federal community resupply port facilities and marine services in the NWT, to restore safe marine operating conditions in the Port of Hay River and at key sections of the Mackenzie River Corridor, and to improve charting and navigational aids

In addition to the Mandate objectives listed above, you are also accountable for:

- Continuing the work with Aboriginal governments and Aboriginal groups on the Mackenzie Valley Highway and lead efforts to secure federal funding to advance the Wrigley to Norman Wells segment of the route through the regulatory phase
- Leading the enhancement of the Motor Vehicle Information System (MVIS) to provide better services to residents by increasing online accessibility to driver and motor vehicle services as well as commercial permitting services
- Pursuing federal infrastructure funding to develop a long-range infrastructure investment agreement that provides flexibility to address Northwest Territories priorities, allocates funding on a base rather than per capita formula, and specifically address the strategic needs of the North
- Supporting the efforts of our government to build and maintain respectful government-to-government relations by implementing the government-wide Aboriginal government engagement strategy
- Supporting the efforts of our government to advance the federal engagement strategy
