Oral Question 830-18(2) Small Community Employment Support Program

This letter is in follow up to the Oral Question 830-18(2) raised on September 21, 2017 concerning Small Community Employment Support (SCES) program expenditures in each community.

Between April 01, 2015 and December 31, 2017, approximately \$4.09 million in SCES program funding has been expended in small Northwest Territories communities. These investments have supported more than 100 projects and have also supported 795 residents to obtain direct employment supports.

Indigenous, municipal and local governments, Indigenous organizations, Aurora College, businesses and industry associations have been involved in the delivery of these community projects.

The Department of Education, Culture and Employment has committed to provide information on the value and number of projects supported by the SCES program in Members' communities.

Further information is detailed in the enclosed attachment, summarized by fiscal year and community.
