# **Introduction**

The 2016-17 Capital Estimates are a summary of infrastructure projects which the Government of the Northwest Territories (GNWT) has deemed a priority for the 2016-17 fiscal year. These Estimates support the priorities of the 17th Legislative Assembly, being:

- Build a strong and sustainable future for our Territory
- Increase employment opportunities
- Strengthen and diversify our economy
- Address housing needs
- Ensure a fair and sustainable health care system

In supporting these priorities, the GNWT is committed to providing key infrastructure; which is the foundation of the modern economy. Infrastructure investment ensures the health and well-being of residents while laying the ground work for growth and private sector investment.

Infrastructure planning requires a balance between responsibilities to existing residents and businesses while investing for future generations. Recognizing this balance and in the spirit of consensus government the GNWT follows a Corporate Capital Planning process (which is detailed in Appendix B). This process culminates into the annual Infrastructure Acquisition Plan; which assists the Government in identifying priority projects. In finalizing the Capital Estimates, the GNWT appreciates there is both a current cost of development and a future liability for the maintenance and ultimate replacement of current infrastructure.

The final approval of the 2016-17 Capital Estimates in the Fall Session of the Legislative Assembly provides a planning period for both departments and contractors. This planning period is aimed to maximize both the procurement process and the relatively short summer construction period in the Northwest Territories.

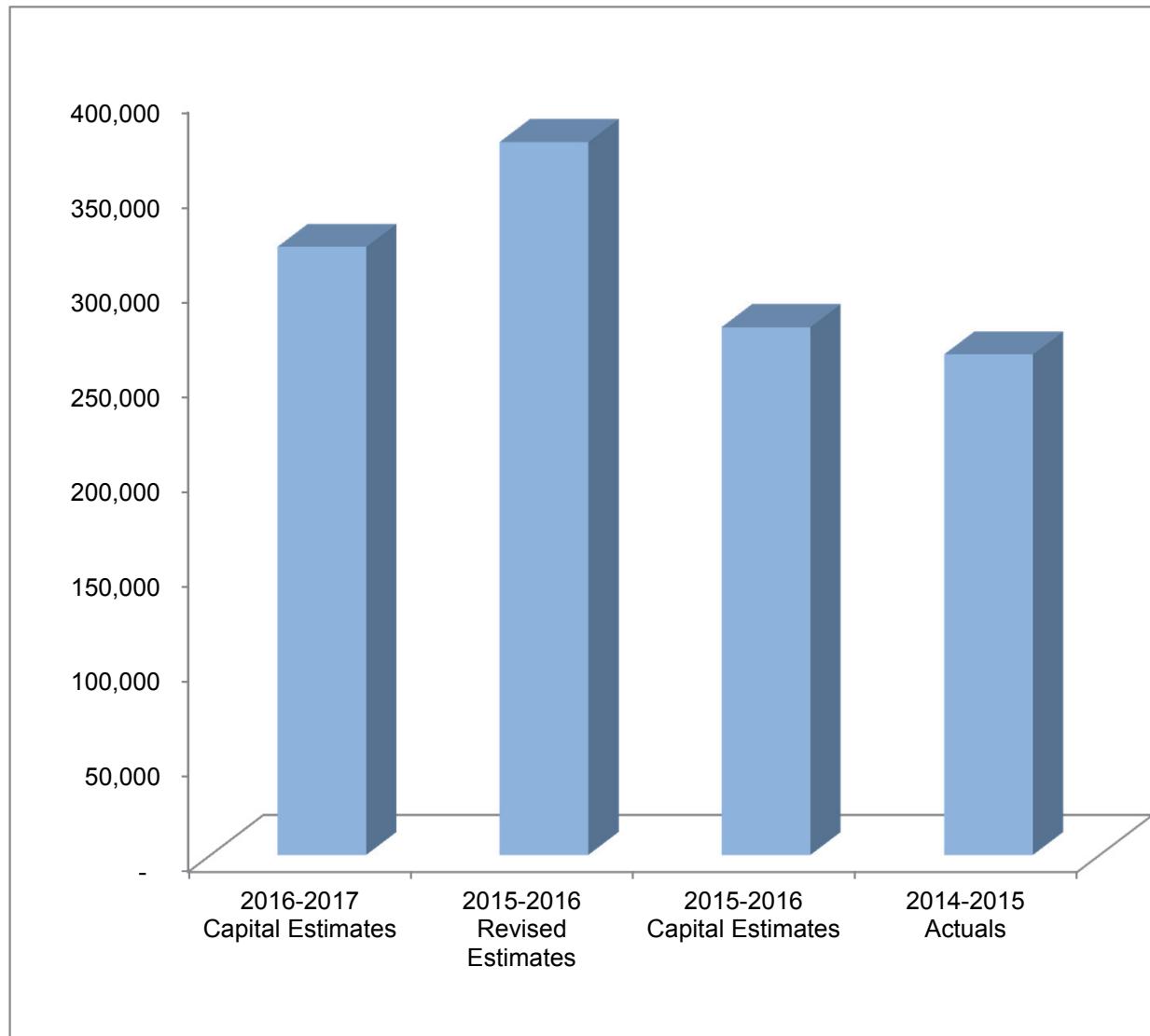

*(thousands of dollars)*



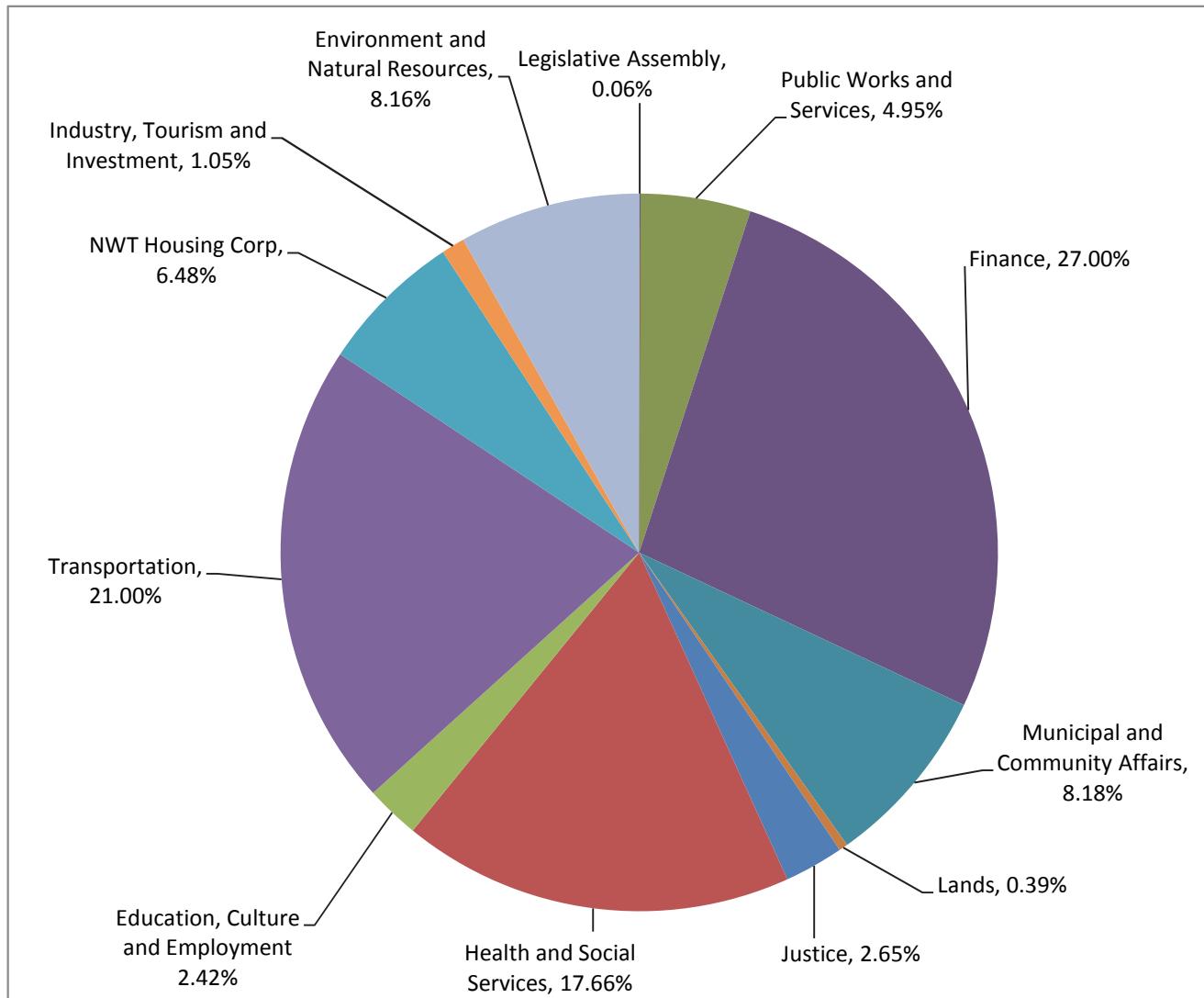

# Environment and Natural Resources

## Conservation, Assessment and Monitoring

The Conservation, Assessment and Monitoring Division (CAM) leads the establishment of protected areas and the development of an ecological representation network to help maintain a healthy environment in the NWT. CAM oversees departmental participation in the NWT regulatory process including: environmental impact assessment and water license and land use permit approvals; advises on measures to be taken to protect or mitigate impact on the environment; and, monitors to ensure these measures have been taken. CAM also works with Aboriginal governments to ensure legal and land claims requirements of cumulative impact monitoring are undertaken throughout the NWT. Initiatives ensure that valued components of the environment are monitored effectively so cumulative impacts of concurrent and sequential uses of land and water, and deposits of waste are understood. CAM promotes a sound approach to land use decision-making by including the best available traditional, ecological and cultural knowledge.

## **Forest Management**

The Forest Management activity initiatives provide for the stewardship of NWT forests through sustainable management of forest resources and forest fire management. In the course of delivering its mandate, Forest Management establishes, operates and ensures the maintenance of its infrastructure at strategic locations across the NWT. Infrastructure includes environmental monitoring assets such as radio communications networks, lightning location networks and remote automatic weather monitoring networks, buildings and other facilities, including, but not limited to, air tanker bases at strategic airfield locations, fixed detection facilities, and wildland fire response bases, and specialized equipment assets such as wildland fire mobile command units. As appropriate, ENR works in collaboration with the Department of Public Works and Services.

## **Water Resources**

The Water Resources Division ensures the water resources stewardship and management objectives of the GNWT and ENR are met in an integrated and timely manner. The Division maintains continuous liaison with all public and private sector organizations with responsibilities for sound water resources stewardship in the NWT and works closely with NWT boards that issue water licenses. The division keeps pace with innovative means to address the water-related implications of development in the NWT.

Water Resources establishes, operates and ensures the maintenance of its infrastructure across the NWT. Infrastructure includes environmental monitoring assets such as remote weather monitoring networks, water monitoring networks, buildings and other facilities, including warehouse and laboratory space. As appropriate, ENR works in collaboration with the Department of Public Works and Services.

## Budget, Treasury and Debt Management

The Budget, Treasury and Debt Management Activity is responsible for the management of the government's financial resources by ensuring that the use of public funds are properly budgeted, monitored, reviewed, and utilized efficiently.

The office of the Deputy Secretary of the Financial Management Board (FMB) oversees the management of the activity in the Division, including the GNWT Public Private Partnership Policy and Management Framework.

The Management Board Secretariat supports the operations of the FMB, and is also responsible for the GNWT's budget cycle.

The Treasury Division is responsible for licensing and regulating insurance companies, agents, brokers and adjusters operating in the NWT, administering legislated tax programs, administering the GNWT's insurance and self-insurance programs, and the GNWT Heritage Fund.

The Program Review Office has four main areas of business: the review of programs and services to clarify and confirm mandates, determine program effectiveness, and report on results with a view to recommending modifications or improvements; working with departments to assist with program review, evaluation, and performance monitoring through direct support and advice; the provision of training to build evaluation capacity in the GNWT; and integrating business planning and risk management into overall government planning processes.

## Minerals and Petroleum Resources

The Minerals and Petroleum Resources activity consists of the Mineral Resources Division, the Petroleum Resources Division, the Northwest Territories Geological Survey Division (NTGS) which was formerly referred to as the Northwest Territories Geoscience Office (NTGO), the Financial Analysis and Royalty Administration Division, the Industrial Initiatives Unit, and the Client Service and Community Relations Unit. The five regional offices across the NWT ensure that businesses and entrepreneurs receive access to programs and resources, to help maximize the benefits from development in their regions.

ITI develops and delivers policy, programs and services related to minerals, exploration and development, and manages land tenure associated with mineral resource rights for public lands in the NWT through the Mining Recorder's Office. The Mineral Information Tenure System (MITS) was implemented upon Devolution of the Mining Recorder's Office to the GNWT in order to comply with changes to the new territorial Mining Regulations. The continued development of the MITS will provide increased efficiency and operational services to the Mining Recorder's Office to ensure the efficient and effective administration of the Mining Regulations.

Upon Devolution, ITI inherited the responsibility for Aboriginal Affairs and Northern Development Canada's extensive geological collection that were collected by government and industry over several decades. The collection consists of thousands of metres of exploration drill core and numerous rock, stream sediment, lake sediment, and glacial till samples. There are also thousands of historic reports and maps from mining properties and advanced exploration projects. All these materials are considered to be government records and must be archived consistent with the Access to Information and Protection of Privacy Act and the Archives Act. The Geological Collections Storage Facility will consist of two components: a warm viewing area within an existing GNWT warehouse, and an adjacent unheated storage facility to accommodate all geological collections.

Liabilities and Financial Assurances Division oversees the management of securities against reclamation obligations of operators for resource development on public land on behalf of the GNWT, ensures a collaborative and coordinated approach among departments and central agencies, and leads policy development efforts related to liabilities and securities.

## Operations

Operations provides leadership by managing the Lands Administration Units, and the Beaufort-Delta, Sahtu, Dehcho, South Slave and North Slave regional offices.

Lands Administration provides the overall leadership, management, expertise, and development of program policies and procedures for the units responsible for Commissioner's and Territorial land administration.

The Commissioner's Lands Administration Unit is responsible for the management of Commissioner's land under the Commissioner's Land Act and Regulations. Territorial Lands Administration is responsible for the management of territorial land under the Northwest Territories Lands Act and Regulations pertaining to surface rights. Responsibilities for both Commissioner's and Territorial land administration includes: maintaining land inventories, managing and administering leases and other dispositions of land, land valuation, quarry permits, securities, processing survey applications, contract administration, record keeping including maintaining the land database, revenue collection, and unauthorized use and occupancy processes. Commissioner's Lands Administration also provides mapping services for land within the Block Land Transfer.

The Land Use Administration Unit manage the land use permitting and land securities processes in the Mackenzie Valley and Inuvialuit Settlement Region (North Slave and Beaufort-Delta Offices), and lead compliance and enforcement of land use activities in accordance with applicable legislation, policies and procedures. The Beaufort-Delta office is also responsible for environmental screening of land use permit applications in the Inuvialuit Settlement Region under the Inuvialuit Final Agreement, and issuance of land use permits in that Region.

The Resource Management Unit in regional offices conduct inspections for land leases, land use permits and water licenses; investigate potential unauthorized uses of land or land development; conduct hazardous materials and spills inspections and abandoned waste site inspection; and issue trespass notices and development permit violations. The Diamond Resource Management Unit in the North Slave office is responsible for all inspection functions at diamond mines.

## Asset Management

The Asset Management activity includes the planning, design, construction, operation and maintenance of buildings and works throughout the Northwest Territories on behalf of the GNWT.

Asset Management coordinates the government's capital planning process, the planning, acquisition and management of general-purpose leased and owned office space, and manages the disposal of surplus GNWT real property assets.

Asset Management manages and coordinates energy investments in existing building infrastructure through the department's Capital Asset Retrofit Fund Program and the GNWT's Energy Priorities Investment Program.

The Risk Management and Safety Program encompasses Deferred Maintenance and is focused on assessing the condition of GNWT building infrastructure, and identifying and undertaking remedial work to ensure that buildings continue to be safe for occupancy, ensuring that critical deferred maintenance items are addressed to maximize the useful life of these assets.

The mandate of the Department of Transportation is to plan, design, construct or reconstruct, acquire, operate and maintain public transportation infrastructure in the NWT; including community airports, docks and the highway system; and to regulate and license individuals and vehicles operating in the territory.

The Department is responsible for a transportation system that consists of 2,200 kilometers of all-weather highway, 1,625 kilometers of publicly constructed winter roads, four ferry and ice crossings and 27 community aerodromes.

The Department of Transportation's mission is to provide for the safe, secure, accessible, and reliable movement of people and goods to serve the social and economic needs and aspirations of the people of the Northwest Territories.

## Highways

The purpose of the Highways Activity is to provide highway infrastructure and services to support the provision of safe, reliable, and cost-effective inter-community travel and road transportation services. The department is responsible for operating, maintaining, rehabilitating, and upgrading public highway infrastructure in the NWT.

The NWT highway system consists of approximately 2,200 kilometers of all-weather road and 1,625 kilometers of publicly constructed winter road. It includes 100 bridges, 234 large diameter culverts, and well over 3,000 small culverts. Supporting infrastructure such as mobile equipment, highway maintenance camps and salt storage sheds helps to maintain the system.

The Road Licensing and Safety Division ensures the protection of public safety and the environment in areas of private and commercial transportation. Commercial vehicle enforcement is undertaken at permanent weigh scales located near Enterprise on the Mackenzie Highway and near Inuvik on the Dempster Highway. The department operates a weigh in motion scale and tolling system near Fort Providence, a self-weigh scale near Fort Simpson and Hay River, and a mobile weigh scale and inspection unit used by enforcement officers on patrol throughout the territory. Commercial carrier inspections are carried out at pull outs across the territory.

<b>Activity</b>	A subdivision of a Department

<b>Deferred Maintenance (DM)</b>	Is a dedicated allocation of funds to the maintenance of Government owned assets. Historically, maintenance has competed for funding with other projects and was often deferred
<b>Department</b>	Organizational entity established by Cabinet to deliver programs and services within a specified mandate
<b>Infrastructure Contribution (IC)</b>	A contribution made to a third party by the GNWT to purchase, construct or develop a Tangible Capital Asset, where the risks and rewards incident to ownership are retained by the third party
<b>Large Capital Asset</b>	A Tangible Capital Asset with a total project cost of at least \$400,000.
<b>Location</b>	Community where the asset is located Various if not located in or near a specific community; eg. a highway project
<b>Public Private Partnerships (P3)</b>	A business venture which is funded and operated through a partnership of government and one or more private sector companies.
<b>Revised Estimates</b>	Includes the Capital Estimates and Supplementary Appropriations (Infrastructure), No. 1 and 2
<b>Small Capital Asset</b>	A Tangible Capital Asset with a total project cost of \$50,000 or greater, but not exceeding \$400,000
<b>Tangible Capital Asset (TCA)</b>	A non-financial asset having physical substance that is acquired, constructed, developed and: <ul style="list-style-type: none"><li>• is held for use in the production or supply of goods, delivery of services or program outputs;</li><li>• has a useful life extending beyond one fiscal year and is intended to be used on a continuing basis;</li><li>• is intended to be used on a continuing basis;</li><li>• is not intended for resale in the ordinary course of operations; and</li><li>• cost is equal to, or greater than, \$50,000</li></ul> Examples of major categories of tangible capital assets are: <ul style="list-style-type: none"><li>• Land (other than land acquired at no cost to the government)</li><li>• Roads, Bridges, Ferries</li><li>• Airstrips and Aprons</li><li>• Buildings</li><li>• Water and Sewer Works</li><li>• Mainframe and software systems</li><li>• Leasehold Improvements</li><li>• Mobile and Heavy Equipment</li><li>• Major Medical Equipment, and</li><li>• Other Major Equipment</li></ul>

## Appendix B

# Capital Planning Process

The Capital Planning Process is a committee-based process that has several groups continuously reviewing and monitoring each step of the process to ensure that there is the proper amount of review and oversight to maintain process integrity.

The Capital Planning Process is built on the following cornerstones:

- Establishment of clear roles and responsibilities
- Accurate and timely project planning
- Justification of capital projects through the capital planning process, and
- Controlling project cost and risk.

This process allows one Government capital investment target and all departmental projects compete for funds within the target. Projects are prioritized on a government-wide basis according to a specific ranking criteria.

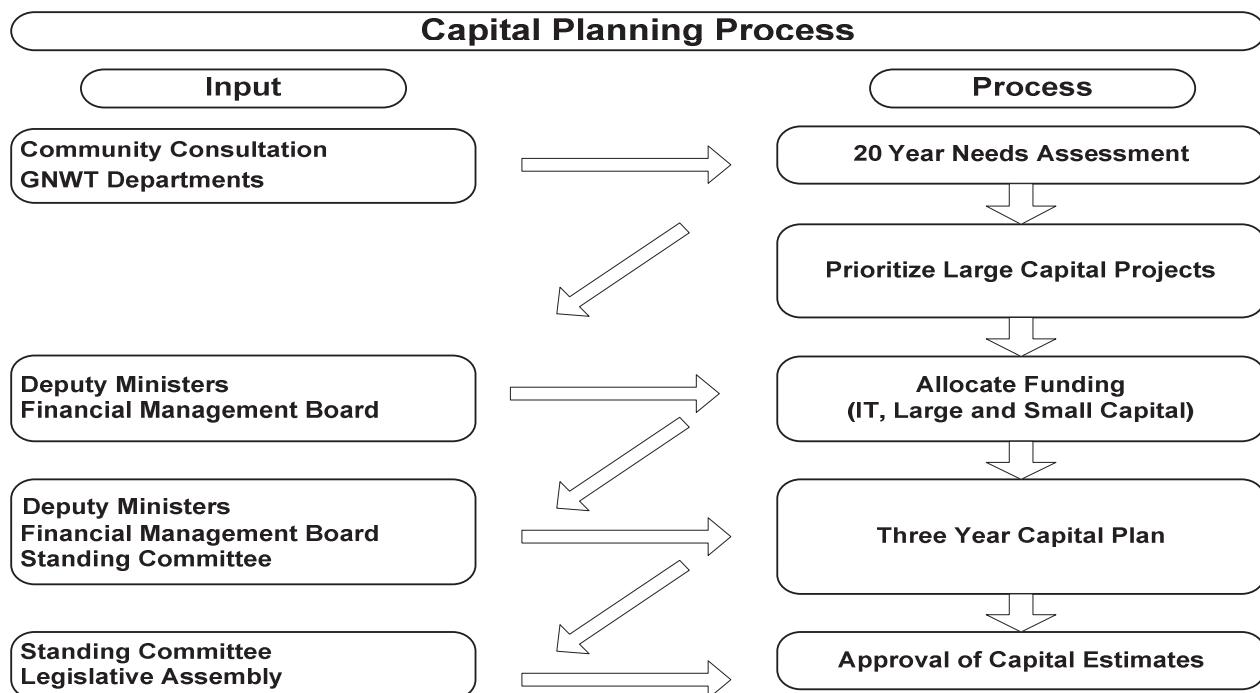
The primary criteria for ranking capital projects are as follows:

1. Protection of People;
2. Protection of Assets;
3. Protection of Environment;
4. Financial Investment; and,
5. Program Needs or Requirement.

Secondary criteria are used to further assess the urgency of projects, within each of the primary criteria. The secondary criteria are as follows:

1. Direct Impact Scale – how many impacted?
2. Severity of Impact – what is the impact?
4. Urgency – how soon is it needed?
3. Mitigation – what else can be done?

The capital planning process can be summarized from the following process chart:
