I want to record with you my opposition to the motion proposed yesterday to extend the 17th Assembly by one year. This move is anti-democratic in the sense that there is no opportunity for public consultation, and little time (five days) for public debate. With devolution scheduled to make place in about three weeks, I don't see the necessity of government continuity for an additional 2.5 years. In 1.5 years, on the original election date, people should have a say about the performance of their MLAs and the decisions they have made about devolution.

I can imagine a situation in which one or more MLA resigns in 2015 to run for the federal seat or as mayor of a tax-based community. That means there will be a by-election and the additional cost - or leaving the seat open, which is worse.

I urge you to leave the election date where it is and face the electors with your skills and decision-making record and see whether they want to return you to the assembly.
