# **Victims Assistance Committee**

## **VICTIMS OF CRIME ACT**

The *Victims of Crime Act* establishes the Victims Assistance Fund (VAF) and provides for the appointment of a Victims Assistance Committee.

#### **VICTIMS ASSISTANCE FUND**

The VAF is a special-purpose fund maintained with revenue from victim fine surcharges from territorial and federal courts. The VAF supports community-based projects and activities that provide services and assistance to victims of crime through:

- Training to sensitize and inform community resource workers about the needs and circumstances of victims of crime;
- Direct services that assist victims through crisis response, personal support, followup assistance, information, and referrals;
- Public awareness and information on the rights and responsibilities of victims, available services, the criminal justice system and its procedures, and any other issues relating to victims of crime;
- Research into the needs and concerns of victims;
- Distribution of victim services information and:
- Promotion of services for victims.

The VAF does not provide direct financial compensation to individual victims or their families. The VAF mandate does not include funding proposals or projects from private businesses. As this is a revolving fund based on victim of crime surcharges from the NWT and Federal Courts, the amounts vary and available funds are limited at times.

#### VICTIMS ASSISTANCE COMMITTEE

Committee members are appointed for three-year terms to make recommendations to the Minister of Justice about priorities and policies regarding the needs and concerns of victims of crime and about disbursements from the revolving Victims Assistance Fund.

The committee's objective is to support comprehensive community services including, but not limited to, victim support, information and assistance, coordination of criminal justice and community justice interventions, and training in best practices of staff and/or volunteers in how to best meet the needs of victims. Where a full-service agency is not feasible, the committee supports innovative and community-based workshops, events, and projects to provide support to victims of crime and to raise awareness in the community of the impact of crime on victims.
