5. That I currently reside at Lot 29, Plan 34, Tsiigehtchic, NWT and have resided in the community of Tsiigehtchic since 1977 and in Lot 29, Plan 34, since February 2011. Prior to living at Lot 29, Plan 34, I resided in Unit 2, Sunshine Inn from July 2008 to January 2011.
6. That when I am not required to be in Yellowknife for Sessions of the Legislative Assembly, meetings of its Committees or other business as a Member, Lot 29, Plan 34, Tsiigehtchic, is the place where I normally reside, sleep, prepare and have meals, and maintain my clothing, furnishings and effects, and it is where people would know to ordinarily contact me when I am not required to be in Yellowknife for Sessions of the Legislative Assembly, meetings of its Committees or other business as a Member.
7. That I consider Lot 29, Plan 34, Tsiigehtchic to be my home and when I refer to home I am referring to this place of residence.



8. That I rent this residence and a copy of a letter from my landlord, dated November 22, 2011, confirming my rental details is attached to this document as exhibit "B". Attached hereto and marked as exhibit "C" is a copy of a letter from my previous landlord in Tsiigehtchic confirming the period of time which I rented the unit in the Sunshine Inn.
9. That attached as exhibit "C" is confirmation from my landlord that I rent from him and have paid my rent. He normally does not give me receipts, however, I have paid my rent when it is due and am current in my rent payments.
10. That my spouse, as defined by the *Family Law Act*, resides with me at this address.
11. That I have seven dependants. Five of my dependents reside with me at this address in Tsiigehtchic.
12. That I pay for the following utilities at my residence:

Power through NWT Power Corporation, water sewer through the municipal office, and fuel. In addition, I pay for a phone connection with NorthwesTel.
13. That attached as exhibit "D" to this document are copies of the following utility bills: I have a list of my power bills from NWT Power for the past 10 months. I have also attached a statement from the Tsiigehtchic Charter Community setting forth my invoice amounts for water and sewer for the past 12 months. I cannot get a receipt for the fuel as I pay in cash and they come and fill up the tank. If I am not there when they arrive, I don't get a receipt. On a go forward basis, I will try to get a receipt from the fuel company when I make arrangements for fuel delivery.
14. That in the taxation year 2010, I filed a tax return with Revenue Canada stating that my place of residence was Box 64, Tsiigehtchic. Attached to this document as exhibit "E" is a copy of my Notice of Assessment showing my mailing address.
