# Aboriginal Student Achievement Project Proposal 2010-2011

#### **Brief rationale of ASA:**

The NWT Aboriginal Student Achievement (ASA) partnership project proposal has been developed in response to the need to eliminate the gap in education achievement between Aboriginal and non-Aboriginal students.

There are promising indicators of overall improved education achievement among Aboriginal students. Indicators include improved senior secondary graduation rates, and more students enrolling in grade 12. Nonetheless, there is more work to do. ECE has identified school attendance as a major factor that contributes to education achievement. The average NWT Aboriginal student misses over 41 school days which is equivalent to missing two full years of school by the time a student reaches high school.

ECE is coordinating four Aboriginal Student Achievement initiatives with its partners in the 2010-11.

- 1. One pilot project, in every community, will focus on attendance.
- 2. A public campaign promoting school attendance, information about the education system, and parental responsibilities in relation to education;
- 3. Departmental research on current literacy projects in NWT schools as they relate to Aboriginal Student Achievement; and
- 4. Implementation of a culturally appropriate orientation for all new teachers in the NWT beginning in 2010-11.

ECE is inviting all NWT education superintendents to apply for \$10 K to design, develop and implement a pilot project for each community within their district focused on increasing attendance throughout the 2010-11 school year. The project will include a fresh idea to achieve success in attendance and student achievement for Aboriginal students and will include matching funds from a partner(s).
