- (3) **SPEAKER:** annual figure of \$41,059 for Speaker.
- (4) **SPECIAL ANNUAL INDEMNITIES FOR EXTRA DUTIES:** Deputy Speaker: \$6,643; Deputy Chair, Committee of the Whole: \$3,986; Chair of Standing Committee: \$5,886; Chair of Special Committee: \$2,943; Chair of Caucus: \$2,943.
- (5) **ALLOWANCE FOR EXPENSES:** Basic Allowance: annual figure of \$6,797 for all Members. Additional Allowance: annual figure of \$6,797 for all Members who do not live within commuting distance of the capital; Ministers are considered to live in Yellowknife and only receive the basic allowance.
- (6) **NORTHERN ALLOWANCE:** Annual amount paid in respect of the community in which Members live. Same as provided under the Collective Agreement.
