(3) SPEAKER: annual figure of \$40,108 for Speaker.

(4) SPECIAL ANNUAL INDEMNITIES FOR EXTRA DUTIES: Deputy Speaker: \$6,489; Deputy Chair, Committee of the Whole: \$3,894; Chair of Standing Committee: \$5,750; Chair of Special Committee: \$2,875; Chair of Caucus: \$2,875.

(5) ALLOWANCE FOR EXPENSES: Basic Allowance: annual figure of \$6,640 for all Members. Additional Allowance: annual figure of \$6,640 for all Members who do not live within commuting distance of the capital; Ministers are considered to live in Yellowknife and only receive the basic allowance.

(6) NORTHERN ALLOWANCE: Annual amount paid in respect of the community in which Members live. Same as provided under the Collective Agreement.
