




Dear Mr. Speaker:

RE: Jackie Jacobson, MLA, Nunakput Private Disclosure Statement

Mr. Jackie Jacobson has failed to file a completed Disclosure Statement with me as required by Section 87 of the *Legislative Assembly and Executive Council Act* (the Act). Mr. Jacobson was provided with copies of the required forms by letter from me dated October 11, 2007. In that letter I advised Mr. Jacobson that he was obligated to complete and file the Disclosure report with me by December 17, 2007.

I reminded Mr. Jacobson of this obligation by facsimile communications sent to him on December 7 and December 14, 2007.

On December 18, 2007, I returned a telephone call from Mr. Jacobson, at which time he told me that he needed to request a two-week extension for the filing of his Disclosure Report. At that time I advised him to fax me immediately setting out the request and the reason for it. At the time of writing this letter, I have heard nothing further from him.

I am providing this report to you in accordance with the provisions of Section 99(2) of the Act. For your assistance I set out hereunder the provisions of Section 99(2) and Section 99(3) of the Act (the latter section sets out your obligations in the circumstances).

"99(2) Notwithstanding paragraph (1)(a), the Conflict of Interest Commissioner may, at any time, submit to the Speaker a report identifying a member who has

(a) filed a disclosure statement or supplemental disclosure statement after the expiry of the time permitted for such filing in section 87 or, where an



- extension of time has been obtained under section 97, after the expiry of such extended period of time; or
- (b) failed to file a disclosure statement or supplemental disclosure statement before the report is submitted to the Speaker where the report is submitted after the expiry of the time permitted for such filing in section 87 or, where an extension of time has been obtained under section 97, after the expiry of such extended period of time.
- (3) The Speaker shall cause a report received under subsection (1) or (2) to be laid before the Legislative Assembly as soon as is reasonably practicable."

I am sending this letter to you by facsimile communication and the original letter by mail.

Additionally, I am sending a copy of this letter by fax to Mr. Jacobson with the original copy by mail.
