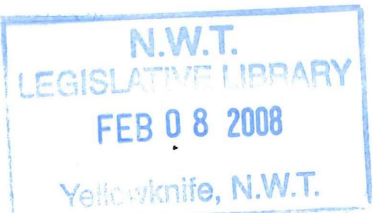


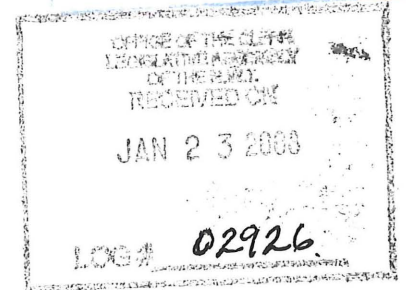

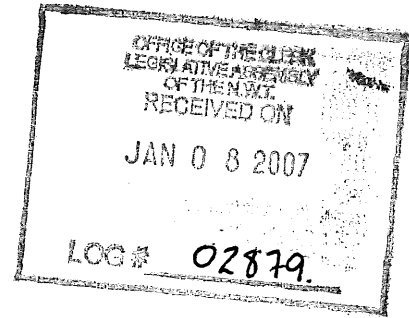

**RE: Robert C. McLeod, MLA, Inuvik Twin Lakes
Private Disclosure Statement**

I advise you that Robert C. McLeod has not filed with me his completed Disclosure Report as required by Section 87 of the *Legislative Assembly and Executive Council Act* (the Act).

Mr. Robert C. McLeod was duly advised of his obligation to complete and file with me a Disclosure Report by December 17, 2007, when I wrote to him in some detail by letter dated October 11, 2007. He was reminded of this obligation by letters sent to him by facsimile communication on December 7, 2007 and December 14, 2007.

I am providing this report to you in accordance with the provisions of Section 99(2) of the Act. For your assistance I set out hereunder the provisions of Section 99(2) and section 99(3) of the Act (the latter section sets out your obligations in the circumstances).

“99(2) Notwithstanding paragraph (1)(a), the Conflict of Interest Commissioner may, at any time, submit to the Speaker a report identifying a member who has

- (a) filed a disclosure statement or supplemental disclosure statement after the expiry of the time permitted for such filing in section 87 or, where an extension of time has been obtained under section 97, after the expiry of such extended period of time; or
- (b) failed to file a disclosure statement or supplemental disclosure statement before the report is submitted to the Speaker where the report is submitted after the expiry of the time permitted for such filing in section 87 or, where an extension of time has been obtained under section 97, after the expiry of such extended period of time.



(3) The Speaker shall cause a report received under subsection (1) or (2) to be laid before the Legislative Assembly as soon as is reasonably practicable.”
