does not exceed \$500,000 per annum.

- b) Loans will not be made to discharge any indebtedness of the applicant.

ESKIMO LOAN FUND

Consideration is being given to the transfer of certain responsibilities respecting loan administration and approval authority to the Commissioner of the NWT during 1971.

Purpose:

- a) Finance the purchase of tools,

 materials and stock in trade necessary for engagement in any gainful
 occupation.
- b) the construction, purchase, reconditioning or repair of vehicles, vessels, canoes, aircraft, commercial buildings, shelters for fishing, hunting or trapping and furniture.
- c) the reconditioning or repair of buildings
- d) the purchase, repair or reconditioning of engines and other machinery including any ancillary equipment required for such engines and other machinery.

Maximum Amounts:

Loans up to \$50,000 may be approved by the Minister of IA and ND.

Loans exceeding \$50,000 require approval of the Treasury Board.

FISHERMENS LOAN FUND
