Wilderness training for offenders

WHITTEHORSE Y.T. (CP) — Youthful prisoners at the W hitchorse Correctional Centre have been roaming through the Yukon wilderness, but they're not on a prison break.

Three groups of eight young offenders have spent 10 days in the wilderness with corrections officer Gary McLaughlan in a territorial governmentsponsored leadership training course. They've gone into the woods with only a minimum of supplies, so minimal that on one occasion they resorted to eating gophers.

V. L. Ogison, director of corrections for the Yukon, says the government hopes the pilot project will give "dissident and indifferent" offenders, a sense of self-confidence, co-operation and leadership ability. He says the boys are despondent and unco-opcrative when they leave for the expedition, but are enthusinstic after returning.

Mr. McLaughlin's diary indicates the wilderness trips are no picnic.

"By the time we stopped for lunch we were so wet, 1 thought wo'd crossed the Mekong Delta. We had walked 10 miles in 11 hours with an average of 55 pounds carried by each of us. The only incident ...was that of our leader getting lost."

The leadership training program is styled after outwardbound courses for young offenders in Ontario and British Columbia. The Yukon government has no permanent camp and the boys camp in tents.

Pricing of Dickins to await commissio

City council Monday asked for a report from the commission board before setting a price on 82 lots in Dickinsfield.

The economic affairs committee recommended that the lots be sold for \$126 per front foot, giving prices for unimproved lots r an g in g from \$6,300 for 50-foot lots to \$3,640 for a 60-foot lot. Local improvement charges add an extra \$2,704 to \$5,239,74 to the price of the lots.

The committee also recommended that seven lots in-Riverbend go to tender on the basis of a reserve bid.

Before council referred the matter to the commissioners, Ald. B. C. Tanner moved that the Dickinsfield lots be advertised for 30 days and then sold at a 20-per-cent discount to individuals wishing to build in 1973.

"Our policy should be to make lots available to individuals without a great big mark-up," Ald. Una Evans said.
