FURTHER TO UR TLX OF FEB 4 CONCERNING THE IMPLEMENTATION OF THE
RECOMMENDATIONS OF THE NWT HOUSING TASK FORCE I AM ADVISING
COMMISSIONER HODGSON THAT THE REMAINING DEPT'L RESPONSIBILITIES UNDER
THE NORTHERN RENTAL HOUSING PROGRAM WILL BE TRANSFERRED TO THE
ADMINISTRATION OF THE NWT GOVT WHEN THE TERRITORIAL GOVT HAS
ESTABLISHED THE NWT HOUSING CORPORATION
I AM ASKING MR HODGSON AND MR HUNT TO DISCUSS DETAILS AND TO COMPLETE
NECESSARY ARRANGEMENTS SOON AS POSSIBLE

WITH RESPECT TO THE OTHER 2 MAJOR TASK FORCE RECOMMENDATIONS YOU
ARE PROBABLY AWARE THAT A FURTHER MEETING TO DISCUSS THEM IS TO BE
HELD IN YELLOWKNIFE EARLY NEXT WEEK BETWEEN FEDERAL AND TERRITORIAL
OFFICIALS

I WILL BE WRITING TO YOU LATER WHEN I RECEIVE FURTHER WORD ON THE
PROGRESS OF THE DISCUSSIONS

MEANWHILE I HAVE INDICATED TO COMMISSIONER HODGSON THAT NO SIGNIFI-
CANT CHANGES ARE TO BE MADE IN THE EXISTING NORTHERN RENTAL HOUSING
PROGRAM UNTIL I HAVE HAD AN OPPORTUNITY TO REVIEW THE WORK OF THE
WORKING GROUP TO CONSIDER ALL PROPOSED CHANGES AND TO DISCUSS THEM
WITH NWT COUNCIL AND GOVT
