THIS RESOLUTION WAS PASSED AT THE LAND CLAIMS MEETING IN RANKIN INLET, NOVEMBER 6, 1980.

THE DELEGATES TO THIS LAND CLAIMS CONFERENCE IN RANKIN INLET EXPRESS AND CONVEY THEIR SINCERE THANKS AND APPRECIATION TO THE CHAIRMAN AND OTHER MEMBERS OF THE NWT LEGISLATIVE ASSEMBLY'S COMMITTEE FOR THEIR VILIFIDES, EFFORTS AND RESULTS.

NOW THEREFORE BE IT RESOLVED THAT:

AND WHEREAS THE CHAIRMAN AND OTHER MEMBERS OF THE COMMITTEE ON UNITY ACTED WITH NOTEMORTHY DILIGENCE AND FAIRNESS IN RESEARCHING AND WRITING THEIR REPORT;

AND WHEREAS THE SPIRIT AND CONTENTS OF THE REPORT OF THE COMMITTEE ON UNITY ARE LIKELY TO CONTRIBUTE IN A DIRECT AND SIGNIFICANT WAY TO THE CREATION OF A NUNAVUT TERRITORY WITH ITS OWN TERRITORIAL GOVERNMENT;

AND WHEREAS THE NWT LEGISLATIVE ASSEMBLY'S COMMITTEE ON UNITY HAS MADE PUBLIC ITS REPORT ON POLITICAL DEVELOPMENT IN THE EXISTING NWT;

AND WHEREAS REPRESENTATIVES OF INUIT TAPIRIAT OF CANADA AND ITS AFFILIATED REGIONAL INUIT ORGANIZATIONS WITHIN NUNAVUT EXPRESSED THIS COMMITMENT DIRECTLY TO THE MEMBERS OF THE LEGISLATIVE COUNCIL IN ITS RECENT SESSION IN FROBISHER BAY;

AND WHEREAS INUIT TAPIRIAT OF CANADA AND ITS AFFILIATED REGIONAL INUIT ORGANIZATIONS WITHIN NUNAVUT HAVE BEEN ACTIVE IN EXPRESSING THE COMMITMENT OF THE PEOPLE OF NUNAVUT TO THE CREATION OF A NUNAVUT TERRITORY WITH ITS OWN TERRITORIAL GOVERNMENT;

WHEREAS THE PEOPLE OF NUNAVUT ARE COMMITTED TO THE CREATION OF A NUNAVUT TERRITORY WITH ITS OWN TERRITORIAL GOVERNMENT;

THIS IS A RESOLUTION REGARDING THE REPORT OF THE NWT LEGISLATIVE ASSEMBLY COMMITTEE ON UNITY.
