I WOULD APPRECIATE YOUR BRINGING THE FOLLOWING POINTS TO THE ATTENTION OF THE LEGISLATIVE ASSEMBLY CONCERNING COMMENTS THAT HAVE BEEN MADE IN THE ASSEMBLY APOUT THE ACTIONS OF THE IN TURN TOWN COUNCIL OVER THE IMPOSITION OF CONTROLS BY THE NAT GOVERNMENT AT THE INUVIK LIQUOR STORE.

THE COURT ACTION BEING TAKEN BY MOTION OF THE JNIVIK COUNCIL DOES NOT RELATE TO LIQUOR CONSUMPTION OR OTHER LIQUOR PROPLEMS IN INJUIK AND WE BELIEVE THAT OUR ACTION IS BEING MISINTERPRETED BY THE NWT LEGISLATIVE ASSEMBLY. THEINUVIK COUNCIL IS CONCERNED WITH THE IMPROPER PROCEDURES ASSOCIATED WITH THE IMPOSITION OF CONTROLS WHERE THERE ARE CLEAR PROCEDURES TO BE FOLLOWED IN THE PRESNT NWT LIQUOR ORDINANCE.

ALSO THHERE HAVE BEEN COMMITMENTS MADE TO THE INUVIK TOWN COUNCIL
PY THE COMMISSIONER AND BY MINISTER GEORGE BRADEN_THAT AVISIT_
WOULD BE MADE TO_MEET WITH THE INUVIK COUNCIL PRICE TO ANY_ACTION
ON LIQUOR CONTROLS AND THAT PROPER PROCEDURES WOULD BE FOLLOWED
PEFORE ANY ADMINISTRATIVE ACTION WAS TAKEN. THE INUVIK_TOWN COUNCIL
IS TAKING A STRONG STAND ON THIS PROCESS OF LAW AND WOULD BE TAKING
THE SAME ACTION IF THE NAWT ADMINISTRATION HAD TAKEN UNIT ATERAL
ACTION ON OTHER MATTERS OF MUNICIPAL JURISDICTION SUCH AS LOCAL
TAXES, DOG CONTROL OR ZONING.

IT IS REGRETTED THAT TERRITORIAL COUNCILLORS ABE ALLOWING INIVIK'S ACTIONS TO BE MISINTERPRETED AS THE REQUIREMENT FOR THE TERRITORIAL GOVERNMENT TO FOLLOW ITS OWN LAWS IS A PASIC FLEMTN OF DEMOCRATIC TRADITION IN THE NORTHWWST TERRITORIES WHICH MIST BE THE CONCERN OF EVERY LEGISLATIVE ASSEMBLY MEMBER. THE INJVIK COUNCIL'SU ATTEMPTS TO TAKE CORRECTIVE ACTION ON OUR LIQUOR PROBLEMS ARE WELL DOCUMENTED AND WE APOLOGIZE TO NO ONE FOR OUR EFFORTS. WE SINCERELY WISH THAT THERE COULD BE MORE INDERSTANDING AND CREATIVE EFFORTS IMPLEMENTED THAT WOULD MKE THE NORTH A PETTER PLACE FOR ALL.
