

# Services to Business Handbook

- This handbook is a combination of as many, reasonable and applicable, federal, territorial, and other programs and services available to existing and potential businesses in the Northwest Territories.
- Resource material for this handbook are comprised of the most recent publications and brochures on programs and services offered by the above mentioned sources. It is assumed that all programs/services are current and in effect. However, it may be possible that some have been discontinued since publication date.
- Additional "hidden" programs/services may not have been included since they are not currently in effect, have not been advertised or indicated publicly, or are not applicable in the N.W.T.
- An applicable selection of assistance programs/services to manufacturing, industry and R. and D. firms is included to hopefully stimulate awareness in this sector which is lacking in the N.W.T. economy. A few export assistance programs/services are included for the same purposes.
- The nature and eligibility of programs/services ranges from general to specific depending on program/service. In all cases further information should be obtained, regardless, before making application.
- The addresses are as current and local as could be determined from available resource materials. Some may be outdated (i.e. federal programs based in Ottawa), others may have a more local or specific address. In all cases the address given should provide information and or directions.
- This handbook was intended to be as flexible and basic as possible. As such it covers a useful range of those programs/ services available without being too ponderous or confusing.

# INTRODUCTION

This handbook was written for the business owner, manager or persons wishing to establish a business. Therefore, the following programs and services have been organized to answer the questions business people ask most often about government programs and services.

- What advice can I get in starting a new business?
- What help can I get in financing my business?
- What is available in the areas of research and development, and innovational incentives?
- What assistance can I get in marketing my products?
- What help is there if I have to adjust to major market changes?
- What special help is available for specific or slow-growth sectors?
- What particular measures are available to help small business?

In response to each of these questions the handbook describes financial assistance programs and the range of services provided by government to business, it also indicates the mix of assistance available, explains who is eligible and indicates where to contact for information or application.

# I. Financial Assistance Programs

# G.N.W.T. Smail Business Loans and Guarantees Fund.

### Nature

The Government of the N.W.T. administers this Fund to provide term loans and loan guarantees to business enterprises in the N.W.T. where the required credit or other financial assistance is not available from other sources on reasonable terms and conditions. Loans and bank loan guarantees are limited to a maximum of \$100,000 and a term of 15 years for the purposes of financing the purchase, installation, renovation, improvement, or expansion of equipment, inventory, or premises used or to be used in carrying on a small business enterprise.

# Eligibility

New or existing business in the N.W.T. whose gross revenues do not exceed \$1 million per year.

# Eskimo Loan Fund (E.L.F.) Eskimo Economic Development Contributions (E.E.D.C.)

### Nature

This program provides funding for direct loans and loan guarantees for commercial enterprises operated by Inuit or Inuit controlled organizations. Purposes include establishment of commercial business, additional working capital to existing businesses, building construction, purchase or renovation, purchase of vehicles and aircraft to be used for commercial purposes. E.E.D.C. grants may be granted in conjunction with E.L.F. loans. There is no prescribed limit for contributions, each case will be decided on its own merits.

# **Interim Subsidiary Agreement (G.D.A.)**

### Nature

The G.D.A. Program provides, through subsidiary agreements, a higher standard of living, quality of life and equality of opportunity for northern residents. Using the combined funding sources of the G.N.W.T., D.R.E.E. and D.I.A.N.D. the G.D.A. currently finances subsidiary agreement projects and programs in the following areas:

# Assistance to Industry (G.N.W.T.)

### Nature

This program is designed to provide contributions to private businesses, umbrella organizations and to government projects destined for private ownership. There is an element of flexibility to meet requirements for immediate interim financing, seed capital, or funds to complement development loans.

# Special Agricultural Rural Development Agreement (Special ARDA)

### Nature

This joint federal-territorial program can provide financial contributions and other assistance to projects which create new jobs, increase income and improve living conditions of residents of the Northwest Territories, particularly those of Indian or Inuit ancestry. Types of eligible projects include commercial businesses resource harvesting, training and special measures needed to help people take advantage of job opportunities. For commercial projects contributions of up to 50% of the costs may be provided.

# Eligibility

For commercial projects a majority of employees must be of Indian or Inuit ancestry. Viability of the proposal is a strong consideration. Priority is given to proposals incorporating Native entrepreneurship.

# Regional Development Incentive Program (R.D.I.P.)

### Nature

The Federal Government provides incentive contributions and loan guarantees to certain manufacturing and processing businesses willing to establish, expand or modernize their facilities. Incentives depend on size and nature of the project. Most manufacturing and processing industries may qualify for contributions and loan guarantees. Certain new commercial facilities may qualify for loan guarantees only.

# Eligibility

Firms planning to establish, expand or modernize manufacturing or processing facilities may qualify for incentives. Loan guarantees may be available to certain commercial projects including business offices, warehousing and freight handling facilities, shopping centres, hotels or motels, convention, recreation and research facilities.

# Commercial Bank Financing.

### Nature

Provides financial Service through Banks and other traditional financial institutions. These services are provided for a multitude of purposes to a broad cross section of the population individually or in business enterprises. These sources of financing must be approached initially since many government financial services require that bank refusals be obtained before an application will be considered.

# Federal Business Development Bank

### Nature

Extends Financial Assistance to new or existing business of almost every type in Canada which do not have other sources of financing available to them on reasonable terms and conditions. Management Services provided to help improve management skills; seminars conducted in smaller centres to meet the needs of the owners and managers of small businesses; sponsors and supports conferences to promote good management practices; develops management training courses for distribution to provincial education authorities. Information Services publishes and distributes booklets on a wide range of topics pertaining to small business; distributes bulletins on business at branch offices with a variety of publications on small business management.

# Eligibility

Financing available to most Canadian companies (with emphasis on the needs of the small business) by means of loans, loan guarantees, equity financing or leasing, or by any combination of these methods.

Ranges in size from a few thousand dollars upward. Business may obtain FBDB assistance on more than one occasion if they meet its requirement.

# Indian Economic Development Fund

### Nature

The program provides advice, assistance and financial support in the field of economic development to Indian people, individually or groups. Financial support in the form of an accountable contribution may be made available for socio-economic research and planning for business development, in such Items as capital costs, equity and technical costs. Financing in the form of direct and loan guarantees also form part of the program, on a last resort basis.

# Eligibility

The program's primary mandate is to deal with status (Treaty) Indians either individually or as a group. The program can participate with non-status indians where community based issues are involved, and where it can be established that significant meaningful benefits will accrue to status Indians.

# Canada Community Development Program (CCDP)

### Nature

The CCDP is designed to allow communities to undertake projects of lasting value which also have the benefit of supplying work to persons who would not otherwise be employed.

# **Enterprise Development Program**

### Nature

The EDP is primarily designed to assist small and medium sized firms undertaking relatively high risk innovative or adjustment projects. EDP provides support by sharing project costs or providing insurance on term loans on a last resort basis. Assistance is available in several forms.

Requirements basically relate to the natures and viability of the project, the viability of the applicant's business operation, the need for assistance and the nature of the industry involved.

# Special Assistance to General and Special Trade Contractors

### Nature

The program provides an extension of EDP loan insurance and other benefits to general and special trade contractors, especially those who want to improve their position on the international market and who are interested in constructing turn-key operations.

# **Design Assistance to Business**

### Nature

Design Canada programs encourage Canadian design and product development through management training, technical assistance, information seminars and development of the design professions. The program provides a confidential directory of designers, design research, financial assistance for design education, advisory services and promotion, recognition and awards for design. Short courses in management training are available to executives responsible for design policy and activity.

# Regional Development Incentives for Designated Regions

### Nature

The department offers cash incentives to firms that establish, expand or modernize facilities in designated regions. Most manufacturing and processing industries are eligible for the development incentives and loan guarantees. Development incentives, usually in the form of outright grants, are available. The Department guarantees loans made to firms in order to help them obtain favourable financing terms.

# Special Investment Tax Credit for Areas of Greatest Disparity

### Nature

This program is aimed at the areas of greatest disparity and covers 5% of the population of Canada. The tax credit is 50% of the eligible capital cost of assets acquired primarily to manufacture and process products.

# **Small Business Loans Act**

### Nature

The department of Industry, Trade and Commerce guarantees loans made to small businesses whose gross annual income does not exceed \$1.5 million during the year in which the loan is made or, in the case of a new firm, if the established income in the first financial period (at least 55 weeks) does not exceed \$1.5 million.

# **Outpost Camps Assistance**

### Nature

Financial assistance may be provided to groups or individuals who wish to live off the land, and follow their traditional lifestyle.

# **Trappers Assistance Program**

### Nature

This program is designed to provide loans to trappers for outfitting of the coming season's activities and to assist trappers to reach their areas. Maximum loan available is \$1,500 per trapper.

# **Trappers Incentive Grants**

### Nature

This program is designed to assist trappers by providing a fur subsidy at the beginning of the trapping season, calculated on the previous seasons fur sales.

# Arts and Crafts Service Small Business Development Section Commerce Division, G.N.W.T.

### Nature

The Small Business Development Section of the GNWT Commerce Division supports the Arts and Craft industry through the provision of advice and assistance in opportunity awareness, project and product development, and provides a liaison between producer and consumer and between the various organizations involved in the industry. The emphasis for development encourages artists and craftsmen to meet their needs through their own organizations.

# **Fisheries Improvement Loans**

### Nature

The Federal Government guarantees loans made to Fishermen by chartered banks and other approved lenders for a wide range of fisheries improvement projects. Loans can be guaranteed for:

Purchase and/or construction of vessels and equipment.

Major repair or overhaul of vessels.

Construction, repair, or alteration of buildings required by a primary fishing enterprise.

Development and improvement of a fishing enterprise.

# Fishing Vessel Insurance

A STATE OF THE STA

### Nature

The fishing Vessel Insurance Plan provides low cost insurance for fishing vessels. The plan provides total or partial loss coverage of vessels based on appraised value of the hull and machinery. Premium rates depend on the construction, condition, age and equipment of each vessel, qualifications of the crew, previous fishermen's insurance-risk record, types of fishing activities in which the vessel engages and its area of operations. Electronic Equipment may also be covered as well as third party collision liability for additional premium.

Owners of Canadian vessels with a value of \$500.00 or more which are involved in a commercial fishery.

# Small Craft Harbours

### Nature

This program is intended to assist existing tourists resort operations which are recognized as main economic activities within their immediate communities, where construction of facilities will have a stimulating effect on the development of a tourist industry, or where location provides access to national historic sites. The program is also available for the construction of commercial fishing wharf facilities.

Funds may be provided for new wharfs and/or launching ramps as an initial and one time expenditure. The maximum expenditure is \$15,000.00.

# Financial Assistance for Film Programs

### Nature

# **Canada Mortgage and Housing Corporation**

The department regulates many marketplace activities, it establishes regulations and standards for packaging, safety. It approves all devices used in trade for weighing and measuring. It serves as a consumer advocate and information service. It grants temporary legal monopolies and maintains a complete record on patents, trademarks, etc. Charters of incorporation are granted and files of company's financial statements are maintained. It is also involved in the investigation of questionable business practices and supervises bankruptcy proceedings.

# **Apprenticeship Training**

### Nature

Apprenticeship training is a combination of learning by doing (training on the job) and formal technical training. Apprenticeship programs are administered under the "Apprentices and Tradesmen Ordinance." The major activities the ordinance provides for are the Apprenticeship Board, Trade Advisory Committees and the designation of Trades.

## On-The-Job-Training

#### Nature

Essentially on-job-training is subsidized training on the job. This subsidy could include transportation assistance, and a percentage of reasonable wages. A "trainee" would work with a skilled person (usually in non-apprenticable trades) until the trainee can take the job. Coupled with this should be intensive life skills training and counselling. Individual contracts are signed for each training position between the employer and the G.N.W.T.

#### Nature

#### Nature

The overall objective of CMITP is to meet the skills needs of employers and to improve the employability and earning capacity of workers through the initiation, expansion, and improvement of employer-provided training.

## **Critical Trade Skills Training Program**

#### Nature

CTSTP features training initiatives to overcome certain chronic manpower shortages that exist in the economy. Subsidies are paid to employers for the training of workers in specific blue collar trades or occupations that are in short supply. Training is provided by employers and/or employer associations, to employee trainees in cooperation with provincial-territorial governments who provide technical support.

## **Small Business Management Training**

#### Nature

Each year the Federal Business Develoment Bank (F.B.D.B.) conducts an extensive program of over 1,000 one-day management seminars at centres across Canada. The federal jurisdiction includes works or businesses of an interprovincial, national, or international nature. The department works in partnership with all parties in labour affairs, helping to pinpoint and analyse issues and problems, searching for equitable solutions and new techniques and acting as an impartial catalyst.

## **Unemployment Insurance Commission (UIC)**

#### Nature

- 1. Administers Unemployment Insurance Act which provides for regular, maternity, Illness and age 65 benefits to entitled claimants. Benefit rate is 662/3% of average weekly insured earnings to a maximum of \$147,/week.
- 2. Administers premium reduction program which allows employers who have a qualified wage loss replacement plan or sick leave plan to be entitled to a reduction in the employer's premium of 1.4X employee's contribution. Maximum reduction is 1.11X employee's premium.
- 3. Provides assistance to employers who need help to complete Record of Employment which the employer must complete within five days when an employee has an interruption of earnings. Many useful publications are also available on various aspects of unemployment insurance from the National Revenue Department, Taxation.

# **Canada Manpower Training Program (CMTP)**

#### Nature

In short CMTP is "institutional training". CMTP is a program of occupational training which provides adults with the skills required for employment or to Incase their earning capacities. The program provides: skill courses — basic training to raise an individual's education level to that required for admission to a skill course — classroom portion of apprenticeship training arranged by territorial authorities — language training — job readiness training — work adjustment training. Courses, depending on the skill, run from one to 52 weeks. Living allowances or unemployment insurance benefits are normally available to full time trainers.

# VI. Income Tax Incentives

## **Investment Tax Credit**

#### Nature

An investment tax credit, which varies, regionally from 7% to 20% is available as a direct reduction from federal tax payable. This credit reduces the cost of new buildings, machinery and equipment principally used in Canada in prescribed activities. It also provides for expenditures on research and development and on investment in equipment for rail, air, water and long-haul transportation within or to and from Canada.

## Research and Development Incentives

#### Nature

The investment tax credit for R & D expenditures is 20% in the Atlantic provinces and 10% in the rest of Canada, while small businesses are allowed a special tax credit of 25%. In addition to writing off 100% current and capital expenditures for R & D tax payers can deduct from their income a further 50% of any increase in such expenditure over the average level of the previous three years.

# Accelerated Capital Cost Allowance for Manufacturing and Processing Industries

#### Nature

Taxpayers may charge 50% straight line depreciation on most new machinery and equipment for use in manufacturing and processing in Canada (including heavy-oil upgrading), thus writing off such assets in two years.

#### Nature

A special rate of tax on manufacturing and processing activities carried on in Canada (including heavy-oil upgrading) reduces the general rate on corporate profits from 36% to 30%. Provincial corporate tax rates ranging from 10% to 15% are levied in addition to the applicable federal rate.

## Special Tax Rates for Incorporated Small Business

#### Nature

Small Canadian controlled private corporations are accorded lower income tax rates on active business income derived from activities carried on in Canada. The federal rate is 10% in manufacturing and processing industries and 15% in other activities. Provincial corporate tax rates ranging from 5% to 12% of income are levied in addition to the federal rate.

## **Metric Conversion**

#### Nature

Conversion to the metric (SI) system in Canada is being implemented on a voluntary basis. Each sector of the economy carries out its own conversion program in conjunction with its suppliers and customers. The entire program is guided and coordinated by the Metric Commission. The Commission provides a wide range of publications, audio-visual aids, symposia and technical information to assist individuals and businesses in conversion to the metric system. The Commission contributes to the cost of replacement or conversion of eligible workers' tools and can provide information on special tax measures that apply to cost of conversion of tools, machines, and measuring instruments.
