SPECIAL COMMITTEE RECOMMENDATIONS

ADMINISTRATIVE STRUCTURE Tabled Way 14, 1982.

Recommendation 1

The Minister of Education shall delegate the administration of education from Kindergarten to Grade 10 (K-10) to ten divisional boards of education.

Recommendation 2

Each education division shall be guaranteed staff to administer, co-ordinate, and implement all of its basic programs.

Recommendation 3

Every community shall be represented on a divisional board of education.

Recommendation 4

All educational staff working in the communities shall be employees of the divisional boards of education.

Divisional boards of education shall with the approval of the Minister of Education establish the length of the school year from between 170 to 200 days.

Recommendation 16

Each local education authority shall determine the language to be used in its classrooms.
