AN ORDINANCE TO ESTABLISH AN ADVISORY
COUNCIL ON THE STATUS OF WOMEN

Statement of Purpose

The purpose of this Bill is to establish an Advisory Council
on the Status of Women.

AN ORDINANCE TO ESTABLISH AN ADVISORY
COUNCIL ON THE STATUS OF WOMEN

The Commissioner of the Northwest Territories, by and with the advice and consent of the Council of the said Territories, enacts as follows:

- Short title 1. This Ordinance may be cited as the Advisory Council on the Status of Women Ordinance.
- Definitions
"Advisory Council" 2. In this Ordinance
 (a) "Advisory Council" means the Advisory Council on the Status of Women established under section 3; and
 (b) "Legislative Assembly" means the Council of the Northwest Territories.
- "Legislative Assembly"
- Advisory Council established 3.(1) There is hereby established a council to be known as the Advisory Council on the Status of Women.
- Composition (2) The Advisory Council shall consist of such number of members as the Commissioner, upon the recommendation of the Executive Member, may prescribe by regulation and such members shall be appointed by the Executive Member.
- Term (3) The members of the Advisory Council shall be appointed for a term of three years.
- Vacancy (4) Where a vacancy occurs during the term of office of a member, the Executive Member may appoint a substitute member for the balance of the term of office of such member.
- Reappointment (5) A member of the Advisory Council may be reappointed.
- Continuance of term (6) Notwithstanding the expiry of the term of office of a member, the member shall remain in office until reappointed or replaced.
- Executive Member shall appoint (7) Within three months of the expiry of a term of office of a member, the Executive Member shall appoint or reappoint a member.

Remuneration and expenses	(8) Members of the Advisory Council shall be paid such remuneration and expenses as the Executive Member directs.
Funding	(9) The costs of operating the Advisory Council shall be paid out of monies appropriated by the Commissioner in Council for the purpose.
President, Vice-President	4.(1) The Executive Member shall appoint one member as President and one member as Vice-President of the Advisory Council.
Duties of President	(2) The President is the chief executive officer of the Advisory Council and shall direct its activities and co-ordinate its work.
Vice-President to act	(3) Where the President is unable to act, the Vice-President shall act as President.
Place of meetings	5.(1) The Advisory Council may, subject to the approval of the Executive Member, hold its meetings anywhere in the Northwest Territories.
Number of meetings	(2) The Advisory Council shall meet at least two times in a year.
Rules	(5) The Advisory Council may make rules governing its own proceedings.
Duties of Advisory Council	6. The Advisory Council shall <ul style="list-style-type: none"> (a) advise the Executive Member on matters relating to the status of women that he refers to the Advisory Council for its consideration; and (b) advise the Executive Member on matters relating to the status of women that it deems appropriate.
Powers of Advisory Council	7. The Advisory Council may <ul style="list-style-type: none"> (a) receive and hear petitions and suggestions concerning the status of women; (b) recommend and undertake appropriate research on matters concerning the status of women; (c) recommend and participate in programs concerning the status of women; (d) publish reports, studies and recommendations as it deems advisable; (e) furnish the public with information on matters concerning the status of women; (f) recommend policies, programs and legislation to promote the status of women; (g) submit reports to the Executive Member for presentation to the Legislative Assembly;

- (h) assist the Executive Member in developing public awareness of the status of women; and
- (1) perform such duties as may be assigned to it by the Executive Member.

Annual report

8.(1) The Advisory Council shall within three months after the end of each fiscal year, submit to the Executive Member an annual report on the activities of the Advisory Council during the year.

Report placed before Legislative Assembly

(2) The Executive Member shall place the annual report before the Legislative Assembly if it is then in session, and if it is not, at the next ensuing session.

Executive Director

9.(1) The Executive Member may appoint an Executive Director of the Advisory Council.

Remuneration

(2) The Executive Director shall be paid such remuneration as the Executive Member may direct.

Duties of Executive Director

- (3) The Executive Director shall
 - (a) perform such functions and duties as may be assigned to the Executive Director by the Advisory Council or the Executive Member;
 - (b) subject to direction from the President, supervise any research or projects undertaken by the Advisory Council;
 - (c) keep and maintain the records of the Advisory Council; and
 - (d) keep the minutes of the meetings of the Advisory Council.

Staff

10.(1) Subject to the approval of the Executive Member, the Advisory Council may employ or engage such persons as it considers necessary to carry out the purposes of this Ordinance.

Public Service Ordinance

(2) All persons employed by the Advisory Council shall be appointed and remunerated in accordance with the Public Service Ordinance.

Coming into force

11. This Ordinance shall come into force on a day to be fixed by the Commissioner.
