

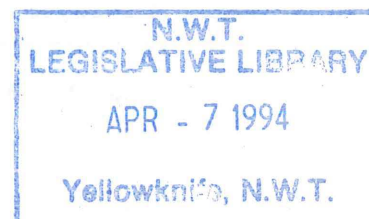
RESOLUTION

Be it resolved that the Russians, Americans, Canadians and other participants here agree to improve air links to facilitate such opportunities as trade and commerce, business joint ventures, scientific and technical cooperation, tourism, cooperative joint ventures between our airlines, and cultural exchanges. It is critical that future opportunities identified at this conference be addressed during 1994.

It is our intention that such action will lead to the development of a sufficient traffic base to enable the parties to recommend to their appropriate levels of government necessary expansions of traffic rights under their air agreements to allow these air linkages to be established on a scheduled basis on East-West and West-East directions on Northern (arctic) routes between our countries.
