WHEREAS, the community of Holman is one of the communities withen the Western Arctic Region.

WHEREAS, this community has joined with other communities in the Western Arctic Region to propose a Western Arctic Region Municipality as proposed by C.O.P.E'S Inuvialuit Land Claims settlement, with limited but developing legislative authority to serve the needs of this distinct cultural and geographic region.

WHEREAS, the N.C.F. has recognized and confirmed W.A.R.M. as a regional government withon the new territory of Nunavut.

WHERAS, in the meeting of the N.C.F. and W.C.F. (Constitutional Alliance) on January 12 and 13, it appears that others have proposed to alter without our knowledge and consent what our community and others in the Western Arctic Region have decided,

THERFORE, be it resolved that;

- The community of Holman strongly opposes any action by the N.C.F., W.C.F. or any government to impose unacceptable constitutional arrangements on us.
- The community of Holman stands together with other communities in the Western Arctic Region in thier present position of being part of the N.C.F. and the territory of Nunavut.
- 3. The community of Holman stands together with other communities in the Western Arctic Region in its willingness to explore possible arrangements withen a Western Territory which shall include as a minimum guarantees for our Western Arctic Region Municipality as proposed by C.O.P.E.'S land claims settlement.
- 4. Any proposed arrangements for the Western Arctic Region communities to become part of a western territory or participate as a member of the W.C.F. requires the approval or ratification of all the Western Arctic Region Communities.
