DEAR MR. PUDLUK:

THIS LETTER IS TO INFORM YOU ABOUT MY CASE AND HOW SOCIAL SERVICES HAS CAUSED A LOT OF PAIN FOR ME AND MY FAMILY. WHILE MY WIFE WAS STILL AT RESOLUTE, I WAS NOT ALLOWED TO SEE OR TALK TO HER FROM APRIL 20 TO APRIL 24. SOME PEOPLE DID SEE AND TALK TO HER. SHE WAS STAYING AT BUILDING 44, JUST ACROSS FROM 100 AND 200 WING, SHE TOLD ME THIS AFTER I SAW HER AGAIN IN SPENCE. THE POLICE OR LAWRENCE HOLT WOULD NOT TELL ME WHERE SHE WAS STAYING AT. SHE SAW NORMAN FRADET, DANNY LEAMAN WHO BROUGHT HER MEALS, JOHN GOODMAN WHO WENT TO CHANGE TV CHANNELS OR SOMETHING AND GAVE HER CANDIES, ANOTHER GUY WHO ALSO WENT TO CHANGE THE CHANNELS, LAWRENCE HOLT AND ALLISON HOLT AND KOOMIE IRALUK. ALLISON AND KOOMIE TOLD MY WIFE THAT SHE CAN GET A HOUSE AND A JOB IN SPENCE BAY. THEY TOLD HER THAT, AFTER THEY TALKED ON THE PHONE TO SOCIAL SERVICES IN SPENCE BAY.

RIGHT NOW SHE (ANNIE) STILL HAS NO JOB AND WE ARE STAYING AT HER PARENT'S PLACE. THERE ARE FIFTEEN (15) PEOPLE NOW LIVING IN THIS 4-BEDROOM HOUSE.

IN THE EARLY MORNING HOURS OF APRIL 24, MY FAMILY LEFT ON P.W.A. AT ABOUT 2:00 THAT AFTERNOON, I PHONED LAWRENCE AND HE FINALLY TOLD ME MY FAMILY HAD LEFT. ~~IT~~ IT LOOKED AS IF MY FAMILY HAD DIED AND I NOW KNOW THE TERRIBLE PAIN PEOPLE FEEL WHEN THEY LOOSE THEIR FAMILY.

I FINALLY TALKED WITH MY WIFE ON APRIL 26 WHEN SHE WAS AT CAMBRIDGE BAY. ON MAY 02, FRIDAY, I TALKED WITH DEPT. OF SOCIAL SERVICES AT FROBISHER BAY AND ASKED THEM IF THEY CAN GIVE ME A TICKET TO SPENCE BAY. THEY SAID NO, BECAUSE I WAS GETTING UNEMPLOYMENT BENEFITS (U.I.C.). I GOT ONE CHERUE FROM THEM IN ABOUT FEBRUARY OR BEGINNING OF MARCH BUT I HAVE RECIEVED NOTHING FROM THEM SINCE. I FINALLY HAD TO BUY MY OWN TICKET AND REACHED SPENCE BAY ON MAY 06.


AT THE BEGINNING OF MAY, MY WIFE ASKED FOR BEDS FROM SOCIAL SERVICES IN SPENCE BAY. THEY SAID NO, BECAUSE SHE ALREADY HAD BEDS IN RESOLUTE. RIGHT NOW THE SOCIAL WORKER, VICTOR BERGEN, IS GIVING MY WIFE ALL KINDS OF MONEY SO THAT SHE CAN BUY BEDS, BLANKETS, SHEETS AND BOOTS. IT LOOKS LIKE THEY ARE TRYING TO GIVE HER MONEY AND THINGS SO THAT SHE WILL NOT GO BACK TO RESOLUTE.

~~IN~~ SPENCE BAY ALONE, SHE (ANNIE) HAS RECEIVED ABOUT \$2,090.00 FROM SOCIAL SERVICES. THEY CERTAINLY SEEMS TO HAVE THE MONEY TO HELP PEOPLI GET DIVORCE. GETTING PEOPLE DIVORCED IS ONE OF THE MAIN THINGS SOCIAL SERVICES DO.

ON MAY 14, I WROTE A LETTER TO CECILY KENWOOD (WHO WORKS WITH COOPER, JOHNSON, HARDY, & FOURNIER LAWYERS IN YELLOWKNIFE) TO ASK HER IF THEY WANT TO TAKE MY CASE. I PLAN TO SUE DEPT. OF SOCIAL SERVICES FOR ABOUT \$123,000.00 FOR CAUSING ME TO SUFFER IN MY MIND AND FOR DOING THE WRONG THING WHEN THEY TOOK AWAY MY FAMILY FROM RESOLUTE. IF DEPT. OF SOCIAL SERVICES WANTS TO GIVE JOBS TO PEOPLE LIKE LAWRENCE HOLT, WHO HAVE CAUSED A LOT OF PAIN IN RESOLUTE, THEN IT IS THEY WHO WILL HAVE TO ANSWER FOR HIM.

I THINK SOME PEOPLE FROM RESOLUTE SHOULD GET TOGETHER AND LAY CHARGES AND/OR SUE DEPT. OF SOCIAL SERVICES FOR ALL THE PAIN THEY CAUSED, FOR ALL THE PAINS LAWRENCE HOLT AND SOCIAL SERVICES CAUSED. THERE SHOULD BE A BIG COURT CASE AGAINST DEPT. OF SOCIAL SERVICES BECAUSE I KNOW THERE IS SOMETHING WRONG WITH THEM.
