It was felt that the Inuvailuit of the Western Arctic wasn't properly represented during the signing of the Agreement by the WCF and the NCF.

Motion#87-/4 Moved by Albert Ruben, Seconded by Andy Thrasher that whereas the Paulatuk Community Corporation is aware that the N.C.F. and the W.C.F. have signed an Agreement on Division to devide the N.W.T. and

Whereas the Inuvialuit were not in any way involved in the drafting of the contents of the Agreement, and

Whereas the Agreement does not adequately address Inuvialuit concerns such as Regional Control over certain developmental activities and resource revenue sharing, and

Whereas the ratification process to approve the Agreement will impose the will of the majority on minorities such as the Inuvialuit,

Now therefor be it resolved that the P.C.C. urges both the I.R.C. and COPE on behalf of Paulatuk, to make our views known to various levels of governments including the N.W.T. Legislative Assembly,

And furthermore, be it resolved that the Paulatuk Community Corporation urges this session of the Legislative Assembly not to endorse the Agreement on Division and that the issue of Division and the Agreement be deferred to the next elected Legislative Assembly.

Motion Carried.
