

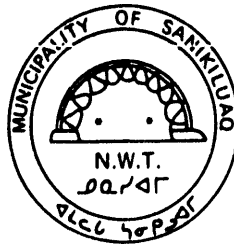

Security Fencing demanding request

As far as we have knowledge that you both don't have
Mandate for just about to our request for you assistance.

This is something that you already aware of. Since we are
receiving a pressure from the whole community, we have right to
keep trying to let it get through.

Apperently our water lake 33cm 3,300 meter x 36.5= 3,650 meter
long is very close to our community, the most closest resident is
only 150 meter away, and the new school is only 120 meter away.

Therefore some 10 to 11 years ago we created 1800-2000 meter
of security fence out of site Development funds for the amount of
\$20,000.00. We spent the total on material and little labourer.

This five (5) foot high of fence was only to keep blown away
light garbage to the lake, and it was working.

After about each 4 months, we usually hire labourer 1-2 days
work to collect blown away garbage. Thus we have windy country.
It was not meant to keep people away from the lake. When it was
first created.

Because it was done very cheaply, we have to spent up to
week for 2 labourer annuly just to repair the damage by the young
kids.

Because of only "T" bars were the only post for wire fence,
without top across bars. These kids usually help themselves to
go over the wire fence and damage the fences. Even thou enough
warnings have been said in the Public radio, we guess some kids
in everywhere don't obey, like some of us usually do in our young
age.

What we really want to say is that we want both human proof
security fence and garbage protection fence.

And the reason is that we are also trying to deal with the Dept. of Education, due to the new school is being built very close to the lake, and it's located in the most dangerous part of the lake, that's when the new school was built. Because of that we would have to built extra long fence beyond the new school. Few hundred extra feet would be extended.

Only if higher than 5 feet could replace our existing fence. Would be great benefit to the whole community.

And the old fencing would be automatically be created in our garbage dump and our Sewage Lagoon.

As we don't have gravel in our dump to cover the junk pile, and light garbage usually gets blown away, like in windy days, we usually get windy Islands.

We like to see this as one of the most priority as community were all shocked when active 15 year old boy was drowned just last fall, and other one was about 8 years ago, northern boy.

This satuation can be expected any time in 6 month on each year.
