SUICIDE EXPERT TO ADDRESS ASSEMBLY

YELLOWKNIFE (March 2, 1989) - In response to concerns about the increasing rate of suicide among young people, Members of the Legislative Assembly today passed a motion inviting an expert on suicide prevention to address the Assembly.

Dr. Ronald Dyck, provincial suicidologist with Alberta Mental Health Services, will appear as a witness during Committee of the Whole on Wednesday, March 8 to assist in the Committee's discussions of suicide prevention and to answer Members' questions.

Dr. Dyck is also on the faculty of the Department of Psychiatry at the University of Alberta and is considered to be one of Canada's foremost experts on suicide prevention and intervention.

Dr. Dyck's appearance before the Legislative Assembly will be recorded in all the aboriginal languages of the Northwest Territories. The Department of Social Services will then make these tapes available to individuals and community groups.

Members of the Legislative Assembly, in passing the motion, noted their concerns about the high incidence of suicide in the Northwest Territories and its effect on family and community life.

On Wednesday, the Legislative Assembly will suspend its normal order of business and immediately resolve into Committee of the Whole in order to discuss this issue in detail.



MLA UPSET WITH MILITARY ACTIVITY IN NORTH

YELLOWKNIFE (May 18, 1989) - Don Morin, MLA for Tu Nede, is outraged that significant military activity is occurring without the consent of the people of the north.

"I learned through the media that this activity is going on, after it has already started," said Mr. Morin. Morin is very concerned that the federal government is prepared to authorize such testing without warnings to, or the consent of, people of the north.

"We have the right to decide if we want our land and our air space to be used for war games, even if they are mock defences against theoretical attacks," said Morin. He is also concerned about the implications of Federal involvement in identifying the North for these war game purposes. He believes that they expect such a war to take place in the North and away from the heavily populated Canadian south and the United States. "Is our own Federal Government saying, in effect, that they are prepared to sacrifice northern Canada in exchange for an American military alliance?" "Was the GNWT involved in this decision? If they were, why aren't they raising objections?" asked Mr. Morin.

Mr. Morin explained that the Legislative Assembly has passed resolutions opposing military build up in the north and in fact has called for the north to be zoned 'Nuclear Free'. "I will be asking the Government Leader to explain his inaction and lack of public comment on this critical next step in the militarization of the North."

"Futhermore I will remind Mr. Patterson that he has voted in favor of a global referendum on disarmament and against cruise missile testing in the north. Lastly, Mr. Patterson voted in opposition to the testing and/or establishment of nuclear weapons and nuclear weapon-related technology in the north," stated Morin.

ECONOMIC STUDIES TO BE RELEASED BY SPECIAL Yellowknife, N.W.T. COMMITTEE

YELLOWKNIFE (June 6, 1989) - The Special Committee on the Northern Economy will release three studies on the northern economy at a press conference scheduled for 11:00 a.m. in the Committee Room of the Legislative Assembly on Wednesday, June 7.

Brian Lewis, MLA for Yellowknife Centre and co-chairman of the Committee, believes these studies will not only provide an in-depth examination of critical sectors of the economy but also encourage public discussion on these important issues.

"We hope that these studies will be widely read and will stimulate a great deal of discussion among residents of the NWT, " said Lewis. "We would like to get comments back from people about these studies and their recommendations."

Mr. Lewis also noted that these studies represent the opinions of the independent research consultants and not those of the Members of the Special Committee.

The first three background study reports are on natural resource development and environmental protection, economic development and tourism programs and a review and assessment of the Native Employment Policy.

The final three studies examine and make recommendations on the domestic economy, adult training programs in the NWT and the economic impact of northern land claims settlements.

They will be released to the public over the next several weeks as they become available.

The studies were commissioned in the fall of 1988 by the Special Committee as part of its mandate to make recommendations for improving the economy.

The Special Committee on the Northern Economy was established by the Eleventh Legislative Assembly to develop a long-term strategy to guide economic development in the Northwest Territories through the 1990s.

The Special Committee has been holding public meetings in different communities across the territories to listen to concerns and suggestions from residents and will table its final report at the fall session of the Legislative Assembly.

Strategy

A year and a half ago the Legislative Assembly set up our Special Committee on the Northern Economy. They told us to go out, study the economy, develop a long-term economic development strategy, and report back by the Fall session of 1989.

To study the economy we adopted a two-fold strategy.

First, we SCHEDULED A SERIES OF PUBLIC MEETINGS. The purpose of these meetings was to hear from community residents and special interest groups—to get their ideas and suggestions for improving the economy.

Over the past year we have held public meetings in each constituency except the High Arctic and Hudson Bay. We will be visiting these two constituencies next week when we travel to Arctic Bay and Sanakiluaq. We have also held meetings with special interest groups: industry, business organizations, native organizations and other groups concerned about the economy.

Second, we decided to CARRY OUT RESEARCH IN SPECIAL AREAS OF THE ECONOMY. We asked our research staff to review all relevant studies and reports completed over the past ten years. We also commissioned a series of six new studies.

Today I wish to announce the release of three of these studies. The remaining three will be released toward the end of this month.

The Studies

The first study, A REVIEW OF ECONOMIC DEVELOPMENT AND TOURISM PROGRAMS. was prepared by R. T. And Associates of Yellowknife. It reviews the major programs of the Department of Economic Development And Tourism, points out their strengths and weaknesses, and recommends changes.

The second study, TOWARDS A SUSTAINABLE APPROACH: NATURAL RESOURCE DEVELOPMENT AND ENVIRONMENTAL PROTECTION IN THE NORTHWEST TERRITORIES. was done by Zella Osberg and Stephen Hazell, two Ottawa based consultants specializing in environmental issues. The study points out the limitations of the present approach to development (based almost exclusively upon environmental hearings) and recommends a permanent strategy based upon the principles of sustainable development.

The third study released today, <u>THE GOVERNMENT OF THE NORTHWEST TERRITORIES' NATIVE EMPLOYMENT POLICY: A REVIEW AND ASSESSMENT</u> was done by Inukshuk Management Consultants of

·			

Yellowknife. The study concludes that, though there have been some secondary benefits, the Native Employment Policy, introduced by the GNWT in 1985, has failed as a policy. It has not significantly increased the number of native staff within the GNWT public service. The study examines the reasons for the failure and recommends changes in government's approach to affirmative action.

Three additional studies will be released at the end of June.

The first of these shows the potential impact of land claim settlements on the NWT economy.

The second outlines a strategy to support the domestic economy (hunting, trapping, fishing, etc),

The third study provides a review of adult training in the NWT.

Responsibility for Content

You will notice on the first page of each one of the studies a statement indicating that the contents of the study represent the opinions of the authors and do not represent the opinions of the members of the Special Committee on the Northern Economy.

Obviously our Committee will be reviewing these studies and their recommendations very carefully. Some of the recommendations may well become part of our Committee's Final Report. But, at present, the opinions expressed are those of the authors of the studies.

Reason For Releasing These Reports.

The previous Special Committees on Education and Housing commissioned their own studies—but they did not make them public. Our Committee has decided upon a different approach.

We have decided to distribute these studies widely in the hope that they will stimulate discussion. We want people to read the studies and get back to us with their comments.

The studies deal with some major issues facing our economy. We really want to know what the public thinks about these issues.

Also, since these studies were conducted with public moneys, we feel that the public should know what kind of advice we are receiving from consultants.

MLA MEETS WITH DEFENSE MINISTER OVER MILITARY ACTIVITY IN NORTH

YELLOWKNIFE (June 22, 1989) - At a meeting this week with Bill McKnight, Minister of National Defense, MLA Don Morin made the Minister aware of serious concerns northerners have about the recent decision to proceed with low level flight testing and training over the East Arm of Great Slave Lake.

At this meeting Mr. Morin, along with representatives of the Dene Nation, raised questions about the growing number of northern military training, testing and base establishment initiatives by the American military. They also expressed their strong opposition to the recent federal approval of low level flight routes.

"I asked the Minister if the low level flight program was part of a larger scheme to turn the north into a large scale military zone... he assured me that while there were no plans beyond what the public was aware of, he stated that the Americans anticipate they will intercept foreign attacks over the north," said Mr. Morin. "Furthermore, he stated that the training had to be as true to life as possible."

"How northerners, or any Canadian for that matter, could accept that a nuclear war will be fought over the north is beyond me... this however, is in fact what the federal government has accepted by negotiating these deals with the Americans," said Mr. Morin. "The new North Warning System that includes the establishment of bases and radar sites throughout the north, the cruise missile testing and the low level flight programs are all recent military activities that the Canadian government has negotiated with the Americans. I'm in a quandary as to how to fight the low level flight decisions," explained Mr. Morin. "There are certainly grave environmental dangers and impacts and yet it is clear to me that this is only one piece of a larger puzzle that will lead to the next war being fought over our heads.

The result will be total destruction of our environment and of our people," he added.

Mr. Morin is currently seeking the support of Dene and Metis leaders and the Executive Council of the GNWT to alter this situation. In addition, Mr. Morin will be contacting community leaders to inform them of the results of the meeting with Mr. McKnight and to ask for their response.

SPECIAL COMMITTEE ON THE NORTHERN ECONOMY HOLDS OTTAWA MEETINGS

YELLOWKNIFE (June 23, 1989) - Brian Lewis, MLA for Yellowknife Centre and co-chairman of the Special Committee on the Northern Economy, announced today that the Special Committee has just concluded a series of meetings with federal government officials in Ottawa. The purpose of the meetings was to allow members of the committee to examine federal plans and to assess their impact upon the economy of the Northwest Territories.

From June 19-22 the Committee met with senior policy makers in eight key departments: DIAND; Employment and Immigration Canada (CEIC); External Affairs; Industry, Science and Technology; Environment; National Defence; Fisheries and Oceans; and the Canadian Oil and Gas Lands Administration (COGLA).

"Even though federal departments are devolving programs and services to the GNWT, the federal government still retains control of almost all our lands and natural resources," said Lewis. "We wanted to know what was in the works and how federal decisions were likely to affect our economy over the next decade."

Among the various issues discussed, Lewis listed: devolution of services from various federal departments to the GNWT; oil and gas developments; the international fur issue; business opportunities that will result from the upgrading of the DEW Line sites and other military capital contruction projects; and the impact of land claim settlements on federal government services delivery in the Northwest Territories.

Lewis noted that committee members were particularly interested in exploring how federal dollars might be used more effectively, particularly to stimulate the development of small business.

In addition to meeting with federal officials, the Special Committee also held discussions with representatives of the Tungavik Federation of Nunavut and with the two NWT MPs, Ethel Blondin of the Western Arctic and Jack Anawak of Nunatsiag.

Mr. Lewis also noted that just prior to these Ottawa meetings the Special Committee wrapped up its series of public meetings with visits to the communities of Arctic Bay and Sanikiluaq.

The committee has now held public meetings in communities in all regions of the Territories and will be tabling its final report in the fall session of the Legislative Assembly.

SPECIAL COMMITTEE ON THE NORTHERN ECONOMY RELEASES THREE MORE STUDIES

YELLOWKNIFE (July 4, 1989) - Brian Lewis, MLA for Yellowknife Centre and co-chairman of the Special Committee on the Northern Economy, announced today the release of three new studies on various aspects of the Northwest Territories' economy.

The first study, TOWARDS A STRATEGY FOR SUPPORTING THE DOMESTIC ECONOMY OF THE NORTHWEST TERRITORIES, was done by Peter Usher and Frederick Weihs of P.J. Usher Consulting Services in Ottawa. It describes how the domestic economy (hunting, trapping, fishing & craft production) works. It emphasizes the importance of this economy to the overall economy of the Northwest Territories and the cultural values of its residents. It suggests ways and means by which this economy can be supported and strengthened.

The second study, ADULT TRAINING IN THE NWT: A REVIEW AND ASSESSMENT, was prepared by Lynn Fogwill of Lynn Fogwill Consulting Services, Yellowknife. In addition to providing an assessment of public sector and private sector training programs, the study also makes a number of recommendations for improving adult training in the Northwest Territories.

The third study released today, COPING WITH THE CASH, describes the potential impacts of the Dene-Metis and Inuit land claim settlements on the economy of the Northwest Territories. It profiles the economic impacts of other settlements; with the native peoples in Alaska, with the Inuvialuit in the NWT, and with the Cree and the Inuit in Northern Quebec. It projects the potential impacts of NWT claims based upon various investment options open to the beneficiaries. The study was carried out by the Sustainable Development Research Group of the Arctic Institute, University of Calgary.

Lewis stressed that the studies and their recommendations do not represent the opinions of the members of the Special Committee on the Northern Economy. They represent the opinions of the author of each report.

"We are releasing these reports to generate discussion within the general public," Lewis said. "We hope that people will read the reports and get back to us with their comments and recommendations."

Lewis noted that the release of these three reports brings to six the total number of studies released by the Committee. The first three studies examine natural resource development and environmental protection, economic development and tourism programs and the GNWT's Native Employment Policy. He also noted that all reports contain a summary in Inuktitut.

The Special Committee plans to release a final study on banking and financial services in the NWT later in the summer.

The Special Committee has now finished its series of public meetings in different communities across the territories and will table its final report at the fall session of the Legislative Assembly.

The Commission was established by the Legislative Assembly of the Northwest Territories during its 1989 winter session. Members of the Commission are the Honorable Justice Calvin Tallis as chairperson, Mr. Richard Hardy of Yellowknife and Ms. Rosemary Kuptana of Ottawa.

The purpose of the Commission is to review the area, boundaries, name and representation of all existing electoral districts, or those existing electoral districts specified by the Legislative Assembly.

The Commission held its first meeting in Yellowknife on June 28th, 1989 and the work of the Commission is now underway. The Commission intends to hold public hearings throughout the Northwest Territories to discuss the possible re-alignment and number of existing electoral district boundaries. There are currently 24 electoral districts.

A report will be prepared by the Commission and submitted to the Legislative Assembly in February, 1990.

NINGARK ELECTED IN NATILIKMIOT

Yellowknife (October 10, 1989) John Ningark was elected as the new Member of the Legislative Assembly for Natilikmiot in a by-election held today.

NERYSOO ELECTED AS SPEAKER

Norman Wells (October 19, 1989) Richard Nerysoo, MLA for Mackenzie Delta, was elected Speaker of the Legislative Assembly by formal resolution when the House opened today.

He is the fifth person to serve in the position since 1975, when the Assembly elected its first Speaker. Mr. Nerysoo is also the first native northerner to serve as Speaker.

In his opening speech, Mr. Nerysoo paid tribute to the former Speaker, Red Pedersen, saying "My predecessor has felt it necessary to relinquish the Chair and his contribution to this Legislature and to our Legislature's standing in the Commonwealth will assist me in my term as your Speaker and I sincerely thank him for that."

He continued, "I feel that the words of one of Canada's greatest parliamentarians, Edward Blake, are appropriate, who said in 1873, 'The privileges of parliament are the privileges of the people, and the rights of parliament are the rights of the people.' These words are true today and we should reflect on them as we strive to improve our Legislature for the Northwest Territories so our children will take pride in our achievements done on their behalf for their future."

The Speaker represents the Legislative Assembly at official functions and in relations with authorities and people outside the Assembly. He is responsible for ensuring the work of the Assembly is carried out smoothly and for enforcing the rules for preserving order during the proceedings. The Speaker is also responsible for the administration of the House and employees of the Legislative Assembly report to him.

Mr. Nerysoo was first elected to the Legislative Assembly in 1979. He was Government Leader and Minister of Justice and Public Services from 1983 to 1985. During the Ninth Assembly, from 1979 to 1983, he was Minister of Renewable Resources and of the Energy and Resource Development Secretariat. He has most recently been a member of the Standing Committee on Finance and an alternate member of the Special Committee on the Northern Economy.

Mr Nerysoo was educated at Fort McPherson, Inuvik and Whitehorse. He is a past vice-president of the NWT Indian Brotherhood (now the Dene Nation) and served a vice-president for the Dene Nation representing the Mackenzie Delta region.


