NWT Income Security Programs: Standing Committee on Government Operations Challenges Department to Act on the Recommendations of the Auditor-General

(YELLOWKNIFE) Wednesday, April 24, 2013 – The Legislative Assembly's Standing Committee on Government Operations (SCOGO) is challenging the Department of Education, Culture and Employment (ECE) to act on the recommendations of the Auditor General of Canada to improve delivery of four Northwest Territories income security programs.

Government Operations is the committee mandated to review reports of the Auditor General of Canada to the NWT Legislative Assembly. The Committee examined the Auditor General's report during public meetings with senior officials from the Office of the Auditor General and the Department of ECE on April 16 and 17 in Yellowknife.

Committee Chair Michael Nadli (MLA Deh Cho) said "We've heard from constituents about all the hoops they have to go through to get income assistance, with delays in payments, lost documents, and rude staff. Now we've heard from the Auditor General that the Department isn't managing its client files according to program requirements. We need to know the \$30 million we spend on these programs is reaching the people who really need it."

"It's encouraging that the Minister accepted all of the Auditor General's recommendations. Officials listened closely during our meetings, and they said they've started to act. We challenge ECE to finalize a comprehensive response, to act on all the recommendations and to report regularly on results to Members and the public over the next two years."

The audit identified systemic problems with the delivery of Income Assistance, Student Financial Assistance, Senior's Home Heating Subsidy, and the Childcare User Subsidy. A majority of files in the review sample didn't comply with key legal and policy requirements - 90% in the case of the Income Assistance Program - and the errors were considered significant.

Wendy Bisaro (MLA Frame Lake), Deputy Chair of SCOGO, added, "Behind the statistics are real people who need our help and our respect - income security program workers and their clients. It's indicative that the Department has a 50% annual turnover rate for Client Service Officers. We expect the Department to support their staff with the necessary tools to become truly client-focused and we will be watching to make sure they do it."

The Auditor General's report underlines the fact that many Client Service Officers (CSOs) are struggling with vague guidelines, lack of monitoring and supervision, and inadequate training.

The Auditor General also called attention to CSO caseloads, which in some cases may be higher than 100 per month, overworked managers, and employees' safety concerns.

The Standing Committee on Government Operations will report on its review during the May-June Session of the Legislative Assembly.

The Committee consists of MLAs Michael Nadli (Deh Cho), Wendy Bisaro (Frame Lake), Alfred Moses (Inuvik Boot Lake), Daryl Dolynny (Range Lake), and Norman Yakeleya (Sahtu).

#### **On the Passing of Shirley Firth-Larsson**

(YELLOWKNIFE) Wednesday, May 1, 2013 – The Members of the 17<sup>th</sup> Legislative Assembly of the Northwest Territories today expressed condolences to the family of Shirley Firth-Larsson, Olympic athlete and Legislative Assembly employee, who passed away on Tuesday.

Speaker Jackie Jacobson said, "On behalf of Members of this Assembly, it is with great sadness and sorrow that I offer condolences to Ms. Firth-Larsson's family and loved ones. Shirley was not only my Executive Assistant, but my good friend, and it was an absolute honour to work with her. She will be missed by many people; she touched so many lives and was such an inspiration to Aboriginal women. The North has lost an amazing person."

Shirley and her sister, Sharon Firth, were part of a pioneering program to introduce skiing to Northern Canada's Aboriginal people and were the first Aboriginal women to be members of Canada's national ski team representing the Northwest Territories. Shirley was inducted into the Canadian Ski Museum and the Skiing Hall of Fame in 1990. She competed in four Winter Olympics, four World Ski Championships, and numerous Canadian and North American Championships. Shirley was also voted the Canadian Women's Nordic Skier of the Year six times by *Ski Racing Magazine*.

After marrying her husband, Jan Larsson, Shirley settled in Europe for over 20 years where she and Jan raised three daughters. While there, she lectured on Dene and Inuit cultures at various universities, schools, and cultural centers in central Europe and Scandinavia. Shirley was awarded the Order of Canada in 1987, the Queen's Golden Jubilee Medal in 2002, and the Queen's Diamond Jubilee Medal in 2012.

"This is a sad day for the North, and especially for the Gwich'in community. She motivated so many youth to work toward their goals; her dedication and passion for the North and its people will truly be missed," said Speaker Jacobson.

"Northerners spend a lot of time on the land and it is not uncommon for travellers to run into trouble and become stranded. Our vast uninhabited expanses and extreme climates put anyone lost in the Arctic in great danger. An aircraft dispatched from Trenton or Victoria two hours after a call for assistance will not arrive in the North for several more hours. We need a responsive Search and Rescue (SAR) system and a SAR base located in the North to better protect both Northerners and visitors to the North," says Ms. Bisaro.

One of the report's recommendations is that National Defence should give priority to the acquisition of new aircraft that are best suited for search and rescue activities and ensure that it has sufficient numbers of these resources to meet search and rescue needs on an ongoing basis. "I am pleased to hear that the Government of Canada has accepted this recommendation, and that the outdated SAR aircraft will be replaced. Still, it's unfortunate that it has taken over ten years to progress this far on improving search and rescue, and that we are as yet no closer to any new aircraft," says Ms. Bisaro.

### Standing Committee on Government Operations Voices Concern with NGO Funding Policy

**News Release** 

**(YELLOWKNIFE) Tuesday, May 28, 2013** – The Standing Committee on Government Operations wants the Department of Executive to improve its Non-Governmental Organization (NGO) Stabilization Fund before budgets for 2014-15 are finalized. The fund helps NGOs who deliver critical services on behalf of the territorial government.

Committee members plan to use their Members' Statements and Oral Questions on Tuesday, June 4 to call attention to their concerns with the policy. Interested NGOs are invited to contact their MLAs and provide feedback on the policy before the sitting.

"The committee's concerns include the need to provide clearer information to applicants, overly restrictive screening criteria and prioritization of projects, and inadequate funding levels," said committee chair Michael M. Nadli. "We conveyed our concerns to Premier Bob McLeod in a letter last December, but the government has not changed either the policy or the funding for 2013-14."

Total funding available under the policy is \$350,000 per year, an amount that has remained the same since the program's first full year of operation in 2010-11. In 2012-13, 27 organizations applied, requesting a total of \$1,082,657. Twenty-one of the 27 were considered eligible for funding, with requests totaling \$807,207. Eleven applicants' projects were prioritized for funding, with requests totaling \$481,845; eight of the eleven successful applicants did not receive the full amount they requested.

NGO representatives are also invited to sit in the public gallery during the June 4 sitting and be recognized for their work.

### NGO Stabilization Fund Concerns Backgrounder

### The Program:

- The GNWT Non-Governmental Organization (NGO) Stabilization Fund is administered by the Department of Executive
- The fund was established in 2009
- The \$350,000 fund provides contributions to a maximum of \$50,000:
- To NGOs who already receive GNWT funding to deliver "critical services," mainly food, shelter, and treatment; for example, homeless shelters, addictions treatment programs, women's shelters
- For "stabilization," including management, governance, organizational development, and extraordinary operations; not core funding or new projects

Results (figures rounded to 100K for those in millions; otherwise nearest thousand)

- <u>In 2011-12</u>
  - 35 groups requested \$1.5 million. Thirteen did not meet eligibility criteria.
  - o 22 eligible groups requested \$800,000. Eight were not recommended for grants.
  - 14 recommended groups requested \$484,000 and received a total of \$350,000. Several did not receive the full amount of their request.
  - Regionally, groups approved included 5 NWT-wide organizations, 4 Yellowknife NGOs, 2 NGOs "North" (Inuvik and Norman Wells) and 3 "South" (Behchoko, Fort Simpson and Hay River).

### • <u>In 2012-13</u>

- o 27 groups requested \$1.1 million. Six did not meet eligibility criteria.
- 21 eligible groups requested \$807,000. Ten were not recommended for grants.
- 11 recommended groups requested \$482,000 and received a total of \$350,000. Eight did not receive the full amount of their request.
- Regionally, groups approved included 4 NWT-wide organizations, 3 Yellowknife NGOs, 4 NGOs "North" (Inuvik) and 0 "South."

### Issues Identified by MLAS and the Standing Committee

- \$350,000 is not adequate, even for the current number of recommended applicants
- Funding is also needed for NGOs that are not now receiving GNWT funds, but that do provide critical programs and services, e.g. food banks
- The non-government sector is not well developed outside Yellowknife and some regional centres. Consideration needs to be given to ways of developing service provider NGOs, e.g., a fund for emerging NGOs, and to funding other types of non-profit groups, e.g. land claims organizations that are providing similar types of critical services.
- The NGO Stabilization Fund is poorly understood and many NGOs do not understand why their applications are not successful. More needs to be done to explain the program criteria in plain language and communicate results clearly.

In 2007, Ms. Bisaro changed her political course again, and was elected to the NWT Legislative Assembly as the Member for the riding of Frame Lake.

#### NWT Citizens Burdened by Unacceptable Delays for Health Care Cards

**(YELLOWKNIFE)** Thursday, June 20, 2013 – Sunday evening a mother contacted Yellowknife Centre MLA Robert Hawkins hoping to receive proof of her son's health care status before he departed for an out of town sports tournament this past Wednesday. In the case of an injury that requires medical attention, she was concerned that her son would be forced to pay upfront for medical services without his health care card.

"I have had constituent after constituent contact me wondering why they have not received their renewed health care card and what they should do in the case of a medical emergency. NWT citizens have been told that they can pay for their medical attention up front to be reimbursed later but who looks after those who cannot pay the large sum outright?" stated Mr. Hawkins.

After being approached by his worried constituent, Hawkins contacted Health and Social Services Minister, Tom Beaulieu, to remedy the issue. Just before her son's departure, she was emailed a screen shot of an image that claimed her families renewed health care cards would arrive on June 25th. Not an official letter, nor an interim health care card, but a screen shot that could have been altered to a suspicious eye.

"I am baffled by the lack of forethought to the recent health care card renewal process and what is making matters worse, this constituent has waited for more than four weeks for their renewal card as their present one is now expiring. The question I keep getting asked is, does Minister Beaulieu recognize the calamity around him or is he oblivious to the seriousness of this problem," remarks Hawkins.

In British Columbia, their residents are issued an official temporary health care card until new ones are received. Hawkins wonders why a similar approach was not taken and why after countless public complaints, this issue of delayed or lost applications has not been addressed. He continues to fight for acceptable means to rectify the lack of responsibility that has been taken and urges the minister to find a remedy so that those who still have not received their health care cards can access medical care immediately.

#### Closing of Nats'ejee K'eh Treatment Centre

# (YELLOWKNIFE) Tuesday, July 16, 2013 – Range Lake MLA Daryl Dolynny is concerned about the Department of Health and Social Services' decision to end its contract with the Nats'ejee K'eh Treatment Centre.

In a stunning blow last week, the Department of Health and Social Services and its Minister made a unilateral decision to cease funding to the territories' sole residential addiction treatment facility. MLA Dolynny questions the decision and the way it was carried out. "The guiding principles of the 17<sup>th</sup> Legislative Assembly clearly state that except under extraordinary circumstances, members of the Legislative Assembly should have the opportunity to discuss significant announcements, changes, or initiatives before they are released to the public," says Mr. Dolynny. Members of the Standing Committee on Social Programs were only briefed by the Minister on Wednesday, July 10 with no opportunity for comment. Mr. Dolynny states, "the use of such element of surprise is completely inconsistent with consensus government."

"The Minister of Health and Social Services and his department are clearly using the recent report from the Ministers' Forum on Addictions and Community Wellness to create a paradigm shift in thinking about addictions and treatment in the NWT. This newly-minted document should not be taking precedent over the department's official strategy, tabled in the Assembly last November," continues Mr. Dolynny. The strategy is called *A Shared Path Toward Wellness* – *Mental Health and Addictions Action Plan 2012-2015.* "It's as if the Minister is now looking at addictions and wellness with binoculars, but only using one of the eye-pieces."

Mr. Dolynny adds that "there are still many gaps in our addictions and wellness programs. We need to look at the full range of services for all NWT residents, not just a select few. We are failing people who need a proper detoxification program, or a stronger integrated service management program. We are failing the youth who need specific programs designed for them. We are failing people who need specialized addiction treatments for crack cocaine addiction, solvent abuse and prescription drug abuse. We need mental health and addictions programs for people who don't fit into the on-the-land and mobile treatment models. And finally, we need to make the best use of existing infrastructure for mental health and addictions. Closing the Nats'ejee K'eh facility goes directly against what was proposed to the Legislative Assembly only months ago. We had few facility options for our residents then; now with this closure we have nothing in the Northwest Territories."

MLA Dolynny says he supports the Minister of Health's intent to improve community wellness. "Even so, I am concerned that the quick closure of this facility is not the best way to go, especially with so little discussion of a transition period," he notes. "We have skilled care workers there who have helped a lot of people over the years. I would like to know what the plan is for them, and just what the plan is for mental health and addictions services for all northerners."

#### Ministerial Response to MLA's questions on fuel price regulation in the NWT

### (YELLOWKNIFE) Friday, July 26, 2013 – Minister Robert C. McLeod responds to MLA Hawkins on fuel price regulation in Yellowknife.

During the most recent sitting of the NWT Legislative Assembly, MLA Hawkins raised questions about the high prices of home heating and automotive fuels across the NWT. On July 11, 2013 Robert C. McLeod, Minister of Municipal and Community Affairs, responded with the following arguments against fuel price regulation.

According to representatives from the Minister's office, fuel price regulation in the NWT is not a cost effective option given measures that are already in place so NWT residents can benefit from the lowest fuel prices possible. In the department's letter to MLA Hawkins, they explain that the Northwest Territories already has some of the lowest taxes on fuel in Canada and that there are consumer cost-saving programs through Petro-Canada and the Yellowknife Co-op that allow consumers to benefit from average gasoline prices comparable to the rest of Canada. The Department of Municipal and Community Affairs provide data in their letter claiming that "[a]s of March 2013, the average gasoline price per litre in Canada was \$1.302, whereas the price per litre in Yellowknife was \$1.312."




Figure 1 Source: Natural Resources Canada

Statistics from the Natural Resources Canada (NRC) website provide a different view, indicating that the average gasoline price per litre in Canada over the past 82 weeks was \$1.278, whereas the average price per litre in Yellowknife was \$1.402 (see figure 1). NRC does not provide statistics on the average prices of neighbouring communities, but this is also something to consider given the astronomical prices that citizens pay in these regions.

MLA Hawkins feels that "further research from a third-party should be conducted to ensure that this is truly the case. Fellow provinces of Prince Edward Island, Quebec, Newfoundland and Labrador, Nova Scotia and New Brunswick have implemented legislation to regulate various fuel prices." Mr. Hawkins believes that "the NWT can learn from both the positive and negative ramifications of fuel regulation in neighbouring provinces so that a solution can be found to meet the diverse needs of the vast territories, but expert consultation is required." He "urges citizens to come forward to voice their concerns" and has set up an online petition so that "we can continue to advocate for consumer interest." #### Nahendeh MLA Kevin Menicoche Calls on the GNWT to Take Action on Academic Achievement

(YELLOWKNIFE) Tuesday, July 30, 2013 – Nahendeh MLA Kevin Menicoche, reacting to this month's release of the 2012 Alberta Achievement Tests assessment results for students of the NWT, said that he is disheartened and deeply concerned by the GNWT's failure to improve education achievement rates over time.

The 2012 Alberta Achievement Tests, along with an assessment of students' functional grade levels and attendance, indicate little improvement in the academic achievement of NWT students over the past six years.

Between 2006-07 and 2011-12, there was a mere 2% increase in the overall proportion of Grade 1 to 9 students performing at or above grade level in English language arts. The results are just as poor in mathematics where the improvement across time amounts to 1%. During the same period of time, the proportion of the government's annual budget spent on Education, Culture and Employment dropped by about 3%.

"In this year's Budget Address, the Minister of Finance said that 'investing in our children is the wisest move we can make,' yet we are not making the necessary investments to ensure their success, and what investments we do make are clearly not producing positive results," said Mr. Menicoche, noting that ECE reviews and reports on performance measures on a regular basis, yet in survey after survey any improvement in student performance remains elusive.

"It is especially distressing to see numbers showing how poorly students are doing in the NWT's smaller communities," said Mr. Menicoche. In the communities, as many as 67% of enrolled grade 3 students are performing below acceptable standards for English language arts, increasing to over 75% by the time they reach grade 9. In math, the numbers are similarly dismal, with almost 65% of grade 3 students performing below standard, increasing to almost 80% by grade 9. "Sadly, we are failing our children," said Mr. Menicoche.

"We cannot allow this to continue," concluded the MLA for Nahendeh. "I urge the Minister of Education to take decisive and proactive steps for positive change as part of the department's education renewal initiative."

**Changes to Health Governance Model Prevents Effective Delivery of Services** 

(YELLOWKNIFE) Thursday, August 29, 2013 – Range Lake MLA Daryl Dolynny is concerned once again about the Department of Health and Social Services' unilateral decision to shut down the Dehcho Health and Social Services Authority and instead appoint a public administrator.

On July 29, 2013 the Department of Health and Social Services announced the termination of the Dehcho Health and Social Services Authority and the appointment of Mr. Jim Antoine as its new public administrator. MLA Dolynny questions the unilateral way in which the department has been making decisions, including this one, throughout the summer. "We just witnessed this a couple weeks ago with the closing of Nats'ejee K'eh, and again with this announcement".

Mr. Dolynny reiterates how "the guiding principles of the 17<sup>th</sup> Legislative Assembly clearly state that except under extraordinary circumstances, members of the Legislative Assembly should have the opportunity to discuss significant announcements, changes, or initiatives before they are released to the public. These surprise and stunning changes in policy are completely inconsistent with consensus government".

Mr. Dolynny does not question the qualifications of Mr. Antoine, but rather the process by which the Department of Health and Social Services has been making its decisions.

MLA Dolynny is troubled by the changing health governance model in the territory and dilemma it presents moving forward. He asks, "with our territory now split down the middle between health boards and public administrators, how do we maintain standards, monitor policy, plan strategically, and appoint medical staff while at the same time ensuring quality care and responsible budgeting for our residents?" Moreover, Mr. Dolynny feels that "this fragmented approach is detrimental to maintaining high standards of health care delivery and does little to reassure the public that tax dollars are being well managed".

Mr. Dolynny has been extremely vocal about the factors preventing the effective delivery of health care in the territory. "Duplicated services, inefficient design, low levels of accountability, continued failures in risk management, and unmet legal requirements are all factors actively impeding our health care system", he said. "We would greatly benefit from a harmonized approach that addresses these shortcomings and ultimately provides more efficient and accessible care to all our residents", he added.

MLA Dolynny concludes by saying, "it is unfortunate that elected members of the Legislative Assembly have no say in the provision of our health care. Removing the debate from the

decision-making process in this manner does a great disservice to the people of the Northwest Territories".

Yellowknife Centre MLA Concerned About Giant Mine Remediation Proposals

(YELLOWKNIFE) Monday, September 30, 2013 – Yellowknife Centre MLA Robert Hawkins is calling on Premier Bob McLeod to encourage Aboriginal Affairs and Northern Development Canada (AANDC) and Environment Canada to provide an incentive for innovative solutions to arsenic contamination at the Giant Mine site.

During the Giant Mine remediation discussion in N'Dilo earlier this week, it was noted that \$1.9 million dollars annually will be required to operate the mine into perpetuity. MLA Hawkins voiced concern that none of the recommended courses of action inspire the innovation necessary to find a permanent solution to this costly dilemma.

To stimulate innovation, MLA Hawkins suggests a lump sum payment of between 10 and 20 million dollars be offered as a reward for designing a permanent solution. "By fostering creative thinking and ingenuity, this could provide the spark that causes people to find a solution to the arsenic problem once and for all", he said. MLA Hawkins proposes that this reward be offered to national and international parties in order to attract the highest level of innovation possible. "If universities and private companies from around the world were to consider this challenge, the chances of achieving a long-term solution will greatly increase", says Mr. Hawkins.

MLA Hawkins continues, "solving this problem requires the kind of spirit that has resulted in the greatest of mankind's achievements. People are motivated by the advancement of science, technology, and the chance to contribute to the betterment of society. The situation at Giant Mine is complex, but this reward would motivate and encourage this type of inspired thinking. Additionally, an original solution would mean unique and great contributions to the field of environmental remediation". According to MLA Hawkins, providing monetary incentive is a low-risk strategy that, if successful, would yield invaluable results. "If a solution is not found, it does not cost the government anything; however, if a solution is found, the upfront price tag still pales in comparison to the cost of maintaining the mine over the long-term", he adds.

Mr. Hawkins hopes the Premier will consider his proposal as a viable option and will make efforts to include this suggestion into the Government of the Northwest Territories' strategy for the remediation of Giant Mine.

#### Members Appointed to Independent Commission to Review Members' Compensation and Benefits

(YELLOWKNIFE) Wednesday, October 2, 2013 – The Honourable Jackie Jacobson, Speaker of the Legislative Assembly, on recommendation of the Board of Management, appointed three members to the Independent Commission to Review Members' Compensation and Benefits.

"I feel very confident in each of the individuals who have been appointed to the Commission and I look forward to seeing their recommendations," said Speaker Jacobson.

The review, to be undertaken within two years of a general election, of the indemnities, allowances, expenses, and benefits provided to Members of the Legislative Assembly is a statutory requirement of the *Legislative Assembly and Executive Council Act*. The Commission, established under the *Act*, will review and assess Members' various benefits to determine the adequacy and appropriateness of the amounts provided and will review and assess the reporting requirements and procedures to determine an acceptable level of public accountability.

The last comprehensive review of Members' compensation and benefits occurred in 2009 with the report tabled in the House in May 2010 by the previous Commission members. The recommendations from this report resulted in a number of changes to legislation, regulations, and Board of Management policies.

Within ten months of the establishment of the Commission, a report will be delivered to the Speaker that may set out recommendations for changes to the indemnities, reimbursements, and all other benefits to which Members are entitled. These recommendations must be debated and formally adopted by the Legislative Assembly before taking effect.

Weledeh MLA Bob Bromley Congratulates Diavik Diamond Mines

(YELLOWKNIFE) Friday, October 11, 2013 – Weledeh MLA Bob Bromley congratulates Diavik Diamond Mines Inc. on receiving the Canadian Wind Energy 2013 Group Leadership Award. Diavik was selected for its four-turbine, 9.2 megawatt wind project constructed at its mine site at Lac de Gras, 300 kilometers northeast of Yellowknife.

Bromley states, "technology like this saves money, uses renewable, northern energy and provides local jobs. This is a perfect example of what a company needs to do to maintain their "social license". In fact, this should not be a voluntary best practice – this should be a requirement of industrial development in today's world."

"Greenhouse Gas (GHG) emissions cause the global climate to change; climate change is happening even faster in the north than in the rest of the globe. Soon, the NWT will have 4 operating diamond mines and they will have come close to doubling NWT GHG emissions," Bromley says.

Bromley calls upon the Government of the NWT to implement meaningful and responsible regulation of GHG emissions, particularly by large emitters such as the mining and oil and gas industry. He notes, "Diavik has taken a crucial first step in demonstrating that we can reduce GHG emissions and save money in the process. Diavik is not alone – wind energy is reducing the use of fossil fuels all around the world."

Bromley also adds, "wind is abundant around those mines and renewable energy is everywhere. Our Government is being too timid - when will we find the fortitude to come through for our people on this looming issue that is being realized more each day?"

The <u>2013 International Panel on Climate Change (IPCC) report</u>, released last month, provides certainty that humankind is causing serious changes in the climate. The report demonstrates that the cost of waiting is skyrocketing, and the time for responsible action is now. "We can see the impacts all across our territory and some of them are traumatic – like the floods in Nahanni Butte. It will be governments such as ours that meets this need - or not," notes Bromley.

#### Lifeguards for Lodune Project at Long Lake Beach

(YELLOWKNIFE) Wednesday, October 23, 2013 – On June 27, 2013, a seven year old boy tragically drowned at Long Lake Beach in Yellowknife. There were no lifeguards at the beach. Media reports indicated that in 2012, a five year old girl was rescued from a near drowning at the same beach.

Range Lake MLA Daryl Dolynny says, "Lifeguards for Lodune was started by a community group to patrol the Long Lake beach to attempt to make it a safer place for children because there are no lifeguards hired to watch over swimmers."

An Industry, Tourism, and Investment spokesperson said there had been an agreement between the Territory and City of Yellowknife to share the cost of lifeguards, but the city hasn't been able to staff the position.

Lifeguards for Lodune spokesperson, Tanya Silke said that they want to encourage a 'no blame' approach to the issue, as many people were blaming the government and the parents. Lifeguards for Lodune is a safety net put into place while parents and guardians wait for the real thing. The whole point is to get lifeguards here and to encourage community spirit and empower people to get involved to make a difference in their town.

Ms. Silke stated, "there have been successes with the project, like the number of community businesses and people who joined forces with us to get supplies for the park patrols and of course our volunteers."

The Lifesaving Society of Alberta and Northwest Territories completed a safety audit of the beach over the summer, but according to Industry, Tourism, and Investment the draft report didn't recommend lifeguards be hired. The NWT government and the Lifesaving Society provided about 30 free personal floatation devices at Long Lake beach and provided educational materials.

Dolynny indicated that the group is concerned about volunteer liability involved with the patrols. Liability insurance costs a lot of money and the small group sees that issue as limiting the number of volunteers. Silke said this week, "it is sad and frustrating that liability concerns are limiting the project. Development of policies and procedures and group governance through a board of directors to guide future operations are also being considered."

MLA Dolynny plans to raise the issue this week in the Legislative Assembly, "the government has a role to play in helping make our NWT territorial parks safe for residents and visitors. Let's get a program in place now and be ready for next summer, lifeguards are needed."

Ms. Silke said the group is planning to operate again next year if nothing is done to hire lifeguards. These incidents in Yellowknife raise overarching concerns about lifeguards at beaches across the NWT.

Representatives of Lifeguards for Lodune will be at the Legislative Assembly at 1:00pm, Thursday, October 24 and interested media are asked to attend.

The establishment of an Electoral Boundaries Commission every eight years is a requirement of the *Electoral Boundaries Commission Act*. The current Commission was established by the Legislative Assembly on October 23, 2012 with a mandate to provide a report within seven months.

The report provides the Legislative Assembly with recommendations for changes to the existing NWT electoral boundaries and includes options for an 18, 19, and 21 Member Legislative Assembly. #### **Options for a New** Mental Health Act

### YELLOWKNIFE (Monday, November 4, 2013) – The Standing Committee on Social Programs (SCOSP) is seeking input from organizations working with mental-health consumers.

"Addictions and mental-health issues are some of the biggest problems we have in the Northwest Territories, and there is no one who is not touched by them," said Committee Chair Alfred Moses.

Addictions and mental-health disorders, along with poverty and crime, are top priorities for the Standing Committee on Social Programs. One way to advance the Committee's work is for the government to partner with non-profit and volunteer organizations in meaningful ways.

The Standing Committee on Social Programs plans to hear from these groups as the NWT *Mental Health Act* undergoes a comprehensive rewrite.

A series of discussion papers has been prepared by the Department of Health and Social Services (DHSS) to identify options for the new Act.

The Standing Committee on Social Programs is seeking input on the discussion papers from any individuals or organizations working with mental-health consumers. The Committee is especially interested in views on the following:

- Should a review board be established to protect patient rights?
- Should community treatment orders be established as alternatives to hospitalization?
- Is a new model for involuntary admission required?
- Should a third-party "patient-rights advisor" be established?
- Is it appropriate for nurse practitioners to perform involuntary psychiatric assessments?

Feedback from stakeholders on the preliminary discussion papers is the first step in a lengthy process. Following this a legislative proposal and draft bill will be developed. There will be other opportunities for non-profit and volunteer organizations to have their say.

Feedback received by Thursday, December 5, 2013 will be considered in the Committee's formal response to the DHSS.
