Yellowknife Centre MLA Advocates for Nonpartisan Senate

(YELLOWKNIFE) Thursday, January 30, 2014 – Yellowknife Centre MLA Robert Hawkins is calling upon the Prime Minister of Canada to follow Liberal leader Justin Trudeau's actions and exclude his Senators from the Conservative Caucus.

In doing so we would create the opportunity to reconfigure the Senate in a fashion similar to the consensus model used by the Northwest Territories and Nunavut, thereby alleviating the pressures of partisanship by allowing Senators to sit as independent members.

According to MLA Hawkins, the ability of Senators to provide sober, second thought to legislation is hindered by binding partisanship. He says, "the success of consensus government stems from its ability to be responsive to the issues people face every day. Canadians have come to realize that the current structure of the Senate does not allow for structural changes without amending the Constitution. The lack of accountability has rendered it a sinking ship."

MLA Hawkins suggests the Prime Minster allow the provinces and territories to devise their own methods of selection, or as suggested by Mr. Trudeau, by establishing an independent appointment committee, thereby allowing the Prime Minister making appointments based on these recommendations. This would operate within the current structure while providing a more accountable framework to Canadians.

MLA Hawkins adds, "the public is tired of hearing about the lack of accountability within the Senate, which continues to be mired in scandal and political posturing. Reform in keeping with a consensus model would dissolve these barriers and bring traditional adversaries together to debate and review legislation based on merit alone. Opposing parties rarely stand together on substantive issues; this could create an environment for unparalleled cooperation."

Mr. Hawkins further adds, "if we continually tolerate politics in this manner, it is of little wonder why voter apathy continues to rise as frustration builds with politics that is far too partisan and self-serving. To that end, I will be writing a letter to the Prime Minister as well as the Honourable Pierre Poilievre, Minister of State for Democratic Reform, to encourage them to examine the opportunities that consensus government could offer the Senate."

Standing Committee on Government Operations Wants to See Improvements on Child and Family Services in the NWT

(YELLOWKNIFE) Tuesday, April 29, 2014 – A searing report by the Office of the Auditor General has shed light on the dismal state of child and family services in the Northwest Territories. The Standing Committee on Government Operations is determined to see dramatic improvements in the delivery of these services.

According to Michael Nadli, Chair of the Standing Committee on Government Operations, "we're at a critical juncture. The system is broken. Accountability is very weak. Workers in the field aren't being properly trained or supervised. Child protection workers aren't assessing long-term risks of abuse and neglect. The situation is unacceptable. And the really heartbreaking part is that the Department has known about the systemic problems for years."

The Standing Committee on Government Operations reviewed the report with Assistant Auditor General Mr. Ronnie Campbell and top officials from the Department of Health and Social Services at a special meeting held April 23-24, 2014. During the proceedings, Deputy Minister Debbie DeLancey conceded there has been substantial failure in the delivery of child and family services.

The report of the Auditor General states that many of the problems outlined in the report are clearly within the Department's control to address.

The Committee will be closely observing the Department's next moves. Few improvements were made to the system following several earlier reports, including the Standing Committee on Social Programs' 2010 review of the *Child* and Family Services Act. "We're concerned that this report will have the same fate as the others," Mr. Nadli stated.

In response to the Auditor General's recommendations, the Department has promised to produce a comprehensive action plan by the end of June, 2014, to conduct quarterly compliance audits on the regional authorities, and to develop system-wide performance indicators.

Wendy Bisaro, Deputy Chair of the Standing Committee on Government Operations, stated, "we are going to recommend that future contribution agreements with the regional authorities have a performance component. Funding should be conditional on the authorities demonstrating compliance with the Act."

The Standing Committee looks forward to further public dialogue with the Honourable Glen Abernethy, Minister of Health and Social Services, and is preparing a response to the Auditor General's report to be tabled in the Legislative Assembly during the May/June sitting.

Standing Committee on Government Operations Presents Report on Auditor General's Findings on Child and Family Services

(YELLOWKNIFE) Thursday, May 29, 2014 – Today the Standing Committee on Government Operations presented its report in response to the Auditor General's findings on child and family services. The Committee's report contains 30 recommendations and is scheduled to be discussed in the House during the May/June sitting of the Legislative Assembly.

Michael Nadli, Chair of the Standing Committee, emphasizes that this is a critical juncture, "the Department must go beyond making minor adjustments and overhaul the entire system. It must assess resource needs, fix the accountability framework, improve standards and procedures, and provide better training to child protection workers."

The Standing Committee on Government Operations discussed the Auditor General's findings with Assistant Auditor General Ronnie Campbell and senior officials from the Department of Health and Social Services at a special meeting held April 23-24, 2014. During the proceedings, Deputy Minister Debbie DeLancey conceded there has been substantial failure in the delivery of child and family services.

The Committee will closely monitor the Department's next moves. Few improvements were made to the system following several earlier reports, including the Standing Committee on Social Programs' 2010 review of the *Child and Family Services Act*. "Continued inaction is unacceptable. We intend to make sure the Department keeps its promises," says Mr. Nadli.

To that end, the Standing Committee had further dialogue with the Honourable Glen Abernethy, Minister of Health and Social Services, on May 26, 2014. The Minister has promised to produce a comprehensive action plan by the end of June 2014, to conduct quarterly compliance audits on the regional authorities, and to develop system-wide performance indicators.

17th Assembly Term of Office

(YELLOWKNIFE) Tuesday, June 3, 2014 – The Prime Minister has advised the Premier of the Northwest Territories of his government's intention to introduce amendments to the *Northwest Territories Act* to allow the 17th Assembly to vary its term. Members of the Legislative Assembly will determine whether to change the October 2015 territorial election date after further discussion in the fall and public consultation.

On March 10, 2014, the Legislative Assembly passed a motion asking the Premier to communicate to the Prime Minister a request for an amendment to the *Northwest Territories Act* that would authorize the Legislative Assembly to vary its term.

The Premier has received from the Prime Minister a letter indicating that his government will be bringing forward an amendment to the *Northwest Territories Act* as requested. The amendment, if passed by the Parliament of Canada, will give the 17th Legislative Assembly the ability to vary its term. If the federal election proceeds as currently scheduled and overlaps with the Northwest Territories election in October 2015, the Legislative Assembly will consider a change to the 2015 election date to avoid a conflict with the overlap. If the federal election proceeds at a different time, there will be no need to consider changes to the territorial election date.

Amendments to the territorial Legislative Assembly and Executive Council Act and Elections and Plebiscites Act would be required to change the territorial election date to a time other than October 2015. No decision has been made on whether to proceed with any changes. Members will review legislation from other jurisdictions that will trigger changes to their election dates to avoid overlap with the federal election in the event that it proceeds in October 2015, and will discuss the matter further this fall to determine whether further consideration of the territorial election date is needed. If any changes to the territorial election date are to be considered there will be no decision made on those changes prior to public consultation.

He has documented significant changes in Arctic ecosystems due to its rapidly warming climate, focusing on the consequences of thawing permafrost – and what this unprecedented change means to all of us.

Kokelj has more than 60 scientific publications to his credit, and some of his findings have been featured on CBC Television and radio. Traditional knowledge has been an important part of his work. Kokelj is the permafrost scientist for the Department of Industry, Tourism and Investment's Geoscience Office, and an adjunct professor at University of Victoria and Carleton University.

A hallmark of Kokelj's work is that it often has broad application, impact and use in other areas. Sharing such ideas is one of the most important goals of *The Knowledge Series*. Accordingly, *Ledge Talks* will be particularly relevant to GNWT employees, but will also be open to the public and media.

Ledge Talks: The Knowledge Series - The Inconvenient Truth About Autism Spectrum Disorder

Cabinet Power Rate Solution Misses Target, Ignores MLAs

(YELLOWKNIFE) Friday, September 26, 2014 – With yet another power subsidy of 20 million dollars added to the taxpayer's burden this year, Cabinet has failed once again to meet the needs of residents and businesses.

Bob Bromley, MLA for Weledeh, notes, "just imagine the lasting reduction in power bills that the 20 million dollars could have given to rate payers by supporting solar panel installations, which provide huge savings and clean power for more than a generation."

Instead, Cabinet's unilateral decision to subsidize rates, at an additional cost to taxpayers on top of existing high subsidies, will undermine citizens' decisions to install solar generation at their homes and businesses. Subsidies such as this hide the true costs associated with burning diesel and remove the motivation for people to seek self-sufficient solutions.

"This is typical of many decisions that have been made in the seven years that I have been serving the constituents of Weledeh," Mr. Bromley said. "Over that period, hundreds of millions of taxpayer dollars have been spent on subsidies while power rates continued to soar. Imagine what hydro, wind, and solar infrastructure could have been installed with these resources. I am tired of seeing the unnecessary rise in the cost of living that our residents and small businesses must apparently suffer while cost-effective and climate-friendly remedies are ignored."

There are a number of off-the-shelf, renewable energy options available on the market that government has been aware of for years. While another energy planning session, such as the one announced, offers some potential for wise guidance in this area, government's record of failing to hear the progressive voice of experts is not good. "When will this government learn from these repeated lessons," asked Mr. Bromley. "Certainly, Cabinet shows no desire to act as a consensus government, or to seek input from duly elected representatives of the people."

Sahtu MLA Applauds Nunavut MP for Standing up for Trappers after RCMP Fur Hat Flap

(YELLOWKNIFE) Wednesday, October 1, 2014 – Sahtu MLA, Norman Yakeleya, has been tracking the federal debate regarding the Royal Canadian Mounted Police phasing out its standard issue muskrat hats. "Whether you're an elder in Colville Lake, or an RCMP officer in Hay River, after the snow falls you'll see people in the NWT wearing their muskrat hats," exclaimed Norman Yakeleya.

Yesterday the debate came to an unofficial close in Ottawa when Dauphin-Swan River-Marquette MP, Robert Sopuck, asked the Federal Environment Minsiter, Leona Aglukkaq, what was happening with the iconic winter headgear.

The debate started when the RCMP said it would switch from its iconic fur hats after the Association for the Protection of Fur Bearing Animals said muskrats caught in traps can suffer before they die, but MP Sopuck defended trapping yesterday in Parliament.

"Like Mr. Sopuck, I represent a remote rural part of Canada, and many of my constituents trap. We cannot let animal rights activists sweep this sustainable renewable industry under the rug. The Muskrat hat is almost as symbolic with the RCMP as the Stetson," said Yakeleya.

In closing Yakeleya said, "I want to congratulate the MP for Dauphin-Swan River-Marquette and the Honourable Leona Aglukkaq for standing up for the Fur Trade, and for our iconic winter headgear."

Sahtu MLA Questions Fracking Protestors' Knowledge of Economic Hardships

(YELLOWKNIFE) Friday, October 10, 2014 – While concerns about water safety and environmental stewardship are important, Sahtu MLA, Norman Yakeleya, is urging the public and the anti-fracking movement to look at the economic and social impacts hitting his riding.

"We are all in a time of constant transition. We have lived through a 20 year land freeze that ended in 1993, while we negotiated our Land claim. At that same time we developed our own regulatory bodies and Land use plans that have enabled us to setup responsible development, which we hope will benefit us all." said Yakeleya.

While discussions and legal questions persist around the NWT Regulatory System, and the proposed single land and water board, permitting and briefings from both government and industry have taken place across the Sahtu. "We realize we can't put all our eggs in one basket, but we are seeing the social impacts in our communities before the boom from industry happens. Break-ins, elder abuse, stealing gas, petty crimes to fuel people's addictions and habits," added Norman Yakeleya.

Striking an environmental and economic balance continues to be a huge challenge across the NWT. "Water safety is paramount, and cumulative impacts need to be addressed in the Sahtu, but the Land and Water Board addresses that, and to think we are blindly putting all our chips on fracking is insulting" Yakeleya said.

While economic and industry practices vary across the NWT, Yakelya said in closing, "the Dene/Metis leaders of Sahtu have never publically criticized other communities or regions for their economic opportunities, even when we know mining impacts Caribou and migratory species. I urge all northerners to seriously look at the poverty and economic impacts we face with no development. We can only curb environmental and social impacts through innovation, investment and responsible development, not fear mongering."

Delay of Territorial Election will Depend on Timing of Federal Election

(YELLOWKNIFE) Thursday, October 16, 2014 – The Caucus of the 17th Legislative Assembly has clarified its position on the timing of the next territorial general election. If, by April 1, 2015, the date of the federal election continues to overlap with the campaign period for the territorial election, the date of the territorial election will be postponed to November 23, 2015. If an announcement is made to change the timing of the federal election prior to April 1, 2015, the territorial election will proceed as planned on October 5, 2015.

Both Canada and the Northwest Territories have adopted fixed election dates. At present, the federal election is scheduled for October 19, 2015. The Prime Minister has the ability to call an election earlier than this date. Municipal elections for tax-based communities and school board elections in Yellowknife are also scheduled for October 19th. The general election for the NWT Legislative Assembly is currently scheduled for October 5, 2015. The result will be a three and a half week overlap in the campaign periods for the two elections between September 14 and October 5, 2015.

"There are many reasons why an overlap in the two campaign periods should be avoided," said Caucus Deputy Chair and MLA for Inuvik Boot Lake Alfred Moses. "Foremost among these is the reality that in many of our small communities, the same staff serve as election officials for both Elections Canada and Elections NWT. The same can be said for the many campaign staff and volunteers that help candidates get their respective messages out and provide a clear choice to the voter. As well, overlapping campaign periods create the risk that partisan politics at the federal level will overshadow and influence the non-partisan nature of territorial politics."

The provinces of Saskatchewan, Manitoba and Prince Edward Island have adopted similar measures to avoid an overlap with the federal election. In each of those jurisdictions, the provincial election will be delayed to April 2016 if the date of the federal election remains unchanged. A bill will be introduced in the Legislative Assembly in the upcoming sitting that will establish April 1, 2015 as the "trigger date." "If the timing of the federal election changes before then," noted Deputy Chair Moses, "we will stick with our October 5, 2015 election date. If nothing's changed at the federal level by April 1, 2015, this measure will automatically bump our date back six weeks to avoid the overlap." General elections have previously been held in the Northwest Territories in late November and early December as recently as 1999 and 2003.

The bill establishing the "trigger date" will be contingent upon the passage of amendments to the *Northwest Territories Act* by the Parliament of Canada. It is expected that this amendment will be introduced in the House of Commons during the current Fall sitting of Parliament.

Nahendeh MLA Disappointed with Postponement of Wrigley RCMP Detachment Opening

(YELLOWKNIFE) Tuesday, October 28, 2014 – The MLA for Nahendeh, Mr. Kevin Menicoche, is disappointed with the announcement released today that the opening of the Wrigley RCMP detachment will be indefinitely postponed.

"From 2009 to 2012, there were a total of 855 calls made for RCMP assistance in Wrigley. That is approximately 285 calls per year. For a population of 133 people, this is very high. Of those calls, 42% were alcohol related. This community needs a permanent RCMP presence, weekly visits are important, but not enough to ensure the safety of residents," said Mr. Menicoche.

"This is something that I have been passionate about since I was elected in 2003. In 2007, the RCMP issued a statement telling the people that they would be building a detachment in Wrigley by 2011. In 2010, they decided to put it off for another three years. Now, they have decided to put the opening of this detachment off indefinitely. Why do the people in my constituency have to wait this long, only to have someone tell them that it isn't going to happen? I am utterly disappointed with the fact that this has happened and I will be raising this issue in the legislature to the Minister of Justice," said Mr. Menicoche.

Legislative Assembly Agrees to Extend the Review Period for Bill 12

(YELLOWKNIFE) Thursday, October 30, 2014 – Today the Legislative Assembly adopted a motion introduced by Mr. Michael Nadli, Chair of the Standing Committee on Government Operations, to extend the review period for Bill 12: *Northern Employee Benefits Services Pension Plan Act* for a further 120 days.

Bill 12, sponsored by the Minister of Finance, sets out the legislative framework for the Northern Employee Benefits Services (NEBS) Pension Plan to continue as a multi-employer, multi-jurisdictional public sector pension plan for employees of approved public sector employers in both the Northwest Territories and Nunavut. The Nunavut Standing Committee on Legislation has been considering Bill 1, which largely mirrors the provisions of Bill 12. Earlier this week, the Nunavut Legislative Assembly adopted a motion to extend the period of time for their Standing Committee to report Bill 1 back to their House by a further 120 days.

"Our Standing Committee on Government Operations held a public hearing on Bill 12, in Yellowknife, on September 25, 2014. During that meeting and in the weeks that followed, Committee received both oral and written submissions expressing a variety of views. Some organizations have called upon both legislatures to withdraw the Bill, while others support the Bill as written. I speak for the Committee in saying that we are in agreement with our colleagues in Nunavut that "neither extreme is necessary or desirable at this stage"," said Mr. Nadli.

"Given the interest already expressed by our constituents, the unique nature of this bill, and the challenges proposed by its multijurisdictional nature, it will take time to do this job properly. I believe that people in the Northwest Territories would agree that this is the best way to ensure that NEBS gets the clear legislative framework that they need and the balanced one they deserve," said Mr. Nadli.

Pay and Benefits for Members of the Legislative Assembly to Remain Unchanged

(YELLOWKNIFE) Thursday, October 30, 2014 - The Caucus of the 17th Legislative Assembly has reviewed the recommendations of the 2014 Independent Commission to Review Members' Compensation and Benefits and has agreed to maintain the status quo with respect to MLA pay levels. The Report of the Independent Commission was tabled in the Legislative Assembly by the Speaker on May 28, 2014. The report recommends no significant changes to the pay and benefits of Members of the Legislative Assembly.

"I'd like to thank the Commission for its thoughtful work," noted Caucus Chair, Norman Yakeleya. "Compensation levels for elected officials must balance the need to attract qualified individuals to public office and ensure that elected positions are not restricted to those of independent means. The recommendations of the Independent Commission indicate that we have struck the right balance in the NWT."

The Legislative Assembly must appoint an Independent Commission to review MLA compensation within two years of the swearing in of a new Assembly. Normally, the recommendations of an Independent Commission take effect for the following Assembly. The 2014 Commission was chaired by Mr. Geoffrey Wiest and included Mr. Gregory Nyuli and former MLA for Mackenzie Delta, David Krutko. The Commission's report (TD83-17(5)) is available at the Legislative Assembly Library or on the Legislative Assembly website, www.assembly.gov.nt.ca, in Tabled Documents, under the Documents & Proceedings heading. The terms of reference for the Commission are attached.

Terms of Reference

Pursuant to Section 35.1 of the *Legislative Assembly and Executive Council Act*, within two years after the polling day for a general election, the Speaker, on the recommendation of the Board of Management, shall establish an independent commission and appoint as its members three individuals who are independent, neutral, and knowledgeable.

The last comprehensive review of Members compensation and benefits occurred in 2009, with a report tabled in May 2010. The recommendations from this report resulted in a number of changes to legislation, regulations and Board of Management policies.

1. PURPOSE

The Commission shall:

- Review and assess the indemnities, additional indemnities, allowances, expenses and benefits provided to Members to determine the adequacy and appropriateness of the amounts provided by way of:
 - Legislative Assembly and Executive Council Act
 - Indemnities, Allowances and Expense Regulations
 - Legislative Assembly Retiring Allowances Act
 - Supplementary Retiring Allowances Act
 - Board of Management Policies
- Review and assess specific items referred to the Commission by the Board of Management.
- Review and assess the reporting requirements and procedures for Members' and Ministers' expenditures to determine the level of accountability acceptable to the public.
- Review any other matter that the Commission considers relevant respecting the compensation, allowances, and benefits provided to all Members and Ministers.
- Provide to the Speaker a report setting out any recommendations for change that the commission determines should be made to Members' or Ministers' indemnities, allowances, reimbursements, and other benefits.

2. GUIDING PRINICPLES

- No Member should seek to serve in public office for purely financial gain. Although the reasons may vary considerably, the underlying motivation for election must be to serve and improve the well being of people of the Northwest Territories.
- 2) The system of remuneration must be transparent, open, and provide an easy to understand system of remuneration to the Members of the Legislative Assembly and Members of the Executive Council while providing a high degree of accountability to the people they serve.
- 3) Remuneration packages, particularly with respect to living, travel and transportation costs, need to be sensitive to the regional differences of job related expenses in order to ensure these factors do not become prohibitive for any Member to represent their constituents.
- 4) The requirement to be available and accountable 24 hours a day, seven days a week, coupled with the lack of job security associated with an election every four years ensures that only certain individuals would consider running for public office. A position of such importance in our democratic system, with such wide-ranging responsibility, should be fairly compensated in order to attract qualified and committed individuals.

3. COMPOSITION

The Commission shall consist of three individuals who are independent, neutral, and knowledgeable. Preferably the commission shall consist of a former Member, a professional with relevant financial or legal designations and experience, and an interested member of the public. Appointment to the Commission will also take into account regional representation within the NWT.

The Speaker, on the recommendation of the Board of Management, will appoint one of the three Commission Members to serve as Chair.

4. RESPONSIBILITIES

The Commission will be responsible for:

Collecting and analyzing research materials from previous commissions and other legislative jurisdictions and position of comparable responsibility within the public and private sectors.

Seeking public input and soliciting Members' submissions.

Reviewing and making recommendations on the following areas of Members' and Ministers' remuneration, or any other areas the Commission considers relevant, including but not restricted to:

- Indemnities Payable to Every Member
- Indemnities Payable to Office Holders
- Non-taxable Allowance for Expenses
- Constituency Work Expense Allowance and Permissible Expenditures
- Duty Travel & Meals
- All Travel Allowances
- Northern Living Allowance
- Leave and Vacation Allowance
- Transition Allowance
- Pension & Benefits Entitlements
- Telecommunications & Computer Equipment Allowances
- Acquisition of Office Inventory Items on Expiry of Office
- Capital Accommodation and Furniture Allowances
- Automatic Adjustment to All Allowances
- Specific Items Referred by the Board of Management

5. REPORT

The Commission shall, within ten months after the day the Commission is established deliver a report to the Speaker that sets out any recommendations for change it determines should be made to the indemnities, allowances, reimbursements, and all other benefits Members are entitled to.

6. FINANCE AND ADMINISTRATION

The Clerk of the Legislative Assembly will provide administrative services and support to the Commission as required. The Commission may seek the

assistance of consultants to provide it with advice and analysis and to ensure an arms-length relationship with the Legislative Assembly.

The Speaker, on the recommendations of the Board of Management, will approve funding for the Commission. The Commission will ensure expenditures do not exceed the allotted funds.

7. REMUNERATION

The Speaker, on the recommendations of the Board of Management, may approve honoraria and reasonable expenses to attend meetings for Members of the Commission, including the Chair.

8. TERMINATION

An appointment of an individual to the Commission terminates on the day the report is laid before the Legislative Assembly., unless the appointment is earlier revoked or otherwise terminated.



Sahtu MLA Applauds Colleagues and Premier for Supporting MMIW Motion

(YELLOWKNIFE) Wednesday, November 5, 2014 – A motion calling for a National Roundtable and a National Inquiry on Missing and Murdered Aboriginal Women and Girls has passed through the 17th Legislative Assembly.

It was moved by Yellowknife Centre MLA Robert Hawkins, "I am grateful for the kind words of support on this sensitive issue, which faces each of our communities in the NWT and across Canada," he said in the house after the recorded vote came to a close.

Sahtu MLA Norman Yakeleya seconded the motion. He had done a considerable amount of research and gathered support from First Nations and Métis Leaders from across the NWT leading up to the vote in the Assembly yesterday.

"This issue affects me personally. I have lost a cousin and an Auntie. Our family, like others, goes to bed every night wondering, "What happened? Will they ever come home," Mr. Yakeleya stated emotionally in his address to the motion.

The vote passed with notable support from NWT Premier Bob McLeod, who has been leading the charge on this issue at the national front with the Premiers of Canada. Justice Minister, David Ramsay, also spoke in favour of the motion, along with Transportation Minister, Tom Beaulieu.

The motion passed by a landslide vote, 17 for it, 0 against, and 1 abstention.

Myself and my colleagues have strongly encouraged the department of Health and Social Services to work on improving the much dated act of 1988 and embark on a mission of change. We need a change that will modernize our approach to improving the *Human Tissue Donation Act*, with a comprehensive process, framework, and proper consent process," says Mr. Dolynny.

"The experience in preparation for today has been very humbling and extremely emotional. In support of this bill today, I would like to thank all the members of the Legislative Assembly and their constituents," said Mr. Dolynny.

The Commissioner of the Northwest Territories will give assent to a number of bills at the end of the fall sitting.

Range Lake MLA Questions Education, Culture and Employment Minister on French School Decision

(YELLOWKNIFE) Thursday, November 6, 2014 – The MLA for Range Lake, Daryl Dolynny, posed questions yesterday to the Minister of Education, Culture and Employment, Jackson Lafferty, on the decisions made by the department on the future of French schools in Yellowknife.

"In September 2013, the GNWT approached YK1 and the Commission scolaire francophone, CSF, to seek an expedient and cost-effective alternative to the court ordered expansion to École Allain St. Cyr. These exploratory discussions involved the review of existing underutilized YK1 space and the needs for the CSF students to determine if alternatives to the court order for additional YK1 space could be found," said Mr. Dolynny.

"What started as an issue of 116 francophone students and their families and the findings of this YK Facility Committee report has now affected half the city of Yellowknife, has pitted neighborhood against neighborhood, school versus school, parent versus parent, and student versus student, and this is wrong. In our eager and frugal mindset of duty, we have dehumanized our education system at the mere expense of trying to dodge a constitutional bullet and we should be embarrassed of those actions. There is no argument that YK1 is dealing with aging infrastructure and enrolment issues, but what we are about to ask of them by this government is seen as nothing more than unfair treatment and misuse of power. They have their own challenges and we are definitely not helping," continued Mr. Dolynny.

There will be a Town Hall meeting regarding potential changes to YK1 schools and programming tonight at 7:00pm at Range Lake North School.

(YELLOWKNIFE) Thursday, November 13, 2014 – On Thursday, November 6, 2014, Regular Members of the Legislative Assembly voted unanimously in favour of a motion calling on the Government of the Northwest Territories to bring forward legislation to establish an Office of the Ombudsman for the Northwest Territories

The motion was introduced by Mr. Michael Nadli, Deh Cho MLA, and Chair of the Standing Committee on Government Operations (SCOGO). SCOGO tabled a report on the topic earlier this year.

"An 'ombudsman' is a fancy word for a citizens' defender—a peacemaker who gives a voice to the people," said Mr. Nadli. "An ombudsman assists people, free of charge, who feel they've been treated unfairly by government."

Ms. Wendy Bisaro, Frame Lake MLA, and Deputy Chair of SCOGO, has been a long-time champion of the idea of an ombudsman. In seconding the motion in the Assembly, Ms. Bisaro noted that "the office can be a good force for government, in that it can promote accountability in administration and improve government through investigations." She observed "Over the last couple of decades, particularly with devolution, our territory has grown and we have grown up, and part of being grown up is recognizing the need to help our neighbors and our friends. The time is now to bring this legislation forward."

Generally the ombudsman has robust powers to conduct confidential investigations but cannot change or reverse government decisions. Earlier this month, Mr. André Marin, Ombudsman for Ontario was invited by the committee to speak on the role of an Ombudsman and promoted the idea of a similar office for the Northwest Territories. "Moral suasion is a primary tool in the ombudsman's toolkit," said Mr. Marin.

"This is an idea whose time has come," Mr. Nadli emphasized. "The Government of the Northwest Territories is becoming more complex, especially now that devolution has been achieved. We hear a lot about the need for better public accountability and an ombudsman would help to ensure the GNWT is on the right track."

In speaking to the motion in the Assembly, Premier Bob McLeod reiterated the issues raised by the Government in a discussion paper produced in 2012 and advised that Cabinet would abstain from the vote. The Government is expected to provide a response to the motion within 120 days.

Nahendeh MLA Pleased Passengers on Air Tindi Plane are Safe

(YELLOWKNIFE) Thursday, November 20, 2014 – The MLA for Nahendeh, Mr. Kevin Menicoche, expresses his relief that Air Tindi Caravan passengers and the pilot are safe and uninjured after an emergency landing on the Great Slave Lake earlier today.

According to a media advisory sent by Air Tindi, "a Caravan aircraft enroute from Yellowknife to Fort Simpson has been forced to land on the Great Slave Lake. The aircraft took off on a scheduled flight this morning from Yellowknife, and due to weather conditions was forced to turn around. The pilot contacted the Air Tindi Operations Centre at 7:21am indicating that the aircraft had landed and that there are no major injuries."

"I am pleased that Air Tindi, the Yellowknife airport, and all emergency personnel responded so quickly and all people onboard are safe and out of harm's way. We often use small planes to travel between communities in the Northwest Territories. This accident is a reminder as to how rapidly things can go wrong and northerners should always be prepared when traveling in the winter. I am pleased that all passengers on this aircraft are safe, my thoughts go out to the families that had to endure the stress of today's incident," says Mr. Menicoche.

Sahtu MLA Welcomes Auditor General's Report on Nutrition North Program

(YELLOWKNIFE) Thursday, November 27, 2014 – Sahtu MLA, Norman Yakeleya, welcomed the highly anticipated report from Canada's Auditor General, Michael Fergusson, on the controversial Nutrition North Program.

"I welcome Mr. Fergusson's report and recommendations. People in the Sahtu and across our northern territories are fed up with high food prices. I think the former Food Mail Program was better for putting savings in Northerners pockets," Yakeleya said after the report was released.

Mr. Fergusson's audit of the federal food subsidy program showed that there is no proof of companies passing on the savings to customers on healthy foods. Stated on CBC News website, "Aboriginal Affairs and Northern Development Canada's 60 million dollar program only gathers data on the "product landed cost," the sum of the wholesale cost of the food, ground transportation and air freight, and the selling price."

"It is extremely disturbing that there is no tool to measure the savings companies are getting. I have to ask if these savings are being passed onto customers in our small remote communities," Yakeleya added.

The audit also found the program, which was intended to promote healthy food choices, also gives subsidies on foods such as ice cream, bacon, and processed cheese spread. The auditor general's report comes days after Ottawa announced it was adding more money to the subsidy.
