AND FURTHER, that all Members of the Legislative Assembly would then receive the extended health care benefit and level 1 of the hospital benefit at no cost.

I MOVE that this Assembly recommends that the indemnity for extra duty for the Chair of the Rules and Procedures Committee be increased from \$3,194 to \$6,296 per year.
