I MOVE that this Assembly create an election rebate for candidates who receive at least five per cent of the votes cast in her or his electoral district in the NWT, reimbursing 50 per cent of eligible personal election expenditures up to a maximum rebate amount of \$3,000.

Committee Motion 143-18(3)

The Member for Yellowknife Centre moved the following motion:

I MOVE that this Assembly support the new NWT polytechnic university to establish a leadership program designed to assist women to gain the skills and knowledge to take on leadership roles, including territorial, indigenous and municipal political positions. The motion was CARRIED.
