October 30, 2020

The Assembly commenced sitting at 10:02 am with the Honourable Frederick Blake Jr., Speaker, presiding.

#### Motions

AND FURTHER that the Speaker be authorized to communicate the effective date of appointment to the Commissioner.

### First Reading of Bills

Bill 16: *An Act to Amend the Income Tax Act*

Introduced by Minister of Finance.

The Honourable Member for Yellowknife South, seconded by the Honourable Member for Hay River North, moved that Bill 16, *An Act to Amend the Income Tax Act*, be read for the first time. The motion was CARRIED.

### Second Reading of Bills

Bill 15: *Miscellaneous Statute Law Amendment Act, 2020*

The Honourable Member for Hay River North, seconded by the Honourable Member for Inuvik Boot Lake, moved that Bill 15, *Miscellaneous Statute Law Amendment Act, 2020*, be read for the second time. The motion was CARRIED.

The Minister of Justice sought unanimous consent to waive Rule 73(2) and have Bill 15 moved directly into Committee of the Whole for consideration on October 30, 2020. Consent was granted.

### Consideration in Committee of the Whole of Bills and Other Matters

The Chair, the Member for Inuvik Twin Lakes, reported that the Committee of the Whole considered Tabled Document 181-19(2): Capital Estimates 2021-2022 and reported progress with two motions carried.

The Member for Inuvik Twin Lakes, seconded by the Member for Nunakput, moved the concurrence of the report of the Committee of the Whole. The motion was CARRIED.

I MOVE that this committee defer further consideration of the estimates for the Northwest Territories Housing Corporation at this time.


The motion was CARRIED.
