### SECOND SESSION OF THE NINETEENTH LEGISLATIVE ASSEMBLY

March 10, 2021

The Assembly commenced sitting at 1:31 pm, with the Honourable Frederick Blake Jr., Speaker, presiding.

AND FURTHERMORE, that Northwest Territories Housing Corporation must include referrals to appropriate government programs prior to beginning the eviction process;

AND FURTHERMORE, that the Government of the Northwest Territories provide a comprehensive response to this motion within 120 days.

Moved by the Member for Tu Nedhé-Wiilideh:


I MOVE that this committee defer further consideration of the estimates for the Northwest Territories Housing Corporation at this time.
