Motions

10-18(2) Referral of Standing Committee Public Engagement Processes and Procedures to the Standing Committee on Rules and Procedures

Moved by Member for Frame Lake.

NOW THEREFORE I MOVE, seconded by the honourable Member for Thebacha, that this Assembly refers the issue of standing committee public engagement and transparency to the Standing Committee on Rules and Procedures to recommend a process that may be adopted by all standing committees of the 18th Legislative Assembly;

AND FURTHER, that the research and analysis include consultation with the public and a jurisdictional review;

AND FURTHERMORE, that the Standing Committee on Rules and Procedures report back to the House with its recommendations during the fall 2016 sitting.

Motion 11-18(2) Appointment of Member to the Human Rights Adjudication Panel

Moved by Member for Yellowknife North.

NOW THEREFORE I MOVE, seconded by the honourable Member for Inuvik Twin Lakes, that Mr. Adrian Wright of Salt Spring Island, BC be recommended to the Commissioner of the Northwest Territories for appointment as a member of the Human Rights Adjudication Panel, effective immediately for a term of four years.

Motion 12-18(2) Extended Adjournment of the House to February 29, 2016

I MOVE, seconded by the honourable Member for Great Slave, that, notwithstanding Rule 4, when this House adjourns on February 25, 2016, it shall be adjourned until Monday, February 29, 2016;

AND FURTHER, that any time prior to February 29, 2016, if the Speaker is satisfied, after consultation with the Executive Council and Members of the Legislative Assembly, that the public interest requires that the House should meet at an earlier time during the adjournment, the Speaker may give notice and thereupon the House shall meet at the time stated in such notice and shall transact its business as it has been duly adjourned to that time.

Consideration in Committee of the Whole of Bills and Other Matters
