- (2) MINISTERIAL AND PREMIER INDEMNITY: annual figure of \$46,869 for Ministers and \$66,604 for Premier.
- (3) SPEAKER: annual figure of \$30,835 for Speaker.
- (4) SPECIAL ANNUAL INDEMNITIES FOR EXTRA DUTIES: Deputy Speaker: \$6,167; Deputy Chair, Committee of the Whole: \$3,701; Chair of Standing Committee: \$5,464; Chair of Special Committee: \$2,732.
- (5) CAPITAL LIVING ALLOWANCE: Annual figure of \$6,784 for Members who live within commuting distance of Yellowknife; \$10,483 for all other Members; Ministers are considered to live in Yellowknife and receive \$6,784.
- (6) NORTHERN ALLOWANCE: Annual amount paid in respect of the community in which Members live. Same as provided under the Collective Agreement.
