## YUKON & NWT PREMIERS CALL TO SUSPEND THE FEDERAL GUN CONTROL PROGRAM

WHITEHORSE - The Premiers of the Northwest Territories and the Yukon have collectively called for the suspension of the federal government's gun control program. The enormous expense of administering the program and the lack of evidence that the legislation is working to prevent armed crime, has forced the northern premiers to speak out, once again, against this federal law.

Yukon Premier Dennis Fentie and NWT Premier Steven Kakfwi have jointly called for Ottawa to reconsider their gun registry until the effectiveness of the program can be audited and a true sense of the program's effectiveness can be determined.

"The North has always been very clear on our views to the C-68 gun control legislation and the differences between rural and urban Canada," said Yukon Premier Fentie. "The people of the North and their use of firearms is dramatically different than Canadians in urban centres. But wasting a billion-plus dollars effects all Canadians equally."

Premier Kakfwi said, "The Government of the Northwest Territories has opposed the Federal Gun Legislation from the very beginning. The current fiasco surrounding the implementation of this ill-conceived federal law just adds to our frustration and belief that it must be reconsidered".

Fentie re-affirmed that the Yukon government would not contribute to the enforcement of the new federal gun legislation. "We will leave it to federal prosecutors to enforce this federal gun registry, I cannot in good faith put more taxpayers dollars into this ill-conceived legislation."

The Premiers identified the need to effectively deal with the criminal use of firearms and to ensure the safety of Canadians, but not by creating legislation that does not deliver positive results at a cost to taxpayers that is not realistic.

## **Search and Rescue Prevention Strategy Conference**

YELLOWKNIFE (January 17) – Search and rescue (SAR) authorities and stakeholders from across the Northwest Territories will gather in Yellowknife next week to consolidate input from regional consultations in 2002 and a conference in March 2001 into an effective prevention strategy.

The Department of Municipal and Community Affairs will host the Territorial Search and Rescue Prevention Conference, January 21-22, 2003 as part of an on-going effort to reduce the incidence and severity of search and rescue (SAR) events."

"A completed strategy will also support future territorial funding proposals and guide the delivery of specific prevention programming," Minister of Municipal and Community Affairs Vince Steen said.

Work on the SAR strategy has been undertaken with the financial support of the federal government through the National Search and Rescue Secretariat (NSS) New Initiatives Fund. The cost-sharing program has been used widely in the NWT to acquire specialized SAR equipment, provide SAR training and develop prevention initiatives to educate residents and raise awareness.

The completed Northwest Territories SAR Prevention Strategy will be presented to communities and territorial SAR authorities and organizations for review.

## Legislation to Help NWT Become Smoke-Free

YELLOWKNIFE (January 22) -- Minister of Health and Social Services J. Michael Miltenberger, says legislation for smoke-free public and work places, and greater control on how tobacco is sold, will bring the NWT one step closer to being smoke-free.

The Department of Health released a discussion paper today in conjunction with National Non-Smoking Week to gauge support for territorial smoking legislation. A Territorial Law To Control Tobacco Use - What Do You Think?, requests public feedback on legislation that would curb high smoking rates and levels of exposure to second hand smoke.

"The time is right to have this dialogue with residents of the NWT," Mr. Miltenberger said. "An increasing number of individuals are choosing to quit, families are making their homes smoke free, community petitions seek to ban smoking in public places and organizations are creating smoke-free environments for their workers and clientele. Legislation would provide a very effective way for government to build on these grass-roots efforts."

Research shows that a ban on smoking in public and work places will significantly reduce exposure to tobacco smoke, lowers tobacco use, encourages smokers to quit, and contributes to savings in the cost of health care. Restrictions on how tobacco is sold and effectively enforcement of a minimum age of purchase reduces access to tobacco products for youth. Both initiatives reinforce the message that smoking is not an acceptable behaviour.


"Moving to a smoke-free society will take a concerted effort by individuals, agencies, the private sector and various levels of government, Mr. Miltenberger noted. "As the Minister responsible for the health portfolio, I am pleased to initiate development of territorial-wide smoking legislation."

## **GNWT - Gwich'in Sign Historic Agreement**

YELLOWKNIFE (January 23) -- The Government of the Northwest Territories has signed a major agreement with the leaders of the Gwich'in Tribal Council that will create new opportunities for the Gwich'in to participate in government contracting in their region.

Under the terms of the Memorandum of Understanding (MOU) signed yesterday, an Aboriginal government will be involved, for the first time, in the GNWT's contracting planning and development process. The agreement will also enable the government to tailor its projects to meet the needs of the local population even more effectively.

"This agreement represents a new way of doing business," Premier Stephen Kakfwi says. "It represents our commitment to work together to ensure an effective and efficient system of government that is accountable to the people it serves. We hope that this agreement will become a model for similar arrangements with other regions."

"We see this MOU as a positive move and a major step forward for the Gwich'in people" President of the Gwich'in Tribal Council Fred Carmichael says. "This MOU clearly shows that Aboriginal Governments are working in partnership with the GNWT in a truly government-to-government fashion. This MOU is a huge step towards achieving our goal of economic self-sufficiency for the Gwich'in people."

The agreement has set a target of awarding fifty percent of the value of government contracts within the settlement area to Gwich'in businesses over the next five years. Both territorial government representatives and Gwich'in leaders say they are confident that this goal can be met. The agreement will become effective on April 1, 2003 and extend to March 31, 2008.

Minister of Resources Wildlife and Economic Development Jim Antoine announced the agreement at a meeting of Gwich'in Chiefs this afternoon in Inuvik.



#### **GNWT Announces Beau-Del Executive Director**

Currently Superintendent of Education, Culture and Employment for the Inuvik Region, Ms. Sullivan has been an employee of the public service since 1987 and a senior manager in the Beaufort-Delta region since 1991.

Ms Sullivan has worked closely with elected community bodies and industry to maximize economic and employment opportunities for all residents of the Beaufort-Delta region and has been instrumental in the development of regional initiatives such as the Regional Training Committee.

Ms. Sullivan's appointment is the result of a joint consultation and hiring process between the GNWT and the Beaufort Delta Interim Regional Council. The position will serve at the Assistant Deputy Minister level within the Department of the Executive, reporting directly to the Secretary to Cabinet.

Ms. Sullivan will assume the duties of her new position on April 1<sup>st</sup> 2003.

#### **Internet Exhibit Modernizes Traditional Trail**

YELLOWKNIFE (January 24) -- The first of three traditional trails to be introduced as internet-based exhibits by the Prince of Wales Northern Heritage Centre was launched today in Edzo.

The *Idaa Trail* is the first module of the interactive website *Lessons from the Land*. It follows the historic Dogrib trail linking the Great Slave and Great Bear Lakes. Visitors to the on-line exhibit can stop at eight different locations along the virtual trail and find historical information and cultural notes such as how to make a birchbark canoe, methods to hunt caribou and stories related to the history of the Dogrib people.

"This modern journey along an ancient path serves to highlight the customs, wisdom and history of the Dogrib people" Minister of Education, Culture and Employment Jake Ootes said. "It helps us to understand how the Dogrib culture is linked to the land, and how modern learning must embrace the lessons of our past."

It is anticipated that the new site will be used to enrich culture and Dogrib-language curriculum in NWT schools. As well as a special section designed for children and students, a teacher's resource guide is available. Lessons from the Land is the result of a five-year collaboration between the Prince of Wales Northern Heritage Centre, the Dogrib nation, elders and members of the Dogrib community. The project was created with the input and support of the Canadian Department of Heritage Museums Assistance Program, Industry Canada, the NWT Literacy Council, Smart Communities, Dogrib Treaty 11 Council and the Dogrib Community Services Board.

Work will now begin on the second of the three-part Lessons from the Land highlighting a traditional trail entitled Journeys of Nuligak to be launched early in 2004.



## **Energy Strategy Discussion Paper Released**

YELLOWKNIFE (January 29) -- Minister of Resources, Wildlife and Economic Development (RWED) Jim Antoine has released a discussion paper outlining energy issues and priorities that will guide consultation on an Energy Strategy for the Northwest Territories.

The paper will be used as the basis for consultations to be held in all NWT communities, and with interested energy stakeholders towards the production of a strategy that will guide progressive NWT energy decision-making into the future.

"Sustainable, affordable and practical ways to reduce the impacts of high-energy costs and greenhouse gas emissions are critical to the economic and social development of the Northwest Territories," Mr. Antoine said.

A solid understanding of the benefits of energy efficiency and the potential for using renewable energy, hydroelectricity, natural gas and conventional fuels are key to the development of an energy strategy that addresses the GNWT's environmental commitments and is acceptable and beneficial for all residents of the NWT.

The discussion paper addresses the following themes:

- Vision, goals and principles for a NWT Energy Strategy;
- Energy efficiency;
- Energy supply options;
- Future of the electricity sector;
- Energy affordability;
- Development of NWT resources; and,
- Environmental challenges.

"We have defined many of the issues, concerns and options which must be addressed in a forward-looking energy plan," Mr. Antoine said. "Now we need the input of industry, business, communities and residents."

## **Emergency Numbers To Be Territory-wide**

YELLOWKNIFE (January 29) — Common territory-wide emergency phone numbers for fire and police will be put into service in the Northwest Territories beginning March 1, 2003.

NWT residents will be able to access emergency services by dialing their community's three - digit exchange plus 1111 for police emergencies or 2222 for fire emergencies. Callers dialing 911 will be instructed to call the appropriate emergency number or the operator.

Minister of Municipal and Community Affairs Vince Steen says common numbers will save time and lives in the event of an emergency. "These emergency numbers will become part of our everyday life here in the Northwest Territories," Mr. Steen said.

The Department of Municipal and Community Affairs has worked with the Department of Public Works and Services, the RCMP and NorthwesTel to bring common emergency numbers to all Northwest Territories communities where emergency numbers exist. Until now, the service has only been available in about half of NWT communities.

The new emergency numbers will be listed in the NorthwestTel 2003/2004 Telephone Directory scheduled for release March 1, 2003.

Emergency Numbers To Be Territory-wide YELLOWKNIFE (January 29)

In September 2001, the Chief Coroner of the Northwest Territories, Percy Kinney, issued a number of safety-related recommendations following an inquest into a death related to a snowmobile accident along the Ingraham Trail. One of the recommendations called for implementation of a 911 service in Yellowknife. The recommendation also called for the service to be expanded across the NWT once the required technological infrastructure was in place.

The City of Yellowknife is reviewing the potential for a 911 service in Yellowknife, but the technological infrastructure is not in place to establish a territory-wide 911 service. The Government of the Northwest Territories, the RCMP and NorthwesTel have identified two alternative measures to improve access to emergency services.

The first measure is the updating the message callers receive when they dial 911. This measure is now in place. The message states there is no 911 service available and advises callers to hang up and dial the common emergency number for their area, or to dial 0 to reach the operator.

The second measure is the implementation of the standard four digit 1111 (police) and 2222 (fire) numbers, preceded by any three-digit exchange or prefix for that area in those locations where these common emergency numbers exist.

#### <u>Premiers Agree on Fair Deal For the Territories – Will The Prime Minister?</u>

OTTAWA (February 3) -- The Premiers of Nunavut, the Northwest Territories and the Yukon and are looking to the federal government to support the creation of an independent fund that recognizes the unique challenges of providing health care services in Canada's North.

Premiers Paul Okalik, Stephen Kakfwi and Dennis Fentie will be in Ottawa Feb. 4-5 for the First Ministers meeting on Health Care with the unanimous backing of their provincial colleagues for a separate, designated fund to support the delivery of basic health care services in Canada's territories.

On February 24<sup>th</sup> in Toronto, Canada's Premiers agreed that a new territorial health care fund should be established to supplement federal transfer payments calculated according to the population of individual provinces and territories.

The new fund would provide an additional .5% of total new health funding per territory to address the challenges of providing health care to small populations scattered over the vast geographical areas of Canada's North.

"Current per capita funding does not take into consideration our small, scattered populations," Nunavut Premier Okalik says. "I appreciate the support of my colleagues in recognizing that this need exists. While the amount is a small part of the national budget, it is significant to the North."

As of 1999, Nunavut's per capita health care expenditures were 3.6 times higher than the national average. TB rates are thirteen times higher than the national average. The infant mortality rate is three times the Canadian average. Travel costs in the territory account for one fifth of the health budget. A medivac (air ambulance) for an infant on an incubator from Iqaluit to Ottawa costs upwards of \$30,000.

"Residents of Canada's North are Canadians just like the citizens of any province," NWT Premier Kakfwi says, "they are no less entitled to the same health services as other Canadians. They expect nothing less than equity and accessibility."



In the Northwest Territories 28 of the 33 communities do not have a doctor. Only two communities provide birthing services. Terminally ill patients and expectant mothers are among the hundreds of patients that must fly thousands of kilometres to receive the services they need. A planned medivac between Inuvik and Yellowknife costs approximately \$10,000.

"The federal government now has the opportunity to demonstrate that it too truly believes in a health care system based on need; a system that recognizes the uniqueness of the North," Yukon Premier Fentie said.

It costs about \$53,000 a year to provide physician services to Old Crow, Yukon for two days a month. The Yukon spends about \$3 million a year, excluding the cost of personnel, to maintain dedicated and standby emergency medical evacuation services. It costs close to \$20,000 for a medivac from Old Crow to Vancouver.

#### Health care deal fails Canadians living in the North

OTTAWA (February 6) – Territorial premiers say they refused to accept a new health care deal with the federal government because it failed to address the pressing circumstances of Canadians in the North.


"We've been working towards finding a solution for our people," Northwest Territories Premier Stephen Kakfwi said. "Two weeks ago in Toronto, all of the premiers agreed to support a Territorial Health Fund to help address the inequality that per capita funding creates in the North. We came to Ottawa with that support and worked incredibly hard to persuade the Prime Minister to do the right thing. What we got instead was an offer for yet another process."

"A process doesn't help to pay the \$30,000 that it costs to fly a pregnant mother from Iqaluit to Ottawa," Nunavut Premier Paul Okalik said. "What occurred today demonstrates the Prime Minister's continued lack of commitment to making a real difference in the appalling state of health care in our territories. Confrontation is not our way, but the Prime Minister gave us no reason to accept his deal."

"We stayed to the end, in good faith, working towards an agreement that was fair to everyone," Yukon Premier Dennis Fentie said. "It is surprising that our Prime Minister, a former Minister of Indian and Northern Affairs, is so insensitive to the unique situation we're facing in the North. The deal being offered was based solely on per capita funding, a formula that everybody knows won't address the significantly higher cost of delivering health care to our people."

What did the territories need to take home?

- A special, dedicated territorial health care fund in addition to new federal health funding, as agreed by all the provincial and territorial premiers in Toronto.
- The fund would equate to .5% of any new federal funds per territory. For example, \$1 billion about \$5 million per territory.

Why were the territories asking for a special fund?

- They have the worst health indicators in the country.
- They have the highest per person health care delivery costs in the country.
- The current per capita funding arrangement fails to meet the basic health needs of Canadians in the North.
- Growing health care deficits.

What did the territories say no to?


Of the \$12 billion offered, the territories would have each taken home \$10.8 million (Nunavut), \$15.6 million (NWT) and \$12 million (Yukon) over three years. To put that into perspective, Nunavut, for example, spends as much on health care in one week as it was offered for the entire year.

## 2003-04 Budget Lays Out Fiscal Challenge

YELLOWKNIFE (February 13) – In his 2003-04 Budget Address to the Legislative Assembly, Finance Minister Joe Handley today laid out the fiscal challenge facing the Government of the Northwest Territories. Despite a growing economy, revenues remain inadequate to meet the needs of NWT residents.

Mr. Handley, however, confirmed his confidence in the NWT economy, and in the need for GNWT investment to continue. He highlighted the achievements of the 14<sup>th</sup> Assembly to date, and called on future governments to build on this foundation.

"Our economy is booming," Mr. Handley noted. "Employment levels are the highest in the country. We are not going to close the window of economic opportunity with a knee jerk reaction to our fiscal situation. We must continue to invest in our future."

Declining revenues, and higher than budgeted expenditures, will lead to a projected operating deficit of \$106 million for the current fiscal year. Revenue forecasts for the 2003-04 budget year, will continue to be below expected spending needs, producing an estimated operating deficit of \$77 million.

"The solution to the GNWT's fiscal challenges lies in careful, well considered actions that do not jeopardize the long-term goals or well being of NWT residents," Mr. Handley stressed.

Today's budget identifies \$70 million in additional spending over last year's budget. Almost \$60 million will address increased costs and new investments in health care, education, housing, justice and community programs. Twenty six million dollars is allocated to meet health care needs alone. Funds will also be made available for small communities to respond to concerns about dust control and to address the needs of youth and other social issues.

Mr. Handley renewed his call on the federal government to recognize its responsibility to participate more fully in the development of the NWT. "Ultimately, our Government's fiscal health depends on federal investment and on equitable resource revenue sharing," he said.

Although capital investments will decline from last year's levels, the Budget contains funding to provide for a range of required infrastructure including needed recreation facilities in a number of small communities.

**2003-04 NWT Budget Lays Out Fiscal Challenge** YELLOWKNIFE (February 13)

The last Budget of the Fourteenth Assembly takes stock of the considerable achievements and investments of the last three years, achievements that will produce positive social and economic returns in the future.

#### **Economic and Fiscal Review**

The NWT economy is expected to level off following the dramatic 19 per cent real growth in 2001. Business investment is expected to decrease following completion of the NWT's second diamond mine. Nevertheless, economic activity and exports will keep the economy growing despite completion of this \$1.3 billion construction project.

The one-time corporate income tax revenues that helped produce a \$120 million operating surplus for 2001-02 will not be repeated in this year. 2002-2003 revenues are forecast to drop to \$774 million, while operating expenses will rise to \$881 million, increasing the \$12 million operating deficit predicted in last year's Budget to a projected \$106 million.

2003-2004 will continue the trend of revenue forecasts below expenditure needs. Revenues of \$854 million are forecast to exceed operating expenditures by \$77 million. Capital investment will decrease \$69 million to \$74 million. However, the year-end cash deficit is forecast to be \$85 million, which will bring total debt to \$214 million, well within the \$300 million limit imposed by the federal government.

Without future large revenue increases, future operating expenditures could result in large operating deficits that cause the GNWT to exceed the borrowing limit.

#### **Taking Stock**

By 2003-04, the GNWT will be investing an additional \$150 million in on-going spending on social programs and \$22 million in on-going economic development initiatives, compared with four years ago. In addition, over \$60 million in highway construction and resurfacing projects has been invested to date as part of the GNWT transportation strategy.

The GNWT faces many of the same fiscal challenges as it faced when the Fourteenth Assembly took office. It also leaves a record of investments that will reduce the fiscal burden faced by future governments.

#### **Building on our Achievements**

The GNWT continues to make investments in its people and to create the environment for better economic opportunities for NWT residents through the following initiatives.

• <u>Social Agenda</u> - The GNWT has responded positively to the recommendations of the Social Agenda working group.

- Healthy Lifestyles The GNWT is introducing the following initiatives to encourage healthy lifestyle choices: increasing the tobacco tax on a carton of cigarettes effective April 1, 2003 by an estimated \$6.80 per carton to discourage smoking; increasing liquor mark-ups 10 per cent to reduce the consumption of alcohol, effective April 1, 2003; and investing \$1.4 million in addressing mental health and addiction needs.
- <u>Health Care</u> \$26 million will be added to the Department of Health and Social Services budget to bring the total budget to \$226 million, including: \$14 million to cope with increased costs; \$8.3 million for the Interim Health Professional Plan announced in December 2002; and almost \$1 million for community demonstration projects.
- Education Almost \$8 million will be added to the Department of Education, Culture and Employment for a total 2003-2004 budget of \$210 million including: \$1.2 million for reducing the pupil-teacher ratio; \$1.9 million for enrolment, new mandatory school programs, and increased utility costs; and \$2.9 million for the Boards to meet increased costs.
- Community Development Funding for community development will be increased to include: \$1 million to pave main streets in non-tax based communities; \$1 million fund for community-sponsored projects to encourage healthy lifestyles, safety and active living; and \$1.7 million in each of the next 3 years in additional grant and contribution funding for specific communities to provide for new housing and renovations to existing housing.
- The Economy Transportation infrastructure is critical for economic development and this Budget continues the investment. \$250,000 is added to the Budget for the Deh Cho Bridge project. \$1 million is budgeted to support the Mackenzie Valley Development project, which includes funding for training, human resource development and building Aboriginal business capacity.
- <u>The Environment</u> \$1 million will be invested in obtaining biophysical baseline data and to support effective environmental monitoring programs. \$300,000 will be made available to undertake energy conservation retrofits.

## **Improved Support for Housing Developers**

YELLOWKNIFE (February 14) – Minister Responsible for the Northwest Territories Housing Corporation (NWTHC) Roger T. Allen has announced changes to the NWT Housing Corporations Loan Guarantee on Interim Financing Program.


The Housing Corporation has reduced the equity requirements for private residential market developers. Developers can now qualify for guarantees on interim financing with only a 15% equity position for new rental units and a 10% equity position for homeownership units. Developers were previously required to contribute 25% equity.

"It is important that the government work with the private sector to address the rising costs of housing," Mr. Allen said. "These changes create a more flexible program and offer improved access to financing for small companies during the construction phase of their projects."

In addition to the more flexible equity requirements the NWT Housing Corporation has also decreased premiums for the Loan Guarantee fee from 1.5% to 0.5%.

"By encouraging and supporting companies to develop additional housing projects, we can work to alleviate the tight Yellowknife housing market and encourage housing development in all NWT communities." Mr. Allan said.

Improved Support for Housing Developers YELLOWKNIFE (February 14)

The NWT Housing Corporation Loan Guarantee on Interim Financing program provides developers with guarantees on interim financing for housing construction projects.

Usually, developers obtain interim financing from financial institutions to finance the construction and sale phase of their project. Banks usually require a 25% equity position by developers, and even at that level, small developers in particular can have difficulty obtaining interim financing.

The NWT Housing Corporation program provides guarantees to banks on behalf of developers in the interest of supporting housing development in the NWT.

The Corporation charges a fee for this service which has also been reduced to .5% of the guarantee. Developers must qualify with the NWT Housing Corporation and the lending institution for the guarantee. Applications are reviewed on a case-by-case basis, examining the specific merits and risks associated with each project.

#### **Legacy of Neglect Continues**

Prime Minister Too Busy to Care about Canada's North

OTTAWA (February 15) -- Prime Minister Jean Chretien has failed to live up to his promise to address the dire health needs of Canadians in the North, say the Premiers of Nunavut, the Northwest Territories and the Yukon said today.

Despite repeated promises, including a statement in the House of Commons, Mr. Chretien has not made any offers to provide additional funding to meet the pressing and critical health care needs of the North, and has not even responded to a request for a meeting.

"We have kept officials in Ottawa for 10 days based on the promise that an agreement would be negotiated and we have not received a single offer or even an invitation to meet," said Northwest Territories Premier Stephen Kakfwi.

"Meanwhile, those in urgent need of health care in the Territories continue to suffer," said Yukon Premier Dennis Fentie. "The legacy of neglect for the North continues."

"The Prime Minister said he agreed this was an urgent issue that had to be addressed, but he has not acted accordingly: He can give speeches in Chicago, but not meet with us at home to discuss the serious difficulties facing Northern Canadians," said Nunavut Premier Paul Okalik.

The Prime Minister has failed to act despite receiving another letter from the provincial premiers unanimously calling for a separated designated health fund for the three territories.

"Despite having a surplus of \$10 billion, the federal government is continuing to deny the people of the North the health care they and all Canadians expect and deserve," said Premier Fentie.

The territorial premiers have postponed a meeting between their health ministers and federal Health Minister Anne McLellan that was scheduled for Feb. 24, requesting that it be rescheduled only when there is an agreement that will address the needs of the North.

The premiers said the federal government is fully aware that past cuts in funding hit the three territories harder than the provinces.

Because of complex funding agreements with Ottawa, the Territories cuts were 3 to 4.5 times deeper than in the provinces.

"For every \$209 the provinces lost, the Northwest Territories and Nunavut lost \$862 and the Yukon lost \$645," said Premier Okalik

"Right now we are diverting funds from other government programs to try to provide basic health care services. Northerners will not have access to the same kind of health care as elsewhere in Canada if we do not receive additional funding," said Premier Fentie

"This is no way to run a country or to live up to the ideal that all Canadians are equal," said Premier Kakfwi.



#### **Territorial Premiers in Ottawa for Budget**

Seek meeting with Prime Minister to Resolve Health Crisis in the North

OTTAWA (February 17) -- Northern premiers have returned to Ottawa on the eve of the tabling of the federal budget in the hopes that Prime Minister Jean Chretien will respond to their requests for a meeting to discuss the health care crisis in the North.

The three Premiers refused to be party to the recently endorsed Health Accord reached at the First Ministers' Meeting in Ottawa on Feb. 5. The funding offered in that deal would not even have covered one week of existing health care costs in the three territories, let alone support the new programs suggested in the Accord.

"This is the most urgent, consuming issue we face in the territories," Northwest Territories Premier Stephen Kakfwi said. "We hope that by being available in Ottawa, the Prime Minister will finally respond to our request for a meeting and we can get the funding issue resolved."

"We are still hoping the Prime Minister meant what he said about wanting to help the people of the North," Nunavut Premier Paul Okalik said. "We are simply asking him to help us ensure that Canadians living in the north have access to the same level of health care as other Canadians."

Premier Dennis Fentie is unable to join his territorial colleagues in Ottawa today because of government duties. He will, however, join them via video and telephone for meetings and media interviews.

"Rest assured I am with my colleagues in spirit. The three territories are united on this issue," Premier Fentie said from Whitehorse. "Without substantive new funding we can't maintain the levels of service we have now, nor even begin to implement the new measures in the Accord."

Because they have received no response to their request for a meeting with the Prime Minister, Premiers Kakfwi and Okalik have returned to Ottawa to emphasize the urgency of their concerns.

As well, there has been no formal offer from the federal government, despite Premiers having left their senior officials in Ottawa since the February 5<sup>th</sup> meeting of First Ministers.

"Sadly, it would seem that the plight of the North has not attracted the attention of the federal government. We are here this week to try to change the government's mind and reverse the legacy of neglect that the North is currently facing," Premier Okalik said.

"We are ready to talk, any time, anywhere, about a meaningful proposal," Premier Kakfwi added.

Examples of the challenges faced by Canadians in the North include:

- In Nunavut, a medivac flight from Iqaluit to Ottawa for a baby in an incubator costs \$30,000. Medivac travel to southern Canada facilities consumes \$28.5 million a year 20% of Nunavut's current health budget
- In the Northwest Territories, only five of its 28 communities have a doctor. Only two communities provide birthing services and expectant mothers have to be flown to these centres two weeks before their due dates, and cared for far away from their families and loved ones.
- In the Yukon, it costs about \$53,000 a year to provide physician services for two days a month to the 280 residents of Old Crow. It costs almost \$20,000 for a medivac from Old Crow to facilities in Vancouver.

## **NWT** to Get Tougher on Impaired Drivers

YELLOWKNIFE (February 17) – Minister of Transportation Joe Handley has introduced tough new legislation to combat impaired driving in the Northwest Territories.

Amendments to the *Motor Vehicles Act*, developed in consultation with various Northwest Territories agencies and interest groups, were presented to the Legislative Assembly for first reading today.

"Our goal is to ensure that NWT streets and highways are safe," Mr. Handley said. "Strong, new penalties and preventative measures are intended to send a forceful message – particularly to those hard-core repeat offenders who insist on defying the law time and time again."

Proposed amendments to the *Act* include giving the Registrar of Motor Vehicles new authority to impose administrative suspensions independent of fines or suspensions imposed as a result of an impaired driving-conviction under the Criminal Code.

While such changes will bring NWT legislation in line with other Canadian jurisdictions, additional features will be unique to the Territory. An automatic, 24-hour suspension is proposed when a driver's blood alcohol content is measured between 0.05% and 0.79% and a 30-day license suspension when a second offence is committed within two years.

NWT legislation will also differ in its emphasis on curbing repeat offences by assessing an offender's driving behaviour and using medical assessments to identify potential problems with respect to substance use.

"This holistic approach to the issue of impaired driving is consistent with this government's interest in the health and well-being of all NWT residents and respects the special circumstances of the North," Mr. Handley said.

NWT to Get Tougher on Impaired Drivers YELLOWKNIFE (February 17)



The Government of the Northwest Territories has introduced amendments to the Motor Vehicles Act to address the problem of drinking and driving in the NWT.

The legislation deals with impaired drivers, repeat offenders, disqualified drivers and new drivers. It gives the Registrar of Motor Vehicles the authority to take administrative action against drivers who drink and drive, separate and apart from any penalties imposed under the Criminal Code. Most importantly, it provides for mandatory medical assessment that can identify conditions that may contribute to drivers operating a vehicle while impaired.

Significant progress has been made in the fight against drinking and driving. In the Northwest Territories, for example, the number of impaired driving convictions declined from 453 to 183 between 1991 and 2000. However, it remains a persistent and unacceptable social problem resulting in the death and injury of thousands of Canadians every year. Impaired driving is the number one cause of criminal death and injury in the country.

In the Northwest Territories, annual traffic injury reports indicate that, on a per capita basis, the severity of drinking and driving is twice that of the rest of Canada.

It should also be noted, that while most of the measures being proposed can be found in other Canadian jurisdictions, the proposed changes to the law in the NWT would give it one of the most comprehensive array of administrative sanctions against drinking and driving in Canada.

The proposed amendments would:

Strengthen roadside suspension provisions. The current Act allows police to suspend a driver's license for 24 hours if they have reasonable grounds to believe a driver is impaired by alcohol, fatigue or other cause. The suspension can be imposed without a breathalyzer test.

Under the proposed amendments, that wouldn't change, but the level of Blood Alcohol Content at which police could suspend a license would be lowered to 0.05 from 0.08 Blood Alcohol Content. If a driver blows over .05 but less than .08, it would trigger an automatic 24-hour suspension.

If it's the second time within two years that a driver has a reading over .05%, the result would be an automatic 30-day suspension.

- Introduce an automatic 90-day administrative suspension for anyone charged with impaired driving for blowing over .08.
- Introduce new administrative driving prohibitions in addition to Criminal Code provisions, including a one-year suspension for the first offence, three-year suspension

for a second offence and five years for the third offence. It will also allow an indefinite suspension of not less than 5 years for subsequent offences or where the offence has caused a death.

- Allow police to impound the vehicle of someone who drives with a suspended license. In the case of a suspension that was caused by an impaired driving conviction, the vehicle is taken away and impounded for 30 days, at the owner's expense. However, the legislation does allow for someone whose vehicle has been impounded to apply to the Registrar to review that and, in exceptional circumstances, release a vehicle.
- Require an offender, before they can get their license reinstated, to purchase an Impaired Driver Assessment Package and complete a self-assessment with respect to drinking and driving, as well as undergo an enhanced driver medical. Based on the view that impaired driving is also a wellness issue, not just one of deterrence, the reason for the assessment is to find out if there are underlying issues of substance use or other conditions that may be connected to why the offence happened.
- Provide for eventual introduction of a graduated license system for new drivers who, evidence clearly shows, are at greater risk of accidents than other drivers. The intent of such a system is to protect those inexperienced drivers and the general public from the mistakes new drivers can make while they acquire the skills and experience to become better drivers. One of the most important features of a graduated license would be a requirement that new drivers never drive after drinking any amount of alcohol.

#### Premiers Announce Progress on Health Care

New \$60-Million Short-Term Funding and Commitment to a Long-Term Solution

OTTAWA (February 20) - The Premiers of the Territories today announced a step forward in addressing the health care crisis in the North. The territories received a floor of \$60 million for a special health fund and a personal commitment from Prime Minister Jean Chrétien to find a more equitable long-term fiscal funding arrangement.

"Two weeks ago we had nothing beyond a small, per capita increase in funding under the CHST," Premier Stephen Kakfwi said. "The three Territories have worked as a team to get this far, and together we will work with the federal government to achieve more equitable treatment."

The Prime Minister also directed his officials to work with the Territories to establish a process that will address the inadequacies in the current per capita based funding formula and the fiscal challenges facing the North.

The commitments came in a meeting with the Prime Minister at 24 Sussex Drive this morning. The new fund will be split equally among the three Territories and used to address immediate health care needs. This fund is in addition to per capita increases announced at the First Ministers' Meeting Feb 5. The precise details of the fund and the process will be finalized by the end of March, the Premiers announced.

The arrangement falls short of the funding the Premiers were seeking, but it represents an important and substantial step forward, Nunavut Premier Paul Okalik said.

"This arrangement represents real money that will provide short-term help to our people and we cannot ignore that," Premier Okalik said. "We have also begun to establish a long-term solution."

Premier Fentie said the Territories will continue to press for a fair and more reasonable deal for Canadians living in the North.

"We have a commitment from the Frime Minister that the federal government will work with us to develop a funding allocation that addresses the inadequacies of per-capita based funding," Premier Fentie said.

## **Appointment - NWT Power Corporation**



## **GNWT/Sirius Settle Dispute over Polar Bear Logo**

YELLOWKNIFE (February 27) - Minister of Resources, Wildlife and Economic Development, Jim Antoine, and the President of Sirius Diamonds Ltd., Stephen Ben-Oliel signed an agreement this week settling a dispute over the use of the polar bear logo on diamonds.

The Agreement clarifies the issues relating to ownership and use of the polar bear trademarks.

"I am pleased that we were able to reach an agreement that will benefit both parties," Mr. Antoine said. "We look forward to working with Sirius Diamonds and other manufacturers to strengthen our secondary diamond industry."

"This settlement is a win-win situation for both Sirius and the GNWT due not only to the conclusion of the trademark dispute but the addition of Sirius to the GNWT Certification and Monitoring Program," Mr. Ben Oliel said. "Sirius is pleased to join the GNWT and the other manufacturers in promoting the secondary diamond industry in the NWT and working with them to present an united front in the face of the Competition Bureau's confusing definition of a Canadian diamond."

The GNWT will continue to be the owner of all official polar bear marks and may license these marks for use on material supporting the Certification and Monitoring Program.

Sirius will be the only diamond manufacturer to hold a licence to laser a four-legged polar bear mark on the girdle of diamonds mined, cut and polished in the NWT and to market and promote POLAR BEAR DIAMONDS<sup>TM</sup> for the next 10 years. The licence may be renewed for additional two-year periods. Sirius will also become part of the GNWT Certification and Monitoring programs.

## **Community Support Key for Pipeline**

CALGARY (March 6) -- Community needs must be given priority if the federal government and oil and gas companies hope to capitalize on resource development in the NWT Premier Kakfwi told delegates to the 3<sup>rd</sup> Annual Arctic Gas Symposium in Calgary today.

NWT residents want more immediate returns from resource revenues already being generated from their jurisdiction. The Premier says he's concerned that without these benefits, community support for resource development will decline.

"If we do not do it right at the community level, we risk undermining all the progress we have made to date," Mr. Kakfwi said.

Kakfwi urged those delegates, with a vested interest in seeing NWT resource development proceed, to lobby the federal government for investment.

"You need certainty and I need your voice," Mr. Kakfwi said. "As much as the petroleum industry needs certainty in order to commit to a pipeline, likewise our communities need certainty that they will have roads, schools, training, healthcare and jobs in place before a pipeline starts."

The Premier noted that the GNWT has kept its word to industry and created the conditions needed for resource development to move forward but he says he's disturbed by the confusion and misunderstanding competing pipeline proposals have generated in communities along the valley.

"All of us, and particularly the federal government, have a responsibility to ensure that the communities most affected by development have priority when it comes to sharing information, decision making, access to benefits and building capacity to manage development," he said.

## **Deh Cho Bridge Act Gets First Reading**

YELLOWKNIFE (March 7) – Minister of Transportation Joseph Handley has introduced the *Deh Cho Bridge Act* giving the government the authority it needs to enter into an agreement to build a bridge across the Mackenzie River at Fort Providence.

The legislation will enable the Minister, with cabinet approval, to commit to the agreement currently under negotiation with the Deh Cho Bridge Corporation, the Fort Providence-based group that wants to build the bridge. It will also permit the GNWT to charge tolls on vehicles that use the bridge.

"This is a necessary preparatory step in the process leading to construction of the bridge," Mr. Handley said. "Its intent is to give government the legal authority required in order to allow a private group to build, operate and maintain what would be an important piece of the NWT's highway system."

The GNWT and the Deh Cho Bridge Corporation are still negotiating the terms of a final agreement. Those negotiations have been going on since the GNWT and the Fort Providence Combined Council Alliance, the community-based organization that preceded the Deh Cho Bridge Corporation, signed a Memorandum of Intent to build the bridge on November 15, 2002.

Under the proposal submitted to government in 2001, the Deh Cho Bridge Corporation would design, build, operate and maintain the bridge for 35 years, after which it would transfer to government ownership. The GNWT will collect tolls and pay them to the bridge developer, along with an amount of money equal to what it costs to operate the existing ferry and ice bridge at Fort Providence.

## **Changes for NWT Workers' Compensation Act**

YELLOWKNIFE (March 12) – Minister Responsible for the Workers' Compensation Board (WCB) Joe Handley today introduced the first in a set of amendments designed to update and revitalize the Northwest Territories workers' compensation system.

Bill 15, amending the *Workers' Compensation Act*, addresses over 70 per cent of recommendations made in 2002 by the WCB's Legislative Review Panel in their report: *Act Now*.

"These are the first comprehensive changes to the Workers' Compensation Act in over 25 years," Mr. Handley noted. "Accountability is key for any system to work effectively. These amendments clearly establish the roles and responsibilities of all players in the WCB system."

Major sections of the Workers' Compensation *Act* have been re-written to make it easier to read and understand.

Proposed amendments will assist in resolving differences in medical opinions regarding treatment plans for injured workers, mandate healthcare providers, injured workers and the WCB to cooperate in the process of a worker's recovery and formally establish the Workers' Advisor office in legislation.

The Workers' Compensation Act legislates the jurisdiction and administration of the Workers' Compensation Board of the Northwest Territories.



## **New Service Charge for Plan Reviews**

YELLOWKNIFE (March 14) – The Government of the Northwest Territories has adopted a user-pay approach for the review of building and construction plans. New service fees will take effect April 1, 2003.

The Office of the Fire Marshal, within the Department of Municipal and Community Affairs (MACA) reviews plans for the construction, alteration or repair of structures, to ensure compliance to the National Building Code (NBC) and to determine that proper precautions are taken against fire and the spread of fire.

The review of these documents is a requirement of the *NWT Fire Prevention Act* and property owners and their agents proposing to construct or alter buildings in the Northwest Territories (NWT) must comply with this requirement.

A fee of \$85.00 per hour, or portion thereof, will now be charged to private and public developers to review plans of all new or renovated facilities in the NWT.

## Kakfwi Enthusiastic about Yukon/NWT Relations

YELLOWKNIFE (March 17) -- Premier Kakfwi says a cooperation accord signed last week between the Yukon and Northwest Territories' governments will pave the way for both jurisdictions to benefit from the construction and operation of a Mackenzie Valley gas pipeline.

The NWT Premier says the signing of the Accord last Thursday launched a new era of NWT – Yukon relations.

"We have major challenges ahead of us which will require collaboration and cooperation," he said.

A formal application to construct a Mackenzie Valley pipeline is expected this fall. Regulatory hearings for a pipeline permit will take a couple of years with construction set to start in about three years.

"Yukoners have already benefited from gas exploration in the Delta. We will ensure they continue to benefit from pipeline construction jobs and business opportunities," the NWT Premier said. "We must now begin the hard work of turning promises into action. There is everything to gain from jointly influencing corporate policy and federal regulatory decisions now."

Premier Kakfwi is also enthusiastic about the increased exploration that a natural gas pipeline will bring to Canada's North.

"Premier Fentie and I both recognize the long term effects a pipeline has for more exploration in the Beaufort Delta, the Mackenzie Valley and north eastern Yukon," he said.

Given that both the Government of Alaska and the US Congress have mandated the Alaska Highway route, the NWT Premier acknowledged that this route will likely come to pass.

"The market for northern gas is huge. Alaska North Slope gas will need to get to market. Any experience Yukoners gain from working on a Mackenzie Valley pipeline will serve them well when the Alaska Highway project comes," Mr. Kakfwi said.

"For now and the foreseeable future, we must take advantage of the Mackenzie Valley project for the benefit of residents in both the Yukon and NWT. By signing the Accord, I said that the GNWT wants to work with the Yukon to do it right," the Premier said.

## **Tobacco Taxes, Liquor Markups to Increase**

YELLOWKNIFE (March 31) -- Increases to Northwest Territories tobacco taxes and liquor markups will take effect tomorrow (April 1, 2003). Minister of Finance Joe Handley announced the increases in his February Budget Address.

Based on price surveys conducted in late February, the tax on cigarettes will increase by \$8.80 per carton of cigarettes and by 3 cents per gram of loose tobacco as required under the *NWT Tobacco Tax Act*.

This figure differs from the amount originally estimated in the Budget because the tobacco tax is set as a percentage of the retail price of cigarettes, which is now higher than originally estimated.

The NWT Liquor Commission will also increase the markup on liquor products by 10 per cent. The higher markups will raise retail liquor prices by approximately 7 per cent for spirits, 3.6 per cent for beer, and 5 per cent for wine.

"We hope that these measures will encourage NWT residents to reconsider and reduce their consumption of tobacco and alcohol," Mr. Handley said.



## Census Coverage Study Still Not Right - Handley

YELLOWKNIFE (March 31) – Minister of Finance Joe Handley says Statistics Canada is still significantly underestimating the 2001 census population of the Northwest Territories.

Statistics Canada released the results of its Census Coverage Study last week. The study, which measures the number of people missed in the original census, estimates an undercoverage rate of 7.25 per cent or nearly 3,000 NWT residents who should have been, but were not, counted in the 2001 census.

This undercoverage rate is the highest for any jurisdiction in Canada. (By comparison, the same rate of error in Ontario would have meant 900,000 missed people.) It confirms the Government of the Northwest Territories' position that the 2001 Census dramatically undercounted the population of the NWT.

However, Statistics Canada's new findings are still significantly lower than those identified by the NWT Bureau of Statistics whose research estimates the net undercoverage in the census at over 10 per cent (approximately 4,100people).

Mr. Handley says that although the census coverage study acknowledges that Statistics Canada undercounted the NWT's population, he's concerned that the new numbers still do not tell the true story. "These figures do not reflect the reality we are seeing in terms of economic activity, housing demand, and other key indicators," he said.

Statistics Canada's numbers are used to calculate funding from the federal government under the Formula Financing Agreement. "The fiscal impact of these numbers, if they stand, could be well over a hundred million dollars," Mr. Handley said.

The results of the coverage study, once finalized, will be incorporated into final population numbers to be released in September 2003. The GNWT, however, has identified a number of problems that it says must be considered before final numbers based on the 2001 census are released. These problems relate to sample design, sample size and survey techniques and raise questions about the quality of the Statistics Canada results.

For example, in the community of Lutselk'e, more than 30 per cent of the dwellings were missed in the 2001 census count. The Statistics Canada undercoverage study used a random sample of only 24 persons in Lutselk'e, many of whom may not have lived in the missed dwellings.

The Bureau of Statistics will be meeting with Statistics Canada to determine how best to incorporate the results of both studies into the final numbers.

#### Northern Premiers Iron out Details of Health Deal with Ottawa

YELLOWKNIFE (April 3, 2003) — Canada's three territorial Premiers have worked out details to a framework health care agreement they reached with the Prime Minister in February. The deal reflects the federal government's recognition that northerners have unique healthcare funding requirements.

The Premier's have worked collaboratively with the Prime Minister to reach an agreement that will increase federal healthcare funding to the territories by an extra \$60 million over the next three years. It will also launch a process for exploring long-term solutions to the inequity of federal per-capita funding agreements.

The \$60 million in funding will be split equally among the three territories and will begin flowing this year. The money will be provided as a grant and is in addition to per capita increases for health care funding announced at the First Ministers' meeting in February 2003.

In February, Premiers Kakfwi, Okalik and Fentie refused to endorse the health accord signed by Canada's First Ministers because it did not recognize the unique challenges of providing health care services in Canada's North. Two weeks later, the Premiers met with the Prime Minister and a tentative agreement was reached to provide immediate new funding and to look at long-term solutions. Today's announcement establishes the terms of the cash grants and formalizes the process for finding solutions to ongoing funding inadequacies. NWT Premier Stephen Kakfwi says he's pleased with the commitment demonstrated by the prime minister's office to address immediate health care needs and to continue discussions on health care financing, but adds the job is far from finished.

"This does not resolve the challenge of providing health care in our remote regions," he noted. "The Prime Minister's continued support will be key to ensuring that the vision, principles and action plan of the First Ministers' Accord on Health Care Renewal apply to all Canadians, including the residents of Canada's North."

Longer-term financing arrangements remain central to discussions with the Prime Minister. A key objective for all three premiers is to find solutions to ensure equitable long-term funding arrangements.



"By standing together Northerners have shown they can reach equitable arrangements with the federal government on our unique concerns," Nunavut Premier Paul Okalik said. I look forward to continuing to work collaboratively with my northern colleagues and the Prime Minister on similar issues."

A meeting is proposed later this spring between federal Health Minister Anne McLellan and her territorial counterparts.

"This meeting will help us continue our work with the federal government to further address the unique health care challenges of the three territories," Yukon Premier Dennis Fentie said. "I look forward to building on the good will that has been established so far."

## **Award Recognizes Reduced Highway Fatalities**

YELLOWKNIFE (April 10) – The American Association of Motor Vehicle Administrators (AAMVA) has awarded the Northwest Territories with an international safety award for its efforts to reduce highway fatalities.

The NWT experienced the greatest percentage decrease in traffic fatalities among Canadian jurisdictions in 2000 with only one fatality on NWT highways that year - a 75 per cent reduction from the four deaths in 1999.

The AAMVA represents state, provincial and territorial officials in the U.S. and Canada who administer and enforce motor vehicle laws. Director, Road Licensing and Safety for the Department of Transportation Gary Walsh accepted the award as its NWT member.

Minister of Transportation Joe Handley says the award recognizes an overall positive trend in the number of highway accidents and fatalities in the Northwest Territories. He says government will continue to improve the NWT highway system and implement other measures designed to improve safety.

"Ultimately, safe highways are produced by safe driving behaviour," Mr. Handley noted.

While NWT highways have become safer, Mr. Handley acknowledges more work needs to be done. In recent months, the GNWT has taken action in a number of specific areas including upgrading highways and introducing tougher laws to combat impaired driving.

## **Aviation Bursaries Available for NWT Students**

YELLOWKNIFE (April 10) – A total of \$40,000 in bursaries will be awarded this year to Northwest Territories students pursuing careers in the aviation industry.

Students have until May 31, 2003 to apply for one of the \$5,000 bursaries to be awarded for the upcoming academic year through the Aviation Career Development Program. The program, now in its third year, is co-sponsored by the Department of Transportation and Canadian North with support from the Northern Air Transport Association (NATA) - the umbrella organization for northern air carriers.

## **NWT Post-Secondary Indicators Report Released**

YELLOWKNIFE (April 15) -- A statistical report profiling the Northwest Territories' adult and post-secondary education system indicates a dramatic rise in the number of Aboriginal students from the NWT enrolled in adult and post-secondary programs.

The biannual Post-Secondary Indicators 2001 Report, released by the Department of Education, Culture and Employment, shows a 67 per cent increase in Aboriginal students attending Aurora College and receiving Student Financial Assistance during the ten-year period from 1991-2001. Over the same ten-year period, the number of Aboriginal students attending college or technical and trades schools outside of the NWT was also up by 59 per cent.

"A sound basic education is essential for personal well-being and participation in our rapidly evolving global society," Minister of Education Culture and Employment Jake Ootes says. "We have reason to be pleased with the quality of our programs and the success of our efforts to provide access to post-secondary education."

The 2001 report includes 19 new indicators to assist in tracking NWT postsecondary students. These include data on employment outcomes and earnings of Aurora College graduates; information on students by age groups and more detailed reporting on students enrolled in academic preparation programs at Aurora College.

Based on Student Financial Assistance data from 2001, females comprised 63 per cent of post-secondary students attending Aurora College, 60 per cent of NWT students at Canadian or international colleges and institutes and 59 per cent of NWT students attending universities in Canada.

### Territories gain support of provinces on housing funding

Winnipeg, MB (April 16, 2003) – Territorial housing ministers have gained valuable support from their provincial counterparts for their efforts to change the way federal funding for housing is calculated.

The support came at a meeting in Winnipeg of federal, provincial and territorial ministers responsible for housing. They discussed strategies to increase affordable housing and to renovate existing housing stocks across Canada.

The ministers said new federal funding for housing should consider specific provincial and territorial needs. At present, funding is calculated on a per-person basis.

Calculating funding on a per-person basis unfairly penalizes jurisdictions with small populations, such as the three territories. Moreover, per-capita funding does not take into account the higher cost of living in remote areas.

"Investigating changes to the current funding model will ensure better treatment for smaller jurisdictions, particularly in Yukon, Northwest Territories and Nunavut," said Kelvin Ng, Nunavut's Minister Responsible for Housing.

"Our provincial counterparts recognize the need to find better ways to fund housing projects in jurisdictions that have smaller populations," said Roger Allen, NWT Minister Responsible for Housing. "Fair and equitable funding solutions are critical to help territorial governments add to our housing stock."

Ministers emphasized that addressing future housing will require a high level of flexibility in the implementation of initiatives. Included in this flexibility should be a recognition of the unique challenges facing remote and northern territories.



## Stanton Hospital Board to be Re-established

YELLOWKNIFE (April 25) – Minister of Health and Social Services J. Michael Miltenberger has announced plans to re-establish a Board of Management for the Stanton Territorial Health Authority.

The nine-member Board will reflect the Authority's territorial mandate. It will include one member from each of the six regional Authorities and the Sahtu where an Authority is currently being developed.

The Board will also include a second member from Yellowknife and an additional member from the Authority or community represented by the Board's Chair to permit the Chair to assume full leadership duties.

## **Conditional Support for De Beers Snap Lake**

YELLOWKNIFE (April 28) -- The Government of the Northwest Territories (GNWT) says comprehensive socio-economic and environmental agreements are needed if the proposed De Beers Snap Lake diamond project is to proceed as planned.

Speaking at public hearings convened by the Mackenzie Valley Environmental Impact Review Board to assess the environmental impact of the project, Acting Deputy Minister of the Department of Resources, Wildlife and Economic Development Doug Doan said that the Snap Lake mine has the potential to make a significant contribution to the economy of the Northwest Territories. However, additional measures must be taken, including socio-economic and environmental agreements, to ensure that the project is both economically and environmentally sustainable.

"Our responsibility in evaluating any proposed development is to ensure that the public interest is served," Mr. Doan said. "We support this project, provided that its socio-economic benefits are shared fairly with all the residents of the NWT, and that sufficient provisions are made to protect the environment for future generations."

While the De Beers proposal satisfies many of the GNWT's concerns, there are still aspects of the plan that must be improved. They include hiring targets for NWT residents, the use of hydroelectricity on-site and the assessment of the project's impact on wildlife management.

"We look forward to working closely with De Beers to conclude agreements that ensure these concerns are addressed satisfactorily," Mr. Doan said.

## **New Inuvik Hospital Starts Move-In**

YELLOWKNIFE (April 28) – Phase I construction of the new Inuvik Regional Hospital is now complete and the Inuvik Regional Health and Social Services Authority is now carrying out its carefully planned transfer of programs and services from the old facility into the new one.

Of paramount importance to the Authority is the continuity of high quality care to patients and long-term care residents during this transition period.

The new hospital, which is seven per cent larger than its predecessor, will continue to offer the same range of acute, birthing and long-term care services. Its design will accommodate future expansion if required.

"This capital project is by far the most ambitious undertaken by the GNWT since Division," says Minister of Health and Social Services J. Michael Miltenberger. "I am pleased to report that we have completed this project on schedule. Residents and health professionals of the Inuvik region can take pride in this new state-of-the-art hospital."

The new hospital has special significance for all of the Northwest Territories because it is the first hospital built since the full transfer of health responsibilities from the federal government in 1988.

The Department of Health and Social Services, assisted by the Inuvik Regional Health and Social Services Authority and the Department of Public Works and Services, completed the design and construction of the new facility with 4801 NWT Ltd., a joint venture group made up of the Uummarmiut Development Corporation and the Nihtat Gwich'in Development Corporation.

Phase II of the project will include the demolition of the old hospital and landscaping of the new site. This is expected to be completed by the fall of 2003.

Inuvik's original hospital was built in 1957-58. Its replacement was made necessary by an aging foundation and its design reflecting outdated service delivery methods.

An official grand opening for the new hospital is planned for this summer.

## **GNWT/Immigration Canada to Support Northern Diamond Industry**



## Alberta, N.W.T. advance co-operation and development

Edmonton... Alberta and the Northwest Territories have agreed to a five-year extension of a Memorandum of Understanding (MOU) for co-operation and development.

The announcement to advance the agreement until October 2008 followed an Edmonton meeting with Alberta Aboriginal Affairs and Northern Development Minister Pearl Calahasen and Northwest Territories Minister of Public Works and Services Vince Steen, who also serves as N.W.T. Minister of Municipal and Community Affairs.

"The approval of the extension is an indication of the importance both governments place on this *Memorandum of Understanding*," said Calahasen. Steen agreed and stated, "We are very good neighbours that share many socioeconomic connections."

Both ministers cited examples of progress since their December 2002 meeting in Yellowknife. "We have been able to move forward on a number of tourism-related initiatives, especially in conjunction with the Deh Cho Travel Connection, which will enhance the tourism experience for visitors to Alberta, the N.W.T. and northeastern B.C," said Calahasen. Steen added, "Since our last meeting, which called for action in the transportation area, a number of significant issues have been addressed, including the development of a joint transportation action plan."

Also participating in the meeting were Northwest Territories Minister of Education, Culture and Employment Jake Ootes and Chair of the Northern Alberta Development Council, Gary Friedel, who is the MLA for Peace River.

"Work undertaken on the development of a strategy related to research and innovation has significant potential and is of tremendous importance," said Ootes. "By working together on research initiatives, Alberta and the Northwest Territories will be able to better identify initiatives that will assist in advancing northern development. As well, we have made substantial progress on increased co-operation and education."

Friedel noted that transportation was again given top priority at the interprovincial gathering. "Maintaining and enhancing our mutual air, rail and road transportation systems is paramount," he said. "Specifically, emphasis was placed on the importance of the Mackenzie Highway and the Mackenzie Northern Railway, essential connectors to our suppliers and to our markets."

The Alberta-Northwest Territories *Memorandum of Understanding* to promote co-operation and development between Alberta and the Northwest Territories was signed in 1998. The next *MOU* meeting is scheduled for this fall in Yellowknife.





## **Specialist Negotiations End Without Contracts**

YELLOWKNIFE (June 3) — Minister of Health and Social Services J. Michael Miltenberger announced today that negotiations with physician specialists, as a group, have ended with specialists declining the offer by the Government of the Northwest Territories to resolve differences through binding arbitration.

The GNWT has offered specialists a 27 per cent pay increase over two years. Specialists are asking for 57 per cent pay increase over two years. The GNWT proposed arbitration because it felt that the difference separating the two parties is too great and would not be resolved through the negotiation process before July 1<sup>st</sup>, 2003.

In March, twelve specialists from the Stanton Territorial Health Authority served notice to the GNWT that on July 1, 2003, they would: terminate their contracts of employment and cease to provide any medical services unless a negotiated settlement is reached.

Binding arbitration would have required both parties to accept the recommendation of an independent arbitrator.

"It became apparent, during the final round of negotiations, that each party believed their proposal was fair, reasonable and competitive," Mr. Miltenberger said. "An independent arbitrator could have assessed the proposals and identified what they considered to be fair, reasonable and competitive. We were prepared to accept that independent assessment."

The Minister said he's extremely disappointed that negotiations were unsuccessful. He says the GNWT proposal included a comprehensive package of pay and benefits that offered specialists, as salaried employees, a means to ensure a better balance of professional and family/personal interests.

As is its standard procedure, when there is a vacancy in the health profession, the Stanton Territorial Health Authority will take the necessary steps to ensure NWT residents continue to have access to specialist services, with a priority on cases requiring urgent care.

Physician Specialists in the Northwest Territories sign individual employment contracts. "We value our specialist workforce and the services they provide," Mr. Miltenberger said. "The process of bargaining with the specialists as a group has been unsuccessful. It is now up to each specialist to decide whether or not they wish to stay in the Northwest Territories and address their individual employment situation with the government."

While direct comparisons are difficult, the NWT specialist physician employment model is competitive to other jurisdiction's physician employment models. Most specialist physicians in Canada are employed through a fee-for-service model where, in order to generate income, physicians must see a large number of patients and perform a significant number of procedures. Fee-for-service physicians are independent business providers, who must pay clinic overhead, staff salaries and benefits, capital costs, insurances and other O&M requirements. A fee-for-service physician loses income when they take time for vacation or continuing medical education as they self-fund their leave. In the NWT specialist employment model, all of the above are provided to the specialist in a salary and benefit package that includes clinic space.

#### **Specialist Services and Coverage at Stanton**

Note: The information presented in this section is subject to change. The following information is based on the best estimate of specialist resources that will be available as of July 1, 2003.

In the event of vacancies in physician specialist positions, it will be necessary to reduce patient services within the hospital and clinics until arrangements are made for locum coverage and recruitment of permanent specialists. The level of service available will increase as staff contract locums or recruit specialists.

#### 1. Medical Clinic and Medical Centre

The Medical Centre and Medical Clinic will be closed for regular specialist appointments in program areas that do not have regular physician specialists or locum coverage. With locum coverage the first priority will be provision of emergency services. The locum physician workload will determine if regular clinic visits can be maintained. Full services at both clinics will be intermittent through July and August.

All physician specialists have long term patients that require regular follow up. The clinic nursing staff and the Medical Director will be coordinating services to ensure that patients requiring regular follow up are seen by the appropriate practitioner in Yellowknife or (in some cases) the Capital Health Authority in Edmonton.

#### 2. Anesthesia

<u>Resources</u>: One physician specialist and four general practitioners with anesthesia skills will provide anesthesia services.

Services: Anesthesia services will be available as required.

#### 3. Ear, Nose and Throat (ENT)

Resources: To date locum services have not been arranged.

<u>Services</u>: Clinic appointments and operating room services will not be available. Emergency cases will be transferred to Edmonton.

#### 4. General Surgery

Resources: Locum services have been arranged for July and August.

<u>Services</u>: Clinic consults will depend on availability of resources and the workload of the locum physician. Initially elective surgery will be cancelled. Emergency surgeries will be performed.

#### 5. Internal Medicine

<u>Resources</u>: Two physician specialist-internists are available. One internist is the Medical Director who will assist with coordinating services.

<u>Services</u>: Initially regular clinic services will be limited. Endoscopic services will continue but may be slightly reduced. The Intensive Care Unit (ICU) will remain open. Chemotherapy and dialysis will continue.

#### 6. Obstetrics/Gynecology

<u>Resources</u>: Locums have been arranged for July and early August. Search for a second locum is underway.

<u>Services</u>: Clinic consults and operating room procedures will depend on the number of locums and workload. Emergency Caesareans and other emergencies will be the priority. If guaranteed emergency coverage for obstetrics is not available, physicians will make appropriate patient care arrangements. The availability of pediatricians directly impacts on the level of obstetrical services that can be offered.

#### 7. Ophthalmology Clinic

<u>Resources</u>: To date locum services have not been arranged. Ophthalmology technicians will be available.

<u>Services</u>: Ophthalmology technicians services require ophthalmologist support in order to continue regular services. There is a possibility of ophthalmologist support via telephone. Emergency services will require transfer to Edmonton. The level of ophthalmology services remains unknown at this time.

#### 8. Orthopedics

Resources: To date locum services have not been arranged.

Services: At this time regular clinic appointments and operating room services will not be available. Emergency cases will be transferred to Edmonton.

#### 9. Pediatrics

Resources: To date locum services have not been arranged.

<u>Services</u>: Clinic appointments and inpatient services will not be available unless we are able to obtain locum physicians. Emergency cases will be transferred to Edmonton. Some high-risk pregnancies may need to be transferred to Edmonton.

#### 10. Psychiatry

Resources: One general practitioner with additional training in psychiatry is available.

<u>Services</u>: Psychiatrist clinic appoints will not be available. The general physician-psychiatry will be available for some consultation and limited emergency services. Patients with severe mental distress will be sent to Edmonton.

#### 11. Radiology

Resources: To date services have not been arranged.

<u>Services</u>: Procedures requiring radiologist services will only be available if we have a radiologist on site. The technologists will provide routine services. General practitioners will provide the initial interpretation for their patients. All films will be sent south for second interpretation by a radiologist.

## **Premier Says Investment Will Pay Off**

YELLOWKNIFE (June 4) -- Premier Stephen Kakfwi says current and projected economic activity in the Northwest Territories will soon make the NWT a net contributor to Canada contributing more than it receives.

In his Sessional statement to Members of the Legislative Assembly, the Premier called upon his colleagues to look beyond its short-term fiscal challenges and maintain a commitment to investment.

"We have consistently addressed our fiscal situation positively and with confidence; and always with the fundamental belief that investment now - in our territory and its residents, will pay dividends in the future," Mr. Kakfwi said.

The Premier told the Legislative Assembly that the Northwest Territories has outgrown its funding agreement with Ottawa.

"There is growing recognition in Ottawa that changes are needed to the Northwest Territories formula financing agreement and per capita funding arrangements are inadequate," he said.

The Premier urged members to remain focused, united and committed to the agenda identified almost four years ago.

"By the end of this summer, I believe the results and successes of our collective commitment will be clearer," the Premier said.

## **Annual Report Shows Improved Air Quality**

YELLOWKNIFE (June 4) – Minister of Resources Wildlife and Economic Development Jim Antoine marked Canada Clean Air Day today by releasing the 2001-2002 Annual Report on the state of air quality in the Northwest Territories.

The report, summarizing information collected on air quality since 1989, shows a continued improvement in air quality in Yellowknife with sulphur dioxide and arsenic concentrations at or close to background levels and dust readings the lowest in 10 years.

In Fort Liard, sulphur dioxide and hydrogen sulphide monitoring indicate no measurable effects in the community from natural gas exploration and development in the area.

While this is good news the Minister says it is critical that NWT residents remain vigilant. "All of us, as individuals and members of our communities, must make choices that help to create a cleaner and safer world for our families, future generations and ourselves," he said.

Thanks to new partnerships with the Government of Canada and municipalities, the Northwest Territories has been able to establish a network of 'state of the art' air quality monitoring stations. The Government of the Northwest Territories has recently upgraded existing air quality monitoring stations in Yellowknife and Fort Laird and opened new stations in both Norman Wells and Inuvik.



## **Family Violence Protection Act Introduced**

YELLOWKNIFE (June 10) – Minister of Justice Roger Allen today introduced Bill 21 - the Family Violence Protection Act. When passed, the Act will provide new protections for people who are threatened with, or are victims of, family violence.

"This Act provides for 24 hour access to emergency protection orders when there is a threat, or situation of family violence," Mr. Allen said. "It provides victims of family violence with long-term protection through protection orders."

An emergency protection order can include a number of provisions, including granting sole use of a home or other property, restricting communication between the people involved, and the seizure of weapons or firearms by the police. Protection orders may include the same protections as an emergency order. They can also include financial compensation or require counseling.

Protections under the proposed Act will be available to anyone in a family or intimate relationship who have lived together. A spouse or former spouse, someone who has had a child with the accused, or the parent or grandparent of any of these people may also apply.

"By including parents and grandparents, we are helping to address some of the concerns of elder abuse raised by community organizations and members of this Legislative Assembly," Mr. Allen noted.

The Minister today recognized the support of Members of the Legislative Assembly and the Coalition Against Family Violence for the draft legislation. "These new protections provide yet another tool aimed at eliminating family violence," he said. "We must continue to work together to develop other solutions to address this problem."

#### **Key Terms**

Respondent - is the person who committed, or is accused of committing, an act of family violence. Applicant - is the person who is a victim of, or threatened with, family violence or someone applying on their behalf

#### Who can apply for protection under the FVPA?

The following people can apply for protection under the Act

- a spouse or former spouse
- anyone who has or is living with someone in a family or intimate relationship (i.e. a parent, grandparent, sibling, child, or boy/girlfriend who have lived together)
- anyone who has had a child with the respondent
- a parent or a grandparent of any of the above people

#### What is family violence?

Family violence occurs when someone through their action or inaction causes any of the following to happen to another person in a family or intimate relationship:

- hurts or damages a person or property
- causes someone to fear for their safety
- causes someone to fear for the safety of a child in their care
- causes a child in their care to fear for his or her safety
- sexual abuse of a person or child in their care
- psychological, emotional or financial abuse that causes harm or fear of harm to someone or a child in their care

#### What protections are available under the FVPA?

Emergency Protection Orders can be issued 24 hours a day from a justice of the peace who is satisfied that family violence has taken place or there is an immediate danger of family violence.

An emergency protection order may:

- remove the respondent from the home
- give the applicant sole use of the home and/or other property
- not allow communication between the people involved
- require the seizure of weapons or firearms by the police

All emergency protection orders are reviewed by the Supreme Court, who may agree with the order, or hold a hearing where they can agree with, change, or revoke the order.

**Protection Orders** are available on application to the Supreme Court. They may be ordered when the Court is satisfied that family violence has occurred. A protection order may contain similar provisions as an emergency protection order. It can also include financial compensation and counselling orders.

A Warrant of Entry is available 24 hours a day and may be issued by a Justice of the Peace who is satisfied someone who may be a victim of family violence can not be reached and is likely in the place to be entered. This gives someone the right to enter and search the place named in the warrant, help the person who may have a victim of family violence, and remove anything that may be evidence of family violence.

#### How will someone apply for an order?

It is proposed that someone could apply for an order by contacting the RCMP or through a 1-800 number, 24 hours a day. A Justice of Peace would hear the evidence and could issue an order.

#### What if someone does not follow an order?

The FVPA makes it illegal to not follow an order. If convicted of breaking an order, preventing someone from performing part of an order, or publishing information not allowed under the Act, a person could face a fine up to \$5000 and six months in jail.

#### Can someone change a protection or emergency protection order?


After an order has been made, the applicant or respondent can apply to the Supreme Court to change or revoke the order.

#### When will the Act come into effect?

The FVPA will come into effect on a day to be fixed by the Commissioner of the Northwest Territories. It will take time to implement the legislation, including planning, training and putting in place new resources to support the Act. A public education campaign will take place before the bill comes into effect.

## **New Youth Justice Legislation Introduced**

YELLOWKNIFE (June 10) – The Youth Justice Act, introduced today by Minister of Justice Roger Allen, will change how youth who commit territorial offences are dealt with.

The Youth Justice Act, which will replace the current Young Offenders Act, will apply to youth between 12 and 17 years of age accused of committing offences set out in territorial legislation like the Motor Vehicles or Liquor Acts, or in municipal bylaws.

"The Youth Justice Act is based on Canada's Youth Criminal Justice Act," the Minister noted. "The same principles of crime prevention, rehabilitation, and meaningful consequences are included in our bill."

The proposed Act will require police to consider alternative measures before charging a youth. These measures could include appearing before a community justice committee, meeting with an elder, warnings, cautions, referrals or formal sanctions.

The Act also provides for 'conferences' that can be called by police or the Court. Community and family members, teachers and others can be called to a conference to provide input on how to deal with a youth accused of a territorial offence.

"The Department of Justice has supported the use of alternative measures and community justice initiatives for many years," Mr. Allen said. "This Act will support the RCMP in considering all possible alternatives to Court when dealing with youth."

The Youth Justice Act also sets out the sentence a youth justice court may impose when a youth is convicted of a territorial offence. If passed, custody sentences will not exceed six months.



## Waste Recovery and Reduction Act Introduced

YELLOWKNIFE (June 12) – New legislation, introduced this week by Minister of Resources, Wildlife and Economic Development Jim Antoine, will pave the way for the recovery, reuse and recycling of materials throughout the Northwest Territories.

The proposed Waste Reduction and Recovery Act, developed in consultation with industry, environmental organizations and the public will, through the development of regulations, allow the Government of the Northwest Territories to establish programs to recover, recycle and reuse waste materials in NWT communities. When passed, it will also allow the GNWT to designate materials for recovery, collect deposits and provide refunds on materials such as beverage containers.

"This Bill reflects our commitment to the environment and the wise use of our resources," Mr. Antoine said. "Our goal is to reduce the impact of these wastes on the northern environment, greenhouse gas emissions and the costs of handling garbage while increasing the lifespan of community landfill sites."

The new legislation will allow for the establishment of an Environment Fund to finance recovery, reuse and recycling programs in NWT communities and for the enforcement of recovery programs.

"This legislation is designed to be flexible enough to allow recovery of different kinds of materials over time," Mr. Antoine noted. "Research and experience in other parts of Canada show more jobs can be associated with recovery programs than with putting garbage in landfills."

## **Minister Questions Written Consent for NIHB**

YELLOWKNIFE (June 12) — Minister of Health and Social Services, J. Michael Miltenberger has joined Nunavut Health Minister Ed Picco in voicing concerns over the federal government's requirement to have signed consent from First Nations and Inuit people accessing the Non-Insured Health Benefits (NIHB) program.

"It is clear that First Nations and Inuit people are concerned about how this consent form will be used," Mr. Miltenberger said.

In September 2002, Health Canada began requesting written consent from clients accessing the NIHB program in order to meet federal privacy requirements.

Mr. Miltenberger says Health Canada has not responded to questions about how this new requirement will impact the GNWT's administration of the program.

"There has not been adequate consultation with the GNWT on this new requirement," he said. Mr. Miltenberger will raise his concerns with federal Minister of Health, Anne McLellan at her next meeting with Canada's three territorial health ministers. He says he wants a resolution to the issue well in advance of the proposed September 2003 implementation date.

"Our first priority is to ensure all NWT residents, including those eligible for NIHB benefits, have access to the services they require. It is not an option for us to decline services to residents because of a unilateral decision made by the Federal Government on how the NIHB program will be run."

## **Changes to Medical Travel Reduce Burden**

YELLOWKNIFE (June 13) – Minister of Health and Social Services, J. Michael Miltenberger, today announced interim changes to the medical travel policy to reduce travel costs for NWT patients without third party insurance coverage.

The following changes take effect immediately:

The medical travel co-payment will not be collected for a patient requiring medical travel if the patient's family income is less than \$80,000 per year;

A patient with a family income of less than \$80,000 per year will be provided the same benefits for accommodation and meals as currently offered for indigent patients; and

A patient with a family income of more than \$80,000 per year will receive an accommodation allowance of \$50 per day and meal allowance of \$18 per day.

"These interim measures will reduce the financial burden on NWT families when a family member must travel to receive medical treatment," Mr. Miltenberger said.


The changes will remain in place until a broader review of all supplementary health benefits is completed.

"These improvements respond to some of the gaps identified in the Medical Travel Policy by this government and concerned residents," the Minister noted. "They reflect the northern reality that residents may be required to travel in order to access medical care."

## Mineral Processing Technicians – Canadian First

Yellowknife (June 16) –Thirteen Northwest Territories residents have become the first in Canada to be certified as Mineral Processing Technicians with specializations in either gold or diamond minerals.

Minister of Education, Culture and Employment, Jake Ootes introduced the new designated occupations: Mineral Processing Technician – Gold Specialization, and Mineral Processing Technician – Diamond Specialization along with the thirteen inaugural recipients of the certification at a ceremony this weekend in Yellowknife.

The Government of the Northwest Territories, along with key industry partners, has recognized the need to develop standards recognizing the expertise required for these important mining positions.

"These individuals are highly skilled but have traditionally received no formal recognition for their knowledge, skills and abilities," the Minister noted. "We realized the need to change that."

The Department of Education, Culture and Employment worked with BHP Billiton Diamonds Inc, Diavik Diamond Mines, Kinross Gold (formerly Echo Bay Mines), Miramar Con Mine, De Beers Canada and Aurora College to identify and develop occupational standards for these new mining occupations.

Occupational standards are just one tool that industry can use to assess the skills and expertise of individuals on the job. An occupational standard outlines the necessary knowledge, skills and attitudes a person requires to perform competently in a given occupation. Certification in a designated occupation indicates that an individual has attained an established level of competency as determined by industry.

The addition of these two new designated occupations brings the total of NWT certified occupations to fourteen. They include other precedent setting certifications developed in the NWT like Diamond Polisher, Crossworker and Diamond Polisher, Brillianteer.

## Minister Wants BSE Compensation to be Flexible

YELLOWKNIFE (June 16) - Minister of Resources, Wildlife and Economic Development Jim Antoine is urging the federal government to ensure compensation for producers affected by the BSE outbreak in Western Canada is flexible enough to meet the needs of all businesses impacted.

Speaking at the emergency meeting of federal, provincial and territorial Ministers of Agriculture in Vancouver on Friday, Mr. Antoine noted that many businesses and producers beyond cattle producers are being impacted by the BSE outbreak.

"Northern producers of caribou and musk-ox meat products for export markets as well as outfitters are feeling the effect of the ban on meat products destined for the United States," he said.

The Minister commended the Government of Canada and the Canadian Food Inspection Agency on their handling of the BSE outbreak. "While we support the proposals to provide financial compensation to western producers, we want to ensure it is flexible," he said.

He brought a similar message from the Nunavut Minister of Sustainable Development Olayuk Akesuk.

"We want to assure northern businesses that their concerns are being considered equally with those of western producers," Mr. Antoine said.

## **GNWT Applauds Aboriginal Pipeline Deal**

YELLOWKNIFE (June 18) -- Minister of Resources, Wildlife and Economic Development Jim Antoine says today's announcement by the Mackenzie Delta Producer Group that agreements have been reached with the Aboriginal Pipeline Group (APG) and TransCanada Pipeline Company (TCPL) marks the official beginning of the Mackenzie Valley natural gas pipeline project.

The Minister commended Trans-Canada pipelines and producers for reaching the funding agreements that will allow the APG and Aboriginal people to become full participants in the proposed Mackenzie Valley natural gas pipeline.

"These historic commercial agreements signal a new era of partnership, co-operation and mutual respect that will help to ensure the project's success." Mr. Antoine said.

A Preliminary Information Package on the proposed pipeline route and development of proven Mackenzie Delta gas fields is being submitted to the boards, committees and agencies responsible for assessing and regulating energy developments in the NWT.

In preparation for this announcement, the GNWT facilitated and strongly supported the development of the June 2002 Cooperation Plan by the regulatory authorities establishing a coordinated review process for the proposed pipeline.

"The filing of the PIP initiates this coordinated regulatory process," Mr. Antoine said. "This will be good for Canada."

Over the next 20 years, resource development in the Northwest Territories, including gas development and diamond mining, will contribute \$65 billion to the national GDP, create 270,000 person years of employment across Canada and generate \$17 billion in royalties and tax revenues nation wide.

"With today's announcement, it is critical that we continue to make important progress towards the completion of a fair resource revenue sharing and devolution agreement," Mr. Antoine said. "Having control over our resources, and a share of resource revenues will ensure that we can be a strong self-reliant Territory."



## **BSE Compensation Fair Says RWED Minister**

YELLOWKNIFE (June 19) - Minister of Resources Wildlife and Economic Development (RWED) Jim Antoine says the financial program aimed at reducing some of the economic impacts arising from the outbreak of BSE in the cattle industry is fair.

The Minister worked with his federal, provincial and territorial colleagues to develop the program, which will provide immediate, short-term relief to those directly affected by the BSE outbreak.

"The number one priority has been, and continues to be, the re-opening of borders," Mr. Antoine said. "This program will meet the most immediate and pressing need. I will continue to work with my federal, provincial and territorial colleagues to monitor and respond to developments as they emerge."

Officials from RWED have surveyed various sectors in the Northwest Territories to determine if there is any cause for immediate concerns.

Outfitters in the NWT have received protocols that they are to follow to ensure their clients do not run into problems at the Canada/United States border. While, the Canadian Tourism Commission has provided the protocols, NWT Arctic Tourism is distributing updates to its membership including outfitters.

"It is essential that we get the message out that these protocols are in place and that we are open for business," Mr. Antoine said. "We will continue to provide updated information to outfitters so that they are current with custom requirements. It is critical that our industry follow these protocols."

There has been no disruption in the commercial export of musk-ox meat because harvests only occur in the winter months. However, new procedures may have to be established once the ban on the export of meat into the US is lifted.

## **Small Claims Limit Raised to \$10,000**

YELLOWKNIFE (July 2) – The Government of the Northwest Territories has increased the dollar amount for civil claims that can be heard by the Territorial Court from \$5,000 to \$10,000.

Minister of Justice Roger Allen says increasing the limit will allow more people to resolve their disputes in the Territorial Court. "The procedures there are more informal, faster and cheaper than in other Courts, and although lawyers sometimes appear, people most often represent themselves," he noted.

The types of small claims most frequently heard by this court include the failure to repay loans, pay for work done or to pay for merchandise bought on credit. Claims can also be made in Territorial Court for damages incurred in the breaking of a contract.

The Territorial Court operates across the Northwest Territories and hears small claims in all communities that it visits. NWT residents living in communities that are not on the Territorial Court circuit can have their case heard in the closest community where it does visit.

To start a small claim action, NWT residents must contact the Court Registry in Yellowknife, Hay River or Inuvik. Forms are available upon request and come with a complete instruction guide on how to initiate a claim.

Before beginning a small claim, however, people are encouraged to resolve the dispute themselves.

"The Territorial Court should be considered a last resort after having tried to resolve their dispute on their own," Mr. Allen said.

## Kakfwi to Seek Premiers' Support for New Deal

YELLOWKNIFE (July 3) – Ensuring a fair deal for the Northwest Territories as Canada reaps huge benefits from development of the NWT's vast gas and diamond resources will be on the table at next week's Annual Premiers Conference in Charlottetown, Premier Stephen Kakfwi said today.

It is one of a number of initiatives being put forward by Canada's provincial and territorial leaders in an attempt to reverse deteriorating relations with the federal Government and renew and strengthen the Canadian federation.

The NWT is set to increase its production of rough diamonds – already \$1 billion a year. Meanwhile, the development of the rich Mackenzie Delta gas fields took a major step last month with a historic partnership agreement between the Aboriginal Pipeline Group, TransCanada Pipelines Ltd, and the Mackenzie Delta Producer Group.

These developments will contribute \$89 billion to the Canadian economy, provide governments with \$31 billion in revenues and create 384,000 jobs - the majority of which will go outside of the NWT. (See attached backgrounder for detailed breakdown of benefits.)

However, under the existing funding arrangements with Ottawa, the NWT has no control over the development of these resources, receives no resource royalties and sees the majority of tax revenues generated by economic growth clawed back from its federal funding.

"A system that denies a jurisdiction any control over its resources and leaves behind less than 4% of the revenues those resources generate is clearly unfair," Mr. Kakfwi said.

"It is also a barrier to our sustainable growth and the ability of the NWT to achieve its potential of becoming a proud, self-reliant and net-contributing partner in Canada. That clearly is not in the national interest."

Mr. Kakfwi has written to Canada's premiers asking them to use next week's annual conference to endorse a statement by the Western Premiers calling on the federal Government to devolve control over northern resources to northern governments, together with a share of resource revenues.

Premier Kakfwi will also ask next week's conference to endorse an initiative launched by the Western Premiers to develop a national diamonds strategy.

The NWT Premier is scheduled to visit Quebec on Sunday to discuss issues of mutual interest with Premier Jean Charest in advance of next week's Annual Premiers Conference.



## **Manufacturers Approved to Buy Rough Diamonds**

YELLOWKNIFE (July 7) – The Government of the Northwest Territories has approved four NWT-based manufacturers as potential buyers of rough diamonds from Rio Tinto Diamonds, the sales agent for Diavik Diamond Mines Incorporated, 60 per cent owners of the Diavik Diamond Mine.

The four manufacturers are: Sirius Diamonds Ltd, Canada Dene Diamonds, Arslanian Cutting Works and Tiffany & Co. They will also require the approval of Rio Tinto Diamonds and are currently in discussions with that company.

Minister of Resources Wildlife and Economic Development Jim Antoine says the GNWT's approval is another significant step in the development of the secondary diamond industry in the NWT and Canada.

"Enabling these manufacturers to have additional supplies of rough diamonds will mean more employment and business growth in the NWT," Mr. Antoine noted.

The NWT has two operating diamond mines, Ekati ™ Diamond Mine, and Diavik. By the end of this year, the two mines will produce 12 per cent of the world's rough diamonds by value.

## National Plan Needed to Reap Gemstone Bonanza

YELLOWKNIFE (July 7) – Premier Stephen Kakfwi says Canada's political leaders must move quickly if the country is to turn the Northwest Territories' booming diamond mining industry into even more lucrative, job-generating national industries.

"Canada is now one of the world's top diggers of diamonds," the Northwest Territories Premier notes, "now we must also become one of its foremost providers of finished diamond products."

Premier Kakfwi will urge his counterparts at the Annual Premiers' Conference in Charlottetown to work together to create a national strategy aimed at ensuring the development of secondary diamond industries in Canada - including those in diamond cutting and polishing, jewelry design and manufacturing and retail sectors.

The Northwest Territories has two operating diamond mines. By the end of this year, they will make Canada the world's third largest producer of rough diamonds, with a value of \$1 billion. Once these diamonds are cut, polished, turned into jewelry, their value will increase to \$7.2 billion.

"But 99 per cent of rough diamonds are leaving the country and the value-added work is being done elsewhere," Mr. Kakfwi says.

In addition to those in the NWT, advanced diamond mine projects exist in Nunavut, Saskatchewan and Ontario. Significant projects are also underway in Alberta, and Quebec and there are exciting prospects in Manitoba and possibilities in the Yukon. Diamond cutting and polishing facilities exist in the NWT, British Columbia and Quebec, and there are significant jewelry centers in Vancouver, Calgary, Toronto and Montreal.

"This is a truly national opportunity," Mr. Kakfwi, says, "if we are to seize it, the time to plan and act is now."

At their annual meeting last month in Kelowna, western Premiers initiated a process to create a national diamond strategy. Premier Kakfwi has since written to all of Canada's premiers asking them to endorse and advance the initiative this week in Charlottetown. On Sunday, he met privately with Quebec Premier Jean Charest to discuss the diamond file and other areas of mutual interest.

On Wednesday, Prince Edward Island Premier Pat Binns has invited his colleagues to join him and Premier Kakfwi at a cutting and polishing demonstration of NWT rough diamonds at Norton's in downtown Charlottetown.

#### Q: Why do we need a national strategy on diamonds?

There is ongoing diamond exploration across Canada. Advanced projects are located in Nunavut, Saskatchewan and Ontario. Significant exploration projects can be found in Alberta and Quebec, with encouraging discoveries in Manitoba and possibilities in the Yukon

As mining projects across Canada are developed, we need to increase our participation in this multi-billion dollar sector. But this will not happen without planning and cooperation. Currently, there is no coordinated national strategy to ensure that benefits and opportunities from the diamond industry are realized for Canadians.

A national strategy is essential if we are to create a strong, competitive value-added diamond industry in Canada and become known for finished diamonds and jewelry, and not simply as diggers of rough diamonds.

#### Q. Why is the NWT so anxious to see a national diamond strategy?

The NWT's two operating mines will produce \$1 billion worth of rough diamonds this year, making Canada the third largest producer of rough diamonds, ahead of South Africa and behind only behind Botswana and Russia.

The \$1 billion worth of rough diamonds we will produce this year will be worth \$7.2 billion when cut, polished, designed, manufactured as jewellery and retailed.

Canada currently participates in less than 1 per cent of the downstream opportunities flowing from our diamond mines. We must now plan to benefit from the extraction of our natural resources by developing value-added industries such as cutting and polishing, and design, manufacture and retail sectors.

A strong Canadian industry will be good for the NWT industry – and the NWT is happy to share the experience it has gained over the last decade to help create one.

#### Q. Has the NWT taken any steps of its own?

Most definitely, a Canadian approach to the diamond industry will require the development of standards to ensure Canadians are properly trained and their training is recognized. The NWT has developed a pre-employment course, the first of its kind in Canada that is now attracting students from all over the world.

Together with industry, the Government of the Northwest Territories has also developed occupational standards and certification for a variety of diamond positions including Sawing, Bruting, Crossworking, Brillianteering and Fancy Cut Specialist. This represents another "world

first" for Canada's diamond industry and the Northwest territories is prepared to share these standards and programs with the rest of Canada.

#### Q: What would a national strategy deal with?

There are a number of issues that need to be addressed in a national diamond strategy. These include: training, security, labour force needs, immigration of skilled labour, marketing of Canadian diamonds, developing a value added industry and competition issues.

#### Q: Is there a problem with the current tax laws?

Yes, the sole remaining luxury tax in Canada is on jewellery and includes everything from watches and tiepins to large jewellery pieces. It does not apply to luxury cars, yachts etc. This 10% hidden is not harmonized with GST, so tourists and visitors cannot get a rebate for it. This means Canadian diamond products are less expensive in United States than in Canada, making it even more difficult to build viable industries such as jewellery making and retail.

## Q: What is wrong with simply mining rough diamond and shipping them out? Isn't there a lot of money to be made from royalties?

There is money to be made (though the NWT is not currently entitled to royalties), but simply being a provider of natural resources, will not allow Canadians to develop value-added industries and will limit our ability to be a key player in the world diamond industry.

Canada be involved in the entire diamond pipeline. We will see more money and jobs for all Canadians if we look beyond just being a supplier of rough diamonds to all the other opportunities that come with this industry.

#### O: How much money is the existing diamond industry in the NWT worth to Canada?

In 2001, the Ekati Diamond Mine contributed \$510 million to the GDP. In 2002, the mine contributed \$640 million. Over the life of three mines (Ekati, Diavik and De Beers Snap Lake), contribution to the GDP is expected to be more than \$25 billion.

#### Q: What is the potential value for secondary industries in Canada.

The scale of value added of the diamond pipeline is very significant. For example, \$1 billion revenue in diamond mining would translate to \$1.74 billion in cutting and polishing and \$7.2 billion in retail and diamond jewelry manufacturing.

## Q: Is it feasible to create secondary diamond industries in Canada? What about the cost? Can we compete with countries with low wages, such as India? What about finding the necessary manpower and training?

Is it feasible to create secondary diamond industries in Canada but we need to start now because it takes time to develop workforce, expertise, technology, etc. We have done this with other resource industries and have never let competition stop us before.

YELLOWKNIFE (July 9) -- Arslanian Cutting Works (NWT) Ltd. cut and polished a Northwest Territories diamond in Prince Edward Island today - the first time that a Canadian diamond has been crafted in PEI.

NWT Premier Stephen Kakfwi and PEI Premier Pat Binns hosted the live display of diamond crafting at Norton's Jewelers in Charlottetown to coincide with the Annual Premiers Conference that begins today.

Premier Kakfwi says today's event reflects the tremendous potential of Canada's emerging diamond industry. "It is an industry that extends well beyond simply mining rough stones in the Northwest Territories," he said. "It encompasses cutting polishing, designing and crafting jewelry.

NWT cutter/polisher Chad Snider prepared and finished the featured 0.3-karat Canada™ diamond. He received hands-on assistance from Saskatchewan Premier Lorne Calvert, Yukon Premier Dennis Fentie as well as Premiers Kakfwi and Binns.

The stone, along with a certificate authenticating its unique production process, will be auctioned Thursday with proceeds benefiting the Anderson House Women's Shelter in Charlottetown.

Premier Kakfwi is asking Canada's Premiers to support the development of a national diamond strategy to ensure that Canadians benefit fully from the economic returns and opportunities presented by the NWT's emerging diamond industry.

## **Community Expertise Recognized**

## Community Leaders in Languages Announced

YELLOWKNIFE (July 14) – Minister of Education, Culture and Employment, Jake Ootes today announced the winners of the 2002-2003 Community Language Leader Awards.

The awards were created as a means to publicly recognize the work of individuals who are committed to the survival of the NWT's official languages. Minister Ootes notes, "These awards acknowledge people's tireless devotion to developing and implementing language resources, programs, and to preserving and promoting languages."

This year's award winners were chosen by language communities at a local level, as those who most embodied the principles of supporting and preserving our languages.

The ten 2002-2003 award winners are:

Mary Heron for her work in Chipewyan. Mary serves on the Regional Chipewyan Language Advisory Committee and provides the Chipewyan language community with a needed link with the community elders.

Louis Beaver for his work in Cree. A fluent Cree speaker who grew up on the land, Louis is an active member of the Cree language program. He helped a great deal in the production of the Bush Cree Dictionary and Medical Terminology.

Rosa Mantla for her work in Dogrib. Rosa's family is traditional Dogrib people who know the value of the Dogrib language. She is a teacher and currently a principal at the Elizabeth Mackenzie Elementary School in Rae-Edzo. For many years, Rosa has developed materials for students, teachers and community people in the Dogrib language.

Neil Colin for his work in Gwich'in. Neil uses the Gwich'in language on a daily basis, within his home and in the public community. He speaks Gwich'in on the street when he meets people, on the local radio station, on the bush radio when speaking with others who live on the land, within the school when speaking with the students. He constantly reminds the community of the importance of learning and speaking Gwich'in.

Edna Elias for her work in Inuinnaqtun. Fluent in the Inuinnaqtun dialect, Edna uses her skills interpreting for the community. Her skills are a big part of the communities' ability to communicate from English to Inuinnaqtun.

Leonard Harry for his work in Inuvialuktun. Harry does translation work for corporations and the Innuvialuit Communications Society and he attends all culture-based activities in the community.

Maurice Mendo for his work in North Slavey. Maurice is always quick to respond to working with the North Slavey Language Coordinator. He helps by offering his knowledge of the North Slavey culture and history to the coordinators', which in turn helps with their interpreting and translation work.

Andy Norwegian for his work with South Slavey. Andy has researched and studied the syntax and prose of the language of the Deh Cho. He teaches classes in the South Slavey language and was involved in the creation of the Slavey dictionary.

And, finally, Lilly Borges Oldham (posthumously), who promoted the French language in the community, Yellowknife schools and provincially. Some of her accomplishments were: organizing the French Pre-Immersion Program; developing Camp de Neiges (annual language winter camp); writing articles for various French magazines and media publications; developing Core and Immersion pamphlets for distribution; and facilitating the birth of École Alain St.-Cyr, the first francophone school in the Northwest Territories.

Ms. Lilly Oldham passed away on August 26, 2002, in Yellowknife. The Lilly Borges Oldham Memorial Second-Language Scholarship Fund has been set up in Lilly's memory. The fund will help students entering post-secondary studies in a second language.

NORMAN WELLS (July 28, 2003) The burn out operation completed July 25 on the wildfire northwest of Norman Wells was successful. Crews are making good progress mopping up and securing the fuel break near the town. The fire continues to burn away from the town. Current size of the fire is about 15,000 hectares.

A burnout operation is planned for a wildfire burning 22 kilometres east of Norman Wells. This will prevent the fire from coming towards town from the southwest corner. Timing of the burnout will depend on conditions. It is tentatively scheduled for this afternoon. This fire is current about 1,100 hectares.

Both fires were started by lightning on July 21.

Conditions remain extreme in the Sahtu region. People are advised to avoid lighting any fires.



## **Current Wildfire Situation in the Sahtu Region**

**Norman Wells -** The burn out operation completed July 25 on the wildfire northwest of Norman Wells was successful. Crews are making good progress mopping up and securing the fuel break near the town. The fire continues to burn away from the town. Current size of the fire is about 15,000 hectares.

A burnout operation is planned for a wildfire burning 22 kilometres east of Norman Wells. This will prevent the fire from coming towards town from the southwest corner. Timing of the burnout will depend on conditions. It is tentatively scheduled for this afternoon. This fire is current about 1,100 hectares.

Both fires were started by lightning on July 21.

## **RWED Urges Comprehensive Reclamation Planning for CanTung**

Fort Simpson (July 29, 2003) — The Department of RWED is recommending that the Mackenzie Valley Land and Water Board take meaningful steps to ensure a thorough and effective abandonment and reclamation effort at the CanTung mine site.

Speaking at the public hearings convened by the Board to determine the future of the mine site, RWED officials strongly recommended that the CanTung mine's existing Water License be renewed for a period of two years — accepting the owner's (NATCL.) estimate of the projected life of the mine, based on proven ore reserves as the most accurate assessment available at this time.

"We believe a two-year time period is both logical and fair," said Doug Doan, Assistant Deputy Minister of the Department of RWED. "We also believe that a two-year renewal will afford NATCL ample time to conduct extensive exploration for new ore deposits."

In addition, RWED recommended that the Board establish a reclamation planning committee. The proposed committee would be responsible for:

- o providing advice to the Board on the abandonment of the reclamation site, including alternate uses of the site;
- o ensuring that the abandonment and restoration is carried out in a manner that engages all stakeholders; and
- o overseeing the monitoring of the abandonment and reclamation activities conducted on the site.

RWED also recommended that the Board establish a security deposit equal to the total outstanding reclamation liability. This is consistent with the Mine Site Reclamation Policy of the Department of Indian Affairs and Northern Development, which placed the cost of reclamation on the developer, so that costs are not passed onto the government and the taxpayer.



Mr. Doan also noted that, to date the residents of the Northwest Territories have received very limited benefits from the operation of the CanTung Mine. He strongly recommended that the Board seek ways to ensure economic opportunities for NWT residents to participate in the abandonment and reclamation phase of the mine's operations.

Meat from hunter-harvested animals can gain immediate entry into the U.S. under permit.

# **Revised Business Incentive Policy Released**

YELLOWKNIFE (August 15) – Minister of Resources, Wildlife and Economic Development (RWED) Jim Antoine today released the Government of the Northwest Territories' revised Business Incentive Policy (BIP).

The improved policy clarifies the definition of a BIP business to emphasize its contribution to the NWT economy and to ensure bona fide northern businesses benefit from the policy. It establishes a formal complaint mechanism to address contract administration issues and sets new thresholds for the application of BIP bid adjustments in favour of northern businesses.

"The NWT economy has changed dramatically since the original BIP was established 11 years ago," Mr. Antoine noted. "The revised BIP is designed to support an NWT economy in which non-renewable resource development and its spin-offs are driving growth more than government spending once did."

The BIP applies to any procurement contracts, other than employment, entered into by Government of the Northwest Territories departments and applicable agencies.

"There is still a need for a policy to encourage and support the development of a healthy private sector, particularly in our smaller communities, to ensure that Northwest Territories businesses can be competitive," the Minister said.

The revised policy will be effective on October 15, 2003. Registered BIP businesses will receive information kits on the revised policy with their renewal notices.

Revised Business Incentive Policy Released YELLOWKNIFE (August 15)



### What is the Business Incentive Policy?

The Business Incentive Policy (BIP) is an economic policy of the Government of the Northwest Territories (GNWT) that applies to any procurement contract entered into directly by the GNWT, with the exception of employment contracts.

The BIP requires GNWT contract authorities to apply BIP bid adjustments to bids of approved NWT and local businesses during the bid evaluation process. Pursuant to the BIP, a Registry of approved NWT businesses is maintained by the Department of Resources, Wildlife and Economic Development (RWED).

### Why was the BIP revised?

The present BIP has been in place since 1992. During the past 11 years, concerns and criticism have been raised that the BIP does not meet key needs of the NWT business community such as access to government contracts or provide fair and consistent contract administration.

The NWT economy has changed dramatically since 1992. Today, non-renewable resource development and its spin-offs are driving growth more than government spending once did. Capital expenditures by the GNWT have significantly declined over the past 11 years in response to increased fiscal pressures and increased demand for government services.

The NWT business community has grown in number and strength since 1992 and has benefited from recent non-renewable resource development activities. There are currently 1,422 registered BIP businesses employing 7,673 NWT residents.

The revised Policy is based on the comprehensive consultation done with the public and the business community across the NWT during the winter of 2001/2002 and the spring and fall of 2002.

#### What were the key issues and design considerations in shaping the revised BIP?

Major issues included accountability and transparency; policy definition of a northern business and monitoring and enforcement.

### What are the six major changes in the revised BIP?

The six major changes include:

- scope of the policy;
- clarification of definitions applying to the BIP;
- the definition of a BIP Business;

- strengthened administrative procedures;
- a formal complaint mechanism; and,
- new thresholds for the application of the BIP bid adjustments.

### Why was a new definition for a BIP business required?

The NWT business community has raised concerns about the old definition not recognizing the contribution of business to the NWT economy. The revised Policy ensures this is taken into account. The BIP now applies to businesses that pay corporate, property and payroll taxes in the NWT. It encourages employment creation by locating businesses in the NWT, which provides a greater benefit to the economy rather than residency of owners.

The new definition was developed in cooperation with the NWT Chamber of Commerce, the NWT Construction Association and the Northern Manufacturers' Association.

#### What is the new definition for a BIP business?

To be eligible for registration under the revised Policy, a BIP Business must:

- maintain legal registration in the NWT;
- maintain a current business license issued by a municipal corporation or the GNWT, where applicable;
- operate from an owned or leased bona fide place of business in the NWT and has done so prior to the date of application;
- comply with the *Payroll Tax Act (NWT)* and not have any overdue returns or liabilities under that Act;
- in the case of a corporation, files, or undertakes to file, a Federal Corporate Income Tax Return that allocates taxable income to the Northwest Territories, or would allocate taxable income to the Northwest Territories if the corporation had taxable income;
- in the case of a co-operative association, files, or undertakes to file, a Federal Corporate Income Tax Return that allocates taxable income to the Northwest Territories, or would allocate taxable income to the Northwest Territories if the co-operative had taxable income;
- in the case of a partnership, the majority interest in the partnership is owned by NWT Residents:
- in the case of a sole proprietorship, the sole proprietor is an NWT Resident.

### Why are thresholds being introduced?

During consultations, the NWT business community expressed the need for a dollar value cap on the application of BIP bid adjustments. The caps recognize that NWT businesses maintain an inventory of goods for small amounts but would likely have large orders delivered from the south providing little value added to the NWT. The majority of GNWT contracts fall within the range of the bid adjustment thresholds. The thresholds are also consistent with those contained in the Agreement on Internal Trade (AIT). The BIP Review recognized that larger NWT businesses have become more competitive with increased capacity to undertake a wide range of contracts.

### What are the new thresholds for the application of the BIP bid adjustments?

#### Credit Cards and Sole Source Contracts

No Bid Adjustment will be applied to credit card purchases or sole source contracts.

#### **Goods Contracts**

For Goods Contracts, excluding credit card purchases or sole source contracts, a 15 percent Bid Adjustment will be applied to the NWT Content. An additional 5 percent Bid Adjustment will be applied to any Local Content.

For Goods Contracts in excess of \$25,000, the Bid Adjustment will be applied to no more than \$25,000 of the bid amount.

### Service Contracts

For Service Contracts, excluding credit card purchases or sole source contracts, a 15 percent Bid Adjustment will be applied to the NWT Content. An additional 5 percent Bid Adjustment will be applied to any Local Content.

For Service Contracts in excess of \$100,000, the Bid Adjustment will be applied to no more than \$100,000 of the bid amount.

### **Construction Contracts**

For Construction Contracts, excluding credit card purchases or sole source contracts, a 15 percent Bid Adjustment will be applied to the NWT Content. An additional 5 percent Bid Adjustment will be applied to any Local Content.

For Construction Contracts in excess of \$1,000,000, the bid Adjustment will be applied to no more than \$1,000,000 of the bid amount.

### What does the new complaint system do for the government and business community?

There was no formal complaint system in the previous policy. Concerns about application procedures and compliance were raised during the public consultation. The new system addresses those concerns. It also provides clear direction about who will address these issues.

#### How does the new formal complaint mechanism work?

Applicants that have been denied registration by a BIP Qualification Committee may appeal in writing to the BIP Senior Management Committee.

# **Minister Announces Judicial Changes**

Chief Judge Halifax was appointed to the Territorial Court (formerly Magistrate's Court) in 1977. He became Chief Judge in 1989. His current term expires on September 1, 2003.

"I want to thank Chief Judge Halifax for his twenty-six years of dedicated service in the Courts, and specifically for his service as Chief Judge," the Minister said.

Judge R. Michel Bourassa has been appointed as Chief Judge of the Territorial Court, effective September 2, 2003.

Judge Bourassa has more than twenty years experience as a member of the Territorial Court. He was appointed as a Judge in 1982. His appointment as Chief Judge is for a five-year term, ending September 1, 2008.

"I have full confidence that the effective administration of the Territorial Court will continue under Judge Bourassa," Mr. Allen said.

The Territorial court hears criminal cases and civil matters, including family matters, child protection and small claims. Additional responsibilities of the Chief Judge include the assignment of judges for Territorial Court hearings and supervision of Justices of the Peace.

Judge Brian Bruser is the third member of the Territorial Court.

# **Draft Water Management Strategy Released**

YELLOWKNIFE (August 28) – The Government of the Northwest Territories today released its draft framework and strategy for the management of drinking water in the NWT.

Titled, *Managing Drinking Water in the Northwest Territories*, the report calls for a three-way approach to protecting drinking water in the NWT: keeping NWT water supplies clean, ensuring water is safe to drink and providing proof that drinking water is safe.

The document provides a framework to guide GNWT departments and other agencies involved in the co-operative effort to ensure clean drinking water. The work is shared between four GNWT departments: Health and Social Services, Municipal and Community Affairs, Public Works and Services, and Resources, Wildlife and Economic Development.

"Shared responsibility for safe drinking water ensures that back-up processes are in place," Minister of Public Works and Services Vince Steen says. "This multi-agency approach provides the necessary checks and balances to safe-guard our system."

Minister of Health and Social Services J. Michael Miltenberger says safe and healthy water supplies are a priority for all NWT communities. "The water we consume is critical to our wellbeing," he noted.

Draft Water Management Strategy Released YELLOWKNIFE (August 28)

### Why are we implementing a Safe Drinking Water Strategy?

Safe drinking water has always been an issue, but the incidents in Walkerton, Ontario and North Battleford, Saskatchewan have really brought the issue to the front lines. It has emphasized the importance of each step involved in providing safe drinking water and encouraged governments to critically examine their water supply systems to ensure that history doesn't repeat itself. It has been determined that one of the most effective methods to ensuring safe drinking water is through a management approach that includes multiple barriers. Since the Walkerton disaster, the majority of Canadian provinces have adopted a multi-barrier approach to drinking water management. Multiple barriers provide multiple layers of protection in case one barrier fails. Implementing a Safe Drinking Water Strategy in the NWT will help to ensure that this type of tragedy doesn't happen here.

#### What is the purpose of this document?

The purpose of this document is to propose a safe drinking water framework and strategy for the NWT. The framework and strategy describe the existing and new activities that form the NWT drinking water system. The framework will act as a guide for GNWT departments involved in this cooperative effort to ensure that NWT drinking water is safe.

### What consultation is taking place? Why aren't we holding public consultation?

The framework and strategy is undergoing stakeholder consultation. Specific organizations have been targeted for the consultation process. Although there are no public meetings scheduled, if a request for community meeting is made, a meeting will be held.

### Where can I get a copy of the framework?

The framework and strategy can be viewed on the PW&S, H&SS, MACA, or the RWED website. (<a href="http://www.pws.gov.nt.ca/WaterAndSanitation/Index.htm">http://www.pws.gov.nt.ca/WaterAndSanitation/Index.htm</a>) If you do not have access to the Internet and you would like a paper copy please contact your Regional MACA or PW&S superintendent. Comments are invited until September 30<sup>th</sup>, 2003.

### Are we the only jurisdiction doing this?

No. Most other Canadian provinces, including British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Nova Scotia, Newfoundland and Prince Edward Island have already adopted a drinking water management strategy. The Northwest Territories is the first of Canada's Northern territories to adopt a drinking water management framework and strategy. Although the strategies may differ between provinces/territory to best suit the individual needs of each province/territory they are all based on similar principles and share the same common goal of protecting public health.

### What drinking water are we talking about?

The framework and strategy is concerned with the public municipal water supply. Bottled water and private drinking water systems are not included.

#### Why treat drinking water?

Generally the NWT community water supply sources are abundant and less threatened by the types of contaminants found in more populated southern Canada. However, most raw water worldwide contains some contaminants, which are often colourless, odourless and tasteless. Other contaminants can make water look bad and some make it unsafe to drink. For example, wildlife that carry contaminants such as E.coli, 'crypto' and giardia are abundant in the NWT. Therefore, source water treatment is necessary to eliminate these and other contaminants from the drinking water supply to ensure the water is safe for human consumption.

### Who tests drinking water?

Community governments are responsible for operating the water treatment plants and providing a safe water supply. This includes submitting routine water samples to the laboratory for bacteriological and chemical analysis according to direction given by the Environmental Health Officer. In communities where the GNWT is the designated operator of the water treatment facility, it becomes the responsibility of the department of PWS to submit routine samples. The Environmental Health Officer, as the regulatory authority, ensures routine water sampling is carried out and conducts additional compliance testing as required.

### Is there something wrong with our water? Why are we doing this?

No, the NWT has some of the best source water quality in the world. This initiative will help to strengthen the preventative/proactive approach that is currently in place to keep NWT drinking water clean and safe.

#### Why are there boil water orders?

A boil water order is an advisory to the public that they should bring their water to a rolling boil for one minute (or more, depending on the nature of the problem), before use in drinking, making infant formula, juice or ice cubes, washing fruit or vegetables, or dental hygiene. Boiling the water ensures that any disease causing organisms are destroyed.

Boil water advisories are most frequently issued because the disinfection treatment step has been compromised for some reason such as high turbidity levels, unacceptable bacteriological quality, or inconsistent testing procedures.

#### What are THMs?

Trihalomethanes are part of a group of disinfection byproducts that are formed when chlorine reacts with naturally occurring organic and inorganic matter. Chlorine is a disinfectant added to drinking water to reduce or eliminate microorganisms, such as bacteria and viruses, which can be present in water supplies. Improvements in treatment methods have meant that less chlorine is

added to drinking water and therefore levels of THMs are also reduced. THM levels in the NWT are generally well below the national guideline value of 100 parts per billion.

### How and when do I clean my water tank?

The department of Health and Social Services has developed instructions for cleaning and disinfecting your water tank. These instructions can be viewed online at: http://www.hlthss.gov.nt.ca/content/Publications/Brochures/PDF/env health/clean water.pdf

Advice on how to clean your water tank can also be obtained from your local Environmental Health Officer.

# Will water plant operators require certification? Are they currently certified? How many are certified?

Operator certification is voluntary in the NWT. Most communities try to ensure that their operators are certified. The NWT government is currently working towards increased operator certification. Five operator certification courses are being offered this fiscal year.

### Who is responsible for drinking water? Isn't water a federal responsibility?

Everyone plays a role in ensuring drinking water is safe. Local community governments hold primary responsibility for managing and operating water treatment and distribution systems safely, and for testing drinking water quality to ensure it is safe. The Department of Health & Social Services is responsible for enforcing the NWT Public Health Act and ensuring water quality meets the Guidelines for Canadian Drinking Water Quality (GCDWQ). Municipal & Community Affairs and Public Works & Services work with community governments to ensure the required infrastructure is in place and is properly maintained and operated. Federal, territorial and municipal governments work with the regional Water Boards and local residents to protect raw water quality. Everyone helps out by letting the appropriate authority know if they have a concern and by keeping their own water tanks clean.

#### What about protecting the watershed?

The regional Water Boards and the Federal Departments of Indian and Northern Affairs, Environment Canada and Fisheries and Oceans have primary responsibility for managing water resources and maintaining the high quality of our raw water supplies. RWED works with these departments and monitors contaminant spills.

H&SS can also take steps to protect the watershed if they feel that drinking water quality is threatened in any way. Community governments, industry and every resident can help by making sure their activities don't pollute lakes or rivers.

#### What is the role of the community?

Communities are the first line of defence in ensuring safe drinking water. Communities that operate and maintain their own systems are directly responsible for managing all aspects of the systems, including safety and public education. The treatment plant operators are responsible for operating and maintaining the systems, and for keeping up their certification. Operators are

responsible for sampling and testing for bacteriological and chemical quality, and recording and reporting water quality results.

### What is the role of the Water Boards?

The role of the Water Boards is to work in conjunction with the communities to ensure that a water license is in place and/or that their current water license is up to date. A number of different agencies are responsible for making decisions that affect drinking water sources. The Water Boards are one of the agencies involved in this coordinated watershed decision making process.

### Where is the funding coming from?

Many of the initiatives described in the framework are already underway and GNWT funding has already been assigned. Any new initiatives will go through the regular GNWT planning process for funding approval.

### What are we going to do with all of this feedback?

Once public input is received, the safe drinking water framework and strategy proposed in this document will be revised accordingly, submitted for approval, and set into motion.

#### What is the deadline for feedback?

Feedback on the draft framework and strategy will be accepted until September 12th, 2003

#### How do I get involved?

# Minister Hopes Impact of Con Mine Closure can be Minimized

YELLOWKNIFE (August 28) -- Minister of Resources, Wildlife and Economic Development Jim Antoine says the announced closure of underground operations at the Con gold mine in Yellowknife comes as difficult news for residents of Yellowknife and the Northwest Territories.

"The city of Yellowknife owes its establishment to the Con and Giant mines," Mr. Antoine said. "Together with their families, the men and women employed by these mines are the foundation and a sustaining force of our community."

Miramar Mining Corporation, the owner of Yellowknife's Con mine, announced yesterday that it will terminate underground mining operations at Con on November 30, 2003 due to ongoing operating losses. Giant Yellowknife mine, also owned by Miramar, will continue to mine ore for processing through the Con Mine's milling facilities.

Mr. Antoine says senior government officials are being asked to review and assess the economic effects that the closure of Con Mine will have on Yellowknife and the NWT and to explore ways that negative economic impacts can be mitigated.

The Minister says he has been assured that the Con Mine will meet its pension obligations and has ensured sufficient funds to more than cover its reclamation obligations.

Miramar Mining Corporation plans to remain a gold producer in the Yellowknife area through mid 2005 generating an estimated 135,000 to 155,000 ounces of gold in that period.

Mr. Antoine expressed his hope that many of the workers displaced by today's announcement can find employment at Giant mine or at Miramar's new gold mining project at Hope Bay in Nunavut.

**CAMBRIDGE BAY, Nunavut (August 29, 2003)** – Territorial premiers will be in Cambridge Bay next week to sign a cooperation accord that will strengthen the North's voice on the national stage.

Premier Dennis Fentie of the Yukon, Premier Stephen Kakfwi of the Northwest Territories and Premier Paul Okalik of Nunavut will sign the Northern Cooperation Accord at a ceremony and a community feast in Cambridge Bay, on September 3

"We will work cooperatively in areas such as the economy, devolution, aboriginal rights, the environment and social policy," said Okalik, who will host the forum. "The strength of northern solidarity was clearly demonstrated earlier this year when the federal government committed an additional \$60 million for the North as part a national health care arrangement."

As part of the accord, the territorial premiers will hold an annual Northern Premiers' Forum. Issues of regional, territorial, national and international interest will be discussed at the forums.

"This accord will reflect the reality that there is much in our history, geography and culture that is shared," said Kakfwi. "This reality provides a strong foundation to develop and advance a common agenda on matters of mutual concern and interest."



Frame Lake MLA Charles Dent says territorial and civic leaders share a common priority when addressing the mine closure. "The individuals and families impacted by the closure of Con mine are our friends, our colleagues and our neighbors," he said. "We all want to do everything we can to help."

Meanwhile, Mayor Van Tighem says the City of Yellowknife will continue to work cooperatively with Miramar Mining and government departments to address the economic impacts of the mine's closure and to support those residents affected. "We'll meet this challenge together, he said. "That's what Northerners do."

"This is a great demonstration of the kind of co-operation that all Canadians expect from their leaders," said Kakfwi. "We look forward to bringing our ideas forward as a team and working for the mutual benefit of not just Northerners but all Canadians."

"This is an extremely important time for Canada and we intend to bring co-operation and partnership to the forefront in the changes that are taking place," Fentie said. "We look forward to sharing our ideas with our colleagues during the Council of the Federation meetings in October."

# Northwest Territories Premier Seeks Business Support For Fair Deal

NEW YORK (September 8) -- A deal on devolution and resource revenue sharing between the Northwest Territories and Canada's federal government will guarantee the strong clear and stable business environment sought by Canadian and US investors, Premier Kakfwi told members of the Canadian Society of New York this morning.

"The resources are in the Northwest Territories," he said. "They will be developed there, and it is in the Northwest Territories that business relationships must be built and decisions made."

The Northwest Territories Premier is in New York and Toronto this week to address and meet with key representatives of Canada's economic and business community. His trip will highlight the benefits and opportunities that exist in the development of the Northwest Territories' natural gas and diamond industries and seek support from Canada's primary business leaders for a fair and equitable devolution and resource sharing agreement between Ottawa and Canada's northern governments.

Under current agreements, the federal government controls the natural resources of the Northwest Territories almost exclusively. Almost all of the royalties realized from resource development in the Northwest Territories flow to Ottawa.

"It costs us more to respond to development than we receive in benefits," Mr. Kakfwi said. "Aboriginal and public governments in the NWT deserve the dignity of being able to provide the physical and social infrastructure to support growth."

While in New York, Premier Kakfwi visited diamond-giant Tiffany's who, later this month, will open a cutting and polishing factory in the Northwest Territories. The Premier also met with Canada's Consul general in New York Pamela Wallin, CIBC World Markets, Lehman Brothers and a number of business, media and diamond industry representatives.

Premier Kakfwi returns to Canada tomorrow to meet with Prime Minister Jean Chretién in Shawinigan. He is scheduled to address the Economic Club of Toronto on Thursday.

# Kakfwi Wraps up Southern Tour

TORONTO (September 11) -- Premier Kakfwi has successfully completed meetings and speaking engagements in New York, Shawinigan, Ottawa and Toronto with representatives of Canada's corporate and investment community and the Prime Minister.



# **Kakfwi Reports Progress With De Beers**



## Federal/NWT Ministers of Justice Meet in YK

YELLOWKNIFE (September 26) -- Minister of Justice Roger Allen met recently with federal Justice Minister Martin Cauchon in Yellowknife. The Ministers discussed a number of issues facing the justice system in the Northwest Territories and Canada.

"Minister Cauchon provided assurances that Justice Canada officials recognize the unique challenges facing the administration of justice in the North - including providing legal aid services and issues related to prosecuting the possession of an unregistered firearm," Mr. Allen said.

Both Ministers believe the focus should be on compliance with the firearms legislation.

Justice Canada prosecutors will continue, in accordance with existing prosecution policy, to consider on a case by case basis, whether it is in the public interest to prosecute the offence of possession of an unregistered firearm.

If a charge is laid for possession of an unregistered firearm, Ministers Cauchon and Allen agree that current prosecution policy allowed federal prosecutors to consider, in appropriate cases, community-based alternatives like diversion to justice committees.

The Ministers also discussed recent funding increases for legal aid.



"The Minister recognizes that our high crime rate, the demands for family law services and the need to serve remote communities place additional pressures on our legal aid system," he said.

# Provinces/Territories to Continue Work on National Diamond Strategy

HALIFAX (September 30) – Provincial and Territorial Mine Ministers have agreed to continue work on a National Diamond Strategy to assist in the development of a diamond industry across Canada that will maximize benefits and opportunities for Canadians.

Provincial and Territorial Premiers endorsed the development of an action plan for a National Diamond Strategy in July 2003.

The Northwest Territories and Québec are co-leading the development of the strategy that will look at a range of issues across the entire diamond industry including diamond exploration, mining, rough diamonds, polished diamonds, diamond jewelry, diamond retail sales and diamond tourism.

Mine Ministers approved and released a mandate, work plan, and the document "Towards A National Diamond Strategy" presented by the NWT at their meeting in Halifax yesterday. This will be provided to Premiers for their consideration at the Council of the Federation meeting on October 24, 2003.

"The development of a National Diamond Strategy led by the Provinces and Territories is the only process that can effectively deal with all the issues involved for Canada and other stakeholders in a consistent, coordinated and fair manner," said NWT Minister of Resources, Wildlife and Economic Development (RWED) Jim Antoine.

Sam Hamad, ministre des Ressources naturelles, de la Faune et des Parcs du Québec said that everyone will be invited to collaborate. "All stakeholders including the federal government, industry, manufacturers, jewelers and retailers will be consulted and involved in the development of the action plan on the strategy that will lead to a strong and competitive diamond industry across Canada."

The elected representative for Matane, Mme. Nancy Charest, was also at the conference to provide support for the development of the strategy.

She is a former Program Manager for the Salt River First Nation in Fort Smith and Community Health Representative in Tulita.

Ms. Wright-Bird will be joined by Rose O'Donnell-King who has been hired as the new Authority's Chief Executive Officer.

Ms. O'Donnell-King brings extensive experience as a senior manager with government in both the Northwest Territories and Nunavut. She has worked as the Regional Superintendent for Social Services in the Kitikmeot region and as the Regional Superintendent for the Department of Education, Culture and Employment in the North Slave.

"I am pleased to welcome Ms. Wright-Bird and Ms. O'Donnell-King into our health and social services system," Mr. Miltenberger said. "This is an important step in the process of creating the new Sahtu Authority."

The new Sahtu Health and Social Services Authority will provide services to the communities of Colville Lake, Fort Good Hope, Norman Wells, Tulita, and Deline. The new Authority will be headquartered in Norman Wells, and current staff will officially begin to report to the new CEO on April 1, 2004.



# **GNWT** takes Action on Official Languages

YELLOWKNIFE (September 3) – On Tuesday, Minister Responsible for the Official Languages Act Jake Ootes tabled the GNWT's response to the Final Report of the Special Committee on the Review of the Official Languages Act.

The document provides a detailed response to the 65 recommendations made by the Special Committee earlier this year and details actions the government will take to implement the committee's recommendations.

Proposed changes to the *Act* include: the formal designation of a Minister Responsible for the *Official Languages Act*; the establishment of an *Aboriginal Languages Revitalization Board*, to focus on promotion and revitalization of Aboriginal languages; and the establishment of an *Official Languages Board* to focus on issues of service delivery and to advise on issues surrounding the *Official Languages Act*.

"At the heart of the work completed by Mr. Nitah and members of the Special Committee on the Review of the *Official Languages Act* lies an abiding respect for the role that languages play in the lives of our citizens, and the value that languages contribute to our culture and society," Mr. Ootes said. "Our government shares these views and goals.

Other legislative changes include the clear designation of eleven official languages and provisions to address the role of a Languages Commissioner. One of the first steps in implementing the Special Committee's report came today with the introduction of legislation to amend the *Official Languages Act*.

"For those recommendations that will need to be implemented over a longer time period, this report will serve as strong recommendation to the 15<sup>th</sup> Legislative Assembly," Mr. Ootes noted.

# **GNWT Welcomes \$80 Million Federal Funding**

YELLOWKNIFE (October 4) - The Government of the Northwest Territories welcomes today's federal funding announcement by Minister of Industry and Minister Responsible for Infrastructure Allan Rock.

The federal Minister announced that the Northwest Territories will receive a total of \$65 million from the federal government's Canadian Strategic Infrastructure Fund (CSIF) for various transportation projects and another \$15 million under the Municipal Rural Infrastructure Fund to address community infrastructure needs.

Besides enabling the Northwest Territories to upgrade transportation and community infrastructure, Premier Stephen Kakfwi says the new funding will translate into jobs, contracts and other business opportunities for all residents of the Northwest Territories.

"It has been a priority of this government to address the immediate and pressing challenge of sustaining infrastructure in the face of unprecedented economic growth," Premier Kakfwi said.

CSIF money will help to improve the Slave Geological Province corridor, including Highway 3 and the Ingraham Trail; the Mackenzie Valley corridor, including the Dempster Highway, as well as the Mackenzie Valley Winter Road through the construction of permanent bridges.

GNWT Minister of Finance Joe Handley says the additional money represents a strategic investment in the future of the Northwest Territories.

He says he's grateful for the overwhelming support that *Corridors for Canada*, the GNWT proposal under the CSIF fund, received from Minister Rock, industry, other levels of government, Western Arctic MP Ethel Blondin-Andrew and organizations such as the Northern Business Coalition."

"This announcement demonstrates again that positive results can be achieved through cooperative efforts and partnerships," he said.



Meanwhile, Minister of Municipal and Community Affairs Vince Steen says the GNWT will use the \$15 million committed under the Municipal Rural Infrastructure Fund for projects that directly benefit residents of communities throughout the NWT.

"Addressing community infrastructure needs is vital to sustaining economic growth and improving the quality of life for our residents," he said.

# Minister Releases Report on Victims' Services

YELLOWKNIFE (October 6) – On Monday, Minister of Justice Roger Allen tabled the Annual Report of the Victims Assistance Committee of the Northwest Territories in the Legislative Assembly.

In the Northwest Territories, victim fine surcharges levied by the Courts are put into the Victims Assistance Fund. The Victims Assistance Committee makes recommendations to the Minister on projects to support from the fund.

In 2002-2003, the Victims Assistance Committee distributed \$148 thousand to support community-based projects and activities that provided services and assistance to victims of crime in Tuktoyaktuk, Inuvik, Yellowknife, Hay River, Fort Smith, and the Dogrib communities.

For the first time, the annual report of the Victims Assistance Committee also includes information on victims' services supported by the Department of Justice. The Department of Justice funds community organizations in Fort Smith, Hay River, Yellowknife, Fort Good Hope and Inuvik to provide victims services.

"This report shows the importance of having these services available to all victims of crime," Mr. Allen said. "In a time of need, victims services workers and volunteers are there to provide information and support."

Last year, 774 people were assisted through victims' services. The majority of those served were adult aboriginal women who were primary victims of crime. The services most often provided were information, personal support and consultations with the RCMP.

"I would like to thank members of the Victims Services Committee for their support and advice as well as the many victims' services workers and volunteers," the Minister said. "They provide an important voice and support network for victims of crime in the NWT."

# Act to Amend the Safety Act Passed

YELLOWKNIFE (October 10) - Bill 23, an Act to amend the *Safety Act* was enacted today by the Legislative Assembly of the Northwest Territories.

The Minister Responsible for the Workers' Compensation Board in the Northwest Territories says changes included in the Bill will work to make NWT work sites safer.

"We all share in the responsibility of ensuring that safety is a priority for workers and employers," he said.

Many of the changes included in the Bill were identified directly from the input of northern workers and employers during a year-long legislative review of the Workers Compensation Act of the Northwest Territories and Nunavut.

Once the Bill becomes law, employers will be required to provide appropriate safety programs to their employees. A Safety Advisory Committee will also be established to make recommendations on safety regulations.

The Bill also more clearly defines a worker and employer, makes allowances for the Chief Safety Officer to issue orders and will require principal contractors or owners to coordinate the activities of all employers when more than one employer is on a work site.

The Nunavut Legislature will consider a similar set of amendments later this month.

# Funding Program a Good Fit for NWT Ootes Says

YELLOWKNIFE (October 9) -- Minister of Education, Culture and Employment Jake Ootes says he's confident that the Northwest Territories can realize significant benefits from the federal Aboriginal Skills and Employment Partnership (ASEP) Program.

The \$85 million five-year program, announced by Hon. Ethel Blondin-Andrew on behalf of Hon. Jane Stewart last week in Inuvik, will provide funds for programs and initiatives aimed at securing and increasing sustainable Aboriginal participation in large economic developments across Canada.

The Government of the Northwest Territories, through its Maximizing Northern Employment initiatives, has already identified various strategies and programs to ensure NWT residents have the training and skills to participate in the extraordinary levels of mining and oil and gas activity that will occur it the NWT.

Two specific strategies, developed over the past two years: the NWT Industrial Mining Skills Strategy and Oil and Gas Industrial Skills Strategy were previously proposed to the federal government and are expected to total approximately \$20 million in new funding. They will be resubmitted under guidelines set out by the new ASEP program.

"This new funding announcement speaks directly to these types of proposals," Mr. Ootes noted.

Studies predict that a Mackenzie Valley gas pipeline would provide almost 60,000 person years of employment over the lifetime of the its related projects and approximately \$3 billion in labour income for the NWT. Additional employment opportunities will also be provided through direct, indirect and induced jobs from the NWT's three diamond mines.

Mr. Ootes says partnership and collaboration between the GNWT, industry and the Aboriginal Summit, have been instrumental in setting the stage for the federal government to provide such funding.

"I am extremely confident that given the level of activity anticipated for this jurisdiction and the excellent work that we have done to date, a large portion of these new federal dollars will be invested here in the NWT," Mr. Ootes said.

Meanwhile, an additional seat has already been created on the NWT Arts Council and the Department of RWED has designated a staff person to focus on arts and crafts development in the NWT.

"Art and artistic expression, in all forms, serve to enrich our lives and our communities. It is an important part of life – not only socially and culturally, but also economically," RWED Minister Jim Antoine said.

Co-chair of the NWT Arts Strategy Advisory Panel Sonny MacDonald says he's pleased by the government's response to the recommendations of the Northwest Territories arts community.

### **Bathurst Caribou Survey Completed**

YELLOWKNIFE (October 17) – A recent survey of the Bathurst caribou herd's calving grounds shows the size of the herd to be about 186,000 animals.

The aerial survey was done in June 2003 by the Department of Resources, Wildlife and Economic Development with financial assistance from the Nunavut Department of Sustainable Development and the federal Department of Indian and Northern Affairs Canada.

The results of this latest survey indicate that the Bathurst caribou herd has been declining by about five percent a year for the past decade.

Minister of Resources Wildlife and Economic Development Jim Antoine says it is natural for caribou herds to increase and decrease in size. Elders and biologists have noted changes in the size of the herd in the past however, Mr. Antoine says, the latest survey results raise some concerns about the current status of the herd.

"We will work more closely with our partners and all harvesters to increase monitoring of the herd and to determine what measures may be required to ensure the herd remains healthy and viable," the Minister said.

The Governments of the Northwest Territories, Nunavut and Canada along with Aboriginal governments and co-management boards are responsible for the management of the Bathurst caribou and their range. The range of the herd extends from the calving grounds near Bathurst Inlet south toward Great Slave Lake and further southeast toward northern Saskatchewan.

Aboriginal harvesters from the NWT and Nunavut hunt the Bathurst caribou across their seasonal ranges. Resident and non-resident hunters harvest Bathurst caribou under a tag and quota system. Tags for commercial use are also available to Aboriginal harvesters.

Results of the June 2003 Bathurst Caribou Calving Ground Survey will be provided to the Bathurst Caribou Management Planning Committee. This committee was established in 2000 to draft a 10-year Bathurst Caribou Management Plan. It will ensure that the management plan and recommended management actions reflect the results of this survey.

### **GNWT Steps Towards Waste Recovery Programs**

YELLOWKNIFE (October 24) – The Government of the Northwest Territories (GNWT) will move ahead with developing territory-wide waste recovery programs thanks to the passage of the new *Waste Reduction and Recovery Act* October 10, 2003.

The new legislation allows the government to establish programs to recover, recycle and reuse waste materials. Minister of Resources, Wildlife and Economic Development (RWED) Jim Antoine says it is a significant step towards reducing the impact of waste on the environment, the amount of litter and the costs of handling garbage in communities and increasing the lifespan of community landfills.

The new legislation also allows the GNWT to ban the distribution or sale of some items that could harm the environment.

The first program to be developed under the new legislation is a beverage container recovery program. Other programs, such as recovery programs for cardboard, plastics, computers and tires, may be added in the future.

"Residents will be consulted before any recovery programs are established," the Minister noted. "The success of recovery programs depends on wide-spread public participation and support."

The costs of establishing, operating and evaluating recovery and recycling programs will be covered by the Environment Fund - a special purpose fund established by the *Waste Reduction* and *Recovery Act*. All deposits and non-refundable fees collected through recovery programs will be paid into the Environment Fund.



### Minimum Wage to Increase in December

YELLOWKNIFE (November 28) – Effective December 28, 2003, the minimum wage in the Northwest Territories will increase from \$6.50 to \$8.25 an hour. The Legislative Assembly approved changes to the minimum wage earlier this year.

"The minimum wage has not been changed since 1991," Minister of Justice Roger Allen notes, "this new wage is reflective of the increased cost of living since 1991."

While the current minimum wage differs for youth under 16 years of age and workers in off-road communities, the minimum wage, taking effect on December 28<sup>th</sup>, will be the same for everyone regardless of their age or location of work.

The Northwest Territories will have the second highest minimum wage in Canada behind Nunavut, where the minimum wage is \$8.50.

# National Day of Remembrance and Action on Violence Against Women

YELLOWKNIFE (December 5) – On December 6, 1989 fourteen young women were murdered at Montreal's l'Ecole Polytechnique. In their memory, Canadians declared December 6<sup>th</sup> as their National Day of Remembrance and Action on Violence Against Women.

"We remember the tragic loss of fourteen young women in the prime of their lives," Premier and Minister Responsible for the Status of Women Stephen Kakfwi said today. "It is an opportunity for all residents of the Northwest Territories and their leaders to renew their commitment to work toward the prevention and elimination of all forms of violence against women."

Speaking from Charlottetown, PEI, where he is attending a Council of Federation meeting with his provincial and territorial colleagues, Premier Kakfwi noted that federal, provincial and territorial Ministers Responsible for the Status of Women met earlier this year in Edmonton and agreed that priority must be given to the circumstances faced by Aboriginal women across Canada.

"We need to be mindful of the many forms that this violence can take," he said. "Particularly in the North, it includes family violence, spousal assault and bullying at schools. We all have a responsibility — as parents, friends, family, schoolteachers and political leaders, to eliminate violence against women."

In Charlottetown today, Premiers will join millions of Canadians wearing a white ribbon to symbolize their pledge never to commit, condone or remain silent about violence against women.

#### Ministers Lang and Antoine Sign Oil and Gas Agreement

WHITEHORSE (December 5) -- Yukon Energy, Mines and Resources Minister Archie Lang and Northwest Territories Resources, Wildlife and Economic Development Minister Jim Antoine signed a Yukon-Northwest Territories Sub-Agreement on Northern Oil and Gas Development today in Whitehorse.

The sub-agreement was negotiated under the Intergovernmental Relations Accord that was signed between the Government of Yukon and the Government of the Northwest Territories Mar. 13. The purpose of the sub-agreement is to undertake cooperative measures to support future oil and gas development in the Yukon and NWT.

"This is one step towards the government's commitment to help Yukoners receive access to employment, training and business opportunities arising from oil and gas and pipeline development in both territories," Lang said. "The sub-agreement will also help to gain access to the proposed Mackenzie Valley pipeline for north Yukon's oil and gas resources."

"The signing of this historic agreement demonstrates the renewed spirit of co-operation and mutual understanding that exists between the Yukon and the Northwest Territories," Antoine said. "It is a solid commitment from which we will work to maximize the benefits of northern development for all of our residents."

The sub-agreement commits both territories to developing an action plan that will identify options and opportunities in a number of areas related to oil and gas development, benefits from oil and gas activity and sharing of geological information. It also recognizes the need for both territories to work cooperatively in the development and management of Beaufort Sea oil and gas resources.

"Working to reach agreements like this demonstrates our government's strong preference to work cooperatively with our northern neighbours to support northern oil and gas, and pipeline development," Lang said. "It's important that the governments of NWT and the Yukon work together to ensure Northerners benefit, regardless of which pipeline proceeds first."




