#### **Emergency Management Meetings in Ottawa**

YELLOWKNIFE (January 28, 2005) – A number of new measures designed to improve Canada's emergency preparedness were developed at a meeting of federal, provincial and territorial ministers responsible for emergency management earlier this week in Ottawa, according to the Minister of Municipal and Community Affairs, the Honourable Michael McLeod. The meeting was co-chaired by Deputy Prime Minister and Minister of Public Safety and Emergency Preparedness, Honourable Anne McLellan, and Ontario Minister of Community Safety and Correctional Services, Honourable Monte Kwinter.

"Cooperation among all levels of government is critical if we are to be prepared for emergency situations," said Minister McLeod. "This was the first gathering of federal, provincial and territorial ministers to discuss emergency management in more than 10 years," he added.

The challenges of ice storms, blackouts, floods, forest fires and medical emergencies such as SARS have demonstrated the need for quick and appropriate response mechanisms at the local, provincial and federal level.

Ministers agreed to an eight-point work plan that will address issues such as working together on emergency response frameworks, updating the federal government's disaster assistance policy, developing a national public alerting strategy, and coordinating federal, provincial and territorial efforts in the areas of training and emergency response exercises.

Ministers agreed to establish a forum that will meet yearly to advance these and other shared objectives.

## Northwest Territories Budget Shows Fiscal House is in Order

**YELLOWKNIFE** (February 10, 2005) – The new Fiscal Responsibility Policy was unveiled by Finance Minister Floyd Roland today when he presented the Government of the Northwest Territories' (GNWT) 2005-06 Budget to the 15<sup>th</sup> Legislative Assembly.

The Fiscal Responsibility Policy was presented as a cornerstone of the Budget and the government's fiscal strategy. The policy sets out the guidelines for how much the government may borrow, what it should borrow for, and how it will be held accountable for its borrowing decisions. Under the policy, the government will have to exercise fiscal discipline in order to generate cash operating surpluses to fund at least 50 per cent of annual capital infrastructure investment.

As part of the fiscal strategy, Moody's Investors Service, a respected international rating agency, was asked to undertake an independent credit rating for the government. On February 9, 2005, Moody's released an Aa3 credit rating for the GNWT. "This excellent rating is a testament to the sound fiscal management of this government," Minister Roland stated.

Today's Budget Address reveals the GNWT's fiscal position has improved significantly since last year. Expenditure restraint measures and increased transfers from the federal government have turned a projected \$46 million operating deficit for the current fiscal year into an expected \$44 million operating surplus.

"The good news in our fiscal situation means we have more flexibility to respond to the serious and pressing challenges we face in government programs, services and investments," said Minister Roland. "However, to ensure our fiscal situation remains sustainable, we have to exercise discipline in our expenditures."

To maintain this positive fiscal situation, the GNWT has kept operational spending growth in its 2005-06 Budget to under one per cent. An operating surplus of \$49 million is projected for 2005-06. The surplus permits the GNWT to budget \$116 million in infrastructure investments in 2005-06 to help meet the large and growing need for public infrastructure in the Northwest Territories.

#### Backgrounder

R(15) 10020594 NWT Budget YELLOWKNIFE (February 10)

The second Budget of the Fifteenth Assembly focuses on sound long-term fiscal planning. Increased revenues have significantly improved the GNWT's fiscal position. However, revenues beyond 2005-06 are uncertain and the GNWT must exercise fiscal prudence. The new Fiscal Responsibility Policy introduced in this Budget sets the guidelines for GNWT fiscal planning.

#### **Economic and Fiscal Review**

- ♦ NWT economic growth has been unprecedented over the last five years and is expected to remain strong, driven largely by diamond mining. Real GDP grew over 62 per cent from 1999 to 2003 and another 10.6 per cent growth is expected in 2004.
- ♦ Final results for 2003-04 show an operating deficit of \$65 million, \$13 million lower than estimated last March.
- ♦ Increased federal funding under the Formula Financing Grant and health care, together with expenditure restraint, have turned the forecast \$46 million deficit for 2004-05 into an expected \$44 million operating surplus.
- ♦ The 2005-06 Budget forecasts an operating surplus of \$49 million. 2005-06 operating expenditures are budgeted to grow by less than one per cent from 2004-05. Capital investment in 2005-06 will be \$106 million.
- Over the medium-term, Government debt is not expected to exceed the \$300 million borrowing limit imposed by the federal government. However, uncertainty over fiscal arrangements with the federal government beyond 2005-06 and a \$290 million Corporate Income Tax repayment to be made in 2006-07 mean that the Government must continue to exercise fiscal prudence.

#### **Fiscal Strategy**

- ♦ The cornerstone of the GNWT's fiscal strategy is the new Fiscal Responsibility Policy, which establishes the guidelines for how much the Government may borrow, what it should borrow for, and how it will be held accountable for its borrowing decisions.
- ♦ The Fiscal Responsibility Policy requires that at least 50 per cent of annual capital infrastructure investment must be financed by the cash generated from operating surpluses. Therefore, the Policy requires that the GNWT exercise fiscal prudence in order to achieve these operating surpluses.
- ♦ As part of the fiscal strategy, Moody's Investors Service, a respected international rating agency, was asked to undertake an independent credit rating for the GNWT. On February 9, 2005, Moody's released a high grade Aa3 credit rating for the GNWT. This rating represents

an independent assessment of the strength of the NWT economy and the GNWT's fiscal position.

#### **Expenditure Measures**

- ◆ Total budgeted expenditures will grow to \$974 million in 2005-06; including \$20 million to meet increased costs and demands of existing programs and services and \$16 million in new initiatives. However, expenditure increases are largely offset by \$26 million in expenditure reductions. Uncertainty in some expenditure areas such as health and public sector wages have required the establishment of a larger than usual supplementary appropriation reserve.
- New expenditure measures focus on priorities identified in the goals of the 15<sup>th</sup> Legislative Assembly's *Strategic Plan*.

#### Strong Northern Voice and Identity

- ♦ \$355,000 for support of initiatives such as the Northern Strategy.
- ♦ \$1.8 million for continuation of devolution and resource revenue sharing negotiations, including a \$500,000 contribution to the Aboriginal Summit for their continued participation.

#### Healthy, Educated People Living in Safe Communities

- ♦ Over \$695 million of the GNWT's operating expenditures are targeted to support social and community programs.
- ♦ \$12 million in additional funds for existing and enhanced health programs and services, including \$895,000 in new funding for eight Community Demonstration projects as part of the Government's Response to the Social Agenda.
- ◆ \$3 million in this Budget for new initiatives in the NWT education system including:
  - \$742,000 for Alberta Learning Services to use, score and report on results of Grade 12 and Alberta achievement tests taken by our students;
  - \$727,000 to support continued development and implementation of early childhood Aboriginal languages immersion programs; and
  - \$622,000 to implement the final year of the Bachelor of Science in Nursing program at Aurora College.
- ♦ Four year Aboriginal Skills and Employment Partnership (ASEP) projects in support of oil and gas and mining will train over 800 Northerners for jobs in these sectors.
- ♦ \$1.4 million for ten new RCMP positions, including six positions assigned to the Rae, Tuktoyaktuk, Fort Providence and Yellowknife detachments, a three-person traffic unit with two officers in Hay River and one officer in Yellowknife, and a new dog and handler unit located in Yellowknife but serving the entire territory.
- ♦ \$400,000 for the on-going operations of the new family law clinic.
- Over \$200,000 has been allocated for the continued public education and training on the *Protection Against Family Violence Act*.

#### Well-Governed, Sustainable Communities

- ♦ The GNWT has introduced a New Deal for Communities designed to provide all NWT communities with the tools and resources they need to operate effectively. In the 2007-08 fiscal year, most community governments will become municipal taxation authorities.
- ♦ Implementation of an interim grant program for 2005-06 to flow property tax revenue to most General Taxation Area communities that do not currently raise their own property tax revenues. This program will continue until community governments are granted full taxation authority on January 1, 2008.
- ♦ As part of the New Deal, the GNWT has established the Community Public Infrastructure plan to provide a funding base for infrastructure development in NWT communities. The Infrastructure Acquisition Plan will include an additional \$13 million in 2006-07, \$15 million in 2007-08 and \$17 million in 2008-09 for General Taxation Area communities. To help these communities with the planning for this work, \$1 million is provided in 2005-06. The Plan also includes an additional \$3 million annually starting in 2006-07 for tax-based communities.

#### Diversified Economy

- ♦ \$500,000 for a partnership program with the private sector to promote Northwest Territories tourism at Expo 2005 in Aichi, Japan.
- ♦ \$32 million in reconstruction projects on our highway system, including the Mackenzie Valley Winter Road, are scheduled for 2005-06 using the 50/50 federal cost-sharing contributions of the Canada Strategic Infrastructure Fund.
- ♦ Additional funding to prepare for the Mackenzie Gas Project includes:
  - \$200,000 for additional resources required to review prospecting permits for potential impacts on heritage areas due to increased land use activity;
  - \$110,000 for additional funding to the Aurora Institute for increased licensing of research applications; and
  - \$120,000 for the Bureau of Statistics to provide support in assessing cumulative social and economic impacts of resource development.

#### Care and Protection of the Natural Environment

- ♦ \$1.5 million will be invested over five years to fund the implementation of the *NWT Protected Areas Strategy Action Plan*.
- ♦ \$275,000 in new funding for the Bathurst Caribou monitoring program to ensure that any impacts of increased human activity on the herd can be identified and mitigated.
- ♦ \$390,000 to address immediate environmental assessment and review requirements.
- ♦ \$250,000 for two new regional Environmental Protection Officer positions in Yellowknife and Inuvik to address regional impacts from development.

#### **Infrastructure Investment**

- ♦ The Fiscal Responsibility Policy requires that at least 50 per cent of GNWT capital investments must be funded by operating surpluses. Budgeted operating surpluses over the three-year planning period permit capital investments of \$116 million in 2005-06.
- The Government's three-year capital investment plan proposes to invest:
  - \$78 million for school replacement and renovation projects;
  - \$48 million for renovations and upgrades to our hospitals and health centres;
  - \$37.2 million for continued improvements to community water and sewer systems;
  - \$22.7 million for replacement, upgrades and capacity increases for community tank farms; and
  - \$9.4 million for new medical equipment for hospitals and health centres.

#### **Revenue Initiatives**

- ♦ The Government will continue to work with the federal government and Expert Panel on Equalization and Territorial Formula Financing to ensure that new Formula Financing arrangements for 2006-07 continue to meet the GNWT's needs.
- ♦ The Government will continue to work with its Aboriginal Summit partners to get a resource revenue sharing and resource devolution agreement with the federal government.
- ♦ The Risk Capital Investment Tax Credit that expired in 2003 will be re-introduced in 2005, with up to \$2 million in tax credits available annually for the next 3 years.

### NORTHWEST FASD PARTNERSHIP ANNOUNCES INAUGURAL MEETING

**VICTORIA** (March 1, 2005) – The Canada Northwest Fetal Alcohol Spectrum Disorder Partnership ministers were pleased to announce the inaugural meeting of a research network board newly-created to address Fetal Alcohol Spectrum Disorder (FASD).

"FASD is an incredibly complex issue that affects the lives of thousands of families," said Linda Reid, B.C. minister of state for early childhood development. "By sharing our resources – most particularly the talents and expertise of leading researchers – we can achieve new milestones more quickly. That, in turn, means better lives and better futures for children and youth affected by this disorder and greater inroads into its prevention."

Under the guidance of FASD expert Dr. Sterling Clarren as CEO/scientific director, the research network will advance research projects and build relationships across and within its jurisdictions. The intention is to compile evidence-based information that will guide progressive, inclusive policy, ultimately bettering the lives of individuals and families affected by the disorder. Plans are currently underway to conduct consultations with stakeholders in the partnership jurisdictions.

"Research and the creation of the Canada Northwest Research Network has been a real focus of the partnership," said Heather Forsyth, Alberta's Minister of Children's Services and the next chair of the partnership. "This board is comprised of some of the best and brightest minds in FASD research and planning, and is poised to lead the way."

FASD is the result of permanent brain damage and affects approximately nine of every 1,000 children born in Canada each year.

# GOVERNMENT OF CANADA AND GOVERNMENT OF NORTHWEST TERRITORIES ANNOUNCE INTENT TO CO-LOCATE IN JOINT EMERGENCY OPERATIONS CENTRE

YELLOWKNIFE, March 09, 2005—The Honourable Ethel Blondin-Andrew, Minister of State (Northern Development) and Member of Parliament for Western Arctic, on behalf of the Honourable Anne McLellan, Deputy Prime Minister and Minister of Public Safety and Emergency Preparedness, and the Honourable Michael McLeod, Minister of Municipal and Community Affairs, Northwest Territories, today announced plans for the establishment of a common, integrated emergency operations centre. The centre, to be located in Yellowknife, will help in responding to security threats and natural disasters in the Northwest Territories.

This co-location initiative will integrate emergency management functions of the Department of Municipal and Community Affairs (MACA) and the Royal Canadian Mounted Police's (RCMP) "G" Division, leading to a more effective overall response to all types of emergencies.

"The Government of Canada believes this is an important step so our two levels of government can maximize efforts in dealing with all types of emergencies – be they threats to public safety or security," said Minister Blondin-Andrew. "Together, we are firmly committed to enhancing our emergency preparedness and response efforts for citizens of the Northwest Territories."

Public Safety and Emergency Preparedness Canada (PSEPC) has also announced its intent to establish a regional office within the MACA/RCMP emergency operations centre. As part of an integrated national emergency response structure, this office will provide for a direct liaison between PSEPC, the Northwest Territories, the Yukon and Nunavut.

"I am pleased that Public Safety and Emergency Preparedness Canada and the RCMP have taken such a cooperative stance in working with our government on this initiative," said Minister McLeod. "This will help advance our common agenda to enhance emergency preparedness arrangements in the Northwest Territories and indeed all the north."

The RCMP is the primary enforcement agency in the Northwest Territories with national security responsibilities. The RCMP is also involved in emergency planning and response with the Government of the Northwest Territories at the territorial level, and with individual communities through the various RCMP detachments across the north.



Discussions to co-locate began shortly after the Government of Canada's *National Security Policy* (NSP) was announced in April 2004. The NSP sets the direction for a national framework and action plan to ensure that the Government of Canada is prepared for and can respond to emerging or occurring threats to national public safety and security. Co-location with provincial/territorial emergency operations centres is a key action item identified in the NSP.

#### **New Owner for Sirius Diamonds**

**YELLOWKNIFE** (March 15, 2005) - The Government of the Northwest Territories (GNWT) and the Receiver, Deloitte & Touche Inc. have agreed to terms for the sale of the Sirius Diamonds operations.

The current owners of Arslanian Cutting Works (NWT) Limited will be forming a new company to purchase the assets of Sirius Diamonds NWT Limited in Yellowknife and Sirius Diamonds Limited in Vancouver. The new owners will continue to operate the Sirius Diamonds factory.

The purchase and sale agreement is subject to court approval under the procedures the Receiver must follow. Final approval could take up to eight weeks. Finance Minister Floyd Roland said, "The new investors have entered into a management agreement with the Receiver which sees them assume immediate management control of the factory, under the supervision of the Receiver. I am very pleased we have concluded this agreement which ensures the continuation of a viable secondary diamond industry in the Northwest Territories."

Under the management agreement the new owners will provide the financing for the purchase of rough diamonds and assume responsibility for payroll and other operating expenses.



#### **New Choices for Victims of Family Violence**

YELLOWKNIFE (March 31, 2005) – New choices for responding to family violence were announced by Minister of Justice and Attorney General Brendan Bell today.

An emergency protection order (EPO) is a way for people to get protection from family violence quickly and easily, without going to court. It is one of three new remedies available under the *Protection Against Family Violence Act*, which comes into force April 1, 2005.


Other remedies available under the Act include protection orders, which are ordered by the Court and can include similar provisions as an EPO but can last longer than 90 days. Also available is a warrant for entry that would allow someone to enter a residence if they believe someone is being held in the house and experiencing family violence.

"These are new tools for people who are living with family violence," said Minister Bell. "They will have a quick way to get help, without having to go to court or hire a lawyer. Emergency protection orders give people a chance to be safe from violence while they decide if they need longer-lasting protection through the courts."

Emergency protection orders are available through the RCMP or through a toll-free number (1-866-223-7775). People can call any time of the day or night, and someone will help them apply for an order. The entire process takes a few hours, from the time of the application to the time the order is issued. A judge reviews the order within three days to make sure it was fair.

Emergency protection orders can last up to 90 days and can include things like:

- Ordering the abuser to stay away from the victim;
- Allowing the victim to use the family home without the abuser being there;
- Requiring the RCMP to take away the abusive person's weapons.



The new legislation defines "family violence" very broadly. People can use emergency protection orders to stay safe from family members who are abusing them in any of the following ways:

- **Physical abuse** injuring family members;
- Psychological abuse threatening someone or making them fear for their safety;
- **Emotional abuse** being so mean to someone that they think they're worthless;
- **Financial abuse** taking someone's money or other things that are valuable;
- Sexual abuse forcing someone to have sex or do other sexual things they don't want to do; and
- **Abusive control** not letting someone come and go freely.

## The Northwest Territories Steps Up Campaign For Fair Deal From Federal Government

**OTTAWA (April 5, 2005)** – Premier Joseph Handley will head a delegation of Northwest Territories cabinet ministers, and business and aboriginal leaders to Ottawa to press for an urgently needed devolution of powers and resource revenue-sharing deal for the NWT.

Premier Handley will deliver a Newsmaker Breakfast speech at the National Press Club, 150 Wellington Street, at 7.30 a.m. Tuesday, April 5, before launching a series of delegation meetings with federal cabinet ministers.

Talks with the federal government have proceeded well in terms of forging an agreement in principle that would see jurisdiction over natural resources pass from Ottawa to the NWT by 2006. Progress now needs to be made to negotiate a resource revenue sharing agreement that fairly shares resource revenues with northern governments.

The rapid growth generated by the diamond industry, Mackenzie Delta/Beaufort Sea natural gas exploration and work on the planned Mackenzie Valley Pipeline has already placed major strains on the NWT in terms of meeting social and infrastructure needs.

The NWT must gain both control of its natural resources and a substantial share of the revenues they generate if this growth is to be sustained in a manner that allows northerners to properly share in the benefits.

"We believe we are close to achieving an agreement in principle this spring and implementation of a final agreement next year, but it will require political will at the federal level to ensure that red tape and bureaucratic stalling is not allowed to prevent this from happening," says Premier Handley.

Premier Handley will also use his breakfast speech at the National Press Club and meetings with senior federal ministers and the Prime Minister to discuss the Mackenzie Valley Pipeline project and the importance of the natural gas supply that it is scheduled to start carrying south in the next few years.

#### **Update on Fort Simpson Study**

YELLOWKNIFE (April 14, 2005) – At a meeting yesterday, the Village of Fort Simpson and the Department of Municipal and Community Affairs (MACA) reviewed a joint study to analyze the implications of a possible change in status for the community government.

However, the Mayor noted that although the study provides an accurate assessment of the Village's situation at the time the study was completed, new policy announcements by MACA mean that some of the information and conclusions may no longer be up-to-date.

The Honourable Michael McLeod, Minister of Municipal and Community Affairs, agreed with Mayor Michaud's assessment, and stated that he was pleased both with the results of the study and today's meeting with the Village Council. "The Department will work with the Village to ensure that information is available to residents of Fort Simpson about policy changes that may have an impact on the study findings,"

"We had a productive meeting and agreed to continue open discussions about the best options for the Village, and how MACA can support them in moving forward," added Minister McLeod.

The study will be publicly released by the Village and used as the basis for consultations between the Village Council and residents of Fort Simpson.

This appointment fills a vacancy on the Territorial Court created by the retirement of former Chief Judge R. Michel Bourassa. The Territorial Court hears both criminal and civil matters, including family law, child protection and civil claims of up to \$10,000.

The *Territorial Court Act* establishes the Judicial Appointments Advisory Committee, which reviews and recommends candidates to the Commissioner-in-Executive Council for appointment to the Territorial Court.





"I can see how this approach can help our staff and students to become better citizens," said Velma Illasiak, principal of Moose Kerr School in Aklavik.


During the conference, the participants have had an opportunity to hear about successful strategies in EBS from Dr. Terry Scott from the University of Florida.

## Funding Support Available for Community Governments to Prepare for the Pipeline

Yellowknife (May 18, 2005) – Community governments in the Northwest Territories (NWT) will receive \$1.295 million to assist them in assessing the impacts of the Mackenzie Gas Project (MGP), and prepare strategies to maximize benefits and minimize potential negative impacts, the Honourable Michael McLeod, Minister for Municipal and Community Affairs (MACA), announced today.

"Community governments in the Mackenzie Valley face many challenges in preparing for the proposed pipeline, along with the associated exploration and development," Minister McLeod states. "We heard this loud and clear at the *Preparing for the Pipeline* community conference my department sponsored in Inuvik last December.

MACA will provide \$20,000 to each of the 21 communities directly affected by the pipeline to assist them in participating in the environmental review process. Subsequent funding of up to \$30,000 per community will be available for the 22 impacted communities (21 directly affected communities plus Yellowknife) to review proposals, assess impacts, negotiate community access agreements and undertake general planning and preparation.

In addition, up to \$15,000 can be accessed by each of the remaining 11 communities in the NWT not identified as being directly or indirectly impacted by the proposed pipeline to help them review, plan and assess any potential impacts or opportunities for their community.

Funding will also be available to support regional workshops, and research and analysis of common issues for NWT communities, which may include engineering, infrastructure and legal research and advice.

The GNWT recognizes communities need support in order to participate meaningfully in the review of the Environmental Impact Statement and the regulatory review process. As well, communities must address capacity shortfalls resulting from the added workload associated with pipeline response and socio-economic pressures.

"Communities have made it clear they need financial support in order to ensure a thorough and balanced review of impacts and opportunities," Minister McLeod added. "I am pleased to provide this support and meet the need. I have listened to communities, and to groups such as the Deh Cho First Nations and Deh Gah Alliance Society, all of whom have stressed the importance of adequate funding for the review of community impacts."



#### **New Rules For New Drivers**

**YELLOWKNIFE** (May 30, 2005) – The rules governing new drivers in the NWT will change on August 1, 2005 when the Department of Transportation introduces a Graduated Driver Licensing (GDL) program designed to make the process of learning to drive a safer experience for everyone involved.

"Graduated Driver Licensing is intended to give new drivers, regardless of age, an appropriate period in which to gain more driving experience and more skills as they progress through stages leading to a full licence," Transportation Minister Michael McLeod said today as he announced the implementation date for the program.

"These new measures, similar to what are in place in the rest of Canada, are another step forward in continuing efforts to make roads in the NWT as safe as they can be," he added. "Our new drivers must be fully prepared to meet the challenges of safely sharing our roadways, both here in the NWT and elsewhere in Canada."

The GDL program will attach some new conditions to the process of acquiring a driver's licence for the first time. Among the changes is a requirement that anyone who obtains a Learner's licence must spend a full 12 months learning to drive before being tested for a full Class 5 licence. During that period, a Learner cannot drive between 11 p.m. and 6 a.m. Similarly, a new Class 5 licence is probationary for 12 months.


New drivers will not be permitted to drive with any amount of alcohol in their blood. Violations will result in a 30-day suspension. The mandatory demerit point licence suspension for experienced driver is 15 points, but will be reduced to six points for novice drivers.

"The GDL program emphasizes to new drivers that they must acquire skills, knowledge and experience in order to become safe drivers," Mr. McLeod said. "It also reinforces the fact that driving a motor vehicle is a privilege that comes with a responsibility to drive in a manner that respects others."

The Honourable Charles Dent, Minister of Education, Culture and Employment congratulated the students from grades 3 to 8 and encouraged them to continue saying no to smoking. He also presented École St. Joseph School Vice Principal Gillian Dawe-Taylor with specially imprinted 'Butthead' soccer balls to celebrate that almost 50% of the school population made the commitment to be smoke-free for life.

Dr. André Corriveau, Chief Medical Officer for the Northwest Territories (NWT) spoke to students about why it is important to pay attention to tobacco issues across the world. He said, "While the rates of tobacco use are dropping in many developed countries such as Canada, the tobacco industry is moving aggressively into developing countries and targeting youth. This is how the tobacco industry starts new generations of smokers. I hope this generation of young people in the NWT will be strong and continue to stay smoke free, so that the tobacco industry doesn't win here."

Student speaker, Katie Heine, a grade 10 student from Sir John Franklin congratulated all the kids who made the commitment and said, "I encourage you not to just sit back, but to take your own actions to move towards a smoke-free society".


Natalie MacFadyen, a Grade 8 student from École St. Joseph School, also spoke about her personal commitment to never start smoking.



#### **Celebrating the Northwest Territories Mining Industry**

**YELLOWKNIFE (June 6, 2005)** – Every year, the Northwest Territories (NWT) and Nunavut Chambers of Mines organizes NWT Mining Week. This year, Mining Week will be held from June 6<sup>th</sup> to 11<sup>th</sup>, 2005. Many activities are planned throughout the week to highlight and celebrate the mining industry of the NWT.

"Mining and mineral exploration are two significant contributors to the NWT economy," said Industry, Tourism and Investment (ITI) Minister Brendan Bell. "In 2004, the mining industry accounted for \$1.8 billion of the \$3.7 billion Gross Domestic Product for the Territory. As well, total mineral exploration accounted for \$109 million spent in the NWT."

A recent survey found that mining companies spent an average of 66% of their total exploration and deposit appraisal expenditures for 2004 in the NWT. This percentage falls between the required Northern Spending in mine construction and operation stages, as outlined in Socio-Economic Agreements between the mining companies and Government of the NWT.

The NWT Geoscience Office is assisting in Mining Week activities by hosting Rock Walks. These guided tours of the local geology will be held every evening during Mining Week. New to the celebrations this year is the Mining Heritage Art Show, featuring photographer George Hunter. This collection of black and white stills is sponsored by the Prince of Wales Northern Heritage Centre, the NWT Mining Heritage Society, the Department of ITI and the NWT and Nunavut Chambers of Mines. Other activities organized for the week include the Prospectors Challenge and the NWT and Nunavut Mine Rescue competition.



#### **Backgrounder**

In the summer of 2002, the Government of Canada and the Government of the Northwest Territories (NWT), along with many other Canadian jurisdictions, signed the Federal/Provincial/Territorial Framework Agreement on Agricultural and Agri-Food Policy for the Twenty-First Century.

The NWT is ready to deliver four elements of the Agricultural Policy Framework (APF) designed to enhance opportunities for the NWT agri-foods industry:

**Food Safety and Quality:** Designed to improve the sector's ability to identify and respond to food safety and quality issues, improve the industry's ability to meet or exceed market requirements, increase consumer confidence and create valued-added opportunities.

**Environment:** Designed to enhance environmental stewardship of water, soil, air and biodiversity resources of the NWT through broadening the general knowledge base as it applies to NWT production.

**Renewal:** Designed to provide farmers with the skills, knowledge and tools to help them succeed in farming; access to advice on increasing profitability through new business opportunities and value-added activities; and opportunities to help them improve farm family incomes and/or make informed choices about sources of income.

**Science and Innovation:** Designed to provide scientific and technical support aimed at developing innovative approaches to the diversification of the agri-foods industry.

The Agreement provides for yearly contributions to the agri-foods industry of the NWT totalling \$435,000 per year on a 60 per cent Federal and 40 per cent NWT basis. The agreement is effective until March 31, 2008, and will equal a cumulative program value of \$2.175 million.

## Continued commitment to partnership and change spell accomplishment for Alberta and the Northwest Territories

Edmonton...The Co-chairs for the Alberta-Northwest Territories Memorandum of Understanding for Cooperation and Development met yesterday in Edmonton. Minister Pearl Calahasen, representing the Government of Alberta, and Minister Michael Miltenberger, representing the Government of the Northwest Territories, were very pleased with the outcome of the meeting.

The collaborative working arrangement between the Governments of Alberta and the Northwest Territories has been in place for seven years now and has seen results in a number of areas including tourism, transportation, and regional economic development. Going forward, the Co-chairs have agreed to focus efforts in areas of mutual concern and interest including the benefits and impacts of resource development, maintenance and required upgrades of northern transportation infrastructure and the management of common water resources.

Specific areas discussed include:

- A wide-ranging discussion on the Mackenzie Gas Project and the potential impacts on communities and northern transportation infrastructure;
- The need to work cooperatively on further reducing the risks to northern communities from forest fires; and
- The need to work towards a tri-lateral agreement between the governments of Alberta, the Northwest Territories and the government of Canada on the management of water resources in the Mackenzie River Basin.

Minister Miltenberger said, "The value of ongoing dialogue and continued collaboration with the Government of Alberta on specific projects cannot be over-stated. We have had good success in the past on common issues such as tourism and we will continue to work together in other areas such as the management of our common water resources."

Minister Calahasen noted, "I will continue to advance issues important to our northern communities at the Alberta Cabinet table and build the relationships necessary to achieve results related to our joint projects and initiatives."

Also participating in the meeting was Ray Danyluk, the Chair of the Northern Alberta Development Council and the MLA for Lac La Biche-St.Paul. Mr. Danyluk said "We will continue to pursue the enhancement of northern highways, rail and scheduled air connections between the regions."

The Alberta-Northwest Territories *Memorandum of Understanding* for Co-operation and Development between Alberta and the Northwest Territories was originally signed by the Premiers of the Northwest Territories and Alberta in 1998 and then extended in 2003 for another five years. The next meeting will be held in Fort Smith, Northwest Territories.





#### NWT Council of Sport and Recreation Partners Council

The development of an NWT Council of Sport and Recreation Partners Council is intended to achieve four primary goals:

- Create a forum for all communities and sport and recreation leaders to have a voice in sport and recreation planning and decision-making.
- Streamline decision-making, and improve coordination in program delivery.
- Provide opportunities for all Northwest Territories (NWT) residents to access sport, recreation and physical activity programs by improving integration and more effective use of resources.
- Establish a mechanism to allocate available resources equitably to address program and community needs.

The Council will provide the Minister of Municipal and Community Affairs (MACA) an official point of contact to discuss sport, recreation and physical activity policy and programming issues.

#### Why a Council?

In April 2003, the Minister of MACA approved the "Northwest Territories Recreation and Sport Board: Final Recommendations Report", which was submitted by all partners as a joint recommendation on the creation of an NWT Council of Sport and Recreation Partners. An Interim Coordinating Team was established with representation from all partners and were tasked with moving the proposal forward.

On October 1, 2004, the partners submitted a "Response to the Draft Proposal for the establishment of the Northwest Territories Council of Sport and Recreation Partners". Input was also received from the Beaufort Delta Sahtu Recreation Association and the NWT Curling Association.

Based on this consultation process and recommendations made by stakeholders, the Minister of MACA announced the intent to proceed with implementation of the NWT Council of Sport and Recreation Partners effective April 2005.

#### What's Next?

1. After the establishment of the Council, it will begin work with partners and regions through its committee structure on its primary areas of responsibility. Initially these will include development of the following:

- a. resource management plan including:
  - support to the Lottery Authority to maximize revenue flow;
  - streamlining administrative expenses; and
  - volunteer and staff support initiatives.
- b. communications and marketing plan;
- c. plan to consolidate partner offices; and
- d. plan to establish system wide priorities and operating principles.
- 2. The Council will provide quarterly progress updates to partners and the Minister on progress. Periodic updates will also be developed for Northwest Territories communities and other interested parties.
- 3. In October 2005, partners are anticipated to submit draft 2006-2007 business plans and budgets to the Council for review.
- 4. The Council is intended to finalize its reviews and makes final recommendations on budget approvals for 2006-2007 in November/December 2005 and forward to the Minister of MACA.
- 5. A final Ministerial decision on budget requests is anticipated in June 2006.
- 6. The partners will begin the first full year of operation in April 2006. During this time, the Council will continue with implementation of its primary duties.



#### School Achievement Indicators Program (SAIP) Results Released

YELLOWKNIFE (June 20, 2005) – The Council of Ministers of Education, Canada (CMEC) has released the 2004 School Achievement Indicators Program (SAIP) Science III results, which included the Northwest Territories as a jurisdiction.

The assessment, which was administered in the spring of 2004, is designed to evaluate the overall level of knowledge and concept understanding of science over time amongst English and French-speaking students aged 13 and 16. This is the third time that the assessment has been administered since it was created in 1996.

Achievement criteria are assessed on a five-level scale. Most 13-year-olds were expected to achieve or exceed level 2, while 16-year-olds were expected to achieve or exceed level 3. In the NWT, almost half of 13-year-olds achieved level 2 or higher, compared to 71% nationally. 49% of NWT 16-year-olds achieved level 3 or higher compared to 64% nationally.

It is not possible to compare NWT results from previous years, as this is the first time the NWT has been assessed in science as a separate jurisdiction from Nunavut. Additionally, in most jurisdictions, a random sample of students participate in the assessment, but because of the small size of our population in the NWT, the test was administered to all students aged 13 and 16. As a result, unlike other jurisdictions, NWT students participate regardless of their grade level at the time of the test, which may skew our comparative results.

The Department of Education, Culture and Employment has already taken steps to improve the level of science achievement for NWT students, with the implementation of the new Western and Northern Canadian Protocol (WNCP) science curriculum in the fall of 2005. It is anticipated that this curriculum will have a positive result on SAIP science results when they are next administered.



# **Engaging Workshop Planned for Aboriginal Language Instructors**

YELLOWKNIFE (July 7, 2005) – Staff involved in providing aboriginal language programming for children will be participating in a training workshop on the Hay River Reserve, hosted by the Department of Education, Culture and Employment (ECE), from July 18<sup>th</sup> to 22<sup>nd</sup>. The workshop will be delivered by Dr. Stephen Greymorning and based on the "Accelerated Second Language Acquisition" model.

The training is designed for those delivering second language instruction to students of different ages and languages. It has received high praise from many individuals and Canadian Aboriginal organizations. The objective of the training is to bring students to a level of language proficiency, while accommodating instructors who may be working with limited time and resources.

Dr. Greymorning is a professor in both the Anthropology and Native American Studies programs at the University of Montana. He has conducted research among indigenous peoples in Australia, New Zealand, Timor, the United States and Canada, and continues working to develop strategies for native language restoration.

Dr. Greymorning's presentation is anticipated to be of particular interest to Language Nest Coordinators. Language Nests are aboriginal language immersion programs for preschool children and their parents. There are currently 18 Language Nests funded by ECE in the Northwest Territories (NWT), with at least one program being offered in each official aboriginal language.

Aboriginal language specialists and instructors who currently work in the education system in the NWT have also been invited to participate in the workshop.

# Expo 2005 - Business Case

The participation of the NWT in Expo 2005 in Japan has the potential to generate benefits to the territory in the following areas:

- Increased awareness of NWT Aurora Tourism and other diverse tourism products
- Increased purchase of NWT diamonds
- New investment in the NWT
- New visitors to the NWT

In 1989, less than 100 Japanese visitors came to the Northwest Territories. This visitation has grown substantially and Aurora viewing companies are expecting approximately 11,000 visitors next season. In future years Aurora traffic is expected to grow between 5-7% annually.

Surveys by ITI indicate each Japanese visitor contributes on average \$747 to the NWT's economy.

The total private and public investment at Expo 2005 will be around \$800,000, \$500,000 will be GNWT funding and the balance reflects strong partnership participation by our

private sector sponsors. Further information on the sponsor involvement in NWT Week please refer to the enclosed press release.

Based on ITI results from the marketing investment after the downturn attributed to SARS, we expect Japanese visitation levels to increase by almost one thousand people in the year following Expo 2005, leaving close to \$750,000 behind in the local economy per year for the next several years. This spending will result in an estimated \$150,000 in tax revenues for the GNWT.

ITI expects the initial increase in visitation to maintain momentum over a number of years. As more people visit the NWT and ongoing marketing by ITI, NWT Tourism and private operators take effect we can expect a significant increase in Japanese visitation to the NWT.

# Funding Announced for New Community Recreation Trails in the Northwest Territories



## \$40 Million To Benefit All Northwest Territories Communities

YELLOWKNIFE (August 8, 2005) – Premier Handley revealed today how the Government of the Northwest Territories proposes to spend the \$40 million in the Northwest Territories. A \$40 million dollar trust fund was announced by the federal government on December 14<sup>th</sup> 2004, to help achieve some of the objectives of the Northern Strategy in the short term.

"Based on what we heard from Northern Leaders through various consultations and at the Circle of Northern Leaders meeting in Inuvik, communities want to utilize this funding to advance urgent priorities at the community level. That is why the Government of the Northwest Territories proposes to establish a \$35 million Community Capacity Building Fund to provide communities with financial support to address their priorities", said Premier Handley. "We know all too well, that per capita funding alone is not an appropriate distribution mechanism in places with comparatively small populations. That is why the Government of the Northwest Territories has taken the position that the per capita formula needs to be supplemented with a base allocation when dividing federal program dollars amongst provinces and territories", said Premier Handley.

Of the remaining \$5 million, \$4 million will be used by the Government of the Northwest Territories (GNWT) to help address serious housing needs in communities most in need. The remaining \$1 million will be spent on youth and healthy living initiatives. Provided the Legislative Assembly approves the appropriation, Communities could access the fund as early as November 1<sup>st</sup>, 2005 for a period of three years. "The Government of the Northwest Territories decided the distribution of the Community Capacity Building Fund will be a combination of base and per capita funding. This means all communities are eligible to receive meaningful levels of funding to help them address their capacity building priorities. All NWT residents could benefit from this important one-time funding, provided there is agreement at the community level on how that money is to be used", said Premier Handley.

The Department of Municipal and Community Affairs (MACA) will administer the fund on behalf of the GNWT. ## \$40 Million Dollar Northern Strategy Funding Allocations

At the launch of the Northern Strategy Framework in December 2004, the federal government announced a one-time investment of \$120 million to help achieve some of the objectives of the Northern Strategy in the short term. The money was to be divided equally among the three territories. The Government of the Northwest Territories has indicated that its share of the money will be invested in communities.

The Government of the Northwest Territories is proposing to set up a \$35 million dollar Community Capacity Building Fund that would provide communities with financial support to address their priorities. The Government of the Northwest Territories is also proposing to invest \$4 million dollars to address the serious housing needs in the NWT, \$500,000 for youth programs and \$500,000 to support Healthy Choices Initiatives.

The proposed allocation formula for the Community Capacity Building Fund strives to achieve a balance between an equitable allocation to all 33 communities and consideration of population/per capita pressures. As well, eligibility criteria are designed to create an incentive for all local governments within a community to collaborate in developing and subsequently endorsing a community plan that benefits the community at large.

Each community in the NWT is eligible to receive a base amount in addition to an amount based on per capita using the most current census data.

The proposed Community Capacity Building fund, as well as proposed investments in housing, youth programs and healthy living initiatives are one-time only allocations. Once the community has agreed on how the funds available through the proposed Community Capacity Building Fund would be used, the money could be drawn down anytime over the next three years, beginning November 1, 2005.

The Department of Municipal and Community Affairs will administer the Community Capacity Building fund on behalf of the Government of the Northwest Territories. Over the next few months they will be contacting communities with more specific details respecting the criteria and allocation of the fund. # Ministers Agree Improvement to Sport and Recreation Infrastructure Necessary

**YELLOWKNIFE (August 10, 2005)** - Federal, provincial and territorial ministers responsible for sport, physical activity and recreation have identified the need to improve sport and recreation infrastructure across Canada as their top priority and committed to working in partnership to develop a national sport and recreation infrastructure program. The ministers held their annual meeting last week in Regina, Saskatchewan, prior to the opening of the Canada Summer Games.

The Honourable Michael McLeod, Minister of Municipal and Community Affairs and Minister Responsible for Sport and Recreation, was pleased with the outcome of last week's meeting. "Every province and territory is searching for creative solutions to fund recreation infrastructure – whether the need is to upgrade aging facilities or put basic infrastructure in communities where none exists," said Minister McLeod.

Minister McLeod added that the Honourable Stephen Owen, Minister of Western Economic Diversification and Minister of State (Sport), was very supportive of provincial and territorial concerns and agreed to work in partnership with provinces and territories to develop a funding program for infrastructure.

Provincial and territorial ministers compared progress on their shared goal of increasing the number of physically active Canadians 10 percentage points by 2010. As well, they adopted a resolution urging the federal government to commit to multi-year bilateral agreements to support provincial and territorial programs promoting physical activity.

"The Northwest Territories has benefited greatly from our bilateral funding agreement with Sport Canada, which has supported numerous activities for youth and multi-sport camps in small communities," noted Minister McLeod. "It's time for Canada to step up to the plate and support programs that will encourage all our residents to become more physically active."

Ministers also set performance targets for Canada at the 2010 Winter Olympic and Paralympic Games, and agreed to work with the Vancouver 2010 Organizing Committee to ensure the Olympic and Paralympic Games are truly Canada's Games.

Minister McLeod attended the official opening of the 2005 Canada Summer Games while in Regina, and welcomed the 104 Northwest Territories athletes as they marched in the ceremony.

## Department of Transportation Warns of Increased Risk of Bison Collisions

**YELLOWKNIFE** (August 23, 2005) — The Department of Transportation is warning highway motorists that the risk of collisions with bison that cross three NWT highways grows greater as the days grow shorter.

"Most vehicle-bison collisions occur between mid-August and mid-November when hours of daylight decrease and there is little or no snow on the ground to provide contrast and make these large, dark animals more visible to drivers," said Art Barnes, South Slave Regional Superintendent with the Department of Transportation. "Drivers traveling through areas inhabited by bison herds must be especially careful during this time of year."

Barnes said the highest risk areas are Highway 3 between Yellowknife and Fort Providence, from the Nyarling River to Fort Smith on Highway 5, and the section of the Liard Highway, Highway 7, from km 0-150.

In 2004, there were a total of 11 vehicle-bison collisions reported in the territory. Eight collisions happened on Highway 3, two on Highway 5 and one on Highway 7. Nine of those collisions occurred between August and November. There have been as many as 14 collisions annually and at least three collisions reported every year since 1989.

Collisions with bison resulted in injuries to two people last year, but there have been as many as six people injured in past years.

Excessive speed is the main reason for collisions with bison, which can weigh more than 1000 kilograms, Barnes said. He said a collision between a vehicle and a single bison, or a group of animals, can cause extensive damage to a vehicle and normally results in the death of the animals.

"When you travel on highways where there are bison, you have to slow down, especially at night," he said. "Even in daylight hours, drivers must be prepared to slow down or stop when bison are near or on the highway." He said bison are unpredictable and seem to be unafraid of vehicles.

"We all like to see bison as we drive along the highways," Barnes said. "But you don't want to see one as it's coming through your windshield."

# New Nurse Practitioner Guidelines Approved for Northwest Territories

**YELLOWKNIFE** (August 24, 2005) - New guidelines that define the appropriate scope of practice for nurse practitioners have been approved for the Northwest Territories, Health and Social Services Minister Michael Miltenberger, announced today.

Minister Miltenberger noted "We are excited with the new guidelines in place, as more and more nurse practitioners are hired in the North, these guidelines will help them develop as professionals and continue to provide excellent client care."

The *Nursing Act* allows Nurse Practitioners to:

- Diagnose diseases, disorders or conditions and communicate that diagnosis to the patient,
- Order and interpret screening and diagnostic tests,
- Select, recommend, supply, prescribe and monitor the effectiveness of drugs, and
- Perform any other procedures allowed in the guidelines.

The *Practice Guidelines for Primary Health Care Nurse Practitioners* were developed by the Registered Nurses Association of the NWT and Nunavut (RNANT/NU). Nurse Practitioners and the Department of Health and Social Services were involved as well. NU nurse practitioners have identical guidelines in place, since the RNANT/NU serves as the regulatory body for nurses in both Nunavut and the NWT.

The guidelines will be printed in booklet form for distribution to nurses. They will also be posted on the RNANT/NU web site (<u>www.rnantnu.ca</u>.)

# Review of Commissioner's Land Applications within Yellowknife Completed

YELLOWKNIFE (September 12, 2005) – The Honourable Michael McLeod, Minister of Municipal and Community Affairs, today announced his decision to transfer three parcels of land to the City of Yellowknife, and to approve a request by the Department of Transportation for access to land required for the future expansion of the Yellowknife Airport.

Minister McLeod also indicated that decisions on further land transfers in the City of Yellowknife will be deferred until January 2006, as requested by the Akaitcho Dene First Nation. This will allow time for the Yellowknives Dene First Nation to complete land identification through the Akaitcho Process negotiations.

Commissioner's land transfers within the City of Yellowknife have been delayed as a result of the on-going Akaitcho Process negotiations, and consultation requirements established under the Akaitcho Interim Measures Agreement and the Government's Land Lease-Only Policy.

"This land transfer eases the pressure the City of Yellowknife faces for land for industrial activity," the Minister stated. He added he is pleased with the commitment by the Akaitcho Dene First Nation to make addressing Yellowknife land issues a priority for the negotiations process.

Outstanding requests for access to land in Yellowknife include the site for a new Territorial Courthouse, and applications for industrial, commercial and residential lands from the City of Yellowknife. Under an agreement between the Government of the Northwest Territories and the Yellowknives Dene First Nation, the Minister can also make decisions about the future ownership of the lands on which the Con and Rycon trailer courts are located, after September 1, 2005.

"The Department needs to move forward, and it is my intention to make decisions on outstanding land issues in January, 2006," the Minister stated. "It is my sincere hope that the decisions and accommodations I have made today will create an environment allowing outstanding Yellowknife land issues to be resolved."

# **Barren-ground Caribou Survey Results Released**

**YELLOWKNIFE** (September 13, 2005) – Results from a July 2005 survey show a decline in populations of the Cape Bathurst, Bluenose West and Bluenose East caribou herds. The results were presented to the Wildlife Management Advisory Council (Northwest Territories) at meetings in Whitehorse on September 10th and 11th.

The photo census survey, completed in July, 2005 shows that the three barren-ground caribou herds, harvested mainly by hunters in the Inuvik and Sahtu regions of the Northwest Territories, have declined from peak numbers observed last decade.

- The Cape Bathurst Herd has declined from an estimate of 17,500 in 1992 to an estimated 2,400 in 2005.
- The Bluenose West Herd has declined from an estimate of 98,900 in 1987 to an estimated 20,800 in 2005.
- The Bluenose East Herd has declined from an estimate of 104,000 in 2000 to an estimated 66,600 in 2005.

Environment and Natural Resources (ENR) Minister Michael Miltenberger stated, "The Government of the Northwest Territories (GNWT) is working closely with co-management boards to develop and implement management and action plans."

Presentations to co-management boards and affected communities will occur throughout September and will also include the Sahtu and Gwich'in Renewable Resources Boards.

ENR Technical Support Manager Dr. Ray Case says, "The observed declines were not unexpected as declines have also been observed in the neighbouring Porcupine and Bathurst caribou herds and the caribou herds tend to increase and decrease in size together. Working with the co-management boards to identify and implement management options is the first step towards ensuring sustainability of the herds."

Minister Miltenberger added, "The GNWT will continue to work with all our partners to ensure the herds stay healthy, viable and able to meet the needs of harvesters today and in the future."

## **Agreement Expands National Highway System in NWT**

YELLOWKNIFE (September 29, 2005) - Transportation Minister Michael McLeod says an agreement reached at a national transportation meeting in Calgary made 847 more kilometres of Northwest Territories (NWT) highways part of the National Highway System (NHS).

"I'm extremely pleased we have been able to expand the NHS within the Northwest Territories," Minister McLeod said today after returning from a meeting of the Council of Ministers Responsible for Transportation and Highway Safety. "Besides creating the potential for funding opportunities, this agreement is also significant as our highways are now being recognized for their role in connecting people and places which helps economic and community development occur."

A total of 1,423 kilometres of highways in the NWT are now part of the National Highway System, an increase from the previous 562 kilometres.

The meeting also provided an opportunity to discuss a number of other issues important to the NWT. Minister McLeod received a positive response from federal Transportation Minister Jean Lapierre when he raised the fact more large commercial aircraft are flying through the territory's skies on polar routes, an issue of concern to the NWT. Minister McLeod noted that as those numbers grow so does the likelihood that some larger aircraft may be forced to make emergency landings at NWT airports. Minister McLeod reported that Minister Lapierre has agreed on the need for future discussions on the issue.

Development of a National Transportation Strategy, as requested by premiers at the recent Council of the Federation meeting, was high on the list of issues Minister McLeod brought forward for discussion. The NWT, British Columbia and Nova Scotia have taken the lead on behalf of all provinces and territories to develop a comprehensive national strategy that would include all regions and all modes of transportation.

"Development of a National Transportation Strategy can be the impetus to complete connecting Canada from coast to coast to coast, while also addressing needs such as northern security and sovereignty," said Minister McLeod. "I hope this process will identify options for a long-term, sustainable national transportation infrastructure program that, not only recognizes the unique needs of our various regions but also, considers nation-building strategic objectives."

Minister McLeod said he believes construction of an all-weather highway up the Mackenzie Valley and across to Tuktoyaktuk on the Arctic coast should be considered one of Canada's priority projects.





# Community Capacity Building Fund Immediately Available

**Yellowknife** (November 2, 2005) – Funding associated with the Community Capacity Building Fund is in place and available to all Northwest Territories communities, announced Michael McLeod, Minister of Municipal and Community Affairs.

"This one-time funding of \$35 million is intended to assist communities in their efforts to advance their unique priorities respecting community capacity building," said Minister McLeod. Once community proposals have received funding approval from Municipal and Community Affairs, the Department will enter into a contribution agreement with the community government that will allow one-time funding allocations to be drawn down at any time over the next three fiscal years (2005-2006 through 2007-2008). ### Beverage Container Program Offers Cash for Your Trash

**Yellowknife** (November 1, 2005) – As of today residents of the Northwest Territories (NWT) will be able to return their empty beverage containers to the nearest community depot for recycling.

Eleven community depots have been licensed to accept beverage containers beginning in November. The community depots are located in Behchokō, Fort Resolution, Nahanni Butte, Gamèti, Trout Lake, Lutselk'e, Yellowknife, Hay River, Inuvik, Fort Smith and Fort Simpson. Three regional processing centres (located in Yellowknife, Hay River and Inuvik) will also be operating in November.

Environment and Natural Resources Minister, Michael Miltenberger, said today, "Together, these depots will serve over 80 percent of the population. Our work to license additional depots continues. I have made a commitment that every resident in the Northwest Territories will have the opportunity to return their empty beverage containers for a refund in the community in which they live."

Ready-to-serve beverage containers such as glass, plastics, aluminum, metals, waxed cardboard, and mixed materials such as juice boxes are all included in the Beverage Container Program, including juice, pop, bottled water, beer, wine, liquor and other alcoholic beverages.

Milk, milk substitute, flavoured milk, yogurt drinks, infant formula, rice milk, and soy milk containers are not included in the program.


Consumers will receive their deposit of either \$.10 or \$.25 for each container they return to the nearest depot.

The Beverage Container Program was developed to deal with the 25 million containers that end up in community landfills or as litter along our streets and highways each year. "That is over 500 beverage containers for every man, woman and child in the NWT," commented Minister Miltenberger. "Not only will this program increase the lifespan of our community landfill sites, it will also reduce litter and help to reduce greenhouse gas emissions because it takes less energy to produce things from recycled materials than from raw materials. The Government of the Northwest Territories has made the commitment to reduce greenhouse gasses and this is another step in that direction."



## GOVERNMENTS OF CANADA AND THE NORTHWEST TERRITORIES TO FUND INTELLIGENT TRANSPORTATION SYSTEMS

YELLOWKNIFE — The Honourable Ethel Blondin-Andrew, Member of Parliament for Western Arctic and Minister of State (Northern Development), on behalf of Transport Minister Jean-C. Lapierre and Michael McLeod, Minister of Transportation for the Northwest Territories, today announced the signing of two contribution agreements to develop and deploy intelligent transportation systems in the Northwest Territories. Combined funding for the agreements totals \$700,000.

"This funding will help address the transportation needs of local residents and travellers to our region," said Ms. Blondin-Andrew. "The selected projects will provide better access to travel-related information and make travel across the Deh Cho Bridge more accommodating for commercial traffic."

The first agreement is for intelligent transportation systems research and development projects. The two governments will each contribute up to \$250,000. One of the projects is to develop and design an electronic tolling system at the Deh Cho Bridge located over the Mackenzie River, near Fort Providence. The remaining funds will be used to design and develop a new website for the Department of Transportation that incorporates intelligent transportation systems such as interactive traveller information.

Under the second agreement, the governments of Canada and the Northwest Territories will each contribute up to \$100,000 to deploy intelligent transportation systems in the territory. One project will see an automated traveller information system and baggage information display signs deployed at Yellowknife Airport at a total cost of \$115,428. The governments of Canada and the Northwest Territories will each contribute \$57,714. The system will provide automated real-time flight information within the terminal building and over the Internet. The remaining joint funding will be applied towards similar intelligent transportation systems in the territory. Intelligent transportation systems consist of a broad range of technologies designed to make transportation safer, more efficient and environmentally friendly.

"These projects demonstrate the government's commitment to making sure Canadians benefit equally from new technologies," said Mr. Lapierre. "By supporting innovation in every province and territory, we are helping to build a better transportation system for all of Canada."

"Modern technology offers new and exciting ways to expand and improve upon the way we communicate with and serve the public, industry and others that rely upon the transportation system in the Northwest Territories," said Mr. McLeod. "These projects will provide convenient access to useful information and transactions that relate directly to improved safety and efficiency."

Federal funding will be provided under the Strategic Highway Infrastructure Program, a \$600-million program to improve highway infrastructure across Canada. Part of this funding, \$100 million, is earmarked for initiatives that better integrate the country's transportation system. One of these is the intelligent transportation systems initiative, which includes applications such as advanced systems for traveller information, traffic management, public transport, commercial vehicle operations, emergency response management and vehicle safety.



Funding for this program is provided for in the existing financial framework.

### **INTELLIGENT TRANSPORTATION SYSTEMS**

Intelligent transportation systems are a broad range of diverse technologies used to make transportation systems safer, more efficient, more reliable and more environmentally friendly, without necessarily having to physically alter existing infrastructure. Since 1999, Transport Canada has been promoting them aggressively and has provided more than \$23 million in support of intelligent transportation systems projects and research in Canada.

Intelligent transportation systems encompass new products and information and communications technologies for the development, operation and management of the transportation system. They include applications such as advanced systems for traveller information, traffic management, public transport, commercial vehicle operations, emergency response management and vehicle safety. They all have in common the integrated application of advanced technologies including information processing, communications, and sensing and control.

The Government of Canada's Intelligent Transportation Systems Plan for Canada: En Route to Intelligent Mobility (1999) sets out the strategy for stimulating the development and deployment of intelligent transportation systems across urban and rural Canada. The goals are to maximize the use and efficiency of existing infrastructure and meet future mobility needs more responsibly. The Intelligent Transportation Systems Plan provides leadership and support to advance the application and compatibility of intelligent transportation systems technologies and to increase the safety, integration, efficiency and sustainability of Canada's transportation system.

Federal funding is provided under the Strategic Highway Infrastructure Program, a \$600-million program to improve highway infrastructure across Canada. Announced in April 2001, the program has two components, a \$500-million highway construction component and a \$100-million national system integration component, of which \$30 million is designated to fund intelligent transportation system initiatives.

- People participating fully in society



# GNWT Applauds US House of Representatives Decision on ANWR

**Yellowknife** (November 10, 2005) – The Government of the Northwest Territories (GNWT) is welcoming a recent decision by the United States House of Representatives to drop a provision from their budget reconciliation bill that would have allowed oil drilling in the Arctic National Wildlife Refuge (ANWR).

"This is very welcome news for all Canadians," Premier Joe Handley said today. "We applaud the efforts of the Government of Canada and the Gwich'in to vigorously oppose oil and gas exploration and development in ANWR."

ANWR is home to part of the calving grounds of the Porcupine caribou herd, a valued resource of the Gwich'in people.

"As Prime Minister Martin stated earlier today, a number of hurdles still remain," added Premier Handley. "We will continue to support the Government of Canada, the Porcupine Caribou Management Board and Gwich'in representatives in their efforts to convince US politicians and bureaucrats that permanent protection for ANWR is required."

The United States House of Representatives dropped the budget provision, which would have allowed for oil drilling in ANWR, yesterday because of a fear it could jeopardize approval of the entire budget bill.

# INAC AND GNWT ANNOUNCE \$2 MILLION INVESTMENT IN GEOSCIENCE IN THE NORTHWEST TERRITORIES

YELLOWKNIFE, NORTHWEST TERRITORIES (November 15, 2005) - The Honourable Ethel Blondin-Andrew, Minister of State (Northern Development) Indian and Northern Affairs Canada (INAC) and the Honourable Brendan Bell, Minister of Industry, Tourism and Investment, Government of the Northwest Territories, are pleased to announce a \$2 million investment in geoscience activities in the NWT this year under the \$90 million dollars for Strategic Investments in Northern Economic Development announced in the 2004 Federal Budget.

"Our government is pleased to offer funding that supports geoscience projects and scientific data collection in the NWT," said Minister Blondin-Andrew. "This will enhance geoscience knowledge throughout the territory and stimulate interest in the North."

The funds will be used to support a variety of projects in 2005 and early 2006 that will meet the needs of communities, industry, geologists, investors and all residents of the North. Projects, identified in consultation with the NWT's Geoscience Advisory Committee, are designed to stimulate new exploration and associated economic activities in the North. Projects underway include: an airborne magnetic survey that will fill a gap in publicly available data; a new data management and distribution system that will provide improved web services and access to data; and a bedrock mapping project that will enhance exploration activities. Additional projects to enhance geoscience knowledge in the NWT have also been identified and are being co-ordinated.

"The commitment of this funding underpins the importance of geoscience as the foundation for resource development," Minister Bell noted. "The information provided by scientific research attracts and focuses exploration - in turn stimulating mineral and oil and gas development - but it all begins with the prospector."

Geoscience and economic development projects such as these are an integral part of the Government of Canada's commitment to an evolving strategy for the North. The Government of Canada is committed to working with Northerners to ensure they can capitalize on the exciting opportunities in Canada, North of 60.

### Backgrounder

The Government of Canada and the GNWT recognize the importance of geoscience information to the Northwest Territories and are committed to enhancing the NWT's geoscience knowledge base. This funding will leverage resources from industry and Canada's academic community, and will stimulate private sector investment in the resource exploration sector.

Geoscience has historically stimulated private expenditures and supports sustainable economic growth and diversity. Geoscience is also used in planning physical infrastructure – suitable locations for roads and bridges, power transmission and communications lines, aids in the identification of areas for parks and tourism, is used by Aboriginal governments for regional and community land use planning, and helps to mitigate risks of naturally occurring metals in the environment.

Indian and Northern Affairs Canada's (INAC) Strategic Investments in Northern Economic Development (SINED) programming set is aimed at establishing strong foundations for economic development. This initiative has a number of program elements, one of which is called the Targeted Investment Program (TIP). This program is being used to guide the investment of the \$90 million announced in Budget 2004 for northern economic development. TIP has four main investment areas: building the knowledge base; enhancing the infrastructure base; increasing northern capacity; and economic diversity.

The overall objectives of the programs under the SINED are to: strengthen the sectors driving the economy; broaden the economic base of each territory by enhancing sectors that can show strong economic returns; strengthen the ability of northerners to participate in local, national and international economic opportunities; and increase coordination amongst partners and programs

Geoscience is a priority investment area and the long-term strategy includes a variety of projects: regional bedrock mapping, airborne geophysics, till sampling and specialty research. These projects will fill in geological gaps where there is little or no research, produce integrated maps of large areas and improve accessibility to new and existing data.

The 2004 Federal Budget announced \$90 million over five years for northern economic development. In order to maintain momentum on current and emerging economic development opportunities, funds were made available in each territory during 2004-2005, while the Government of Canada continued work with key economic players to identify priorities and develop territory-specific investment plans for the longer term. A variety of projects form part of INAC's new fund for northern economic development. Work continues to build the longer term framework that will guide investments until 2009.

### **NWT Passenger, Air Traffic Grows Sharply in 2004**

YELLOWKNIFE (November 17, 2005) – Passenger and air traffic at the six largest airports in the Northwest Territories rose sharply in 2004 on the wings of a surging economy.

The annual NWT Airport Statistics Report from the Department of Transportation says air traffic, measured by the number of arriving and departing flights, grew by seven per cent last year, while passenger traffic experienced growth of eight per cent.

The department says Yellowknife, Inuvik, Norman Wells, Fort Smith, Hay River and Fort Simpson saw a total of 93,003 aircraft arrive or depart last year, up from 86,600 in 2003 and 81,196 in 2002.

Yellowknife Airport, the busiest airport in the NWT, registered the largest increase from 40,548 to 44,065, a difference of nine per cent. However, the greatest percentage increase belonged to Norman Wells Airport, where aircraft movements went from 14,078 in 2003 to 15,754 last year, 12 per cent higher.

Fort Simpson experienced seven per cent growth. Traffic there increased from 2,853 to 3,061. The level of aircraft activity in Fort Smith Airport in 2004 was six per cent higher than the previous year, 7,751 compared with 7,322.

The 2004 total in Hay River was 6,341, three per cent higher than the 6,150 arrivals and departures in 2003. The airport in Inuvik was also busier last year. The traffic total there increased from 15,649 to 16,031, a two per cent change.

Meanwhile, the total number of passengers who either arrived or departed at the six airports is estimated at 509,900, an eight per cent increase over the 2003 figure of 473,400.


Yellowknife led the way with an estimated 348,800 passengers, up from 320,000 in 2003. Inuvik handled 57,426 passengers, 1,126 more than the year before. In Norman Wells, the total went from 42,900 to 48,048, from 20,900 to 22,154 in Fort Smith, 27,000 to 27,810 in Hay River and from 6,300 to 6,741 in Fort Simpson.

"This significant increase in the level of activity within the aviation industry is indicative of the type of traffic growth being witnessed across all sectors of transportation in the Northwest Territories," said Transportation Minister Michael McLeod. "Strong economic growth and sustained resource exploration and development mean we can expect corresponding increases in passenger and air traffic will continue."

### GNWT SUPPORTS THE MACKENZIE GAS PROJECT

YELLOWKNIFE (November 23, 2005) – Premier Joe Handley and Finance Minister Floyd Roland are offering strong encouragement to industry to proceed to the public hearings phase of the environmental assessment and regulatory process for the Mackenzie Gas Project. The Premier and Minister Roland sent a letter of support to the project proponents confirming the intentions of the Government of the Northwest Territories to develop a stable fiscal regime for the project.

"Considering the size of the investment – an estimated \$7 billion – it is understandable industry would want some level of assurance that governments are not going to change the rules substantially once the investment is made," said Minister Roland. "This letter clearly communicates our intention to work with industry and the federal government to ensure the Mackenzie Gas Project (MGP) proceeds."

Imperial Oil Resources Ventures Limited, as the lead proponent for the development of the MGP, has stated that progress on access and benefits agreements with Aboriginal organizations, and some assurances regarding the project's fiscal regime, are required before making the decision to proceed to the public hearings phase of the regulatory process.

The GNWT continues to call on the federal government to address the related issue of resource royalty sharing. The federal government has a responsibility to ensure the people of the Northwest Territories will benefit fairly from revenues generated from this important project. This is a fundamental principle that the Prime Minister has recognized in other agreements such as the Newfoundland and Labrador and Nova Scotia Offshore Accords.

"A fair devolution and resource revenue sharing agreement with the federal government will bring Northerners the fiscal certainty required as we move ahead", said Premier Handley, "It is critical the federal government recognize and address our situation and negotiate a fair agreement ensuring Northerners benefit from revenues generated from resource development in the Northwest Territories. In the meantime, we need to manage the areas we do control to ensure a secure economic future and an environmentally responsible project for northern people and governments."

The federal and territorial governments exercise control over the royalty regime for the MGP, and discussions with between government and industry were initiated earlier this year. The GNWT's letter to industry outlines the GNWT's intention to work towards a memorandum of understanding regarding the current and post-devolution royalty regime for the project. Key to achieving this memorandum is the analysis of all potential fiscal scenarios for the MGP, including those in a post-devolution scenario.

### Mackenzie Gas Project Fiscal Assurances

As you know, the Government of the Northwest Territories (GNWT) has been meeting with your representatives to discuss ways the GNWT can increase certainty for your respective companies regarding the development of the Mackenzie Gas Project (MGP) in the Northwest Territories (NWT), as described in your Environmental Impact Statement filed with regulatory authorities.

The opening of the Mackenzie Delta and Valley to development has the potential to provide your companies with economic opportunities for years to come. However, the GNWT recognizes that there are additional risks associated with the initial, capital-intensive investment in a greenfield development such as the MGP.

The GNWT also recognizes that the development of the Mackenzie Gas Project will provide substantial benefits for the NWT and Canada, providing potential adverse impacts are adequately mitigated. From the outset, including the creation of the Aboriginal Pipeline Group in 2000, the GNWT has been supportive of the MGP and has always taken a cooperative approach with your companies.

In the spirit of this cooperation and in consideration of the size of the investment and the associated risks, the GNWT recognizes the need to promote a stable and secure fiscal environment for the development and ongoing operations of the MGP. It is not the intention of the GNWT to introduce or support any new, targeted tax or royalty changes (post-devolution) that would negatively impact project economics for the MGP.

For the GNWT to follow through on these intentions, there are some unique factors that need to be considered. As you know, for northerners to fully realize the benefits of development, a fair deal on devolution of authority over lands and resources, and a resource revenue sharing agreement, is required between the government of Canada, the GNWT and NWT Aboriginal governments. In the absence of such an agreement, it is important that the GNWT understand the implications of any new arrangements that might be developed between Canada and your companies regarding the fiscal environment for the MGP.

However, based on the premise that information will be shared, and in the interests of offering your companies strong encouragement to proceed to the next phase of the regulatory process for the MGP, the GNWT can confirm its intention to develop the following principles in a memorandum of understanding to be developed over the coming months:

- 1) It is the intention of the GNWT to maintain a post-devolution royalty regime for the three anchor fields of the MGP that would not exceed the royalty burden of the regime as currently defined in the *Canadian Petroleum Resources Act*.
- 2) It is not the intention of the GNWT to increase property taxes with respect to the MGP's assets disproportionately to property taxes payable on similar properties in other regions of Canada.

3) It is not the intention of the GNWT to impose any other tax or fiscal measure that would have the effect of directly targeting the MGP operations and facilities due to its limited scope of application.

With respect to the filing of corporate income tax, the GNWT is committed to working with you to determine fair and equitable arrangements for the allocation of these taxes by end of June 2006.

With respect to current and future property taxes, the authority may not be directly within the jurisdiction of the GNWT, but we do not believe that your companies should have any concerns. The current fiscal and royalty regime in the NWT is very competitive. It is in the interests of all northern governments to remain competitive and to provide a stable, predictable fiscal environment.

With respect to the property taxes that could be levied on the estimated 3% of the pipeline length that would fall within municipal boundaries, many of our municipalities have a long history of dealing responsibly with industry.

Also, property taxation on public lands outside municipalities has not been a matter for negotiation of Aboriginal self-government agreements and it is not the intention of this Government to change this approach. The need to maintain a coordinated, harmonized tax system across the NWT is a key principle in this Government's approach to negotiating self-government agreements. We also need to recognize that the Government of Canada is a key party to the negotiation of Aboriginal self-government agreements.

The GNWT will endeavor to ensure that future devolution agreements will honour commitments made by Canada with respect to the MGP, provided a collaborative approach that includes the GNWT is taken in arriving at those commitments.

The GNWT is confident that though our cooperative working relationship with your companies, we can provide you with assurances that the GNWT is committed to promoting a stable and predictable fiscal and royalty regime for the MGP. However, any commitments are subject to the plenary legislative authority of the NWT Legislative Assembly.

To be clear, nothing in this letter should be construed as fettering any discretionary power conferred. In addition nothing in this letter constitutes a legally binding commitment or obligation of the GNWT or confers any right on your companies.

Finally, although it is necessary for this letter to presume the MGP will receive the essential regulatory approvals, nothing in it should be construed as prejudicing the position of the GNWT or fettering the discretion of any official in any regulatory process.

# **GNWT Releases New Proposal for Transportation Infrastructure Funding**

YELLOWKNIFE (November 29, 2005) — The Government of the Northwest Territories (GNWT) released two funding proposals today that seek more federal investment for projects that would both strengthen the territory's existing highway system and extend the Mackenzie Valley highway to the shores of the Artic Ocean.

Connecting Canada: Coast to Coast and Corridors for Canada II: Building on Our Success were made public by Transportation Minister Michael McLeod, whose department developed the two proposals with projects worth an estimated \$862 million in total.

"Together, these proposals address both the current, critical needs of our struggling highway system and offer a realistic plan to make our territory and our nation stronger and more prosperous by completing the missing link in a highway system," said Minister McLeod. "They have the combined potential to dramatically change the state and the extent of the territory's transportation infrastructure.

Corridors for Canada II addresses the urgent need to spend \$162 million on the existing highway infrastructure to meet the growing demands being placed on it by resource development and a rapidly expanding economy. It follows and updates the original Corridors for Canada proposal that was submitted to the federal government in 2002. The outcome was \$130 million in joint funding from the GNWT and the Government of Canada through the Canada Strategic Infrastructure Fund (CSIF).

The GNWT has used that money to improve the Liard, Mackenzie, Dempster, Yellowknife and Ingraham Trail highways and to carry out grade improvements and construct permanent bridges on the Mackenzie Valley Winter Road.

"We are proud of what has been accomplished, in partnership with the Government of Canada, through the first *Corridors for Canada* proposal," said Minister McLeod. "That significant investment has increased safety, capacity and reliability of the territorial transportation system."

"However, since the first funding proposal was developed in 2002, the extent of resource development and the corresponding pressures on the transportation system continue to increase," he said.

He said the new proposal not only identifies the ways in which the Northwest Territories and its residents would benefit from more improvements to the transportation system, but also how all of Canada stands to gain from resource developments in the North.

"All Canadians will benefit from expanding infrastructure partnerships and improving Canada's transportation corridors," Minister McLeod added.

Connecting Canada is an imaginative, \$700 million proposal to complete the all-weather highway down the Mackenzie Valley from Wrigley to Tuktoyaktuk on the coast of the Arctic Ocean.

"It's a project whose time has come," Minister McLeod said.

The project would consist of a number of different pieces, including an all-weather road from Inuvik to Tuktoyaktuk, extension of the all-weather road from Wrigley to the Dempster Highway south of Inuvik, and improvements to the existing Mackenzie Highway.

"This highway would serve the interests of Northerners and Canadians in many ways," the minister said. "Resource development along the Mackenzie Valley and in the Beaufort Delta, northern sovereignty, emergency response, economic and social development, and our capacity to adapt to climate change would all be positively affected."

# Safer Heating: The Office of the Fire Marshal and the City of Yellowknife Advise Caution when Using Space Heaters

YELLOWKNIFE (December 7, 2005) – Advice to use extreme caution when using space heaters to help heat your home or outbuildings this winter, was offered today by the Office of the Fire Marshal and the City of Yellowknife Fire Division. According to the National Fire Protection Association (NFPA) supplemental heating equipment, such as electrical and kerosene heaters, is the leading cause of home fires during the months of December, January and February and is second only to cooking equipment as the leading cause of home fires year-round.

"As heating costs rise in the Northwest Territories, residents are looking for alternative methods to heat their homes. It is important to remember a few safety precautions when using space heaters," says Bernie Van Tighem, Fire Marshal for the Northwest Territories. "Caution should always be used with space heaters, and manufacturers' directions and the National Fire Code should always be followed."

### Safety Tips and Precautions When Using Space Heaters

The City of Yellowknife Fire Division and the Office of the Fire Marshal offer the following safety tips and precautions when using space heaters:

- Space heaters have one function to provide supplemental heat. They should not be used to warm bedding, cook food, thaw pipes or dry clothing. Misusing space heaters can put you and your family at risk of fire or burn injuries.
- Select heating equipment that has the Underwriters Laboratories of Canada (ULC) or the Canadian Standards Association (CSA) mark. The ULC or CSA mark on a product means that ULC or CSA technical staff members have tested or certified representative samples of the product for foreseeable safety hazards.
- Remember the safety zone. Keep things that burn away from space heaters.
- Turn off space heaters when you are not in the room or when you go to sleep.
- Supervise children and pets at all times when space heaters are in use. Even the slightest contact with a heating coil or element can cause a severe burn.
- If you have an electric space heater, check for frayed insulation, broken wires or overheating. All related problems should be repaired by a professional technician before operating.
- When buying space heaters, look for devices with automatic shut-off features and heating element guards.
- Use only the fuel recommended by the manufacturer in liquid-fuelled space heater. Never use gasoline or any other substitute fuel. The wrong fuel could burn hotter than the equipment's design limits and cause a serious fire.
- When refuelling, turn off the heater and let it cool down completely before adding fuel. Wipe up any spills promptly.
- When considering buying a kerosene heater, check with the Fire Department or the Office of the Fire Marshal to find out if it is legal in your community.
- Avoid using extension cords with space heaters. If you must use one, make sure you
  choose an extension cord of the right wire gauge size and type for your heaters.
- Keep the air heater's power supply cord away from high-traffic areas in your home in order to avoid people walking on or tripping over the cord.

Space heaters designed for home use, while seemingly harmless, are responsible for 2600 fires and 130 deaths annually in North America. These heaters are not substitutes for central heating, and they are not all designed for extended use.

Space heaters designed for industrial use also have specific installation and use requirements.

- Be sure to follow manufacturers' instructions and the National Fire Code.
- Always have a qualified electrician install these devices.
- Ensure your heater is rated for the job it is to perform.
- If your heater over limit switch is triggered and the unit shuts down, have a qualified electrician inspect it, as this is a sign of abnormal operation.
- Ensure that the appropriate clearances are provided for the unit. Clearances are vitally
  important to ensure surrounding combustibles do not heat up over time making them
  more susceptible to ignition.

# Fire Marshal's Order Regarding the Closure of the Pinecrest Hotel in Fort Smith

YELLOWKNIFE (December 7, 2005) – The Office of the Fire Marshal has deemed the Pinecrest Hotel a high-risk building that cannot be protected by the existing fire protection and response systems and on December 2, 2005, issued an Order to close the building immediately. In the event of a fire, there is little opportunity for residents to evacuate the building safely, particularly those residents with mobility issues. In addition, due to the condition of the building, it is unsafe for fire fighters to enter the building to fight a fire.

The Pinecrest Hotel is therefore extremely unsafe and presents a significant risk to the life safety of residents. The infractions discovered during an inspection of the Pinecrest Hotel by the Assistant Fire Marshal on November 30, 2005, initiated as a result of concerns raised by the Fort Smith Volunteer Fire Department, include:

- A lack of a functioning alarm system;
- Uncertainty regarding the proper functioning of the sprinkler system;
- Missing structural fire separations (walls, ceilings and floors that meet required fire resistance ratings) intended to restrict the spread of fire and smoke;
- Missing stairs and blocked exits throughout the building;
- Improper storage of combustible materials throughout the building; and
- The building was being heated by burning scrap and other inappropriate materials in a wood-burning furnace.

Social service agencies in Fort Smith, along with relevant GNWT Departments, are coordinating their efforts and are working to identify the support needed for affected residents.

The Office of the Fire Marshal has provided the owner of the building with precise instructions as to actions the building owner must take before the conditions of the order will be reconsidered. The Fire Marshal will be in Fort Smith December 7 and 8 and will be available to meet with the building owner, displaced residents and other impacted stakeholders at that time.

The Office of the Fire Marshal is charged under the *Fire Prevention Act* to enforce codes and standards related to fire and life safety. Where a demonstrated risk to life safety exists, the Fire Marshal can issue an order requiring changes or renovations to a building, building closure or building demolition.

### **NWT Traffic Accidents, Injuries Drop in 2004**

**YELLOWKNIFE** (December 7, 2005) – The number of traffic accidents and injuries in the NWT dropped slightly in 2004 despite an increase in the number of vehicles and drivers.

The Department of Transportation's 2004 Traffic Collision Facts report says there were a total of 798 collisions on the territory's roads that year, 2.6 per cent fewer than the 819 recorded in 2003. The number of collisions in which people were injured decreased to 113, 13.1 per cent fewer than the 2003 total of 130. The 2004 number is the lowest in 16 years.

The number of people injured went from 172 in 2003 to 151 last year, a difference of 12.2 per cent. Collisions claimed the lives of three people both years.

The number of collisions involving alcohol also declined. In 2004, there were 50, four less than 2003. Overall, alcohol was a factor in six per cent of collisions, about the same as in 2003.

The department also says that drivers between the ages of 15 and 19 had almost twice as many collisions as other drivers. On average, nine per cent of drivers 15-19 were in a collision, compared with three per cent of drivers 35 to 44 years of age.

Statistics from last year also point to the value of wearing a seat belt. Only seven per cent of accident victims wearing seat belts were injured, but that number jumped to 20 per cent for anyone who didn't buckle up.

Year-over-year totals also showed a 3.3 per cent increase in the number of registered vehicles in the territory during 2004. The total was 33,642 in 2004 and 32,567 the previous year. The number of licensed drivers also grew by 5.4 per cent to 30,958, compared with 29,368 in 2003.

Based on a Transport Canada method for estimating economic costs related to collisions, the department says the NWT figure for 2004 amounted to \$11.6 million, down from \$11.9 million in 2003.

"It's encouraging to see positive developments in the area of highway safety," said Transportation Minister Michael McLeod. "Government, working with police, agencies and concerned individuals, will continue to look at ways by which we can make our roads as safe as possible."


"Trapping has become a necessary last resort because other attempts to control the increasing coyote population have been unsuccessful," Airport Manager Michel Lafrance said today. "Coyotes on the runway pose a safety risk to aircraft during takeoff and landing,"

Renewable Resource Officers with the Department of Environment and Natural Resources will set traps inside the airport fence only, Mr. Lafrance said. They are expected to be in place by Monday, December 12.

He said warning signs will be posted along the fence and that anyone walking pets near the 575-hectare property should keep their animals on a leash. Any animals other than covotes caught in the traps will be released.

## Hunters Asked to Participate in the Bathurst Caribou Herd Monitoring Program

YELLOWKNIFE (December 13, 2005): Staff at the North Slave Regional office of Environment and Natural Resources (ENR) are asking for help from Northwest Territories (NWT) hunters through their participation in a monitoring program that samples harvested barren-ground caribou.

"Caribou are a way of life in the North, both traditionally and economically and by monitoring the health of animals from the Bathurst herd, we will continue to learn more about the herd and NWT caribou in general," said ENR Minister, Michael Miltenberger.

The North Slave Regional office is providing data collection kits, which include a sample bag, ruler, marker, pencil and a data sheet for the harvesters to fill in. Hunters are asked to collect the kidney and any fat surrounding it, in addition to taking a measurement of the amount of back fat on the caribou.

"For example, we're looking at the amount of fat on the kidney, which, when studied with other indicators, is an excellent barometer of the overall condition of the animal," said Caribou Monitoring Programs Technician, Dave Abernethy. "We are asking harvesters to record information about the condition of harvested caribou, as well as some general observations of the caribou in the group. This information, combined with field studies, will help us to understand the overall health and condition of the caribou herd."

Community hunts and the outfitting industry are also participating in the monitoring program. Resident hunters interested in participating in this study are asked to drop into or call the North Slave Regional Office at 873-7184.



As Northern Premiers, we have been working hard on a number of issues we believe are not just of great importance to the people of Yukon, Northwest Territories and Nunavut but will have significant implications for all Canadians as we work towards building a stronger Canadian Federation.

In that regard, we ask that as national party leaders you use the opportunity of the current federal election campaign to make clear to Northerners, and all Canadians, your views on the following matters:

1) Adequacy of funding for programs in the North: As you know the federal government has, as recently as the November First Ministers' Meeting on Aboriginal issues, recognized the unique circumstances in the North in terms of the higher cost of providing services to our residents. The need to provide a base amount plus per capita to territories is well understood and supported by all jurisdictions. The Council of the Federation, which includes all of Canada's premiers, has also taken the position that the current interim Territorial Formula

Financing arrangements no longer takes into account the difference between the expenditure needs and the revenue means of the territorial governments.

Recent failed attempts to come to an agreement on funding of the Early Learning and Child Care initiative in the North is a good example of how Northerners may be left out of a program because of Canada's insistence on a per-capita approach to funding that will not meet the unique costs and circumstances we face in meeting the developmental needs of a young and vulnerable population.

- 2) Strategy for northern development: Much work has been done in the North to advance our common goal of developing a comprehensive strategy for building capacity, building healthier communities and building the Northern economy so that we can fulfill our tremendous potential. We believe it is essential to the people of the North that the territories and Canada move ahead with a common vision for the North and look forward to discussing how you and your parties might proceed with the development of this vision.
- 3) Devolution and land claims: As you know, the three territories are at different stages of development in terms of devolution of responsibilities, completion of land claims and implementation of self-government agreements. We have been supportive of each others' efforts in all of these areas including the completion of an Agreement in Principle on Devolution and Resource Revenue Sharing for the NWT, the commencement of Devolution talks with Nunavut by the end of the year, the completion of the three outstanding land claims and the appropriate implementation of final and self-government agreements in the
- 4) Outcomes of the recent First Ministers' Meeting on Aboriginal issues: Significant progress was made at this meeting and we would like to know whether you intend to follow through on commitments made in Kelowna, including Canada's important recognition and acknowledgement that there are unique circumstances in the North and that measures be taken to ensure that the territories can benefit from any programs or initiatives developed as a result of the great work done at the FMM.

These issues are as complex as they are important to the North. We look forward to your reply and, in the interest of providing northern voters with as much information as possible, we are pleased to make public your responses.
