Standing Committee on Legislation:

Terms of Reference:

The Standing Committee on Legislation shall:

- a) examine such matters as may be referred to it by the Legislative Assembly;
- b) review all bills and legislative action papers referred to the committee;
- c) examine all orders, regulations or statutory instruments issued by the regulation-making authority;
- d) examine any other matters of a legislative nature as determined necessary by the Standing Committee; and
- e) establish its quorum to be five Members including the Chair

BILL 16 - AN ACT TO AMEND THE ARCTIC COLLEGE ACT

The Standing Committee on Legislation has met to begin its review of Bill 16, An Act to Amend the Arctic College Act.

During our initial meeting to review this Bill, it became apparent that this piece of legislation will require greater scrutiny. Many problems and concerns arose in our initial deliberations, and the Committee feels that more time will be required to review this amendment, than the 5th session will permit.

Therefore, the Committee would like to advise this Assembly, that we will not complete our review of this Bill before the prorogation of the 5th session. The government may wish to re-introduce this Bill in the 6th Session in April so an adequate review by this Committee can be delivered during that session's adjournment.
