

STATUTORY DECLARATION OF RESIDENCE

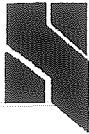
CANADA ) I, Michael Miltenberger, of the Town
NORTHWEST TERRITORIES ) of Fort Smith, in the Northwest,
TO WIT ) MAKE OAT THAT SAY AS FOLLOWS:

- 1. That I am aware of the meaning of "residency" with respect to the requirement of a Statutory Declaration of residence in connection with a Member's request to receive the Capital Accommodation Allowance under the Legislative Assembly and Executive Council Act.
2. That residency respecting this matter means the place at which a Member ordinarily resides when he or she is not required to be in Yellowknife for Sessions of the Legislative Assembly or meeting of its Committees.
3. That my place of ordinary residence is 102 Wilderness Road, Fort Smith, Northwest Territories and that I was ordinarily resident at that address on October 20, 2006.
4. That I own the property at this address and when I am not required to be in Yellowknife for Sessions of the Legislative Assembly or meetings of its Committees, this is the place at which I normally reside, sleep, prepare meals and maintain my furniture and personal effects.
5. That my spouse resides at the above address with me.
6. That I consider my home at 102 Wilderness Road, Fort Smith, NT to be my home and when I refer to "home" I am referring to this place of residence.
7. That I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath, and knowing that improperly being in receipt of the Capital Accommodation Allowance can constitute a criminal offence.

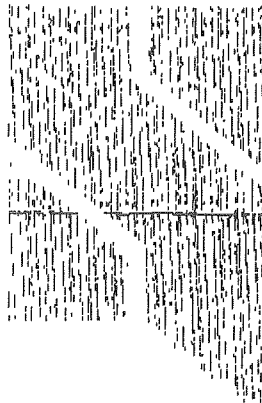
