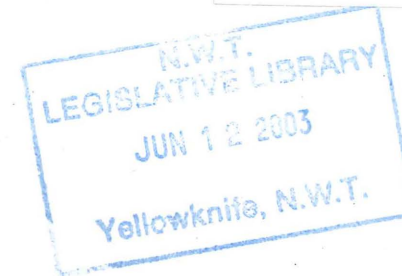

- (5) CAPITAL LIVING ALLOWANCE: Annual figure of \$6,027 for Members who live within commuting distance of Yellowknife; \$9,315 for all other Members; Ministers are considered to live in Yellowknife and receive \$6,027.
