RESOLUTION NO. 1  
DOGRIB TREATY 11 COUNCIL  
FIRST ASSEMBLY  
RAE, N.W.T.  
AUGUST 24TH - 28TH 1992

DOGRIB NATION CLAIM

WHEREAS the Dogrib communities of Rae-Edzo, Lac La Martre, Rae Lakes and Snare Lake have joined together to re-establish the Dogrib Nation under the Dogrib Treaty 11 Council, and

WHEREAS the Minister of Indian Affairs, Hon. Tom Siddon, met with the Dogrib Nation on January 14th 1991 in Rae, N.W.T., and indicated that he would consider negotiating a separate regional claim for the four Dogrib communities of Rae-Edzo, Lac La Martre, Rae Lakes and Snare Lake, and

WHEREAS the Dogrib Treaty 11 Council accepts the fundamental principles of the comprehensive claims policy,

THEREFORE, BE IT RESOLVED THAT:

1. The Dogrib Treaty 11 Council assume full control and responsibility for negotiation of any Land Claims Agreement for the Dogrib Nation, and that the Dene Nation and the Metis Nation henceforth not represent the Dogrib Nation in any future Land Claims and/or other related negotiations with any levels of Government,
2. The Dogrib Treaty 11 Council initiate negotiation with the Federal Government of Canada for a Dogrib Nation Regional Comprehensive Claim on behalf of the four Dogrib communities of Rae-Edzo, Lac La Martre, Rae Lakes and Snare Lake, and
3. The Government of Canada be requested to provide adequate funding, under a negotiation loan contribution agreement with the Dogrib Treaty 11 Council, so that the work required to plan for, negotiate and settle a comprehensive Land Claim can be carried out in the Region as soon as possible.

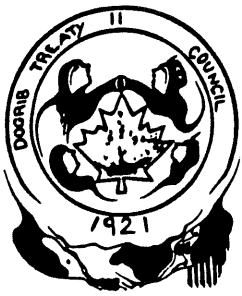
