Dear George;

Our experiences with nurses and Baffin Region Health services have generally been very favourable in the past. We now have a situation however, that the community cannot tolerate any longer, and we require immediate action.

Cora Scott has been here for around 2 years, and we do realize she is suppose to be leaving soon, but we do not want her services in this community effective immediately.

We are also concerned that a future injustice may be done with her receiving future benefits when her conduct may not have been ethical in terms of nursing standards. For all of the above reasons and to be sure a situation like this never happens again, we request a formal community inquiry be conducted. Your immediate action on this matter is required.
