MANDATE FOR THE ADVISORY COUNCIL:



The Act to establish the Advisory Council on the Status of Women was proclaimed on January 16, 1984.

The Advisory Council consists of such number of members as the Minister deems appropriate, who are representative of the women in the Territories and their interests. Council members are appointed for a three year period.

The Act states that their duties are:

To advise the Minister on matters referred to them and on issues they deem appropriate.

Regarding concerns of women they may:

Receive and hear petitions and suggestions.

Recommend and undertake appropriate research.

Recommend and participate in programs.

Publish reports, studies and recommendations.

Furnish the public with information.

Recommend policies and programs to promote the status of women.

Submit reports to the Minister for presentation to the Legislative Assembly.

Assist the Minister in developing public awareness of the status of women.

#### **ISSUES ADDRESSED:**

The Advisory Council has pressed the government to hire more women at senior levels and has recently been pleased to see some progress made.

The Council has also been encouraging the government to include women in the Affirmative Action program, now at the policy development stage. This will continue to be a priority concern.

Native women's rights under the Indian Act - Bill C-31.

Trapping rights for native people.

Initiatives to address the problem of spousal assault.

Fair sentences for batterers and sexual assault offenders.

De-indexing of senior citizens' pensions and family allowances.

Developed a Talent Bank of women's names from which recommendations for appointments of women to various boards and councils are made.

The Council has lobbied for major improvements in the field of childcare for northerners, including:

- An increase in the level of financing for students in training;
- An increase in the number of spaces;
- Development of legislation and standards.

In the area of education they have lobbied for:

- School counsellor training that will include counselling skills for problems such as spousal assault, sexual abuse and incest;
- Self-defence training for girls;
- Distance education for women in remote communities who are unable to take advantage of traditional educational opportunities because of financial or family circumstances;
- Removal of sex stereotyping in the school curriculum;
- Midwifery training for nurses at the Iqaluit (Frobisher Bay) Hospital, and midwives to be more generally available in the N.W.T.
