RESOLUTION #2 - 88

NORTHERN ENERGY ACCORD

Whereas the Government of the Northwest Territories and the Government of Canada have recently signed an Agreement-in-Principle on a Northern Energy Accord (to transfer legislative and management responsibilities for oil and gas from the federal to the territorial government) and:

Whereas this Agreement-in-Principle was signed without consultation from the Inuit as represented by the Tungavik Federation of Nunavut and;

Whereas said consultation was agreed upon through a Memorandum of Understanding signed by both Nellie Cournoyea, Minister of Energy, Mines and Resources, Government of the N.W.T. and Donat Milortuk, President of the Tungavik Federation of Nunavut on April 11, 1988 and;

Whereas much of the Agreement-in-Principle itself is unacceptable to the inuit;

Now Therefore Be It Resolved that the Board Meeting of the Keewatin Inuit Association held in Rankin Inlet on September 28, 1988 reject the Northern Energy Accord Agreement-in-Principle and;

Further Be it Resolved that the Keewatin Inuit Association strongly recommends that the Territorial Government meet with representatives of northern aboriginal peoples to establish the long awaited northern accord team and renegotiate with the federal government principles for the said accord.

I urge you to act promptly on this matter.
