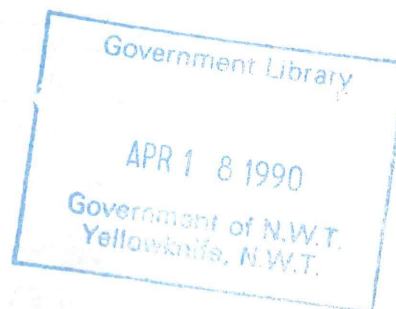
**RE: PETITION CONCERNING CHARLES PASTORI**


