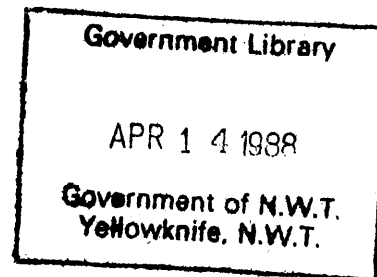

INTRODUCTION

This handbook is an information document to provide a single source of information on the membership of public committees, boards and councils in the Northwest Territories, as appointed by the Legislative Assembly, the Executive Council, a Minister or the Commissioner. It is published annually by the Priorities and Planning Secretariat of the Government of the Northwest Territories.

The authority under which each agency acts varies and is specified for each listing along with a description of its function, who appoints members, and who the agency reports to.

All public boards are subject to the provisions contained in the Financial Administration Act and the Government of the Northwest Territories Financial Administration manual.

APPOINTMENT PROCEDURES

ACCOUNTABILITY

The final appointment authority for boards and agencies varies with the legislation or policy under which it was formed. The Minister responsible may appoint members to a board where that authority has been specified in the legislation or policy establishing it. In other instances, the Executive Council or Commissioner must approve appointments. The governing instrument should be referred to in each case.

NOMINATION PROCEDURE

- The Minister responsible is notified by the Board Chairman that a vacancy will occur six weeks prior to the term expiring or at the time an unexpected vacancy occurs.
- The Minister may seek suggestions for suitable candidates for board membership from:
 - Colleagues
 - MLAs
 - Deputy Minister (who may request Regional Superintendents' input)
 - Regional Directors
 - Community and Regional Councils
 - Chairman of the Board in question
 - Other persons or agencies relevant to the board's activities
- Nomination for Appointment forms (attached as Annex A) will be completed for each nominee by the person making the nomination. These forms are available from the board chairman, Deputy Minister, Regional Director or Regional Superintendent. The Deputy Minister will make persons making the nomination aware of any particular qualifications the board appointee should have.
- The names will be compiled by a person designated by the Minister (usually a Deputy Minister or equivalent position).
- Candidates identified by the Minister as suitable and qualified for a particular board shall be screened by the Deputy Minister for potential conflicts of interest as defined in the "Act Respecting Conflict of Interest of Members of Boards and Municipal Councils." The Deputy Minister will then contact appointees selected by the Minister to ensure they are willing to participate on the board in question and understand the duties and responsibilities of the position.
- If the Minister or Commissioner has the authority to make the appointment, an Information Item is prepared by the Minister,

indicating candidates remaining and the Minister's choice, and placed on the Executive Council agenda. The Information Item should have as an attachment a list of membership of the current board as contained in the Public Committee, Boards and Councils up[date issued annually by the Priorities and Planning Secretariat (sample attached as Annex B).

- Community level committees may be appointed without going through the above nominating procedure, (eg. Community Social Assistance Appeal Committees). These appointments, however, must follow the legislated appointment procedures.
- Once the meeting of the Executive Council takes place with the information item on the agenda, and there are no objections or specific direction given to the contrary, the Minister takes the appropriate steps to make the appointment as specified under the section on appointment procedures below.
- If the Executive Council has the authority to make the appointment, the item should be placed on the Executive Council agenda as a Decision Item in Decision Paper format with the membership list attached as given in Annex B.

In some instances, the Legislative Assembly must approve nominations prior to appointments being made. This should be done after the above nomination procedure.

APPOINTMENT PROCEDURE

For Boards Created through Legislation

After the proposed appointment has appeared as an Information Item on the Executive Council agenda, or the Legislative Assembly has confirmed appointments as required by Legislation, the Chairman of the Board is contacted by the Minister and advised of the appointment.

The Deputy Minister of the department providing administrative support or who deals with that board, obtains the necessary forms (Attached as Annex C) from the Legislation Division and provides the necessary information to prepare the appointment.

The Legislation Division prepares the appointment on the appropriate instrument for signature by the Minister or Commissioner as specified in the Legislation creating the board or agency. It is this instrument which makes the appointment official.

Although statutory requirements may call for the Commissioner to sign the instrument prepared by the Legislation Division of the Department of Justice, it is normal practice for the Minister responsible to make the official notification of the appointment by means of a letter from the Minister to the appointee.

The Legislation Division registers the instrument and publishes it in the NWT Gazette.

For Boards Created through Policy

Where the individual Minister has appointment authority, a letter from the Minister makes the appointment official after the appointment has appeared as an Information Item on the Executive Council agenda.

Where the Executive Council has appointment authority, a Record of Decision is required to make the appointment official. In this case the letter from the Minister responsible serves as notification of the appointment.

For consistency with appointments made for organizations created through Legislation, the appointment form attached as Annex D should be completed, signed by the Minister responsible, and forwarded to the Legislation Division for publication in the NWT Gazette.

The Minister's authority would be noted as either the meeting number where the item appeared as an Information Item in the case where the Minister has authority, or the Record of Decision number in the case where the Executive Council has authority for the appointment. Although publication of board appointments in the NWT Gazette is not a legal requirement, it provides a single reference source for all appointments made by the Government of the Northwest Territories.
