# AN ACT TO AMEND THE BOILERS AND PRESSURE VESSELS ACT

### Statement of Purpose

The purpose of this Bill is to amend the <u>Boilers and</u> <u>Pressure Vessels Act</u> to change the imperial measurements to metric; to replace the Director with the Minister in respect of certain powers; to replace the Director with the chief inspector in respect of certain powers; to amend certain provisions in the Act respecting certificates of qualification and welding operators; to amend the offence provision to specify that the maximum penalty under this Act is \$5,000 or imprisonment of one year or both; and to amend the regulation-making provisions with respect to certificates of qualification, welding operators and plants.

#### IMPORTANT

This Bill is tabled for public review. This proposed Act does not represent the final policy of the Government of the Northwest Territories and is subject to change after public review and comments. Furthermore, changes of a technical nature can be expected to prepare the Bill for introduction in the Legislative Assembly.

## AN ACT TO AMEND THE BOILERS AND PRESSURE VESSELS ACT

The Commissioner of the Northwest Territories, by and with the advice and consent of the Legislative Assembly enacts as follows: 10

1. The <u>Boilers and Pressure Vessels Act</u> is amended by this Act.

"Operator must be qualified

39.(1) No person shall perform the duties of a chief operating engineer, an operating engineer, a shift engineer or an operator in respect of a plant unless that person holds a temporary certificate of qualification or a certificate of qualification of a class prescribed by regulation that qualifies him to perform those duties in respect of that plant.

(2) No owner of a plant prescribed by regulation shall operate the plant or permit the plant to be operated except under the supervision and attendance of persons who hold temporary certificates of qualification or certificates of qualification of the classes prescribed by regulation in respect of that plant.

Plant may be unattended (3) The owner of a plant prescribed by regulation, with the approval of the chief inspector, may leave the plant unattended provided that the plant is otherwise operated in compliance with the Act, the regulations and any terms or conditions stipulated by the chief inspector.".

Terms and conditions

(2) The chief inspector may issue a temporary certificate of qualification to a person who 5 pays the fees prescribed by regulation, who meets the requirements set out in the regulations and who, in the opinion of the chief inspector, has sufficient experience to operate a plant of the capacity, type or class specified 10 in the certificate.

(3) A certificate of gualification or а temporary certificate of qualification is subject to the terms and conditions set out in 15 the certificate and in the regulations.".

"Issue of welding performance qualification card

51.(1) An inspector shall issue a welding performance qualification card to any person who meets the qualifications required by regulation, 45 passes any examinations or tests required by regulation and pays the fees prescribed by regulation.

Recognition of extraterritorial certificates (2) An inspector may issue a welding performance qualification card to a person without requiring the person to pass an examination or test where the person holds a certificate satisfactory to the chief inspector issued by a province or other jurisdiction that qualifies the person to be a welding operator.

(3) An inspector may issue a provisional

welding performance qualification card to a

person who passes any examinations or tests

required by regulation and pays the fees

(4) A welding performance qualification card or

a provisional welding performance qualification

prescribed by regulation.

Provisional welding performance qualification card

Terms and conditions

Cancellation or suspension

card is subject to the terms and conditions set out on the card and in the regulations.
(5) An inspector may cancel or suspend a 20 provisional welding performance qualification card or a welding performance qualification card

- if the holder of the card
   (a) is incompetent or negligent in the
   discharge of his duties as a welding 25
   operator;
  - (b) has obtained his certificate through misrepresentation or fraud;
  - (c) allows another person to operate under his certificate;
  - (d) fails any test required by the Act or the regulations; or
  - (e) contravenes any other provision of the Act or the regulations.

Appeal

Welding operator must be qualified (6) A person whose welding performance qualification card has been cancelled or suspended under subsection (5) may appeal to the Commissioner in accordance with section 45.

(7) Except where exempted by regulation, no person shall weld a boiler, pressure vessel or plant unless the person holds a welding performance qualification card issued under the regulations authorizing him to do that type of welding.

Prohibition

(8) Except where exempted by regulation, no owner shall require, cause or permit any person to weld a boiler, pressure vessel or plant unless the welding operator holds a welding performance qualification card issued under the regulations authorizing him to do that type of welding.".

"Offence and penalty 54. Every person who violates this Act or the regulations is guilty of an offence punishable on summary conviction and is liable, for each day or part of a day on which the offence occurs or continues, to a fine not exceeding \$5,000 or to imprisonment for a term not exceeding one year or both.".

  - (z.3) providing for the issuance, reinstatement, renewal and terms and conditions of welding performance qualification cards, duplicate welding performance qualification cards and provisional welding performance qualification cards;
  - (z.4) requiring the requalification or reexamination of welding operators and respecting the examinations and tests to be passed;

- (z.5) prescribing the powers and duties of each class of welding operators;
- (z.6) governing welding procedures relating to the fabrication or repair of any boiler, pressure vessel or plant;
- (z.7) respecting the exemption of welding operators from the requirement to hold a welding performance qualification card;
- (z.8) respecting the supervision and attendance by holders of certificates 15 of qualification of plants, types of plants or classes within types of plants; and
- (z.9) establishing classes of boilers and pressure vessels.".

27. Subsection 55(2) is amended by adding ", or such code as amended from time to time" after "such code".
