Surplus due to late approval of EDA agreement and fewer applications than expected. Additional funding was required to fund unbudgeted NWT Business Council activity, additional secretarial support and directorate operating costs. In addition an increased volume of consumer inquiries resulting from Travel Arctic's new advertising campaign required additional funds.

Surplus in Police Services activity is the result of austerity measures relative to the Police Services Agreement and difficulties in maintaining full staff in the Native Special Constable Program. The requirement in Directorate arises from issues relative to the Meech Accord while the requirement in Consumer Affairs is the result of the proclamation of the Residential Tenancies Act. The legal aid overexpenditure is primarily caused by increased tariffs with the Law Society, retroactive April 1, 1987.

Fire operations increase required due to a salary funding shortfall. Surpluses in other areas arise from staff vacancies and lower grants and contribution requirements.

Financial Assistance overexpenditures are the result of the Employment Enhancement Program (\$550) not replacing social assistance costs as anticipated, an increase in "other needs items" due to greater client awareness of benefits available and a greater downswing in community employment than anticipated due to such factors as the delays in EDA and Special ARDA projects.

Family and Children's Services surplus is the result of the late opening of the Territorial Treatment Centre and restricted southern placements in anticipation of the opening. Also there were lower foster care expenses in Inuvik, Baffin, and Kitikmeot.

Young Offenders experienced a substantial decline in open custody demand and less open custody travel.
