## LITERACY PROGRAMS FUNDING - FORT MCPHERSON

The Department of Education has recognized the seriousness of the illiteracy issue in the Northwest Territories. The Department launched a major literacy initiative in 1988-89 and announced a refined Northwest Territories Literacy Strategy during the Fall 1990 sitting of the Legislative Assembly.

The N.W.T. Literacy Strategy has provided additional funding for literacy programs in each of the past three fiscal years, totalling just over \$2 million. Funds were allocated to Arctic College for additional literacy programs, that would enhance the College's mandate to deliver adult basic education and literacy programs at the community level. The College has added literacy programs, in region, through the community learning centres every and particularly in communities without a resident adult educator. was made available funding Secondly, to non-governmental, community-based programs through the Community Literacy Projects Fund to support innovative approaches to illiteracy. The same level of (additional) funding is incorporated into the 1991-92 Department of Education budget currently before the Legislative Assembly.

The residents of Fort Mcpherson, or any community in the Inuvik region, may submit a proposal (through the Local Education the Band Council or a similar non-governmental Authority, organization) for literacy program funding under the Community Literacy Projects Fund. The deadline for 1991-92 funding is April 15, 1991. Information is available from the Literacy Office, Department of Education, GNWT, Yellowknife, X1A 2L9.

Specific program plans or requests for a literacy program through Arctic College may be submitted to the Aurora Campus of Arctic College through the local adult educator; or where there is no adult educator, directly to the Campus.
