THAT WHEREAS, the Dogrib Treaty 11 group met in March to discuss their position of the land claim process, and,

THAT WHEREAS, this group consists of the communities of Rae, Lac La Martre, Rae Lakes and Snare Lake, and

THAT WHEREAS, the Treaty 11 communities would like to clarify their positions taken at the 1990 Detah Assembly and the November 28, 1990 Leadership meeting in Yellowknife, and

THEREFORE, BE IT RESOLVED THAT, the Dogrib Treaty 11 communities declare their neutrality on the issue of the settlement of the claims process, and,

THEREFORE, BE IT FURTHER RESOLVED THAT, this position be announced at the upcoming April 8, 1991 leadership meeting in Yellowknife, to indicate the Dogrib Treaty 11 communities intent to explore other alternatives
