SIXTEENTH SESSION

Ottawa, January 26 - February 3, 1959.

VOTES AND PROCEEDINGS

3 o'clock P.M.

The First Session of the Council for the year 1959, being the Sixteenth Session of the Council of the Northwest Territories, was convened at Ottawa, at 3 o'clock P.M. on Monday, January 26, 1959.

All members except Mr. Audette were present.

PRAYERS.

The Commissioner addressed the Council. His address is set forth in Sessional Paper No. 1.

Mr. Nicholson, seconded by Mr. Gall, moved that the Council express to the Commissioner its appreciation for his opening address. Mr. Nicholson's speech is set forth in Sessional Paper No. 2.

During the debate on the motion, the following subjects were discussed:

- (1) an expression of welcome to Mr. E.J. Gall, as the new member of the Council for the constituency of Mackenzie North;
- (2) regret at the deaths of Dr. Charles Camsell and His Excellency Bishop Trocellier;
- a need for long-term planning for the Municipal District of Yellowknife to prevent a recurrence of the present housing shortage and to alleviate the burden on utilities;
- (4) the acute shortage of electricity in the Yellowknife area;
- (5) the lack of facilities in the Territories for the accommodation and treatment of retarded children;
- the general improvement in the economic situation in the Territories and especially the better price being obtained for fur;

- (8) a suggestion that the time may have come when some administrative functions of the Territorial Government could be transferred to the north;
- a statement that settlements in the north should be able to grow their own vegetables;
- (10) the importance of providing Indians and Eskimos with the means of making a living without clustering around centres of white population;

- (11) a recommendation that small children attending school away from home be accommodated in small hostels where they can receive the individual attention they require;
- (12) the pressing need for a permanent dentist in the northern Mackenzie District;
- (13) the necessity of extending full liquor privileges to Indians and Eskimos and the possibility of doing so in conjunction with some form of rationing;
- the satisfaction of contractors with local labour at Fort Simpson;
- (15) the need for a start on the construction of a causeway across the Snye at Fort Simpson and the availability of equipment in the area for this purpose;
- (16) the importance of roads in opening up timber and game resources;
- (17) the magnanimity of the Indian people and a suggestion that it be emulated;
- (18) a statement that people in the Fort Simpson area can make their own furniture from wood grown locally and a recommendation that a course in furniture-making be incorporated in the Vocational Training Program;
- (19) an expression of praise for the work of Northern Health Services;
- (20) an expression of gratitude to the Grey Nuns for their work in the hospitals of the north;
- (21) a statement that the north is one of the few areas in the world where most of the problems are not man-made;
- (22) a statement that the Territories can expect to progress from the colonial stage to full provincial status only if greater responsibilities are imposed on the Council and a reference to the fundamental importance of the financial arrangements with the Government of Canada as a factor in this development;
- a recommendation that the Council seriously consider assuming greater responsibility for the problems of the Indian and the Eskimo people;
- (24) the importance of implementing a hospital insurance scheme without delay;
- (25) a suggestion that new lakes be opened to limited commercial fishing;
- (26) a recommendation that cold storage plants be constructed for the fishing industry;
- (27) a statement that the design of government buildings in the north has not changed in 30 years and that it is not suited to northern conditions;
- (28) a statement that game resources are not being fully utilized;

- (29) the need for a bridge at Hay River to complete the Mackenzie Highway;
- (30) a statement that isolation pay for government employees should be made uniform throughout the Territories.

The Council adjourned at 6 o'clock P.M.

TUESDAY, JANUARY 27, 1959.

10 o'clock AIM.

PRAYERS.

The Council continued the debate on the motion that it express to the Commissioner its appreciation for his opening address.

During the debate, the following subjects were discussed:

- (I) a statement that it was in the interest of employers to hire Indians;
- (2) the importance of not encouraging unskilled labourers to go into the north unless there is a shortage which cannot be overcome locally;
- (3) a statement of appreciation for the outstanding service of Mr. R.A. Bishop as Secretary of the Council;
- (4) a statement that the Mackenzie Highway is being surveyed from Hay River south for the purpose of reconstruction;
- (5) a statement that the area around Alexandra Falls is reserved for the development of hydro power and a recommendation that it not be released for any other purpose;
- (6) a report that wood is to be used to heat schools at Lac la Martre and Jean Marie River.

The Council went into Committee of the Whole to consider further the motion on the Commissioner's opening address, Mr. Goodall in the chair.

A number of the subjects referred to in the formal debate were discussed in greater detail. In addition, the following points were considered:

- (1) a concern for old people living in the Territories who are in need of some form of care and a suggestion that assistance be given to private institutions in the Territories for this work;
- (2) the possibility of providing temporary sources of power at Yellowknife by means of portable generators;

- delays in administrative procedures in the north and a statement that forthcoming changes in organization should overcome them;
- (4)—a statement that representatives of the Indian Affairs Branch of the Department of Citizenship and Immigration have extensive discretionary powers when there is an emergency;
- (5) the possibility of growing grain in the Aklavik area and the suggestion that an experimental agricultural station be established there;
- (6) a statement that the Department of Agriculture is doing more experimental work in the north;
- (7) a statement that the missions in the north have given up growing potatoes because of the increased labour costs;

The Committee adjourned at 1 o'clock p.m.

3 o'clock P.M.

The Committee continued its consideration of the motion on the Commissioner's opening address, Mr. Goodall in the chair.

In addition to the subjects referred to in the formal debate, the Committee considered the following:

- (1) the fact that sawmills on the Mackenzie River established by the Indian Affairs Branch are primarily to enable Indians to obtain lumber for their houses;
- a recommendation that a suitable building be established in each Indian settlement as a community hall. It was felt, however, that schemes of this kind should be undertaken on the initiative of the local people rather than the government and that government assistance should depend on the effort the people in a locality are prepared to make;
 - (3) a proposal that an Unsatisfied Judgments Fund be established for the Northwest Territories and the difficulty of making the fund large enough to meet claims when there are so few vehicles;
 - (4) a suggestion that licence fees for school buses be reduced;
 - -(5) a request that officers of the Department of Northern Affairs and National Resources assist people in preparing unemployment insurance claims;
 - (6) the desirability of imposing rigid sanitation and residence codes on Eskimos relocated in new settlements;
 - (7) a recommendation that Indians catching fish for their own use in the domestic fishing areas of Great Slave Lake be permitted to sell their catch for cash but that a limit be imposed on the amount of fish taken by each person;

- (8) a recommendation that airstrips be built at Fort Rae and Coppermine;
- (9) a suggestion that airstrips throughout the Territories be opened to all aircraft and the explanation that the Air Transport Board presently exercises control by means of licensing routes rather than by restricting entry of aircraft into particular airports.

The Council adjourned at 6 o'clock p.m.

PRAYERS.

The Commissioner welcomed Mr. Audette.

The Committee continued its consideration of the motion on the Commissioner's opening address, Mr. Goodall in the chair.

In addition to the subjects referred to in the formal debate, the Committee considered the question of adopting an appropriate emblem for the motor vehicle licence plates of the Northwest Territories. It was suggested that the plates should also be brighter in colour and should have a new motto.

Mr. Goodall presented the report of the Committee. The Committee recommended favourably on the motion on the Commissioner's opening address. The question being put on the motion, it was carried unanimously.

Mr. Brown, seconded by Mr. Nicholson, moved that Mr. F.B. Fingland be appointed Secretary of the Council.

The question being put on the motion, it was carried unanimously.

Mr. Drury, seconded by Mr. Audette, moved that an expression of gratitude be conveyed to Mr. R.A. Bishop for the outstanding way in which he performed his duties as Secretary to the Council.

The question being put on the motion, it was carried unanimously.

On a motion by Mr. Drury, seconded by Mr. Audette, Bill 1, An Ordinance to Amend the Business Licence Ordinance, was read the first time.

On a motion by Mr. Goodall, seconded by Mr. Porritt, Bill 2, An Ordinance Respecting Co-operative Associations, was read the first time.

"THAT Rule No. 2 of the Rules of the Council be suspended from 3 P.M. to 6 P.M. on Monday, the 2nd of February, 1959."

The question being put on the motion, it was carried unanimously.

Mr. Porritt, seconded by Mr. Gall, moved

"THAT this Council go on record as recommending to the Government of Canada the desirability of commencing construction at the earliest possible date of the railway projected from northern Alberta to Great Slave Lake, and we advocate the choice of route which will, in our opinion, now and in the future serve the greatest number of people and make the greatest contribution to the development and settlement of the area as well as the welfare and economy of Canada."
